BOARD MATTER

1. **MOMENT OF SILENCE** (9:35 a.m.)

Chairman McKay acknowledged that:

- Yesterday, March 4, 2024, a large number of Fairfax County Fire Department and Public Safety members attended the funeral service of Sterling Volunteer Firefighter Trevor Brown, who died in the recent house explosion in neighboring Loudoun County
- He, along with Supervisor Walkinshaw, former Chairman Sharon Bulova, and former Supervisor Penny Gross attended Former Fairfax City Mayor John Mason's Memorial Service, which was held Saturday, March 2, 2024

The Board asked everyone to keep in thoughts the family and friends of:

- Reverend Alan Farley, who died recently. He was a West Springfield High School graduate, civil war re-enactor, and was dedicated to doing missionary work in the community
- Ken Hartman, who died recently. He was an original resident of Ravensworth Farms and served as treasurer for its Civic Association; was a Navy veteran, engineer, and active member of the First Presbyterian Church of Annandale

AGENDA ITEMS

2. <u>RESOLUTION OF RECOGNITION PRESENTED TO HEMAN BEKELE</u> (9:37 a.m.)

Chairman McKay relinquished the Chair to Vice-Chairman Smith and moved approval of the Resolution of Recognition presented to Heman Bekele for winning the 2023 Young Scientist Challenge and being named America's Top Young Scientist. Supervisor Walkinshaw seconded the motion and it carried by unanimous vote.

Chairman McKay relinquished the Chair to Vice-Chairman Smith and moved approval of the Resolution of Recognition presented to Lula Bauer, Executive Director of the Lee Mount Vernon Sports Club, for her induction into the Va-DC Soccer Hall of Fame. Supervisor Lusk seconded the motion and it carried by unanimous vote.

Vice-Chairman Smith returned the gavel to Chairman McKay.

5. <u>PROCLAMATION DESIGNATING MARCH 10–16, 2024, AS "FLOOD AWARENESS WEEK" IN FAIRFAX COUNTY</u> (10:11 a.m.)

Supervisor Walkinshaw moved approval of the Proclamation designating March 10–16, 2024, as "Flood Awareness Week" in Fairfax County. The motion was multiply seconded and it carried by unanimous vote.

6. PROCLAMATION DESIGNATING MARCH 3–9, 2024, AS "CONSUMER PROTECTION WEEK" IN FAIRFAX COUNTY (10:28 a.m.)

Chairman McKay relinquished the Chair to Vice-Chairman Smith and moved approval of the Proclamation designating March 3–9, 2024, as "Consumer Protection Week" in Fairfax County. Supervisor Palchik and Supervisor Lusk jointly seconded the motion and it carried by unanimous vote.

Vice-Chairman Smith returned the gavel to Chairman McKay.

7. PRESENTATION OF THE TRANSPORTATION ADVISORY COMMISSION (TAC) 2022 AND 2023 TRANSPORTATION ACHIEVEMENT AWARDS (10:39 a.m.)

Michael Champness, Chairman, TAC, acknowledged the presence of TAC Members Christie Garton (Vice-Chairman) and Kevin Morse (Braddock District), and Staff Coordinator, Calvin Lam, who were present in the Board Auditorium.

Mr. Champness presented the 2022 and 2023 TAC Transportation Achievement Awards to the following:

• 2022 – Burke VRE Connector Trail Phase IV Project Team

• 2023 – Active Transportation Projects Team

8. **REPORT ON GENERAL ASSEMBLY ACTIVITIES** (10:52 a.m.)

Supervisor Walkinshaw, Chairman of the Board's Legislative Committee, stated that the Committee met on February 23 and March 1. He presented the report on General Assembly activities, noting the following:

- The County initiatives continue to move through the legislative process successfully. Both initiatives have passed through the House and the Senate and are headed to Governor Youngkin for consideration:
 - O The first initiative addresses local speed limits and gives local governments the authority to reduce speed limits in business and residential districts from 25 to 15 miles-per-hour. The Virginia Department of Transportation has to date not opposed the bill and that helped speed the path through the General Assembly
 - The second initiative addresses deadlines for certifying election results
- A key area of focus for the remainder of the session will be the 2024-2026 Biennium Budget. During the last two Legislative Committee meetings, staff provided an analysis of how the budgets adopted by the House and the Senate affect key County priorities. That budget is now in conference and staff are closely monitoring the negotiations and will provide updates as it unfolds
- The House and Senates budget approach K–12 funding in very different ways:
 - The Senate budget provides \$198.6 million statewide to fully eliminate the cap on support positions that were implemented in FY 2010 as a budget cutting measure during the great recession and eliminating that cap has been a longtime priority of the County and other localities. It also includes \$121.3 million in FY 2025 to restore funding for K 12 education that is required to compensate for the elimination of the State portion of the sales tax on food. Governor Youngkin did not include that funding in his introduced budget, despite the fact that it was a critical component of the agreement that he agreed to, to eliminate the grocery tax. When compared to the

Fairfax County Public Schools (FCPS) advertised budget that the County has been discussing with the School Board, the Senate budget would provide an additional \$43.1 million more than FCPS anticipated when its budget was built

- o The House budget takes a different approach to K-12 funding and does not fund the two key items just mentioned. It directs most of its increased funding into the at-risk add-on formula, which unfortunately measures poverty across entire school divisions and as a result does not appropriately reflect the high concentrations of poverty that exist in some schools within FCPS and in some areas of the County. The House budget also contains a dramatically higher staffing standard for English language learners which would require substantial local cost. It is an unfunded new mandate on local school systems. When compared to that FCPS advertised budget, the House budget results in a negative impact to FCPS of \$58.3 million
- In Virginia, unlike Maryland, local jurisdictions have historically provided substantial funding for the Washington Metropolitan Area Transit Authority (WMATA), though the benefits of metro (very real financial benefits especially), are shared by the entire Commonwealth. It is vital that the Commonwealth provide funding for WMATA to address the looming budget shortfall to put the agency on sound financial footing without diverting resources from other transportation needs in Northern Virginia and the Commonwealth. While the House budget includes additional funding to help mitigate WMATA's shortfall, the Senate passed budget does not include such assistance. Although this past weekend the Chair of the Senate Finance and Appropriations Committee did announce that the Senate would be supportive of including WMATA funding in the final budget conference report. Staff will continue to watch that issue closely as a budget is negotiated
- Both budgets include funding to eliminate the Priority I waitlist for developmental disability slots over the biennium, as well as to increase reimbursement rates. Those Medicaid waivers are a lifeline for people with developmental disabilities, providing them with access to essential services and care. Despite almost yearly investments from the Commonwealth to increase the number of waiver slots, the Fairfax-Falls Church Priority I waitlist has doubled since FY 2018 and includes more than 1200 individuals,

which is more than one-third of the approximately 3400 individuals on the entire Statewide waiting list. The waivers have been increased, but the waitlist is growing faster than the increases

• The Legislative Committee also receives updates on a number of bills related to public safety, land use, human services, and transportation, among other topics. While just over 1400 Bills have passed both chambers and await gubernatorial action, nearly 700 Bills are still awaiting final disposition. There is a lot of items to work through in a short period of time. Sometimes these things get resolved very quickly in the final days or hours of the session, and sometimes extra time is needed

Supervisor Walkinshaw moved adoption of Legislative Committee Report Number Three. Chairman McKay seconded the motion. Following discussion regarding education funding and the Medicaid waiver issue, the question was called on the motion and it carried by a vote of nine, Supervisor Herrity voting "NAY."

ADDITIONAL BOARD MATTERS

9. <u>PROCLAMATION REQUEST DESIGNATING MAY 2024 AS "JEWISH AMERICAN HERITAGE MONTH"</u> (11:04 a.m.)

Chairman McKay relinquished the Chair to Vice-Chairman Smith and, jointly with Supervisor Jimenez and Supervisor Palchik and asked unanimous consent that the Board direct staff to prepare a Proclamation designating May 2024 as "Jewish American Heritage Month" in the County. Without objection, it was so ordered.

10. PROCLAMATION REQUEST DESIGNATING MAY 2024 AS "NATIONAL FOSTER CARE MONTH" (11:04 a.m.)

Chairman McKay asked unanimous consent that the Board direct staff to prepare a Proclamation designating May 2024 as "National Foster Care Month" in the County. Without objection, it was so ordered.

11. PROCLAMATION REQUEST DESIGNATING MARCH 21, 2024, AS "SAVE SOIL DAY" (11:04 a.m.)

Chairman McKay asked unanimous consent that the Board direct staff to prepare a Proclamation designating March 21, 2024, as "Save Soil Day" in the County. Without objection, it was so ordered.

12. <u>RESOLUTION OF RECOGNITION REQUEST FOR NORTHERN VIRGINIA FAMILY SERVICE</u> (11:04 a.m.)

Chairman McKay asked unanimous consent that the Board direct staff to prepare a Resolution of Recognition for Northern Virginia Family Service, in recognition of its 100th anniversary on May 3, 2024. Without objection, it was so ordered.

13. RESOLUTION OF RECOGNITION REQUEST FOR VOLUNTEER FAIRFAX (11:04 a.m.)

Chairman McKay asked unanimous consent that the Board direct staff to prepare a Resolution of Recognition for Volunteer Fairfax's 50th anniversary, which coincides with its annual Volunteer Appreciation Day, which is on May 9, 2024, this year. Without objection, it was so ordered.

14. NOTICE OF LAND USE PUBLIC HEARINGS TO RENTERS IN APARTMENT BUILDINGS AND TO OWNERS AND RENTERS WITHIN MANUFACTURED HOUSING COMMUNITIES (11:05 a.m.)

Chairman McKay stated that on December 6, 2022, the Board directed staff to explore whether the County's written notice procedures for land use applications meet the Board's goals to encourage robust public participation in the land use process. Specifically, the Board identified two areas of concern. The first relates to whether renters of apartments and renters and owners of manufactured homes are receiving adequate notice of land use applications, particularly applications that apply to the property on which they live. The second relates to the requirement that written notification be provided by certified mail, which can impact accessibility if residents are not home to receive the certified mail. While individualized written notice is only one way in which the community is engaged, it is one of the most direct ways to inform and encourage public participation in development proposals in neighborhoods.

On January 18, 2024, staff delivered a memo to the Board reviewing these issues and recommending a pair of pilot projects related to written notice.

First, staff recommended a pilot project for the County to provide written notice to (i) all residents of a manufactured housing community of any public hearing for a land use application on or adjacent to that community, and (ii) to all residents of any apartment complex that is the subject of a land use application. As discussed in the memo, such notice would be provided in the same manner and on the same schedule as other written notice of public hearings. This additional notice would be in addition to any outreach efforts undertaken by the applicant and/or the Supervisor's office during the land use process.

Second, staff recommended a pilot project to use first-class mail rather than certified mail to deliver written notice of public hearings on zoning applications. As expressed in the memo, applicants would prepare notice packets, using

first-class mail stamps, and deliver those packets to staff with appropriate documentation for review and mailing. This will require some modifications to the current affidavits and documentation used, as well as coordination on appropriate timing to meet the requirements of the Virginia Code and the Zoning Ordinance.

Therefore, to effectuate the Board's goal of increasing public engagement in the land use process, jointly with Vice-Chairman Smith, Supervisor Lusk, Supervisor Storck, and Supervisor Walkinshaw, Chairman McKay moved that the Board direct:

- The Department of Planning and Development (DPD) and the Department of Clerk Services to initiate the two pilot projects proposed in DPD's January 18, 2024, memo. The pilot project to provide written notice to residents and owners in manufactured housing communities and renters in apartment buildings should begin immediately; the pilot project to utilize first-class mail should begin as soon as possible after appropriate outreach to and coordination with the development community
- Staff report to the Board in a year with recommendations as to the effectiveness of the initiatives, and whether they should be continued on a permanent basis

Vice-Chairman Smith and Supervisor Lusk jointly seconded the motion and it carried by unanimous vote.

Vice-Chairman Smith returned the gavel to Chairman McKay.

15. <u>RECOGNITION REQUEST FOR THE 2024 FIRST AMENDMENT PRESS</u> <u>FREEDOM AWARD</u> (11:10 a.m.)

Supervisor Smith stated that the Journalism Education Association (JEA), with representatives from the National Scholastic Press Association (NSPA), and the Quill and Scroll International Honorary Society recently named Chantilly High School (CHS), McLean High School (MHS), and West Springfield High School (WSHS), recipients of the 2024 First Amendment Press Freedom Award. The three schools are among 28 schools from across the United States to receive this award and this is the tenth consecutive year that CHS has received this recognition, the seventh consecutive award for MHS, and the second for WSHS.

The award recognizes public high schools that actively support, teach, and protect First Amendment rights and responsibilities of students and teachers, with an emphasis on student-run media where students make all final decisions of content.

Therefore, jointly with Supervisor Bierman and Supervisor Herrity, Supervisor Smith asked unanimous consent that the Board direct staff to invite representatives from CHS, MHS, WSHS and the journalism students from the

respective schools to appear before the Board to be acknowledged for their superior achievement. Without objection, it was so ordered.

16. PROCLAMATION REQUEST FOR ATHLETIC STATE ACHIEVEMENTS (11:11 a.m.)

Supervisor Walkinshaw stated that the County is fortunate to offer its students a diverse range of sports opportunities. Participation in school-based athletics not only complements classroom learning but also enhances students' attitudes towards academics and overall performance. It serves as a healthy outlet, promoting physical well-being and fostering teamwork and relationships.

The County is proud to highlight the achievements of athletes from Woodson High School and Lake Braddock Secondary School at their recent State championships. Below are their notable accomplishments:

Therefore, jointly with Chairman McKay, Supervisor Herrity, Supervisor Jimenez, and Supervisor Palchik, Supervisor Walkinshaw asked unanimous consent that the Board direct the Office of Public Affairs to prepare Proclamations in recognition of the athletes' special achievements, along with their coaches and families, to be presented at a later date. Without objection, it was so ordered.

17. PROCLAMATION REQUEST DESIGNATING MARCH 31, 2024, AS "TRANSGENDER VISIBILITY DAY" (11:12 a.m.)

Supervisor Bierman stated that March 31 is International Transgender Day of Visibility. It was created in 2009 as a day dedicated to celebrating the lives and accomplishments of transgender people and to raising awareness of the continuing challenges faced by transgender people.

The County is home to the Transgender Education Association whose mission is to support transgender and gender-nonconforming people and their friends, family, and partners, and to provide educational resources and information to all interested parties.

In celebration of the County's richly diverse population and its One Fairfax policy, the County affirms and restates its commitment to build a culture of inclusion and acceptance of transgender individuals and appreciate that the County grows stronger when all persons in the County are recognized and celebrated.

Therefore, jointly with Chairman McKay, Supervisor Alcorn, Supervisor Jimenez, Supervisor Lusk, Supervisor Palchik, Supervisor Smith, Supervisor Storck, and Supervisor Walkinshaw, Supervisor Bierman moved that the Board direct staff to:

- Prepare a Proclamation designating March 31, 2024, as "Transgender Visibility Day" in the County, to be presented to the Transgender Education Association at the March 19, 2024, Board Meeting
- Invite representatives of the transgender community and their allies to the March 19, 2024, Board Meeting, for presentation of the Proclamation

Supervisor Palchik and Supervisor Smith jointly seconded the motion and it carried by a vote of nine, Supervisor Herrity being out of the room.

18. NO BOARD MATTERS FOR SUPERVISOR LUSK (FRANCONIA DISTRICT) (11:15 a.m.)

Supervisor Lusk announced that he had no Board Matters to present today.

19. NO BOARD MATTERS FOR SUPERVISOR ALCORN (HUNTER MILL DISTRICT) (11:15 a.m.)

Supervisor Alcorn announced that he had no Board Matters to present today.

20. <u>ANNANDALE HIGH SCHOOL (AHS) PRINCIPAL HONORED FOR</u> EDUCATIONAL LEADERSHIP (11:15 a.m.)

Supervisor Jimenez announced that Shawn DeRose, Principal at AHS, recently was awarded a Northern Virginia Leadership Award, presented by Leadership Fairfax. Supervisor Jimenez stated that Mr. DeRose received the Educational Leadership Award, which recognizes a teacher or administrator who has demonstrated a long-term and consistent pattern of excellent leadership, exemplifies a passion for educating, embraces innovation, and provides inspirational leadership to students,

parents, and the community. On behalf of the Board, Supervisor Jimenez congratulated Mr. DeRose on being selected for the award.

21. **WOMEN'S HISTORY MONTH** (11:16 a.m.)

Supervisor Storck announced that March is Woman's History Month and provided a brief history, highlighting places in the County where the community can celebrate and learn more about it. He shared information pertaining to Elizabeth Hartwell and Ann Pamela Cunningham regarding their contributions to the County.

(NOTE: Later in the meeting, Supervisor Palchik presented a Board Matter on Women's History Month. See Clerk's Summary Item #23.)

22. PROCLAMATION REQUEST FOR HOLY TRINITY LUTHERAN CHURCH (HTLC) (11:20 a.m.)

Supervisor Palchik stated that in the Providence District, and across the County, the community is fortunate to have a multitude of faith communities that feel called to provide community outreach and support to improve the lives of congregants and community members. One such congregation, the HTLC, has been an incredible community resource for Falls Church and surrounding areas for the past 75 years.

HTLC was formally established on January 24, 1949, and it soon embarked on what is now a long tradition of service and support to those in need. Within a few years, the church began sponsoring a German refugee family and a Boy Scout troop and began offering kindergarten in response to community interest.

During the 1960s, HTLC's community outreach and service expanded to include regular blood drives, sewing projects to assist the needy, a nursing home visitation program, and frequent youth and music events open to the community. HTLC provided key leadership for forming the Falls Church Community Services Council in 1969 and has supported the Council ever since.

In subsequent decades, the Church's community outreach and services to the community grew to include over 40 years of Meals on Wheels delivery, 15 years of regular volunteering at Miriam's Kitchen, and it was one of the first churches in the County to participate in the FACETS Hypothermia Prevention Program. Since 2007, it has hosted an overnight hypothermia shelter for a week each year. HTLC also established a special endowment fund that distributes thousands of dollars to local service organizations annually.

In recent years, HTLC has added community outreach and support activities focused on education and the arts. For nearly a decade, HTLC has provided tutoring, books, and other needed items to Graham Road Elementary School, and in 2017 it met a community need for more infant childcare by making part of its facility available. The church also presents a free annual Concert Series for the

community, as well as a visual art display space and receptions for the Vienna Arts Society.

HTLC has been a bedrock, not only for its own faith community, but for other communities in the Falls Church area. HTLC's growth has mirrored that of the County by serving the changing community in the array of new challenges that have arisen. Supervisor Palchik expressed her appreciation for the dedicated commitment to community that Holy Trinity Lutheran Church has displayed for 75 years and looks forward to its continued leadership in the years ahead.

Therefore, Supervisor Palchik asked unanimous consent that the Board direct staff to prepare a Proclamation in recognition of HTLC's 75th anniversary and appreciation of its history of service to the community, to be presented at an anniversary celebration event later this year. Without objection, it was so ordered.

23. **WOMEN'S HISTORY MONTH** (11:24 a.m.)

(NOTE: Earlier in the meeting, Supervisor Storck presented a Board Matter pertaining to Women's History Month. See Clerk's Summary Item #21.)

Supervisor Palchik announced that on March 22, 2024, from 2 p.m. – 5 p.m., in the Board Auditorium, the University of Virginia will give a presentation: "The Gains, Gaps and Goals – The Status of Women and Girls in Fairfax County," followed by a panel discussion, and audience question and answer period. Light refreshments will also be provided and it will be livestreamed on Cable Channel 16. The formal finalized invitation and additional information is forthcoming. Supervisor Palchik also shared that a Women's History Month Proclamation will be presented at the event.

24. PUBLICITY AND PROCLAMATION REQUESTS DESIGNATING MAY 2024 AS "LYME DISEASE AWARENESS MONTH" AND "FIGHT THE BITE AWARENESS MONTH" (11:26 a.m.)

Supervisor Herrity stated that tick and mosquito season will be here soon and many will be spending more time outdoors in the warmer months. Since the pandemic, residents have spent more time outside, contributing to higher numbers of confirmed and likely cases of Lyme Disease, the fastest spreading vector-borne disease in the United States. Several hundred cases of Lyme Disease have been reported in Virginia in the last few years and many cases go unreported, as symptoms, like the 'Bulls-eye' rash, go undetected or are misdiagnosed. Supervisor Herrity stated that the Virginia Department of Health (VDH) shared with his office, that since 2020, many efforts to track Lyme Disease were diverted to the pandemic effort so more cases than normal likely were not reported.

Lyme Disease, Zika Virus, West Nile Virus, and other vector-borne diseases can have severe health impacts on constituents. Chronic forms of these diseases can be particularly debilitating and research funding is unfortunately limited.

Consequently, Lyme Disease and other tick-borne diseases can be difficult to diagnose as most residents and many medical providers are unfamiliar with its symptoms. In the last two years, the National Capital Lyme and Tick-Borne Disease Association has spearheaded efforts through legislation in the General Assembly to promote education on tick-borne illnesses, including House Bill 850 in 2022 and House Bill 2008 in 2023. As a result of those efforts, last summer a working group of State agencies and partners were tasked with making the following recommendations to address:

- Increasing the public awareness of tick-borne diseases and strategies for preventing the transmission of tick-borne diseases
- Educating health care providers and the public about the importance of and the need for early diagnosis and treatment of tick-borne diseases
- Improving public health surveillance and data collection related to tick-borne diseases
- Developing and implementing strategies to reduce the tick populations, to in turn reduce the risk of exposure to and transmission of tick-borne diseases in the Commonwealth

The working group submitted its findings to Governor Youngkin and the VDH with recommendations, including creating lesson plans for K-12 education on tick-borne diseases, continuing education for medical providers, and modernization of visuals used for public health data on tick-borne diseases.

Lyme is a terrible disease that can take many forms, from muscle pain to arthritis, to heart disease and Bell's Palsy. It can cause flu-like symptoms as well as extreme fatigue. Lyme Disease Awareness month is officially recognized in May and provides an opportunity to bring this issue to the public's attention. County residents can protect themselves by performing tick checks after outdoor activities and promptly removing attached ticks. This education is especially important for children, as 30 percent of the 476,000 cases reported by the Centers for Disease Control and Prevention annually are children.

Mosquito bites also can transmit various diseases such as Zika and West Nile Virus. County residents can be instrumental in eliminating places where mosquitoes lay their eggs by checking their properties weekly for stagnant water by tipping and tossing flowerpots, buckets, toys and other containers that might collect water.

Therefore, Supervisor Herrity asked unanimous consent that the Board direct staff to:

• Prepare a Proclamation designating May 2024 as "Lyme Disease Awareness Month," to be presented to Monte Skall, Director of the

National Capital Lyme and Tick-Borne Disease Association, at the May 7, 2024, Board Meeting

- Share information on preventing and recognizing the symptoms of Lyme Disease, to include County partners at Fairfax County Public Schools for students and parents to educate themselves as well
- Prepare a Proclamation designating May 2024 as "Fight the Bite Awareness Month," to be presented to the Fairfax County Health Department at the May 7, 2024, Board Meeting

Without objection, it was so ordered.

25. RESOLUTION OF RECOGNITION REQUEST FOR THE CHANTILLY HIGH SCHOOL WRESTLING TEAM (11:30 a.m.)

Supervisor Herrity stated that the Chantilly High School Wrestling Team participated in the Virginia Class 6 State Tournament over the weekend of February 16, 2024, at a sports tourism facility in Virginia Beach. 11 athletes qualified for the tournament, with the Chantilly Chargers taking 2nd place overall. This successful run was led by Carter Shin and Ezekiel Keel, who each won 1st place in the State Championships for their 106 and 120-weight categories respectively. In addition, the Chantilly Wrestling Head Coach, Mark Weader, was recognized as the Concorde District Coach of the Year for his efforts to develop a championship-contending wrestling program. His tenure in Northern Virginia extends to George Mason University as well. Prior to taking over the Chantilly wrestling program, Coach Weader was a student-athlete turned coach for the George Mason University wrestling team until his retirement in 2011, after 16 years with the department.

Therefore, jointly with Supervisor Smith, Supervisor Herrity asked unanimous consent that the Board direct staff to prepare a Resolution of Recognition, in honor of Head Coach Mark Weader, Carter Shin and Ezekiel Keel, for their performance at the Virginia Class 6 State Wrestling Tournament, to be presented before the Board at the appropriate date, along with the other high school athletics presentations for the spring 2024 season. Without objection, it was so ordered.

26. RESOLUTION OF RECOGNITION REQUEST FOR THE LANGLEY HIGH SCHOOL ICE HOCKEY TEAM (11:31 a.m.)

Supervisor Herrity stated that the Langley Ice Hockey team won the Northern Virginia Scholastic Hockey League (NVSHL) championship, dominating the Stone Bridge Bulldogs 4 - 1. This performance adds to an incredible 34-straight win run and their fourth title in six years, winning the last three consecutively. They are only the second team in league history to three-peat and will be going on to Nationals on March 21, 2024. They are led by their Coach, Patrick Keough, their

all-league senior forward, Noah Scheinerman, and their goalie, Harrison Smith, who made 27 saves and was recognized as the NVSHL Player of the Year.

Therefore, jointly with Supervisor Bierman, Supervisor Herrity moved that the Board direct staff to prepare a Resolution of Recognition for the Langley Saxons Ice Hockey team for winning their third straight NVSHL title and for their historic winning streak, to be presented before the Board at the appropriate date along with the other high school athletics presentations for the spring 2024 season. Chairman McKay seconded the motion. Following discussion regarding the good practice of allowing a Board Member to initiate presentation requests when it pertains to their district, the question was called on the motion and it carried by unanimous vote.

Supervisor Herrity announced that a teen job fair was held on March 2, 2024, at Chantilly High School. He thanked the businesses and the community for attending the event and making it a success. Supervisor Herrity announced that another teen job fair will be held on March 9, 2024, at West Springfield High School and he encouraged the community to attend the event.
