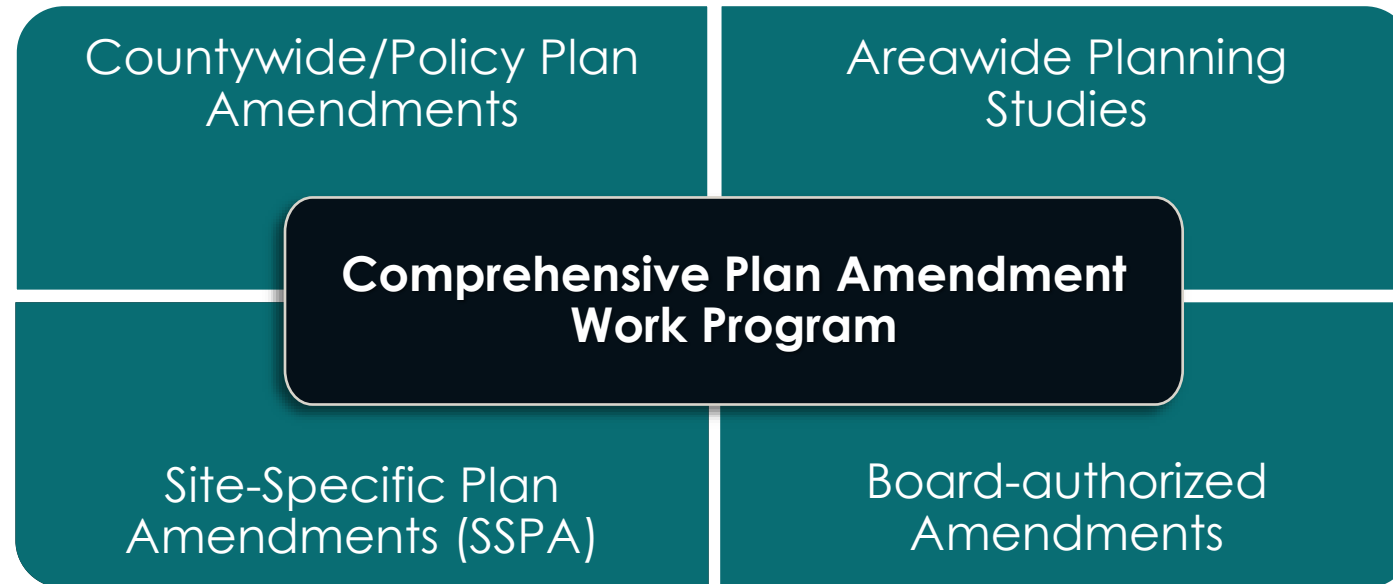

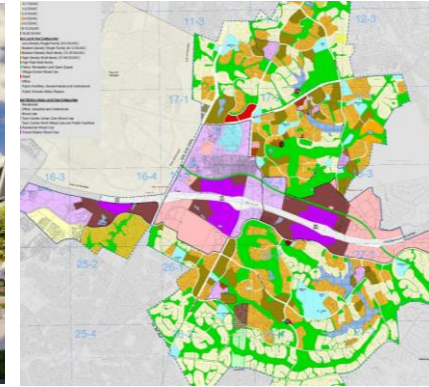
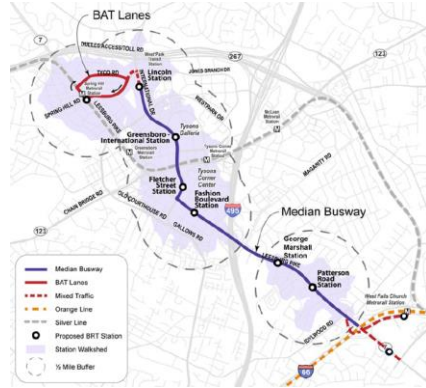


# Comprehensive Plan Amendment Work Program

April 2023 – present:  
15 Plan Amendments  
Adopted

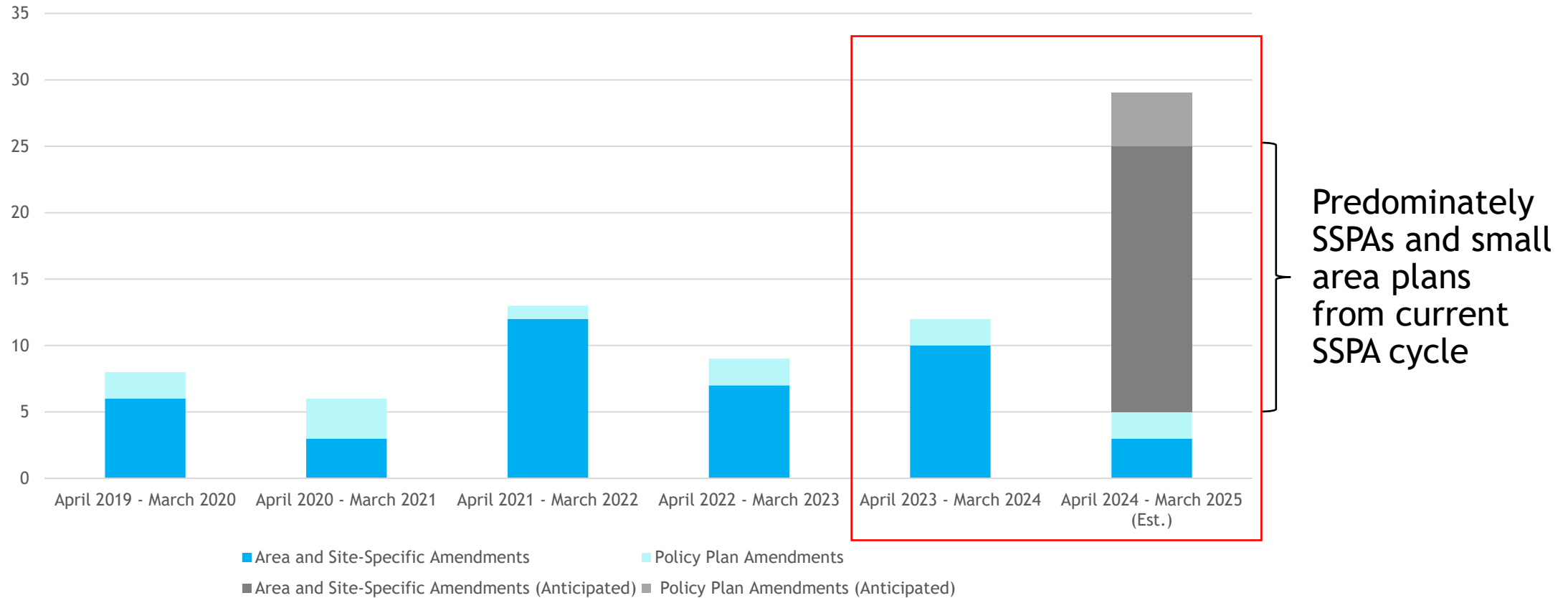
Net Plan Change:

- 3,700 units
- ~800 committed affordable (22%)
- 4.1m SF non-residential uses



# Comprehensive Plan Amendment Work Program

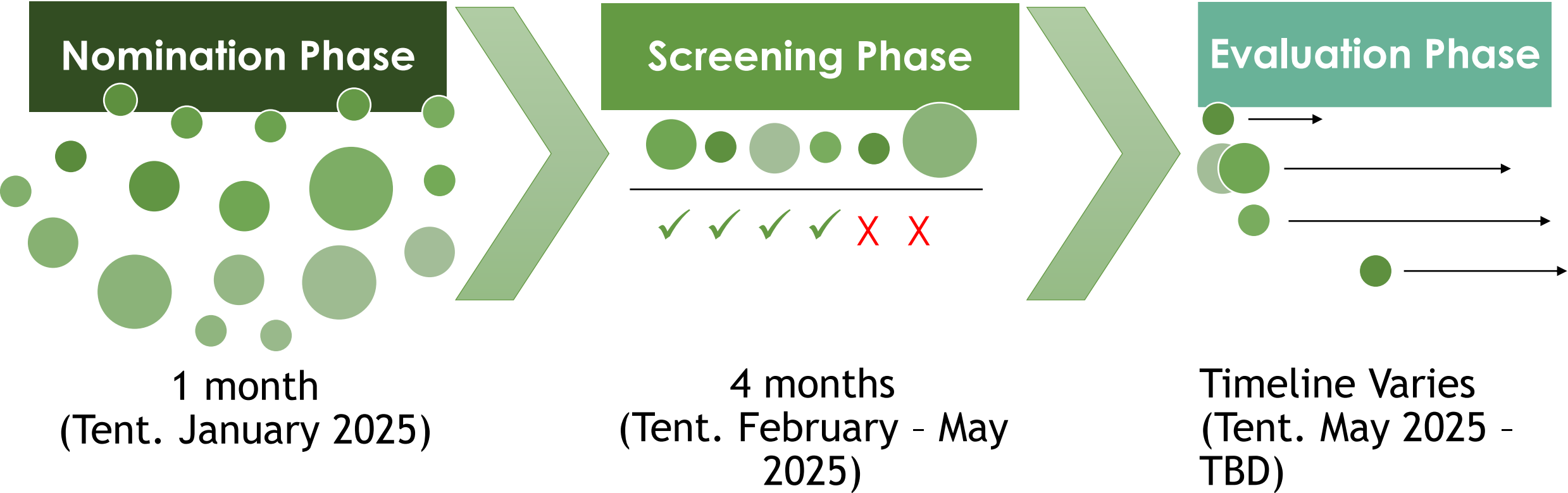
Number of Plan Amendments Adopted - April to March



# 2025 Site-Specific Plan Amendment Process

- Bi-annual, countywide cycle for reviewing site-specific proposals (“nominations”) to change the Comprehensive Plan’s land use recommendations
- Preparation for 2025 SSPA is underway
- Planning Commission and Board of Supervisors committee meetings in Fall 2024 to review process parameters, lessons learned from prior round, and draft timeline
- Outreach to industry, community open houses, and land use groups ongoing
- Nomination period anticipated to begin in January 2025

# Countywide SSPA Process



Goal: Reduce  
Overall Timeline



## Lessons Learned

- 2-year cycle more in line with market changes and greater use of SSPA (compared to Board-authorizations) helps with workforce planning
- Nomination and Screening period reduced to 5 months from 9 months
- Evaluation Phase tiering system functioning as intended

## Proposed Changes

- Depending on volume, may be able to tighten screening timeline further



# Countywide SSPA Process



Goal: Increase Inclusion  
and Community  
Engagement



## Lessons Learned

- Screening Phase community meetings were well attended (over 1,800 attendees across 18 meetings)
- Collaboration with NCS on engagement support in areas of greater socioeconomic vulnerability increased inclusion
- Adaptive Engagement during Evaluation Phase is more efficient than default task forces

## Proposed Changes

- Communities of Opportunity Index maps as nomination submission item
- Monitor engagement best practices

Goal: Achieve Better Balance of Resources for Long Range Planning



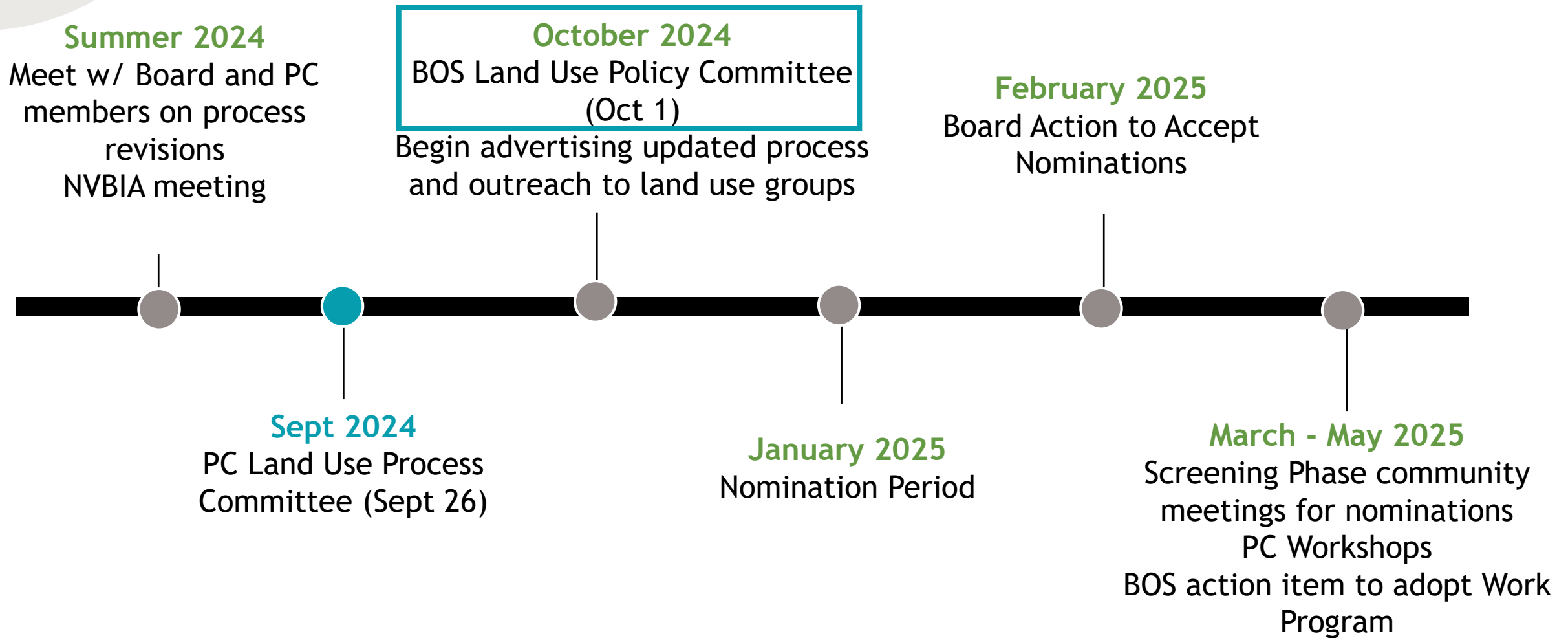
## Lessons Learned

- More information needed from nominators post-Screening
- Expansion of individual nominations into small area plans often require County-funded transportation studies

## Proposed Changes

- Nominator acknowledgements on transportation and enviro studies, affordable housing preservation, and concept revisions
- Stricter screening for logical planning areas
- Staff request for funding for transportation assessments on small area plan studies with new Work Program
