The meeting was called to order at 10:10 a.m. with all members being present, with the exception of Supervisor Davis and Supervisor McConnell, and with Chairman Moore presiding.

Supervisor Davis arrived at 10:15 a.m.

Supervisor McConnell arrived at 10:50 a.m.

Others present were Richard A. King, Acting County Executive; David T. Stitt, County Attorney; Theodore Austell, III, Executive Assistant to the County Executive; William Howland, Assistant to the County Executive; Viki L. Lester, Deputy Clerk to the Board of Supervisors; and Patti M. Hicks, Deputy Clerk to the Board of Supervisors.

2. MOMENT OF SILENT MEDITATION (TAPE 1)

During the moment of silent meditation, Supervisor Richards asked that everyone present remember the family of Mary Lee latum.

3. CROWNING OF LORD FAIRFAX AND LADY FAIRFAX (TAPE 1)

Chairman Moore announced that there was a wonderful celebration at the crowning of Lord Fairfax and Lady Fairfax last night.

Supervisor Pennino moved that the Board officially recognize Artie's Restaurant and thank them for their generosity and graciousness in hosting the Fairfax Fair party and the crowning of Lord Fairfax and Lady Fairfax. This motion was seconded by Supervisor Hyland.

Chairman Moore relinquished the Chair to Acting Chairman Alexander and asked that the motion be amended to include direction to staff to prepare a special presentation before the Board in honor of all those persons who devote their time and energy to the success of the Fairfax Fair, and this was accepted.

Acting Chairman Alexander returned the gavel to Chairman Moore.

The question was then called on the motion, and as amended, carried by a vote of seven, Supervisor Davis and Supervisor McConnell not yet having arrived.

Supervisor Richards moved approval of the presentation of the Certificates of Appreciation presented to Scott R. Hutson and Caroline S. Chang, Fairfax County students, commending them for outstanding scholastic achievement and being selected as Presidential Scholars by the 1991 United States Presidential Scholars Program. This motion was seconded by Supervisor Pennino and carried by a vote of eight, Supervisor McConnell not yet having arrived.

5. CERTIFICATES OF APPRECIATION PRESENTED TO RICHARD BRANDES AND CHRISTOPHER SCHMITZ, OWNERS OF MEINEKE MUFFLERS (TAPE 1)

Supervisor Pennino moved approval of the presentation of the Certificates of Appreciation presented to Richard Brandes and Christopher Schmitz commending Meineke Mufflers for being selected as the Number One exhaust and brake service facility in the Nation and for the outstanding service it provides to the citizens of Fairfax County by collecting used motor oil. This motion was seconded by Supervisor Hyland and carried by a vote of seven, Supervisor Hanley being out of the room, Supervisor McConnell not yet having arrived.

6. RESOLUTION COMMENDING REVEREND GERRY CREEDON (TAPE 1)

Supervisor Hyland moved adoption of the Resolution, presented to Reverend Gerry Creedon, commending him for his many efforts to improve the lives of people in the community and beyond. This motion was seconded by Supervisor Davis and carried by a vote of seven, Supervisor Hanley being out of the room, Supervisor McConnell not yet having arrived.

8. 10:00 A.M. - PRESENTATION OF ANNUAL AWARDS FOR CONTRIBUTIONS TO HISTORIC PRESERVATION. BY THE FAIRFAX COUNTY HISTORY COMMISSION (TAPES 1-2)

On behalf of the Fairfax County History Commission, Chairman Patrick Reed presented the Commission's awards to the following individuals:

- Ms. Martha Williams who, in her many years as a high school social studies teacher, exposed between 1,600 and 2,000 students to some aspect of historic preservation, and in archaeology program for Fairfax County;
- Barbara and Mike Keck, owners of the "From Out of the Past" bookstore on Route One who have become the historians of Route One. As part of their efforts, they have produced a videotape history drawn from photographs, scrapbooks, magazines, and postcards; and
- Mr. James Moyer and Mr. Thomas Evans, who produced the "Mosby Tours", for those who wish to know more about the Civil War history of this area.

Supervisor Moore stated that she had received a letter from Kohann Whitney, Chairman, School Board, informing her that the School Board will be renovating the auditorium at Luther Jackson Intermediate School where School Board meetings are held. She said that the School Board was requesting confirmation from the Board of Supervisors that an additional seat will be necessary to accommodate a School Board Member from the newly created Sully Supervisor District.

Therefore, Supervisor Moore asked unanimous consent that the Board direct staff to inform the School Board that it should proceed with the addition of a seat to accommodate the Representative from Sully District. Without objection, it was so ordered.

Following discussion, Supervisor Hanley stated that the <u>Virginia State Code</u> allows for up to 11 members of the School Board. She said that the question that needs to be resolved is whether or not the Student non-voting member is considered a member of the School Board and counts as one of the 11 authorized members. She said that if so, the Board would need to pursue a legislative change in the General Assembly next year.

Supervisor Moore asked unanimous consent that the Board direct staff to review the requirement for additional representation on other Boards, Authorities, Commissions, and Advisory Groups. Without objection, it was so ordered.

Supervisor Hanley asked unanimous consent that the Board direct the County Attorney to:

- Recirculate the memorandum sent to the Legislative Committee which included the original discussion regarding redistricting and what would require legislative change; and
- Specifically research the issue of whether the non-voting student is considered a member under the Code.

Without objection, it was so ordered.

Supervisor Moore asked unanimous consent that the Board direct staff take into consideration the fiscal implications of adding a new member to the various Boards, Authorities, Commissions, and Advisory Groups and how they can be handled. Without objection, it was so ordered.

15. CLIFTON FOREST SUBDIVISION (TAPE 4)

Supervisor Moore stated that residents of Clifton Forest Subdivision had contacted her office to inquire as to what progress the County is making in addressing their water problems. She said that the residents that have wells no longer have adequate quantities of water. She said that it was her understanding that staff of the Health Department and Department of Environmental Management (DEM) are looking at ways the County might be able to assist the residents in finding a dependable water supply.

lherefore, Supervisor Moore asked unanimous consent that the Board direct staff to report as expeditiously as possible with a status report including a list of possible grants at the State level for which the residents might apply. Without objection, it was so ordered.

(NOIE: Later in the meeting, there was additional discussion regarding Clifton Forest Subdivision. See Clerk's Summary Item CL#68.)

16. BRADDOCK FARMS SUBDIVISION (TAPE 4)

Supervisor Moore stated that residents of Braddock Farms Subdivision had contacted her office and expressed concern because the builder who constructed their homes was unable to finish the project. She said that individuals purchased their homes in good faith and are anxious to see unfinished items completed. She said that they have offered to finish the "punch list" themselves if the bond money could be turned over to them. She noted that the Department of Public Works will soon have the responsibility of completing the "punch list".

Therefore, Supervisor Moore moved that the Board direct staff to expedite the Braddock Farms project so that these residents can begin to enjoy their new homes. This motion was seconded by Supervisor McConnell and carried by unanimous vote.

17. MOTOR VEHICLE ACCIDENTS (TAPE 4)

Supervisor Moore stated that motor vehicle accidents are the leading cause of death of Americans from the age of one to 44. They are the leading cause of spinal cord injury and brain damage. She said that in 1988 they cost Virginia nearly \$1.5 billion. Motor Voters is a non-profit consumer organization dedicated to promoting auto safety which believes that adequate reporting of automobile crashes is a cost effective way to educate the public about the benefits of safety

restraints such as seat belts and air bags. She said that in many jurisdictions the police include information regarding air bags in their crash reports.

Therefore, Supervisor Moore asked unanimous consent that Supervisor Bulova and the Transportation Safety Commission review the issues raised by this organization and consider recommending including information about air bags in police reports. Without objection, it was so ordered.

Vice-Chairman Pennino returned the gavel to Chairman Moore.

18. <u>RECYCLING "JUNK" AUTOMOBILES</u> (TAPE 4)

Supervisor Hyland announced that the National Kidney Foundation accepts "junk" automobiles. They will take any car whether or not it works and they will tow it away at no cost.

Supervisor Hyland said that contributors receive a receipt for the donated automobile's current market value which could entitle them to take a charitable contribution deduction on federal and state income tax returns. The National Kidney Foundation sells the cars at auction or to dismantlers with proceeds going for medical research, organ donor programs, public education and patient services.

Therefore, Supervisor Hyland asked unanimous consent that the Board direct the Office of Public Affairs to make this information available to County residents. Without objection, it was so ordered.

19. SUPPORT REQUESTED FOR GEORGE MASON STUDY ON WETLANDS (TAPE 4)

Supervisor Hyland stated that the Mount Vernon Council has submitted a resolution requesting the Board's support of the George Mason Study on Wetlands.

Supervisor Hyland said that the Environmental Impact Statement (EIS) currently being prepared for the Woodrow Wilson Bridge expansion covers but a small range of the Potomac River up and downstream of the proposed bridge. He explained that the George Mason Study provides more extensive information regarding wetlands which may provide important data to the bridge EIS.

Therefore, Supervisor Hyland moved that the Board support the conduct of the wetlands study and direct staff to assist George Mason University in its efforts in any way it can. This motion was seconded by Supervisor Alexander. Following discussion, Vice-Chairman Pennino stated that she had brought this issue up previously and she moved that the motion be amended to direct staff to provide a status report on its efforts thus far and what efforts it can make in the future and this was accepted.

The question was called on the motion, and as amended, carried by a vote of seven, Supervisor McConnell and Chairman Moore being out of the room.

20. HOUSEHOLD HAZARDOUS WASTE WORKSHOP (TAPE 4)

Supervisor Hyland stated that on May 1, 1991, Fairfax County staff member David Duncan, who is responsible for Fairfax County's Household Hazardous Waste Program, addressed the Chesapeake Bay's Local Government Advisory Committee (LGAC) on the County's program. Due to the interest expressed by the participating members of LGAC, they now are sponsoring a Bay wide household hazardous waste workshop.

Supervisor Hyland said that the "Household Hazardous Waste Management at the Local Level" workshop will be held on Wednesday, June 5, 1991 at the Department of Agriculture in Annapolis, Maryland. For detailed information please call Eric Jenkins at 1-800-446-5422 or 202-962-3360.

WORTHINGTON WOODS AND SOUTHGATE WOODS' WHERNSIDE STREET (TAPE 4)

Supervisor Hyland stated that he had received a letter from Anthony Bement, President of Southgate Woods Homeowners Association, requesting a resolution to the anticipated safety hazards when Worthington Woods section of Whernside Street is connected to the Southgate Woods section of Whernside Street.

Supervisor Hyland explained that this road parallels (within one block) Route One, which has two signalized intersections in this vicinity. He said that it is highly likely that people traveling through the area will use Whernside Street to bypass Route One traffic and the two signal lights.

Supervisor Hyland said that Mr. Bement is requesting that the Southgate Woods section of Whernside Street be vacated. However, the Office of Transportation has indicated that it would not recommend such a vacation at least until the two sections are open.

Therefore, Supervisor Hyland moved that the Board direct the Office of Transportation to:

 Look for ways of preventing cut-through traffic between Southgate Woods and Worthington Woods; and Provide this information as expeditiously as possible because the two sections of roads are to be connected very soon.

This motion was seconded by Supervisor Alexander at carried by a vote of seven, Supervisor McConnell and Chairman Moore be a out of the room.

22. APPEAL PROCESS FOR ROADS THAT GO NOWHERE (TAPE 4)

Supervisor Hyland stated that recently he has been involved in trying to find ways to allow homes to be built along roads that will remain dead ended and do not meet County nor Virginia Department of Transportation (VDOT) roadway standards. In both instances, these home sites are located at a dead end roadway. These roads do not now nor will they ever connect to any other road.

Supervisor Hyland said that the current Code of the County of Fairfax, Chapter 2, Section 2-1-5, does have an exemption allowing for "the construction, within a substandard roadway, of improvements such as driveways to service a maximum of three residences provided that all owners agree not to petition for public maintenance of the roadway. ...The appeal procedure could only serve to remove the cap of only three residences on a substandard roadway."

However, Supervisor Hyland stated that when the property owners involved would be the fourth house on an unimproved roadway, and all homeowners agree not to request public maintenance of their roadway, there should be a way in which these property owners can appeal to the Governing Body to get a waiver. He said that this ordinance as it currently exists assumes that the road connects to another roadway which allows the general public to use the road to get to another destination.

Supervisor Hyland said that because of this ordinance the homeowner who would be building a home on a dead end street is precluded from building a home unless the homeowner puts up an inordinate amount of money which would be held in escrow until the road is built (if ever) or, in the alternative, the homeowners could build the road themselves.

Supervisor Hyland stated that he is currently working with a homeowner who would be required to escrow approximately \$50,000. This is an unfair burden, especially if, as in this case, VDOT has stated the subject road will never be incorporated into VDOT's system.

Supervisor Hyland questioned whether it is logical to base an ordinance on the number of homes to be served rather than to base the ordinance on whether or not the roadway will ever connect to a road at both ends.

Therefore, Supervisor Hyland moved that the Board direct staff to review this ordinance and report with alternatives that can be used by homeowners who have lots that are situated on dead end roadways. This motion was seconded by Supervisor Alexander.

Following discussion, the question was called on the motion which carried by a vote of seven, Supervisor McConnell abstaining, and Chairman Moore being out of the room.

23. RMA POLICY (TAPE 4)

Supervisor Hyland distributed to Board Members a copy of the proposed RMA Policy. He added that there was still time to comment on this issue.

Vice-Chairman Pennino relinquished the Chair to Acting-Chairman Alexander and asked unanimous consent that the Board direct staff to provide an analysis of what Fairfax County did versus the proposed RMA policy. Without objection, it was so ordered.

Acting-Chairman Alexander returned the gavel to Vice-Chairman Pennino.

PROPOSED ESTABLISHMENT OF A COMMISSION TO CONSIDER CLOSING AND RELOCATION OF THE DISTRICT OF COLUMBIA'S (D.C.) CORRECTIONAL COMPLEX LOCATED IN LORTON, VIRGINIA (TAPE 4)

Supervisor Hyland stated that he had received a letter from Congressman Wolf's office which has invited him to testify before the Subcommittee on Judiciary and Education of the Committee of the District of Columbia (D.C.) at a hearing to be held on June 20, 1991 concerning Congressman Wolf's Bill which would establish a Commission to consider the closing and relocation of the D.C. Correctional Complex located in Lorton, Virginia.

Supervisor Davis moved that the Board designate Supervisor Hyland to testify before the Subcommittee on Judiciary and Education of the Committee of D.C. This motion was seconded jointly by Supervisor Bulova and Supervisor Alexander and carried by a vote of seven, Supervisor McConnell and Chairman Moore being out of the room.

Supervisor Hyland asked unanimous consent that the Board direct staff to review the letter and provide its comments. Without objection, it was so ordered.

25. PROPOSED CITIZEN AND PROFESSIONAL COORDINATING COMMITTEE (TAPE 4)

(BACs)

Supervisor Alexander stated that Secretary of Iransportation John Milliken's request for funds for the 95/395/495 interchange bypass project is great news for Lee District.

Supervisor Alexander said that the conceptual plans for an elevated bypass could have huge impacts. He noted that it is critical that the affected people in Lee District have direct input to any and all planning from the inception of this project.

Supervisor Alexander stated that he has requested Secretary Milliken to allow him to appoint a citizen and professional coordinating committee to work with VDOT and their consultants throughout the preliminary and final design. He explained that such a committee would consist of area citizens, Fairfax County staff from the Offic of Transportation and the Office of Road Program, Department of Public works. He added that their mission would be to ensure that all design and construction on this project is environmentally sensitive and has minimal impact on homes and businesses.

Therefore, Supervisor Alexander moved that the Board transmit a letter to Secretary Milliken endorsing his request. This motion was seconded by Supervisor Hanley and carried by a vote of eight, Chairman Moore being out of the room.

26. RESTRICTING TRUCK TRAFFIC ON OLD TELEGRAPH ROAD (TAPE 4)

Supervisor Alexander stated that his office has recently received complaints about large trucks traveling through the very narrow residential portion of Old Telegraph Road, both north and south of Hayfield Road to lelegraph Road. He said that residents believe that trucks are doing this to avoid the traffic signal at the Hayfield and Telegraph Road intersection.

Supervisor Alexander said that this situation is unsafe as Old Telegraph Road is an extremely narrow shoulderless road. He said that large trucks have no business using this road when safe, wide streets with signal-controlled intersections are available a few hundred feet down the road. He added that an additional discussion of this matter has already taken place between his staff and representatives of the Virginia Department of Transportation (VDOT), and it was agreed that the situation may warrant restrictions.

Supervisor Alexander moved that the Board direct staff to:

- Evaluate this situation and recommend if restricting trucks on Old Telegraph Road is feasible; and
- Should truck restrictions prove to be warranted, prepare the necessary Resolution for adoption by the Board and schedule the required public hearing.

This motion was seconded by Supervisor Hyland and carried by a vote of five, Supervisor Davis, Supervisor Hanley, Supervisor McConnell, and Chairman Moore being out of the room.

27. REQUEST FOR LOGO SIGNS TO BE PLACED ON TRAFFIC SIGNAL MAST ARMS (TAPE 4)

Supervisor Alexander asked unanimous consent that the Board:

- Endorse the request of the Southeast Fairfax Development Corporation's (SFDC) permit application to the Virginia Department of Transportation (VDO1) for logo signs to be placed on traffic signal mast arms at nine intersections along the Route One corridor; and
- Direct staff to notify VDOT of the Board's endorsement of the SFDC request and that it would like to expedite the permission to place the signs.

Without objection, it was so ordered.

28. EXPEDITIOUS PROCESSING OF THE SITE PLAN AND REZONING APPLICATION FOR FAIRFAX AFFORDABLE HOUSING (TAPE 4)

Supervisor Alexander moved that the Board direct staff to expeditiously process the Site Plan and Rezoning Application for Fairfax Affordable South Housing (South County Housing Coalition, Incorporated) located at 3424 Lockheed Boulevard. He added that Fairfax Affordable Housing is a non-profit organization which is providing affordable housing units in the Lee, Mount Vernon and Springfield Districts.

Supervisor Alexander stated that the applicant has gained the support of the Hybla Valley Civic Association, the Groveton Civic Association, and the Lee District Land Use Committee.

This motion was seconded Supervisor Davis and carried by a vote of seven, Supervisor McConnell and Chairman Moore being absent.

29. FUNDING FOR SPORTS TEAMS AND LEAGUES THAT CANNOT AFFORD TO PAY OFFICIALS (TAPE 4)

Supervisor Alexander stated that Board Members had received an outline from the Community of Sports indicating how the \$100,000 has been spent for sports teams and leagues that cannot afford to pay officials. He said that he had requested during the mid-year review the Board determine if money is available to reinstate this. He said that he would be discussing this issue with the County Executive and he would address it at a later meeting.

30. EXPEDITIOUS PROCESSING OF THE REZONING AND DEVELOPMENT PLAN FOR FRANCONIA ELEMENTARY SCHOOL (TAPE 4)

Supervisor Alexander moved that the Board direct staff to:

- Expedite the rezoning and development plan for Franconia Elementary School; and
- At the same time review this issue within 30 days to determine if the process can be resolved.

This motion was seconded by Supervisor Hyland.

Supervisor Alexander stated that Franconia Elementary School is currently zoned in the R-1 and R-2 Districts. He explained that it needs to be rezoned to the R-3 District to comply with Floor Area Ratio (FAR) requirements to accommodate temporary trailers for the students. He said that due to the R-1 and R-2 zoning, the planned trailers cannot be added until the FAR issue is resolved.

Supervisor Alexander said that a timely rezoning will ensure the needed trailers will be in place for the beginning of the 1991-92 school year.

Chairman Moore relinquished the Chair to Vice-Chairman Pennino and moved to amend the motion to include requesting Schools staff to make the request as early as possible and this was accepted.

Vice-Chairman Pennino returned the gavel to Chairman Moore.

Following discussion, with input from James P. Zook, Director, Office of Comprehensive Planning, the question was called on the motion which carried by a vote of seven, Supervisor Hanley and Supervisor McConnell being out of the room.

31. UPDATE ON THE I-95 HIGH OCCUPANCY VEHICLE (HOV) PROJECT (TAPE 4)

Supervisor Alexander provided the Board with an update on the issue of the addition of a lane to northbound I-95, in which case the Virginia Department of Transportation (VDOT) will have to widen the bridge that overpasses Franconia Road. During the construction, the ramp from northbound I-95 to westbound Old Keene Mill Road will be unusable.

Supervisor Alexander explained that VDO1's proposed solution is to temporarily (six months to a year) install an additional signalized intersection east of I-95. He noted that an additional signal at this site will create a tremendous bottleneck.

Supervisor Alexander pointed out that traffic needing to go west on Old Keene Mill Road from northbound I-95 can use the existing eastbound ramp, and make a U-turn at Commerce Street, or use Commerce itself as a detour. He noted that it would cause less trouble to add a few seconds to the signal at Commerce Street and Loisdale Road, than to introduce a new signal in the middle of a "weave" area.

Supervisor Alexander stated that the ramp has already been paved even though VDOT had been requested not to. He noted that the intersection is the busiest in the State and the potential for problems is great.

Supervisor Alexander said that Andrew Bailey, Engineer, VDOT, will be present later in the day to discuss this issue.

Chairman Moore relinquished the Chair to Acting-Chairman Alexander and asked unanimous consent that the Board direct Shiva K. Pant, Director, Office of Iransportation and other appropriate staff members to be present this afternoon to discuss this issue with Mr. Bailey. Without objection, it was so ordered.

Acting-Chairman Hyland returned the gavel to Chairman Moore.

32. DEATH OF HELEN WILSON, FORMER ADMINISTRATIVE AIDE TO LEE DISTRICT SUPERVISOR JOSEPH ALEXANDER (TAPE 4)

Supervisor Alexander announced that Helen Wilson, a former Administrative Aide, had passed away over the weekend. He said that the funeral would be held on Wednesday, June 5, 1991 at 11:00 a.m. at the Demaine Funeral Home. Viewing will be on Tuesday, June 4, 1991 from 2:00 p.m. until 4:00 p.m. and from 7:00 until 9:00 p.m.

33. OFFICE OF PUBLIC AFFAIRS COMMENDED FOR ARTICLE "A GUIDE TO COUNTY ZONING TERMINOLOGY" PUBLISHED IN THE WEEKLY AGENDA (TAPE 5)

Supervisor Bulova commended the Office of Public Affairs for the excellent article published in the May 16, 1991 edition of the Weekly Agenda entitled, "A Guide to County Zoning Terminology." In her opinion, she stated that the article had been the best explanation of zoning terminology and Floor Area Ratios (FARs) that she had ever seen. She stated that often it is taken for granted that the average citizen understands all the zoning acronyms and terminology used and the article did a great job of making the arcane understandable.

Supervisor Bulova asked unanimous consent that the Board direct staff to ensure that an additional supply of the guide is available for distribution to interested citizens. Without objection, it was so ordered.

REQUEST FOR INFORMATION REGARDING FEDERAL PROJECT "A-76." WHICH CONVERTS DELIVERY OF FEDERAL SERVICES TO PRIVATE INDUSTRY (TAPE 5)

Supervisor Bulova stated that recently a constituent had shared with her his experiences with a federal project called "A-76," which converts delivery of federal services to private industry. Apparently, this program has been in effect (in some form or another) for approximately 15 years. The constituent felt that Fairfax County may want to review the program to determine its applicability to the County as a cost cutting mechanism. Supervisor Bulova noted that a printed document describing this program is available through the federal Office of Management and Budget.

Supervisor Bulova asked unanimous consent that the Board direct staff to investigate Project A-76 and report to the Board on its applicability to Fairfax County. Without objection, it was so ordered.

Supervisor Davis called to the Board's attention the fact that he is very familiar with Project A-76 and works with it on a daily basis. He stated that he would transmit his comments regarding this program to Supervisor Bulova and staff.

25. ENFORCEMENT BY CAR INSPECTION FACILITIES: LAW ENFORCEMENT REGARDING HEIGHT OF VEHICLE BUMPERS AND BRIGHTNESS OF LIGHTS (TAPE 5)

Supervisor Bulova stated that several years ago a law was passed that bans vehicle bumpers that are heightened ("jacked-up") to a dangerous degree. She stated that recently it was called to her attention that this law is not being sufficiently enforced, that many individuals are not aware of this law and police and car inspection facilities are not aggressive enough about enforcing the law.

Accordingly, Supervisor Bulova asked unanimous consent that the Board direct staff to investigate the enforcement of the law and report to the Board with its findings.

Supervisor Pennino called to the Board's attention her concern of trucks using oversized tires to "jack-up" the vehicle. She stated that these trucks are so high that the headlights are positioned at a level that flashes into the vehicles and blinds drivers at night. She asked that the request be amended to include that staff investigate this matter and report its findings, and this was accepted.

Without objection, the amended request was so ordered.

ARTICLE PUBLISHED IN LOUDOUN TIMES-MIRROR NEWSPAPER ENTITLED. "NOISE LIMITS MAY AID ASHBURN VILLAGE" (TAPE 5)

Supervisor Davis distributed to Board Members copies of an article that appeared in the <u>Loudoun limes-Mirror</u> Newspaper entitled, "Noise Limits May Aid Ashburn Village." The article announced that the Public Services Committee of the Loudoun County Board of Supervisors voted to endorse a compromise allowing a local developer of Ashburn Village to proceed with plans to build homes in an area previously restricted for residential construction because of noise from Dulles International Airport (Dulles).

Supervisor Davis expressed his concern that presently Dulles flights are routed in direct corridors over areas that are not currently developed residentially. If those areas are allowed to develop residentially, he stated that airport officials will have no choice but to scatter flights over surrounding areas and, unlike Washington International Airport, Dulles does not have a river in close proximity to assist in absorbing the sound. He stated that, in his opinion, to disperse the noise equally over all airport neighbors because of the loss of adequate buffers would amount to a disastrous situation.

Supervisor Davis called to the Board's attention the fact that there are currently 300 scheduled flights per day at Dulles, however, it is proposed ultimately that Dulles schedule 1,406 flights per day. Many of these flights will involve large long-range aircraft and scheduling will have to allow for crossing many time zones. Given the projected growth of aviation at Dulles, he stated that it makes good sense to not only respect current noise contours around the airport but to give them even greater berth.

Supervisor Davis asked unanimous consent that the Board direct staff to:

- Monitor this situation closely and report to the Board with continual updates; and
- Report with a policy for consideration that would formally express the Fairfax County Board of Supervisors' concerns to the Loudoun County Board of Supervisors before it proceeds with the proposal regarding development in this area.

Supervisor Pennino called to the Board's attention the fact that later in today's meeting, the Board would be considering Action Item A-20 - Request to Expand the Airports Advisory Committee's (AACs) Responsibilities and Feasibility of Establishing a Countywide Aircraft Noise Complaint Center. She asked that the request be amended to

include that the Board refer this matter to the AAC for its review and to report to the Board with its findings and recommendations, and this was accepted.

Without objection, the amended request was so ordered.

Accordingly, as his next Board Matter, Supervisor Davis then called to the Board's attention $Action\ Item\ A-20$.

37. A-20 - REQUEST TO EXPAND THE AIRPORTS ADVISORY COMMITTEE'S (AACS) RESPONSIBILITIES AND FEASIBILITY OF ESTABLISHING A COUNTYWIDE AIRCRAFT NOISE COMPLAINT CENTER (TAPE 5)

(BACs)

(R) Supervisor Davis called to the Board's attention Action Item A-20 - Request to Expand the Airports Advisory Committee's (AACs) Responsibilities and Feasibility of Establishing a Countywide Aircraft Noise Complaint Center. He moved that the Board concur in the recommendation of staff and adopt the Resolution contained in Attachment Two of the Memorandum to the Board revising the charter to permit the AAC to address airport related issues on a comprehensive basis. This motion was seconded by Supervisor Pennino.

Supervisor Richards asked that the motion be amended as follows:

• INCLUDE the deleted language on Page Iwo of the revised Resolution (handwritten Page Four), third paragraph from the top of the page, modified to delete only the words. "...from both airports...." to read:

"WHEREAS, the Board of Supervisors recognizes that the problem of over-flight noise will continue to be a concern."

This was accepted.

Supervisor Richards asked that the motion be amended as follows:

 <u>REVISE</u> the language on Page Three of the revised Resolution (handwritten Page Five), third paragraph from the top of the page, Bullet (c), to read:

"...the Federation of <u>Citizens</u> Associations..."

This was accepted.

Supervisor Hyland asked that the motion be amended to include that the Board direct staff to research and report on:

- What extent does the Metropolitan Washington Airports Authority (MWAA) now involve itself in land use issues surrounding Dulles International Airport (Dulles); and
- What extent does and should MWAA communicate to any abutting jurisdiction its position regarding the placement of residential development within areas that are anticipated to be utilized in connection with flight operations.

This was accepted.

Following Board discussion, the question was called on the motion, and as amended, carried by unanimous vote.

38. PROCLAMATION DESIGNATING "BONE MARROW AWARENESS WEEK" (TAPE 5)

Supervisor Davis distributed to Board Members copies of a Proclamation designating "BONE MARROW AWARENESS WEEK" in Fairfax County. He called to the Board's attention the fact that each day in the United States 24 individuals die who could be saved by a bone marrow transplant, more than 9,000 individuals each year. Until recently, individuals diagnosed with cancer have had little chance of living a normal life; however, doctors have now determined that bone marrow transplants can serve as a cure for those enduring some forms of cancer.

Supervisor Davis stated that the search for a potential donor is mostly limited to the list of individuals on the National Marrow Donor Program Registry. The more extensive the list, the greater the chances are for patients needing a transplant to find a suitable match.

Through the outstanding efforts of Congressman Frank R. Wolf, Supervisor Davis announced that federal grants have been received to hold three drives for potential donors during the weekend of June 22-23, 1991. He urged all interested individuals to attend the drives to be held at:

- Saint Thomas Moore located on Route 50 in Arlington:
- Drew Model School located in South Arlington; and

 Eden Center located across from the Willston Center.

Supervisor Davis moved that the Board approve the Proclamation:

- Designating the week of June 17 through June 23, 1991 as "BONE MARKOW AWARENESS WEEK" in Fairfax County, and urging citizens to consider giving of themselves to save the life of another:
- Giving time off during "BONE MARROW AWARENESS WEEK," with pay, to County employees wishing to donate and be tested for the National Registry; and
- Directing staff to include in the <u>Weekly Agenda</u> information on the Bone Marrow lesting Process which includes the times, dates, and information on the tests available during "BONE MARROW AWARENESS WEEK."

This motion was seconded by Supervisor Pennino and carried by unanimous vote.

39. BOARD OF SUPERVISORS' CONCURRENCE IN SPECIAL EXCEPTION APPLICATION SE 91-M-004 (TAPE 5)

Supervisor Davis called to the Board's attention Special Exception Application SE 91-M-004, a request submitted by the Annandale Volunteer Fire Department to construct a new fire station behind the existing fire station located on Columbia Pike. Of the application property, 2.5 acres is owned by and has been conveyed by the Board of Supervisors to the Annandale Volunteer Fire Department; however, the plat has not yet been recorded.

Accordingly, because the property is still owned by the Board, Supervisor Davis moved that the Board of Supervisors concur in the filing of Special Exception Application SE 91-M-004 so that the application, including the 2.5 acres owned by the Board, can proceed. He stated that this action should not be construed as a favorable recommendation on the application by the Board and does not relieve the applicant/owner from compliance with the provisions of any applicable ordinances, regulations or adopted standards. This motion was seconded by Supervisor Bulova and carried by unanimous vote.

40. DEPARTMENT OF EXTENSION AND CONTINUING EDUCATION'S GYPSY MOTH OFFICE COMMENDED FOR OUTSTANDING PERFORMANCE AND STAFF REQUESTED TO REVIEW A PORTION OF MANTUA SUBDIVISION FOR SPRAYING (TAPE 5)

Supervisor Hanley commended this year's outstanding performance by the Department of Extension and Continuing Education's Gypsy Moth Office, killing gypsy moth caterpillars and saving many trees.

Supervisor Hanley called the Board's attention to a small section of the Mantua Subdivision in which the spraying for caterpillars did not work. She moved that the Board direct staff to review the situation and report with recommendations on whether Fairfax County must pay for the spraying in this small area where the Dimilin spraying failed. This motion was seconded by Supervisor Alexander and carried by a vote of eight, Chairman Moore being out of the room.

41. RECOGNITION OF MISS CHRISTINA ("GIGI") HYLAND (TAPE 5)

Supervisor Hyland proudly recognized the presence in the Board Room of his daughter, Christina ("Gigi"). He warmly welcomed her and introduced her to Board Members.

42. STATUS REPORT REQUESTED ON PROCEDURE REQUESTED FOR IMPLEMENTATION OF AUTHORITY GRANTED BY THE GENERAL ASSEMBLY TO GRANT LOANS TO VOLUNTEER FIRE DEPARTMENTS (TAPE 5)

Supervisor Hanley stated that at the Board of Supervisors' meeting held on July 23, 1990, action had been taken to direct staff to develop a procedure for implementation of the new authority granted by the General Assembly in 1990 for Fairfax County to grant loans to Volunteer Fire Departments to assist in station renovations, expansions, and the like. She stated that the Board has yet to receive a response from staff and she moved that the Board direct staff to report with a procedure to implement this authority, with the understanding that funding for such a program is subject to the availability of funds at a future date. This motion was seconded by Supervisor Davis and carried by a vote of seven, Supervisor Hyland and Chairman Moore being out of the room.

43. REQUEST FOR LETTER OF COMMENDATION CONGRATULATING THE COLONIES CITIZENS ASSOCIATION FOR RECEIVING A NATIONAL COMMUNITY ASSOCIATION OF THE YEAR AWARD (TAPE 5)

Supervisor Hanley announced that the citizens association for The Colonies, located on Magarity Road in Providence District, has received a National Community Association of the Year Award for associations of its size. This award indicates that The Colonies has attained an

exceptionally high level of performance in all facets of its operation. She asked unanimous consent that the Board direct staff to prepare a letter of commendation congratulating lhe Colonies Citizens Association for being the recipient of this prestigious award. Without objection, it was so ordered.

44. BRIEFING ON HOLMES RUN CIVIC ASSOCIATION CELEBRATION COMMEMORATING ITS 40TH ANNIVERSARY (TAPE 5)

Supervisor Hanley briefed Board Members on the successful activities held by Holmes Run Civic Association in celebration of its 40th anniversary. She stated that the activities included a dinner/dance, a picnic, and a house and garden tour. Most impressive, she announced, had been the fact that 77 former residents of Holmes Run returned for the dinner/dance.

Supervisor Hanley wished all neighborhoods in Fairfax County the same sense of community continuity and cooperation.

45. UPDATE ON STATUS OF WHITTIER SCHOOL TASK FORCE (TAPE 5)

(BACs)

Supervisor Hanley briefed Board Members that the Whittier School lask Force has not yet been appointed; however, she assured interested individuals that these appointments would be made sometime in the future.

In response to a query by Supervisor Hanley, Anthony Griffin, Deputy County Executive for Planning and Development, responded that the City of Falls Church has requested the use of Whittier School for library purposes while its present location is undergoing renovations. He informed Board Members that staff is currently negotiating this use with the City of Falls Church.

46. EUROPE WRESTLING TOUR PLANNED FOR ATHLETES IN ACTION. AN ATHLETIC MINISTRY OF THE CAMPUS CRUSADE FOR CHRIST (TAPE 5)

Supervisor Hanley called to the Board's attention a letter that she had received requesting donations and community support for a wrestling tour planned for Athletes in Action, an Athletic Ministry of the Campus Crusade for Christ. The team, representing George Mason University (GMU) and the United States, is scheduled to tour Europe this summer, competing with the best teams in Germany, Czechoslovakia, and Hungary.

Supervisor Hanley announced that each member of the team must raise \$3,200 to cover the cost of the trip. She stated that any individual interested in supporting this effort may contact her office or GMU for further details.

47. <u>DEDICATION OF GAZEBO AT MEADOWLARK PARK</u> (TAPE 6)

Supervisor Pennino stated that she recently attended the dedication of the beautiful new gazebo at Meadowlark Park. While in the park, she discovered a lovely and rare pink ladyslipper blooming in all her glory. Supervisor Pennino stated that she immediately went home and got her family to come share in this beautiful find. To her utter dismay, upon her return to the park, the entire ladyslipper, root and all, had been dug up by someone. Supervisor Pennino noted with sadness that the beauty of this pink ladyslipper would not continue to be shared in its natural habitat by everyone visiting Meadowlark Park.

48. CUTTING OF GRASS AROUND THE NORTH COUNTY GOVERNMENTAL CENTER (TAPL 6)

Supervisor Pennino moved that the Board publicly commend PFC Tracey B. Smith, PFC John S. Irace, and Officer Anthony J. Black of the Reston Police Substation for their willingness to volunteer their time, effort, and equipment in making the grounds around the North County Governmental Center more attractive.

This motion was seconded by Supervisor Hyland, who asked to amend the motion to include the names of several police officers of the Mount Vernon Substation who did exactly the same thing two weeks ago, and this was accepted.

Supervisor Richards and other Board Members echoed the same commendations for police officers in their jurisdictions who have exerted extra effort in order to maintain the grounds around the Supervisors' offices.

The question was then called on the motion, as amended, which carried by a vote of eight. Chairman Moore being out of the room.

49. NUMBER OF PROCLAMATIONS, RESOLUTIONS AND CERTIFICATES ISSUED BY THE BOARD (TAPE 6)

Due to the large number of proclamations requested by Board Members, Supervisor Pennino moved that, effective this date, June 3, 1991, all proclamations, resolutions, and certificates requested by any Member of the Board be voted on by the entire Board of Supervisors. This motion was seconded by Supervisor Davis and carried by unanimous vote.

50. CONGRATULATIONS TO MRS. BRYN PAVEK FOR 1990 HUMAN RIGHTS AWARD (TAPE 6)

Supervisor Pennino congratulated Mrs. Bryn Pavek, Executive Director of the Reston Community Center, on her receipt of the 1990 Human Rights Award and asked unanimous consent that the Board enter this award into the public record. Without objection, it was so ordered.

51. RECOGNITION OF MR. PHIL YATES' GRANDSON ON THE OFFICE FOR CHILDREN POSTER (TAPE 6)

Supervisor Pennino moved that the Board extend special recognition and congratulations to Chris, the grandson of Mr. Phil Yates (a former County employee), for Chris' selection as a poster child for the Office for Children. This motion was seconded by Supervisor Hyland and carried by a vote of eight, Chairman Moore being out of the room.

52. FAILURE TO INCLUDE PART OF RESTON IN THE CENTREVILLE DISTRICT REDISTRICTING (TAPE 6)

(Verbatim)

Supervisor Pennino stated that part of Reston was not included in the Centreville District after the Board agreed that all of Reston would be in the same voting District. She noted that staff has stated that an addendum at this time could jeopardize the entire redistricting plan. Although nothing can be done at this time to correct this oversight, Supervisor Pennino noted that at the next session of the General Assembly there will be an opportunity for Fairfax County to make adjustments. Therefore, she asked unanimous consent that the Board refer this matter to the Legislative Subcommittee for submission to the General Assembly. Without objection, it was so ordered.

53. TRANSFER OF "TOWN GREEN" TO THE PARK AUTHORITY (TAPE 6)

Supervisor Pennino reminded Board Members that several years ago when she was working with Reston Land Corporation on the Towne Center, she was able to secure a large area of the lowne Center for public facilities such as the library, police station and human services building. At the same time, she noted the Cameron Glen facility, an all purpose home for the elderly, was also planned for this area. Supervisor Pennino added that the citizens of Reston thought a passive park would be ideal for this elderly site as well. Arrangements between INOVA Health Systems, formerly called Fairfax Hospital Association (FHA), and the County were made which set aside a portion of the Cameron Glen site for this so-called "Town Green". This land was then transferred to the Board of Supervisors.

Since she and the citizens of Reston agree that the Park Authority, not the Board of Supervisors, should be the owner of this land, Supervisor Pennino moved that the Board direct staff to:

- Investigate the transfer of this parcel from the Board of Supervisors to the Park Authority; and
- Because of the high degree of interest in this park by the Reston citizens, establish a Citizens Task Force to work with the Park Authority in order to maintain the park and help raise funds to support the open green area.

This motion was seconded by Chairman Moore and carried by a vote of seven, Supervisor Hanley and Supervisor Richards being out of the room.

54. <u>SUPPORT AND PRESERVATION OF THE PET-A-PET FARM</u> (TAPE 6)

Supervisor Pennino stated that all of Fairfax County has shown its support for the Pet-A-Pet Farm located adjacent to Reston, Virginia. With a notation that this area involves a 30 acre tract, Supervisor Pennino asked unanimous consent that the Board direct staff to investigate the possibility that at such time as rezonings are granted if, as a matter of proffer, the proffer can be stated in such a way that the open land, if the Board of Supervisors so desires, goes to the Northern Virginia Regional Park Authority. Without objection, it was so ordered.

55. C-1 - CONTINUED REMITTANCE TO THE TOWNS OF HERNDON AND VIENNA OF THE COUNTY COURT FACILITIES FEE (TAPE 6)

Supervisor Pennino called the Board's attention to <u>Consideration Item</u> <u>One - Continued Remittance to the Towns of Herndon and Vienna of the</u> <u>County Court Facilities Fee.</u>

The Board next considered an item contained in the Memorandum to the Board dated June 3, 1991 regarding continued remittance to the lowns of Herndon and Vienna of the County Court Facilities Fee.

Supervisor Pennino moved that the Board of Supervisors direct the Acting County Executive, if these court fees are collected and received by Fairfax County, to remit these funds back to the towns from which they are collected. This motion was seconded by Supervisor Hyland and carried by a vote of eight, Supervisor Alexander being out of the room.

56. HERNDON FESTIVAL (TAPE 6)

Supervisor Richards called the Board's attention to the Herndon Festival held this past weekend and asked that special recognition be given to her staff and the Dranesville representatives who serve on the School Board, the Planning Commission, the Community Services Board, and the Water Authority for staffing of the booths at the Festival.

57. VANDALISM AT THE MCLEAN LITTLE LEAGUE PARK (TAPE 6)

Supervisor Richards stated that the recent vandalism of the McLean Little League Park was most disturbing. She noted that most of the damage is not covered by insurance. A \$1,000 reward is being offered for information which leads to the arrest and conviction of the persons responsible for the massive destruction at the park. Anyone who knows anything at all about this vandalism may call Investigator Sheehan at 893-0886.

Supervisor Richards stated that those persons in the community who would like to help pay for the repairs to the park may send their checks to the McLean Little League, P. O. Box 222, McLean, Virginia, 22101.

58. SELECTION OF MS. BERNICE POLK OF MCLEAN HIGH SCHOOL AS THE VIRGINIA STATE ATHLETIC DIRECTOR OF THE YEAR (TAPE 6)

Supervisor Richards congratulated Ms. Bernice Polk of McLean High School on being chosen the Virginia State Athletic Director of the Year.

PROPOSAL FOR THE CREATION OF THE GEORGETOWN PIKE HISTORIC DISTRICT (TAPE 6)

Supervisor Richards called the Board's attention to a draft of the Northern Virginia Soil and Water Conservation District's proposal for the creation of the Georgetown Pike Historic District to ensure long-term protection of Georgetown Pike's status as a Virginia byway. The document proposes that the Ad Hoc Committee on the Preservation of Georgetown Pike work with the Office of Comprehensive Planning's Environmental and Heritage Resources Branch.

Therefore, Supervisor Richards moved that the Board:

 Direct the County Attorney to work with the Heritage Resources Branch to add a provision to the Historic Overlay District in the Zoning Ordinance to describe highway corridor districts for scenic and historic byway; and • Direct the Heritage Resources Branch to work with the Ad Hoc Committee in order to establish appropriate language creating an overlay district for Georgetown Pike with provisions and guidelines appropriate to Fairfax County. In doing so, staff should also request that the State consider the eligibility of the entire length of the Pike, which is already a historic byway, for nomination to the National Register of Historic Places.

This motion was seconded by Supervisor Pennino and carried by a vote of seven, Supervisor Alexander and Supervisor Bulova being out of the room.

60. CONCERN OF THE TURKEY RUN CITIZENS ASSOCIATION ABOUT POTENTIAL DEVELOPMENT WITH THE LANGLEY FORK HISTORIC DISTRICT (TAPE 6)

As the Turkey Run Citizens Association is concerned about potential development within the Langley Fork Historic District being compatible with existing structures, Supervisor Richards moved that the Board direct staff to work with the Architectural Review Board and the concerned citizens to set specific guidelines for appropriate mass and height for all new structures within each Historic Overlay District. This motion was seconded by Supervisor Hyland and carried by a vote of seven, Supervisor Alexander and Supervisor Bulova being out of the room.

61. ADMIN 4 - ADDITIONAL TIME TO COMMENCE CONSTRUCTION FOR SPECIAL EXCEPTION APPLICATION SE 85-D-028. ROUSE AND ASSOCIATES TYSONS CORNER (DRANESVILLE DISTRICT) (TAPE 6)

(ET) Supervisor Richards called the Board's attention to Administrative Item Four - Additional Time to Commence Construction for Special Exception Application SE 85-D-028, Rouse and Associates Tysons Corner (Dranesville District) and moved that the Board approve the request for 12 months additional time to commence construction for Special Exception Application SE 85-D-028 pursuant to the provisions of Section 9-015 of the Zoning Ordinance. This motion was seconded by Supervisor Davis and carried by a vote of seven, Supervisor Alexander and Supervisor Bulova being out of the room.

62. CROWELL'S CORNER CITIZENS ASSOCIATION'S CONCERN ABOUT CUT-THROUGH TRAFFIC (TAPE 6)

Supervisor Richards stated that her staff has been working with the Crowell's Corner Citizens Association, the Office of Transportation, and the Department of Environmental Management (DEM) regarding the inter-parcel access requirement by DEM as part of the approval of this subdivision. Although the Board has a policy that inter-parcel access

be provided by the developer of each subdivision, the extension of Mill Farm Drive to Crowell Road would become a cut-through for thousands of commuters going from Route 7 to the Dulles Toll Road.

Therefore, since inter-parcel access would be a detriment for the current residents along Mill Farm Drive and Crowell, Supervisor Richards moved that the Board:

- Direct staff to waive the requirement of inter-parcel access for the Carper Ridge Subdivision; and
- Direct staff to notify the Virginia Department of lransportation (VDOT) of Fairfax County's position as it relates to this issue.

This motion was seconded by Supervisor Pennino and carried by a vote of seven. Supervisor Alexander and Supervisor Bulova being out of the room.

63. RESOLUTION CREATING TRANSPORTATION COORDINATING COUNCIL FOR NORTHERN VIRGINIA (TAPE 6)

(R) Supervisor Richards called the Board's attention to a letter addressed to Chairman Moore from Transportation Secretary Milliken proposing the creation of a Transportation Coordinating Council for Northern Virginia and moved Board adoption of the Resolution creating this Council, with the appropriate insertions of the name of the County and the elected officials now serving on the Northern Virginia Transportation Commission. This motion was seconded by Supervisor Davis and carried by a vote of eight, Supervisor Bulova being out of the room.

64. PREVIOUS DISCUSSION REGARDING THE RENAMING OF DRANESVILLE DISTRICT (TAPE 6)

Supervisor Richards referred to her previous discussion regarding the renaming of the Dranesville District, and stated that she had tried, in a humorous way, to suggest some names for Dranesville. However, she noted, on a serious note, that the District will remain as Dranesville.

65. <u>COUNTY SPONSORED FARMERS' MARKETS</u> (TAPE 6)

Supervisor McConnell stated that it has been brought to her attention that the County sponsored farmers' markets may be receiving favorable treatment versus the private farmers' markets in the County. For instance, the County sponsored markets pay only \$30.00 per season for

their permits while the private markets pay \$50.00. In addition, the private markets are paying Business and Professional Operating License (BPOL) fees and property taxes.

Therefore, Supervisor McConnell asked unanimous consent that the Board direct staff to review this matter and report back to the Board as expeditiously as possible with a comparison of the regulations imposed on the private versus the County sponsored markets. Without objection, it was so ordered.

66. PLANNING HORIZONS WORKSHOP (TAPE 6)

Supervisor McConnell reminded Board Members that at the Planning Horizons Workshop last Friday, she mentioned the need to have Task Force recommendations in the rationales for both the Task Force and the Planning Commission's recommendations. She noted that since that time, she has heard that there is a great deal of criticism about this issue and that many of the citizens who served on the lask Force felt that their services were not really recognized and were being ignored.

Following discussion, with input from James P. Zook, Director, Office of Comprehensive Planning, Supervisor McConnell moved that the Board direct staff to provide the lask Force's rationale to the Board. This motion was seconded by Supervisor Davis.

Supervisor Hanley asked that the motion be amended to include all those issues which were not addressed at the Workshop, and this was accepted.

The question was called on the motion, as amended, which carried by unanimous vote.

67. WOODSON HIGH SCHOOL RECYCLING PROGRAM (TAPE 6)

Supervisor McConnell stated that it has been brought to her attention that the Woodson High School Pyramid Pilot Recycling Program, which includes Woodson, Frost Intermediate and five elementary schools, is coming to an end. It appears that this program has been a great success and may be something that the Board might want to look at in order to enhance some of the ideas in the County's overall program.

Following discussion, with input from John W. diZerega, Director, Department of Public Works, Supervisor McConnell asked unanimous consent that the Board:

 Direct staff to obtain copies of the upcoming report on this school project; and Expedite efforts to coordinate the recycling programs of the Schools with those existing in County.

Without objection, it was so ordered.

68. CREATION OF SPECIAL SMALL TAX DISTRICT FOR CLIFTON FOREST SUBDIVISION (TAPE 6)

Supervisor McConnell asked unanimous consent that the Board direct the County Attorney to investigate the possibility of creating a Special Small Tax District for the Clifton Forest Subdivision. Without objection, it was so ordered.

(NOIE: Earlier in the meeting, there was additional discussion regarding Clifton Forest Subdivision. See Clerk's Summary Item CL#15.)

69. CONCURRENT PROCESSING OF APPLICATIONS BY THE RESTON HOSPITAL CENTER (TAPE 6)

Supervisor Pennino moved that the Board direct the Department of Environmental Management (DEM) to review and process the Site Plan for HCA Health Services of Virginia, Incorporated for property identified as Tax Map 17-1 ((1)) 3D concurrently with the processing of Rezoning Application 91-C-014. Special Exception Amendment Application SEA 84-C-092-4, Proffered Condition Amendment Applications PCA 89-C-025-3, PCA 86-C-119-4, PCA 86-C-121-4, and PCA 85-C-088-4. This motion was seconded by Supervisor Davis and carried by a vote of eight, Supervisor McConnell being out of the room.

70. CONCURRENT PROCESSING OF APPLICATIONS BY SKYLINE CENTER (TAPE 6)

Supervisor Davis moved that the Board direct DEM to review and process the Site Plan for residential development of Tax Map 62-3 ((1))-43 and 43A concurrently with the review and processing of Development Plan Amendment Application DPA-C-52-7 with no prejudice towards the Board's ability to deny or grant the DPA. This motion was seconded by Supervisor Pennino and carried by a vote of eight, Supervisor McConnell being out of the room.

71. RECESS/EXECUTIVE SESSION (TAPE 6)

At 1:45 p.m., Supervisor Davis moved that the Board recess and go into Executive Session for matters set forth in the Agenda as well as for discussion of actual and probable litigation and other specific legal matters requiring the provision of legal counsel, as well as:

 To amend Item 3G of the Agenda to read, "Master File", in place of, "In Chancery Number 115184." This motion was jointly seconded by Supervisor Hanley and Supervisor Pennino and carried by a vote of eight, Supervisor McConnell being out of the room.

At 4:25 p.m., the Board reconvened in the Board Room with all Board Members present, and with Chairman Moore presiding.

72. ACTIONS FROM EXECUTIVE SESSION (TAPE 7)

A. CERTIFICATION BY BOARD MEMBERS REGARDING ITEMS DISCUSSED IN EXECUTIVE SESSION

Supervisor Bulova moved that the Board of Supervisors certify that, to the best of their knowledge, only public business matters lawfully exempted from the open meeting requirements prescribed by the Virginia Freedom of Information Act and only matters identified in the motion to convene Executive Session were heard, discussed or considered by the Board during the Executive Session. This motion was seconded by Supervisor Pennino and carried by unanimous vote.

B. SETTLEMENT OF BOARD OF SUPERVISORS VERSUS CONSTANCE R. TURNER. ET AL. AT LAW NUMBER 119385

Supervisor Richards moved that the Board authorize settlement of Constance R. lurner, et al, versus the Board of Supervisors of Fairfax County Virginia, in At Law Number 119385, according to terms and conditions outlined by the County Attorney in Executive Session. This motion was seconded by Supervisor Hyland and carried by unanimous vote.

73. ADMINISTRATIVE ITEMS (TAPE 7)

Supervisor Pennino moved approval of the Administrative Items with the exception of $\underline{\text{Administrative Items Six}}$ and $\underline{\text{Seven}}$. This motion was seconded by Supervisor Hyland and carried by unanimous vote.
