Supervisor Bulova asked unanimous consent that the Board direct staff to prepare a Proclamation designating the week of October 11 through October 17, 1992 as "INTERNATIONAL HISTORY WEEK." Without objection, it was so ordered.

## 7.WANG COMPUTER SYSTEM (Tape 2)

Chairman Davis stated that it has come to his attention that Wang Laboratories, Incorporated filed for Chapter 11 bankruptcy last week. With a notation regarding the County's large investment in Wang hardware and software, he expressed his concern about the effect Wang's bankruptcy may have on the County's investment.

Chairman Davis said that a responsible reaction to this situation would be to reassess the County's computer needs and future plans for information technology as it applies to the Wang systems now being used. He added that the County needs to be assured that its future needs as Wang users will be met or prepare a plan to begin replacing equipment with a better and more secure technology.

Chairman Davis stated that he was concerned about Wang's future when he read in the August 24 issue of Computerworld magazine statements such as, "The majority of (Wang) users said they are no longer comfortable doing business with Wang," and "The majority of users interviewed last week said they are jumping ship now and expect to be completely off VS within two years."

In relation to this matter, Chairman Davis relinquished the Chair to Acting-Chairman Hanley and moved that the Board direct staff to:

- •Provide its recommendations with regard to this matter;
- •Provide the County's related annual expenditures since it first acquired this equipment;
- •Provide the projected future annual expenditures; and

•Provide a listing of which agencies use Wang equipment and the total number of Wang users by agency.

Supervisor Davis noted that money is in short supply and he wants to avoid a situation in the near future where the Board of Supervisors is forced into an eleventh hour decision because contingency plans, in the event of Wang's demise, were not considered early enough.

This motion was seconded by Supervisor Berger and carried by a vote of nine, Supervisor McConnell being absent.

Acting-Chairman Hanley returned the gavel to Chairman Davis.
