<u>Update on 50+ Initiative:</u> <u>Partnership to Provide Medical Transportation</u>

Outcome Desired: To increase capacity for older adults and individuals with disabilities to get to a medical appointment

Northern Virginia Mobility Access Project (NVMAP) Taxi Transportation Pilot Program:

- ➤ Piloted during Summer 2018
- Utilized funding from the Enhanced Mobility Grant
- ➤ Partnered with ten agencies and community based organizations to provide nonemergency medical transportation and transportation for trips of necessity to older adults (50 and over) and individuals with disabilities
- >Annualized estimate of providing 3,000 rides at a cost of \$17.90 per ride
- Exploring options on how to bring program to scale and alternative funding opportunities

<u>Update on 50+ Initiative:</u> <u>Mobility Management Program</u>

Outcome Desired: Establish and maintain a Mobility Management program In 2016, FTA through MWCOG awarded NCS an Enhanced Mobility of Seniors & Individuals with Disabilities Grant.

Since the last 50+ update in September 2017 and through resources received from the grant, Mobility Management staff have:

- Finalized Transportation Toolkit to provide education and training for Transportation Navigators within the community
- Northern Virginia Mobility Access Project (NVMAP) launched the Taxi Voucher Marketing Initiative
- Supported older adults and individuals with disabilities displaced by Forest Glen fire through taxi voucher initiative
- > Supported volunteer transportation efforts and increased capacity
- > Designed, implemented, and administered the NVMAP Taxi Transportation Pilot Program

<u>Update on 50+ Initiative:</u> <u>Mobility Management Program (cont'd)</u>

Fairfax County has been awarded a second round of funding for the Enhanced Mobility for Seniors & Individuals with Disabilities Grant which will begin January 2019. Focus will be on:

- ➤ Continue Mobility Management efforts
- ➤ Promote travel training programs within the Fairfax community
- ➤ Improvements and enhancements of the Human Services Transportation call center

Additional funding opportunities:

- Exploring other private, state and federal funding sources including the FTA grant for transit coordination projects that improve access to healthcare
- ➤ Section 5310 Grant Enhanced Mobility for Seniors & Individuals with Disabilities Grant (2019)

<u>Update: Transportation Options, Programs and Services (T.O.P.S.) Program</u>

➤T.O.P.S. – Transportation Options, Programs and Services-Redesigned and Automated Taxi Voucher Program

➤RFP for an electronic swipe card issued and proposals are due October 12, 2018

➤Other agencies will be able to use this transportation debit card vendor
