Updates since June 2018 Consolidated Community Funding Advisory Committee

- Consolidated Community Funding Advisory Committee (CCFAC) has nine new members, bringing committee to 17
- Wide cross section of community represented
- Orientation sessions presented for new members

#### Updates from June 2018 CCFP Process Improvement Workgroup

- A workgroup has been formed of county staff, CCFAC members and nonprofit representatives. Their objective will be to create sustainable changes and improve processes of the CCFP. To that end, they will explore:
  - Unintended consequences
  - Gaps in services
  - Strategies to strengthen CCFP
  - Create a definition of core safety net services. Suggested definition may model Loudoun County's:

"Those services that assist vulnerable and disadvantaged individuals and families in meeting a critical need for safety, health, security and independence."

#### Additional Updates Interagency Team

- Representation on team from eight Health and Human Service areas, Office of Strategy Management (OSM) and Department of Procurement and Material Management (DPMM) working on integrated strategies related to CCFPfunded services
- Concurrently, the Interagency team will be working on:
  - Strengthening the role of the Technical Advisory Committee (TAC)
  - Enhancing feedback and support to funding pool applicants

#### Update Spring Grant Writing Workshop

- Office of Public Private Partnerships (OP3) Grants, Research and Training Center and DPMM
- Focusing on grant writing in general and information related specifically to CCFP

#### Discussion BOS Input on CCFP Priorities

- CCFAC recommends using "categories" instead of "priorities"
  - BOS in agreement?
- BOS is valued stakeholder in category setting process

#### Discussion Priorities for Next Funding Cycle

- Preparing for CCFP FY 2021-2022
- Fall 2018/Winter 2019:
  - 25 in-person community engagement sessions
  - 684 online survey responses
  - Paper surveys
- Community, stakeholder and nonprofit input received
- CCFAC reviewed information and discussed drafts; a sub-committee reviewed to ensure the language is reflective of that input

#### Discussion Priorities (Categories)

- These are draft documents
- Outcome statements and service examples have been updated to reflect community and CCFAC input
  - Recommending a new category "Food & Nutrition" (was in Health)
- Will develop an overarching statement that will apply to all categories to capture One Fairfax, services to enable participation such as transportation, etc.
