FY 2023: New Investments Deployed

- The FCRHA released a Notice of Funding Availability for \$52M
- Capitalized by the Board:
 \$33M in local funds
 - \circ \$19M in federal ARPA funds
- All but \$8.7M committed
- Anticipate full commitment in the coming months



FY 2023: New Investments Deployed

- Board has already approved:
 - \$33.3 million for SOMOS
 - 453 units, new construction
 - Providence District
 - \$15 million for Colvin Woods
 - 259 units, preservation
 - Hunter Mill District
- Currently \$8.7 million available
- Anticipate full commitment in the coming months to other pipeline projects




Deals Closed Since June Housing Committee

- The FCRHA and HCD continue to close both preservation and new construction deals at a rapid pace
- Since June Housing Committee, FCRHA/HCD closed on:
 - Colvin Woods, 259 units market affordable preserved and committed
 - Braddock Senior, 80 senior units, new construction
