1. 3 P.M. – CONTINUATION OF THE PUBLIC HEARING ON THE COUNTY EXECUTIVE'S PROPOSED FISCAL YEAR (FY) 2024 ADVERTISED BUDGET PLAN, THE ADVERTISED CAPITAL IMPROVEMENT PROGRAM (CIP) FOR FYS 2024-2028 (WITH FUTURE FYS TO 2033) AND THE CURRENT APPROPRIATION IN THE FY 2023 REVISED BUDGET PLAN (3:01 p.m.)

A Certificate of Publication was filed from the editor of the *Washington Times* showing that notice of said public hearing was duly advertised in that newspaper in the issues of March 24 and March 31, 2023.

Chairman McKay announced that this is the second of three nights of public hearings on the FY 2024 Advertised Budget Plan, the Advertised Capital Improvement Program (CIP) for FY 2024-2028 and the FY 2023 Third Quarter

Review. During this public hearing, testimony will also be accepted on the FY 2024 Effective Tax Rate.

Chairman McKay announced that Supervisor Lusk is running late, but on his way from a Council of Governments meeting.

Chairman McKay provided instructions regarding the rules of order for this meeting.

The Board heard testimony from 63 speakers, which included 8 video presentations.
