<u>Board Decision on the Fairfax County Capital Improvement Program (CIP) for Fiscal</u> Years 2025-2029 (with Future Fiscal Years to 2034)

ISSUE:

Board decision on the Fairfax County Capital Improvement Program (CIP) for Fiscal Years 2025 - 2029 (With Future Fiscal Years to 2034).

RECOMMENDATION:

The County Executive recommends that the Board of Supervisors approve the <u>FY 2025 – FY 2029 Advertised Capital Improvement Program (With Future Fiscal Years to 2034)</u>, as presented on February 20, 2024, and discussed at the March 12, 2024, budget committee meeting. The following motions are recommended:

- Support the Planning Commission motions as approved on April 3, 2024.
- Make all necessary adjustments to reflect actions taken during the Board's decision on the FY 2024 Third Quarter Review and the FY 2025 Adopted Budget Plan that impact the CIP.

TIMING:

The Advertised Capital Improvement Program was discussed at the Board's Budget Committee meeting on March 12, 2024, and final adoption of the CIP is scheduled for April 30, 2024.

BACKGROUND:

The Board of Supervisors considered the FY 2025 – FY 2029 Advertised Capital Improvement Program (With Future Fiscal Years to 2034) at a budget committee meeting on March 12, 2024. The Planning Commission held several CIP work sessions and conducted its markup of the CIP on April 3, 2024. The Planning Commissioners proposed several CIP motions, all of which were approved unanimously. A summary of the Planning Commission action on the CIP is included as Attachment I.

Therefore, the following actions are recommended to the Board of Supervisors:

Approve the <u>FY 2025 – FY 2029 Advertised Capital Improvement Program (With Future Fiscal Years to 2034)</u>;

- Direct staff in the Department of Transportation to consider setting aside a portion
 of the funding allocated for the bicycle and pedestrian access program as part of
 the next year-end process to begin to provide safety measures at prioritized sites
 near Metro stations and other activity centers; and
- Direct staff to formalize the process of equity review when making an annual CIP decision and, where possible, highlight Communities of Opportunity Dashboard associated with capital projects in the CIP to support equity, informed planning, decision making, and alignment with relevant focus of areas that are brought to our attention in the One Fairfax Policy.

FISCAL IMPACT:

As shown on page 24 of the FY 2025 – FY 2029 Advertised Capital Improvement Program (With Future Fiscal Years to 2034), the total CIP cost including all program elements, is \$14.301 billion (including \$1.060 billion for Non-County Managed Programs, such as NOVA Parks and the Water Supply). This includes \$2.727 billion authorized or expended through FY 2024, \$7.786 billion scheduled over the FY 2025 – FY 2029 period, and \$3.788 billion projected in the FY 2030 – FY 2034 period. These estimates may be adjusted slightly to accommodate actions taken during the Board's decision on the FY 2024 Third Quarter Review and the FY 2025 Adopted Budget Plan that impact the CIP.
