10. <u>10:15 A.M. – REPORT ON GENERAL ASSEMBLY ACTIVITIES</u> (10:27 a.m.)

Chairman Connolly, Chairman of the Board's Legislative Committee, announced that the committee had its first meeting of the session this past Friday. He noted that transportation legislation had been introduced and the committee hopes to get more details as well as understand what is in the fine print, particularly concerning land use and other transportation and road issues.

Chairman Connolly added that the committee had reviewed County-initiated legislation, all of which is active with the exception of the living wage which was withdrawn, and presented a short list of other items being considered.

Chairman Connolly stated that the committee will meet every Friday, and reminded Board Members of the upcoming legislative reception. Input was provided by Katie Boyle, Management Analyst I, Office of the County Executive, concerning the time and location: Tuesday, February 13, 2007, at 5:30 p.m. at the Old City Hall in Richmond.

Chairman Connolly relinquished the Chair to Vice-Chairman Bulova and moved adoption of the Legislative Report. Supervisor Hudgins seconded the motion.

Supervisor Hudgins asked unanimous consent that the Board direct staff to review the addition to the legislative program on the Washington Area Housing Trust Fund budget amendment to support it. Without objection, it was so ordered.

The question was called on the motion and it carried by unanimous vote.

Chairman Connolly asked unanimous consent that the Board direct staff to provide a comprehensive analysis of the transportation initiative. Without objection, it was so ordered.

Vice-Chairman Bulova returned the gavel to Chairman Connolly.

Chairman Connolly announced that he had just been informed that there is a toll road provision in the enactment clause that would undo the Virginia Department of Transportation (VDOT) – Metropolitan Washington Airports Authority (MWAA) Toll Road Agreement.

Supervisor Hyland moved that the Board go on record expressing its opposition to that particular provision in the transportation bill. Supervisor Hudgins seconded the motion and it carried by unanimous vote.

Discussion ensued concerning the elimination of High-Occupancy Toll (HOT) lanes, among other things, and raising revenue. Supervisor Bulova asked unanimous consent that the Board direct staff to prepare a comparison, by jurisdiction, of local revenue raising abilities. Without objection, it was so ordered.

Discussion continued concerning the bonding authority. Supervisor Frey asked unanimous consent that the Board direct the County Attorney to determine:

- Who the bonding authority would be.
- Whose bonds they would be.
- Whose backing would be required.

Without objection, it was so ordered.

Discussion continued concerning the General Assembly's request to the County to impose fees and taxes, specifically the Department of Motor Vehicle new driver license fee.

Chairman Connolly relinquished the Chair to Vice-Chairman Bulova and asked unanimous consent that the Board direct staff to determine whether the State or the County would be responsible for the bonded indebtedness in imposing such fees and taxes. Without objection, it was so ordered.

Vice-Chairman Bulova returned the gavel to Chairman Connolly.

Supervisor Frey asked unanimous consent that the Board direct staff to determine whether the bonded indebtedness would be charged to the local governments individually or to the Northern Virginia Transportation Authority. Without objection, it was so ordered.

Discussion continued concerning disseminating information concerning General Assembly activities, particularly transportation. Supervisor McConnell asked unanimous consent that the Board direct staff to begin working on ways to disseminate that information to the public. Without objection, it was so ordered.

Discussion continued concerning accountability and tracking initiatives.

Chairman Connolly relinquished the Chair to Vice-Chairman Bulova and asked unanimous consent that the Board direct the Office of Public Affairs to develop a template for the Board to consider for an appropriate format. Without objection, it was so ordered.

Vice-Chairman Bulova returned the gavel to Chairman Connolly.

ADMIN 2 – AUTHORIZATION TO ADVERTISE PUBLIC HEARINGS TO CONSIDER PROPOSED AMENDMENTS TO THE CODE OF THE COUNTY OF FAIRFAX, CHAPTER 112 (ZONING ORDINANCE), REGARDING AFFORDABLE DWELLING UNITS – LIMITS ON BUILDING PERMITS AND RESIDENTIAL USE PERMITS

(R) (As) Adopted the Resolution authorizing the advertisement of a public hearing to be held before the Planning Commission on February 22, 2007, and before the Board on March 26, 2007, at 4:30 p.m. to consider proposed amendments to the Code of the County of Fairfax, Chapter 112 (Zoning Ordinance). The amendment will allow all building permits to be issued within the project, but will restrict Residential Use Permit issuance to 75 percent of the total number of units until such time as at least 75 percent of the Affordable Dwelling Units in the development have been issued Residential Use Permits for all types of developments, except for rental multiple family dwelling units.

She noted that when staff from her office, or the residents themselves, contact the VDOT representatives, they encounter difficulties in establishing whether the area in question is within the VDOT right-of-way. 22. <u>I-1 - CONTRACT AWARD - ALPS DRIVE SANITARY SEWER</u> <u>EXTENSION AND IMPROVEMENT (DRANESVILLE DISTRICT)</u> (12:09 p.m.)

The Board next considered an item contained in the Board Agenda dated January 22, 2007, requesting authorization for staff to award a contract to Martin and Gass, Incorporated, in the amount of \$323,738 for the construction of the Alps Drive Sanitary Sewer Extension and Improvement, Project Number X00826, Extension Projects in Fund 402, Sewer Construction Improvements.

The staff was directed administratively to proceed as proposed.

23. I-2 – STATE CORPORATION COMMISSION (SCC) FINAL ORDER FOR COLUMBIA GAS OF VIRGINIA RESULTS IN A \$2 MILLION REDUCTION IN CUSTOMER BILLS (12:09 p.m.)

The Board next considered an item contained in the Board Agenda dated January 22, 2007, announcing the SCC's final order for Columbia Gas of Virginia resulting in a \$2 million reduction in customer bills.

Following a brief discussion regarding the Consumer Protection Division, Department of Cable Communications and Consumer Protection, Supervisor Bulova asked unanimous consent that the Board direct staff to ensure that the community is made aware of the effectiveness and success of the Consumer Protection Division in obtaining a \$2 million reduction in customer bills. Without objection, it was so ordered.

ADDITIONAL BOARD MATTERS

24. ENCOURAGING VOLUNTEERISM IN COUNTY PARKS (12:11 p.m.)

Chairman Connolly, jointly with Supervisor DuBois, noted that the Park Authority has worked with hundreds of County residents on a variety of environmental improvement programs including Invasive Management Areas (IMA) and riparian buffer plantings. The Park Authority prohibits volunteers from using power equipment on IMA projects in parks. This dampens the enthusiasm of volunteers who must use bare hands and hand tools to battle well-established non-native vines, grasses, and shrubs. The Great Falls Citizen Association, the Potomac Appalachian Trail Club, the Potomac River Green Ways Coalition, the Hunters Valley Riding Club, and the Mid-Atlantic Off-Road Enthusiasts have expressed concerns that there are a number of institutional barriers to volunteering to plant riparian buffers, improve trails, and conduct other public service projects in County Parks. The County is fortunate to have not only an extraordinarily extensive park system used by thousands of County residents, but also enthusiastic citizen volunteers.

Accordingly, jointly with Supervisor DuBois, Chairman Connolly relinquished the Chair to Vice-Chairman Bulova and moved that the Board request the Park Authority to allow experienced volunteers to use power tools in IMA projects and take all other appropriate steps to reduce institutional barriers to volunteerism in County parks. Supervisor DuBois seconded the motion.

Following discussion regarding spraying, Chairman Connolly clarified that this issue was included in his motion as part of institutional barriers in general.

The question was called on the motion, as clarified, which carried by a vote of nine, Supervisor Frey being out of the room.

25. **MODEL JUDICIARY PROGRAM** (12:13 p.m.)

Chairman Connolly reported that he and Supervisor Hudgins recently attended the Model Judicial Program where students from a number of area high schools put on mock trials as part of this program. He noted that this activity is a labor of love of Judge Stanley Klein.

Accordingly, Chairman Connolly asked unanimous consent that the Board direct staff to invite Judge Klein and the others involved with making this program possible to appear before the Board to be recognized and honored. Without objection, it was so ordered.

Chairman Connolly asked unanimous consent that the Board direct the County Attorney to ensure that all of the appropriate people are included for recognition. Without objection, it was so ordered.

There was a brief discussion regarding previous participation by staff.

Vice-Chairman Bulova returned the gavel to Chairman Connolly.

26. <u>MARCH IS "INCLUDING PEOPLE WITH DEVELOPMENTAL DISABILITIES" MONTH</u> (12:14 p.m.)

Supervisor Bulova said that throughout the United States, March will be celebrated as "Including People with Developmental Disabilities Month." In the County, during the month of March, the Arc of Northern Virginia, in conjunction with People First, a self-advocacy group for people with developmental disabilities, and the Fairfax-Falls Church Community Services Board (CSB), educate the public about the abilities and needs of people with developmental disabilities and their families.

Therefore, Supervisor Bulova asked unanimous consent that the Board:

- Proclaim March as "Including People with Developmental Disabilities Month" in Fairfax County.
- Direct staff to invite the Arc and the CSB to appear before the Board on February 26, 2007, to accept this proclamation.

Without objection, it was so ordered.

27. <u>RECOGNITION OF "THE COOKIE LADY" GERMAINE BROUSSARD</u> (12:15 p.m.)

Supervisor Smyth said she, Supervisor DuBois, and Chairman Connolly would like to recognize the fact that the County is proud to be the home of "The Cookie Lady." Ms. Germaine Broussard, as she is otherwise known, has baked more than 15,000 cookies for troops serving overseas for a little over three years now.

Noting that Ms. Broussard has also been involved in many other worthwhile activities as outlined in the written Board Matter, Supervisor Smyth, jointly with Supervisor DuBois and Chairman Connolly, asked unanimous consent that the Board direct staff to invite her to appear before the Board on February 5 to be presented with a Certificate of Recognition. Without objection, it was so ordered.

28. <u>BURGLARY PREVENTION SEMINAR (PROVIDENCE DISTRICT)</u> (12:16 p.m.)

Supervisor Smyth said that the Police Department will conduct a seminar about preventing home burglaries on Wednesday, January 24, from 7 p.m. - 8:45 p.m. at the James Lee Community Center, 2855-A Annandale Road, Falls Church, in the Providence District. This seminar is free and open to the public; no registration is required. This seminar was previously presented on December 11 at the McLean Governmental Center and was very well received.

Supervisor Smyth invited Board Members, County staff, and residents to this seminar and asked unanimous consent that the Board direct the Office of Public Affairs to help publicize the seminar. Additional information may also be obtained by contacting MPO Tom Black of the Police Department, McLean District Station, at 703-556-7750 or by calling her office. Without objection, it was so ordered.

29. <u>VIRGINIA DEPARTMENT OF TRANSPORTATION (VDOT)</u> <u>RESPONSIBILITIES</u> (12:17 p.m.)

(NOTE: Earlier in the meeting, the Board discussed VDOT issues. See Clerk's Summary Item #15.)

With reference to the Board's earlier action regarding VDOT and the issue of trash, Supervisor Smyth said the Board mentioned Prince William County's sixperson group that cleans roads. She asserted that this is an assumption of State responsibilities. Therefore, Supervisor Smyth asked unanimous consent that the Board direct the County Executive to review this apparent relinquishment of State responsibility for maintenance and the potential unfunded mandate for the County this situation could create. Without objection, it was so ordered.

(NOTE: Later in the meeting, the Board took additional action regarding VDOT. See Clerk's Summary Item #36.)

30. RECOGNIZING THE **EFFORTS OF** YOUTH **VOLUNTEERS'** INVOLVEMENT IN THE MILLER HEIGHTS **NEIGHBORHOOD** ASSOCIATION'S TRAFFIC CALMING INITIATIVE (PROVIDENCE **DISTRICT**) (12:18 p.m.)

Supervisor Smyth said the Miller Heights Neighborhood Association in Oakton has persevered for about two years toward completion of its application for the Residential Traffic Administration Program. Upon successful conclusion of the ongoing balloting phase, the neighborhood will have achieved a long sought after goal to improve traffic safety in the neighborhood through an array of traffic calming devices along Miller Heights Road.

Supervisor Smyth reported that this Oakton neighborhood suffered a tragic loss of life late last October. Two teenagers were driving and went off the road, resulting in the passenger's death. In spite of this, the community's response demonstrated strength. Friends of the two teenagers initiated a program to install reflectors on mailboxes to improve visibility along the dark stretch of roadway where the accident took place. In coordination with the Miller Heights Neighborhood Association, and with guidance from the Virginia Department of Transportation, reflectors were offered to all homeowners along Miller Heights Road.

Supervisor Smyth said that other young volunteers directed their efforts toward reminding residents to cast their ballots for the traffic calming proposal. Their efforts will help to ensure that the balloting process proceeds efficiently and will lead to a safer environment.

Therefore, Supervisor Smyth moved that the Board direct staff to invite all of the youth volunteers involved to appear before the Board to be recognized for their commitment and dedication to public safety and civic activity. Supervisor DuBois seconded the motion and it carried by unanimous vote.

31. <u>FAIRFAX COUNTY VISITATION AND SUPERVISED EXCHANGE</u> (SVSE) REPORT (12:19 p.m.)

(BACs) (NOTE: Earlier in the meeting, the Board made an appointment to the SVSE. See page 13.)

Supervisor Hudgins said that as noted earlier, the SVSE Task Force provided a status report to the joint meeting of the Human Service and Housing Committees on Friday, January 19. The SVSE Task Force was appointed on July 31, 2006, to develop a model for supervised visitation and exchange program, giving special attention to community needs, the type of program services to be provided, possible site locations, and a plan for funding.

Supervisor Hudgins noted that the task force established a mission "to provide a healthy, age appropriate, and accessible environment where children and their parents are supported through a continuum of family oriented services." It noted that SVSE is needed to maintain child bonds with the non-custodial parent, while protecting the interest of the child and documenting compliance of both parents.

Supervisor Hudgins said that the task force recommended a three phase model. The program began with Phase I offering intake and SVSE at the courthouse on a limited basis. Phase II will expand on Phase I with intake therapist and supportive services such as therapeutic intervention, training, and referral. Phase II is dependent on available funding, and Phase III will look to replicate the program at other sites.

Accordingly, Supervisor Hudgins moved that the Board accept the SVSE Task Force Report recommendations as follows:

- Establish the three phase model as outlined in the report.
- Continue its work for another year.
- Add the Domestic Violence Coordinator for Fairfax County to the task force.
- Provide a status report to the Board by the end of 2007.

Supervisor Hudgins further moved that the Board commend the task force for its comprehensive as well as thoughtful approach to addressing a critical issue facing the community.

Supervisor Bulova seconded the motion, which carried by unanimous vote.

32. RESTON CHILDREN CENTER'S (RCC) FORTIETH ANNIVERSARY (HUNTER MILL DISTRICT) (12:22 p.m.)

Supervisor Hudgins noted that the RCC, founded in 1964, was Reston's first non-profit, parent-oriented cooperative, dedicated to the developmental and educational needs of children, and to provide quality support systems for families. RCC was one of the first child care programs in Reston and the first in the County to provide infant care. In addition to infant care, RCC currently provides preschool education and before and after-school enrichment for children in grades K-6. In 1988 RCC was the first after-school program in Reston honored with national accreditation and the fourth in Virginia accredited by the National School Age Child Care Alliance.

Supervisor Hudgins announced that on February 10 the RCC will celebrate with a fortieth birthday gala at the Hidden Creek Country Club in Reston from 6-11 p.m.

Accordingly, Supervisor Hudgins moved that the Board direct staff to invite the families of RCC to appear before the Board to be recognized for its 40 years of continuous quality after-school and preschool care to the Reston community. Vice-Chairman Bulova seconded the motion, which carried by a vote of nine, Chairman Connolly being out of the room.

33. <u>DEPARTMENT OF FAMILY SERVICES' HEART GALLERY RECEPTION</u> (12:23 p.m.)

Supervisor Hudgins called the Board's attention to information she distributed in regard to the January 31 Department of Family Services' Heart Gallery Reception at the Government Center as part of its foster care and adoption outreach. Featured in *The Washington Post* last Thursday and sponsored by Freddie Mac, the gallery is the first of its kind in the Washington metropolitan area and one of more than 60 Heart Galleries nationwide. The children featured are from the DC area. Since November 2005, the exhibit with photos of 48 children has traveled around the capital area with a success of adoption to date of 14 children.

Supervisor Hudgins reported that the Heart Gallery will be at the Government Center and she asked unanimous consent that the Board direct the Office of Public Affairs to assist in continuing to share the story of this very critical need for a warm and loving home for these children and invite Board Members to join in the Department of Family Services' Heart Gallery Reception on January 31 from 4-6 p.m. at the Government Center for the celebration. Without objection, it was so ordered.

34. **HUMAN RIGHTS COMMISSION FAIR HOUSING REPORT** (12:24 p.m.)

(BACs) Supervisor Hudgins noted that Board Members received in their offices a report from the Human Rights Commission on the testing for fair housing and the

accessibility. She commended the report, but noted that the number for testing was very low.

Accordingly, Supervisor Hudgins asked unanimous consent that the Board direct staff to provide a response in terms of viability of the data and efforts to reach more units. Without objection, it was so ordered.

35. **PIPELINE UPGRADE (SULLY DISTRICT)** (12:26 p.m.)

Jointly with Chairman Connolly, Supervisor Frey said that they had been working with Williams Transco Company, which seeks to expand a pipeline that runs through the Virginia Run community. It has three pipelines now and would like to upgrade one of the 30 inch lines to a 42 inch line because of increased demand in the region and the entire northeast region of the US. The Federal Energy Regulatory Commission (FERC) has reviewed the environmental assessment and has set a deadline of February 16 for comments.

Supervisor Frey said that this past weekend he, State Senator Cuccinelli (R_37), and Delegate Hugo (R-40) met with the community and walked the pipeline area. The community has serious concerns to be addressed, and more time is needed for another meeting.

Accordingly, Supervisor Frey moved that the Board direct staff to prepare a letter for the Chairman's signature to the FERC requesting additional time to comment on the environmental assessments to work with the community and the company to resolve the issues. Chairman Connolly seconded the motion.

Following a brief discussion regarding the concern about above-ground structures, the question was called on the motion, which carried by unanimous vote.

36. **SNOW REMOVAL** (12:28 p.m.)

(NOTE: Earlier in the meeting, the Board discussed issues regarding the Virginia Department of Transportation (VDOT). See Clerk's Summary Items #15 and #29.)

Supervisor McConnell announced that her office had received several emails from citizens who were upset about snow removal today.

Chairman Connolly relinquished the Chair to Vice-Chairman Bulova and asked unanimous consent that the Board direct staff to broadcast on Channel 16 that snow removal is a responsibility of VDOT. Without objection, it was so ordered.

Vice-Chairman Bulova returned the gavel to Chairman Connolly.

A brief discussion ensued regarding snow removal by VDOT.

Supervisor Gross asked unanimous consent that the Board direct staff to also broadcast on Channel 16 safety tips for driving in ice and snow. Without objection, it was so ordered.

37. PARKING ISSUE ON TINA LANE (DRANESVILLE DISTRICT) (12:33 p.m.)

(R) Supervisor DuBois said that one of her constituents, the owner of 6600 Tina Lane, lives near Langley High School and half of his property is included in Residential Permit Parking District 20.

However, since 6600 Tina Lane is a corner lot, only the section along Ridge Drive is protected by the residential permit parking restrictions. She pointed out that the section along Tina Lane has been consistently damaged by student drivers, thus causing undue hardship upon her constituent. The Department of Transportation (DOT) has witnessed the damage and will support the installation of "No-parking" signs at this location.

Therefore, Supervisor DuBois moved that the Board adopt the Resolution directing DOT to work with the Virginia Department of Transportation to ensure that "No Parking" signs are installed at 6600 Tina Lane, McLean, 22101. Chairman Connolly seconded the motion and it carried by unanimous vote, Supervisor Bulova, Supervisor DuBois, Supervisor Frey, Supervisor Gross, Supervisor Hudgins, Supervisor Hyland, Supervisor Kauffman, Supervisor McConnell, Supervisor Smyth, and Chairman Connolly voting "AYE."

38. GOVERNING BOARD OF THE McLEAN COMMUNITY CENTER (MCC) (DRANESVILLE DISTRICT) (12:35 p.m.)

(BACs) Supervisor DuBois said that in 1984, the Board approved revisions to the Memorandum of Understanding (MOU) with the Governing Board of the McLean Community Center (MCC). Section IV of that MOU provides for the composition of the Governing Board of the MCC. Section IV (B) provides that the Governing Board of the MCC shall set up procedures for the election of candidates, and also provides that the Board shall approve those standards and procedures. The Board of Supervisors approved those Standards and Procedures on May 14, 1984, as Attachment I to the MOU.

Supervisor DuBois stated that in November, the Governing Board asked her to investigate what actions would be required to amend the approved election standards and procedures. In particular, MCC wishes to allow for absentee balloting, including the use of mail-in ballots, to ensure that elderly, infirm, or out-of-town residents of Small District 1 have an opportunity to vote. The Center mistakenly believed that it had such authority which was challenged in 2006 by a losing candidate.

Specifically, three changes to the election procedures are requested:

- Formalization of the current absentee ballot process.
- Removal of all references to samples that no longer exist.
- Permission to use random rather than alphabetical listings of candidates' names on the ballot.

Supervisor DuBois noted that the County Attorney has advised her that these recommended amendments can be enacted by approval of a Board Matter.

Therefore, Supervisor DuBois moved that the Board approve the revisions noted above, and outlined in Attachment I of the MCC Governing Board MOU, to go into effect immediately before notice for this spring's election is publicized. Supervisor Bulova seconded the motion and it carried by unanimous vote.

39. **ZONTA CLUB OF FAIRFAX** (12:36 p.m.)

Supervisor Gross said that the Zonta Club of Fairfax will celebrate its fiftieth anniversary in early February. The Fairfax Chapter is part of Zonta International, a worldwide service organization of executives in business and the professional advancing the status of women worldwide.

Therefore, Supervisor Gross asked unanimous consent that the Board direct staff to prepare a proclamation for the Chairman's signature and hers, for presentation to the Zonta Club at its celebratory luncheon on February 3. Without objection, it was so ordered.

40. **CROWN SERVICE STATIONS (MASON DISTRICT)** (12:37 p.m.)

Supervisor Gross said that changes in ownership of two former Crown service stations in Mason District will require special exception applications since their previous Board of Zoning Appeals (BZA) approvals, years ago, were conditioned that they were granted to the applicant only and any change would require approval of the Board. The BZA cannot consider such a request, and so the applicant must go through the rather daunting process of a special exception to simply change ownership.

Therefore, Supervisor Gross moved that the Board grant expedited processing for a public hearing on Special Exception Application SE-2006-MA-028, Petroleum Marketing Group, Incorporated, for property located at 6014 Leesburg Pike, Tax Map 61-2((1))7, Revitalization Area, H-C, C-5. The Planning Commission's public hearing is scheduled for April 18, and the applicant has asked for a Board date as soon as possible after that date. Supervisor Bulova seconded the motion and it carried by unanimous vote.

Supervisor Gross moved that the Board grant expedited processing for a public hearing on Special Exception Application SE-2006-MA-029, Petroleum Marketing Group, Incorporated, for property located at 6464 Edsall Road. The Planning Commission hearing date is April 18. Supervisor Bulova seconded the motion and it carried by unanimous vote.

These motions should not be construed as a favorable recommendation of this application by the Board and does not relieve the applicant of compliance with the provisions of any applicable ordinances, regulations, or adopted standards.

There was a brief discussion regarding similar special exception applications.

41. <u>RENOVATIONS BY THE MISTRY FAMILY (MASON DISTRICT)</u> (12:39 p.m.)

Supervisor Gross said that a 1950s-era home, built in the floodplain of Longbranch Creek, was purchased a few years ago by the Mistry family that desired to remodel and add a second story addition to the original structure. Appropriate building permits were applied for and issued, and renovations began. The contractor discovered that the original first-floor exterior walls could not support the addition. Unaware of a Floodplain Determination Approval Condition, the contractor proceeded to dismantle the first story exterior walls down to the foundation.

Supervisor Gross stated that things proceeded from bad to worse after that, and a special exception is needed to rectify the errors and allow the owners to complete construction and move into their home. The owners and their agent have been working diligently with County staff to pursue a special exception, and they have asked for Board action to advance these efforts.

Therefore, Supervisor Gross moved that the Board:

- Direct the Director of the Department of Public Works and Environmental Services to permit concurrent processing of the grading plan and amended building plan processes and other related documents and applications.
- Grant approval for an expedited Board date for the application.
- Direct the Building Inspections Branch to perform the necessary
 and required inspections, or permit the applicant to use a private
 inspection service to allow the applicants, at their own risk, to
 continue construction of the single family home, after such time as
 the amended building plans are approved and a favorable staff
 report is presented for this project.

These motions should not be construed as a favorable recommendation of this application by the Board and does not relieve the applicant of compliance with the provisions of any applicable ordinances, regulations, or adopted standards.

Supervisor Bulova seconded the motion.

Following discussion regarding the last bullet of the motion, the question was called on the motion and it carried by unanimous vote.

42. **TREE ACTION PLAN** (12:44 p.m.)

Supervisor Gross said that on December 31, 2006, the Board's Environmental Committee received a presentation on a final draft of the long-awaited 64-page report entitled "Tree Action Plan." This document represents a 20-year strategic plan to conserve and manage the County's tree and forest resources, which are referred to as the "urban forest."

As requested by the Board's Environmental Committee, in April 2006 a working group comprised of representatives from County staff, tree commissioners, Virginia State forestry and transportation officials, non-profit tree planting organizations, and the land development industry convened to finalize the Tree Action Plan. The Tree Action Plan originated from a charge given to the Tree Commission and the Urban Forest Management Division by Chairman Connolly in October 2004.

The Tree Action Plan urges the County to commit to three important goals that support the Board's goals in the Environmental Agenda and that will help conserve the urban forest. These goals include:

- Preservation of Current Tree Assets (preserve existing trees).
- Enhancement of the Legacy for Future Generations (plant new trees).
- Increase the Effectiveness of Urban Forestry within County Policies and Planning Efforts.

Supervisor Gross said that at the Environmental Committee, the Members of the Board who were present, asked her to present a Board Matter at the earliest possible date that will show this Board's concurrence with the general direction of the major goals and core recommendations of the Tree Action Plan. During this same discussion, a draft proposal to amend the Board's Environmental Agenda was circulated and discussed. The draft proposes that strategic and tactical language be added to the current environmental agenda to highlight the need to conserve and manage the County's tree and forest resources. The Environmental Committee agreed to discuss the draft language amendment at its next meeting scheduled for March 19.

Therefore, Supervisor Gross moved that the Board:

- Endorse the Goals and Actions in the Tree Action Plan and direct the County Executive to disseminate the plan to the Environmental Coordinating Committee for appropriate follow-up action.
- Direct the County Executive to take steps to publish and promote the Tree Action Plan at the official Earth Day/Arbor Day Celebration in April 2007, and at other such environmental events throughout the County.

Supervisor Bulova seconded the motion and it carried by unanimous vote.

43. REQUEST FOR AN OUT-OF-TURN PLAN AMENDMENT (LEE DISTRICT) (12:47 p.m.)

Supervisor Kauffman said that the owners of property located at 7800 and 7722 Backlick Road, better known as the Mike Pallone Auto Dealerships, have requested an Out-of-Turn Plan Amendment for their property. One of the dealerships has now closed, and the owners are contemplating future reuse of the property. He noted that the businesses sit adjacent to the Engineer Proving Grounds (EPG). The Base Realignment and Closure Commission (BRAC) has recommended that upwards of 18,000 employees be transferred to the EPG site. This action will require significant office development in the area of the EPG.

Supervisor Kauffman said that currently the Pallone Dealerships are zoned C-8 (2.47 acres) and I-5 (9.45 acres). The C-8 zoning district allows for .25 floor area ratio (FAR) for office by-right and a .5 FAR by special exception. The Industrial zoned property allows for .5 FAR by-right and up to 1.0 FAR by special exception already.

To foster the office development in an appropriate manner, Supervisor Kauffman moved that the Board authorize an Out-of-Turn Plan Amendment for the Pallone Auto Dealership properties to allow for office development up to 2.0 FAR. To secure the high end of the density range, primary access to the property must be provided by a street other than Backlick Road and the transportation analysis should provide consideration of access through the EPG or Fullerton Road. Supervisor DuBois seconded the motion.

Following discussion regarding the proposal, the question was called on the motion and it carried by unanimous vote.

44. **UNIVERSAL DESIGN DEMONSTRATION** (12:51 p.m.)

Supervisor Kauffman announced that the Board's Committee on Aging will be touring the Universal Design Demonstration House on Tuesday, January 23.

Transportation for Board Members is available. They will leave from the front of the Government Center at 9 a.m. and will return by lunch time. This is an exciting opportunity for the Board to explore universal design up close. He noted that staff from the Department of Planning and Zoning, the building community, and local media will also be attending.

Supervisor Kauffman announced that more information regarding the home and the days and hours it is open can be found at www.pwcgov.org/ud.

45. **OPEN HOUSE (LEE DISTRICT)** (12:51 p.m.)

Supervisor Kauffman announced that there will be an open house on Saturday, January 27, 2007, from 1 p.m. until 4 p.m. at the Franconia Governmental Center.

46. **REELECTION (LEE DISTRICT)** (12:52 p.m.)

Supervisor Kauffman announced that he would not be seeking reelection.

(NOTE: Later in the meeting, there was further discussion of this item. See Clerk's Summary Item #48.)

47. **NEIGHBORHOOD STABILITY (LEE DISTRICT)** (12:53 p.m.)

Supervisor Kauffman said that for the first decade of his service as a County Supervisor, the first three questions he would get when visiting with citizens would focus on transportation and gridlock. More and more, the first three questions he hears today target the loss of neighborhood stability in the communities.

Supervisor Kauffman noted that these are not minor issues. Not only do they affect personal and public safety, sanitation, and property values, but they speak to the basic issue of fairness. The Board expects its citizens and neighbors to play by the rules. In exchange, the government enforces those rules. When government breaks this implicit contract, it puts another nail in the coffin of public trust.

Supervisor Kauffman noted that this loss of neighborhood stability includes single family residential homes turned into commercial uses such as boarding/apartment houses and multiple employee business operations. It includes small fleets of commercial vehicles on neighborhood streets, junk cars, trash left to pile-up in yards, and all manner of health code violations.

Supervisor Kauffman said that the Board can begin with changing how the County uses existing tools to address this destabilization, press for faster enforcement, and ask the State for legislation to allow the County to impose more serious penalties for these violations—many of which are serious safety hazards.

Here's a list of some of the things he is working on in response to this growing problem:

- Taking complaints about zoning, health code, and building violations as serious priorities.
- Working with the Chief of Zoning Enforcement to get a new mix of inspectors with more skills, fresh eyes, and a stronger attitude toward enforcement to serve the district. The County has begun cross-training inspectors and, as of January 1, many of them have already been trained and certified to enforce the property maintenance code. Adding multi-lingual inspectors to the staff so language difficulties should no longer be a barrier to enforcement or an excuse. Also working with the police to ensure they work closely with zoning inspectors and provide mutual support as necessary.
- Working to develop a zero tolerance policy in Lee District so if a
 problem is found with a clear zoning violation, County inspectors
 can issue a field notice or corrective order on the spot. The days of
 holding violator's hands for weeks and asking them nicely to
 resolve neighborhood problems before a violation is issued must
 end. The bottom line is that faster enforcement is needed and
 compliance actions to keep neighborhood problems from
 spreading.
- Cracking down on unlicensed contractors and un-permitted construction. The County Attorney joined him on an evening inspection of some of these homes. He met with neighbors living next to problem properties and gained a "street level" understanding of the problems.
- Working with Delegate Sickles (D-43) to amend State law to stiffen the penalties for landlords who are running commercial boarding houses in residential communities. Increasing the fine from \$1000 to \$2500 per occurrence. Consider the possibility of jail time and ways to keep landlords from perpetuating these boarding houses. Stop blaming the victims of overcrowding and start going after the enablers—the ones who are profiting from the unsafe situations they create.
- Engaging the entire community in this effort. He has reached out to State officials, local chambers of commerce, real estate agents, and homeowner and civic associations.

Supervisor Kauffman asserted that playing by the rules, vigilance, and public safety are key in all these efforts. The health and safety problems in

neighborhoods are real and have even resulted in deaths in the County. A community split between those who play by the rules and those who do not divides and destabilizes neighborhoods.

Supervisor Kauffman urged interested individuals to call his office at (703) 971-6262 with any concerns about zoning violations, un-permitted construction, or other related problems.

48. **REELECTION (LEE DISTRICT)** (12:58 p.m.)

(NOTE: Earlier in the meeting this issue was announced. See Clerk's Summary Item #46.)

Board Members reflected on their years of service with Supervisor Kauffman.

49. <u>JOINT BOARD MATTER OF CHAIRMAN CONNOLLY AND SUPERVISOR HYLAND REGARDING THE CREATION OF A HUNTINGTON COMMUNITY FLOOD INSURANCE GRANT PROGRAM (MOUNT VERNON DISTRICT) (1:06 p.m.)</u>

Supervisor Hyland said that the torrential rains that fell on the County on June 25-26, 2006, were particularly devastating to the Huntington Community, where as many as 160 homes were flooded. One of the recommendations of the Army Corps of Engineers' study, which was commissioned by the County, was for property owners to obtain flood insurance as a temporary measure until more lasting solutions to the potential for more flooding can be identified and implemented.

Because the Huntington Community is within the existing Route One Rehabilitation District, Virginia Code Section 36-52.3 permits the Board to designate an area that would include within its boundaries the homes in the Huntington Community that experienced the June flooding or are deemed susceptible to future flooding. That same Code section also empowers the Board to establish a program directed toward prevention and elimination of deteriorating conditions in such an area that would enable the Redevelopment and Housing Authority to reimburse resident owners, depending on their income levels, for the cost of obtaining flood insurance through Federal Emergency Management Association's (FEMA) National Flood Insurance Program.

Therefore, jointly with Chairman Connolly, Supervisor Hyland moved that the Board direct staff to explore the creation of such an area and program and return to the Board with an appropriate Board Item for review at the Board's February 26, 2007, meeting. Chairman Connolly seconded the motion.

Following discussion regarding the proposal, Supervisor Gross asked unanimous consent that the Board direct staff to review this FEMA flood insurance program. Without objection, it was so ordered.

Supervisor DuBois asked unanimous consent that the Board direct staff to report with estimated costs of the program. Without objection, it was so ordered.

The question was called on the motion and it carried by unanimous vote.

50. <u>ALEXANDRIA TECH CENTER OWNER'S ASSOCIATION LETTER</u> (MOUNT VERNON DISTRICT) (1:11 p.m.)

Supervisor Hyland said that last week Chairman Connolly, Alexandria City Mayor Bill Euille and he attended a briefing by the Corps of Engineers to the Huntington Community on the causes of the June flood. Also present at the meeting were several people from the Alexandria Tech Center Owner's Association. They independently hired a consulting hydrologist to determine what factors caused the damage to their buildings in Eisenhower Avenue. This independent consultant's findings were similar to those of the Corps.

In their letter they ask for Governor Tim Kaine's assistance to review the Corps of Engineers as well as their consultant's findings and have the Virginia Department of Transportation (VDOT) take remedial action to restore Cameron Run to its "original design condition and capacity" since, according to their letter, Cameron Run is in VDOT's right-of-way in an engineered channel constructed as part of the Beltway's development. As stated in the meeting to the Huntington Community, anything the County does to address this problem will be jointly coordinated with the City of Alexandria since it affects both jurisdictions.

Therefore, Supervisor Hyland asked unanimous consent that the Board refer this letter to the County Executive and Department of Public Works and Environmental Services to ensure that there are no gaps in County study areas and the requests for information and assistance and to coordinate efforts with the City of Alexandria. Without objection, it was so ordered.

51. <u>SIMULTANEOUS PROCESSING FOR 1111 I STREET (MOUNT VERNON DISTRICT)</u> (1:13 p.m.)

Supervisor Hyland said that in the New Alexandria neighborhood of the Mount Vernon District is a very narrow property, which has been vacant and boarded up since Hurricane Isabel. On several occasions, police officers have had to secure the property from vandals. Due to the property's size and zoning, R-20, the applicant has been working with staff and the New Alexandria Civic Association (NACA) for years to assemble a special exception and variance application to redevelop this blight. One year ago, the NACA passed a resolution supporting the proposal. The applicant and the NACA request that staff process this application expeditiously.

Therefore, Supervisor Hyland moved that the Board direct staff to concurrently process the special exception and variance applications for Tax Map Parcel 93-2

((7)) (4) 3 and its associated site plan. Supervisor McConnell seconded the motion and it carried by unanimous vote.

These motions should not be construed as a favorable recommendation of this application by the Board and does not relieve the applicant of compliance with the provisions of any applicable ordinances, regulations, or adopted standards.

52. <u>COYOTES IN THE COUNTY (COUNTYWIDE)</u> (1:14 p.m.)

Supervisor Hyland said it has come to his attention that communities near George Washington's Grist Mill in the Mount Vernon District have sighted coyotes. According to Animal Control, there are coyotes throughout large areas of the east coast and this includes much of the County. Animal Control Officers expressed their concerns about the trapping methods and their ability to control the coyote population. At this time the County has no official policy recognizing the issues surrounding the increase in the coyote's population in the urbanizing environment. This is to the frustration of both those who live among them, like these residents in Grist Mill, and some animal control officers. It is important to note that, according to Animal Control, coyotes cannot be caught with humane traps and trapping these animals may pose a hazard to pets and humans.

Therefore, Supervisor Hyland moved that the Board direct the County Executive and Animal Control Services to study this issue and propose recommendations regarding the management of the coyote population in the County. The second to this motion was inaudible.

Following input from Anthony H. Griffin, County Executive, regarding coyotes as a predator for Canada geese, the question was called on the motion and it carried by unanimous vote.

53. <u>HEALTH CARE ADVISORY BOARD'S (HCAB) ROLE IN SPECIAL EXCEPTION APPLICATION REVIEW</u> (1:16 p.m.)

(BACs) Supervisor Hyland said that he recently received a letter from Marlene Blum, Chairman of the HCAB. She expressed her frustration with interpretations of the Zoning Ordinance that have disallowed her Board's review of certain land use applications, specifically the Springfield and Lorton Healthplexes. These ambulatory care facilities provide 24 hour emergency departments and outpatient services, as well as office space for doctors. However, because the patients do not stay overnight, the Department of Planning and Zoning classifies these facilities as office buildings. Due to the ever changing face of health care in the County, Supervisor Hyland said that perhaps the Zoning Ordinance needs an additional use category that defines a Healthplex as a medical office facility that receives EMS transported patients, and such a facility would necessitate the review of the HCAB.

Therefore, Supervisor Hyland moved that the Board direct the Department of Planning and Zoning to review this issue and report with its recommendations. Supervisor Smyth seconded the motion.

Following discussion regarding parking issues and the motion, the question was called on the motion and it carried by unanimous vote.

54. NOTIFICATION PROCESS FOR RENEWAL OF SPECIAL USE PERMIT (MOUNT VERNON DISTRICT) (1:18 p.m.)

Supervisor Hyland said on January 23, 2007, representatives of Vulcan Quarry in the Mount Vernon District will appear before the Board of Zoning Appeals to seek renewal of its special use permit. He said that it has come to his attention that many property owners who are supposedly affected by the blasting, did not receive notification of the renewal process. The current County code requires the notification of ten different, but "abutting or immediately" adjacent properties to the applicant. In the case of a quarry, the impact can potentially be felt further than ten properties away due to blasting. The range of notification needs to be expanded to ensure those properties that are near, but not "abutting or immediately across" from the applicant, be duly notified.

Therefore, Supervisor Hyland moved that the Board direct the County Executive to study this issue and propose recommendations regarding the possible expansion of notification areas for the renewal of special use permits. Supervisor McConnell seconded the motion and it carried by unanimous vote.

55. TAXES ON USED TRAILER (MOUNT VERNON DISTRICT) (1:20 p.m.)

Supervisor Hyland asked unanimous consent that the Board refer the issue of a constituent paying taxes on a used trailer bought in 1974 for \$75 to staff for review. Without objection, it was so ordered.

56. **RECESS/CLOSED SESSION** (1:22 p.m.)

Supervisor Gross moved that the Board recess and go into closed session for discussion and consideration of matters enumerated in Virginia Code Section (§) 2.2-3711 and listed in the agenda for this meeting as follows:

- (a) Discussion or consideration of personnel matters pursuant to Virginia Code § 2.2-3711(A) (1).

Supervisor Kauffman seconded the motion and it <u>CARRIED</u> by a recorded vote of eight, Supervisor DuBois and Supervisor Frey voting "NAY."
