At a regular meeting of the Board of Supervisors of Fairfax County, Virginia, held in the Board Auditorium of the Government Center at Fairfax, Virginia, on Tuesday, February 23, 2010, at 9:08 a.m., there were present:

BOARD MATTER

1. **MOMENT OF SILENCE** (9:08 a.m.)

Supervisor Herrity asked everyone to keep in thoughts the family of Frank Chianese, father of Assistant County Executive Catherine A. Chianese, who died on February 11, 2010. He retired from the Marine Corps in 1962.

AGENDA ITEMS

2. PROCLAMATION DESIGNATING MARCH 2010 AS "WOMEN'S HISTORY MONTH" IN FAIRFAX COUNTY (9:10 a.m.)

Supervisor Gross moved approval of the Proclamation to designate March 2010 as "Women's History Month" in Fairfax County. Supervisor Foust and Supervisor Hyland jointly seconded the motion and it carried by unanimous vote.

Supervisor Hudgins reminded everyone about the upcoming Women's Voices Forum organized by the Commission for Women, which will be held on Saturday, March 20, 2010, from 9 a.m. to 3 p.m.

3. PROCLAMATION DESIGNATING FEBRUARY 7–14, 2010, AS "CONGENITAL HEART DEFECT AWARENESS WEEK" IN FAIRFAX COUNTY (9:29 a.m.)

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and moved approval of the Proclamation to designate February 7–14, 2010, as "Congenital Heart Defect Awareness Week" in Fairfax County. Supervisor McKay seconded the motion and it carried by unanimous vote.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

4. <u>CERTIFICATE OF RECOGNITION PRESENTED TO MR. MARVIN</u> <u>CANTOR</u> (9:39 a.m.)

(BACs) Chairman Bulova relinquished the Chair to Vice-Chairman Gross and moved approval of the Certificate of Recognition presented to Mr. Marvin Cantor for his service on the Board of Building and Fire Prevention Code Appeals. Supervisor Hyland and Supervisor Smyth jointly seconded the motion and it carried by unanimous vote.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

5. <u>CERTIFICATE OF RECOGNITION PRESENTED TO TYSONS LAND USE TASK FORCE</u> (9:49 a.m.)

(BACs) Chairman Bulova relinquished the Chair to Vice-Chairman Gross and moved approval of the Certificate of Recognition presented to Tysons Land Use Task Force for its work to develop a community vision for the redevelopment of Tysons Corner. This motion was multiply seconded and it carried by a vote of nine, Supervisor Hyland being out of the room.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

6. PROCLAMATION DESIGNATING MARCH 2010 AS "ALTERNATIVE DISPUTE RESOLUTION MONTH" IN FAIRFAX COUNTY (10:04 a.m.)

Supervisor Smyth moved approval of the Proclamation to designate March 2010 as "Alternative Dispute Resolution Month" in Fairfax County. Supervisor Foust and Supervisor Gross jointly seconded the motion and it carried by unanimous vote.

7. <u>RESOLUTION OF RECOGNITION PRESENTED TO THE PARK AUTHORITY</u> (10:23 a.m.)

Supervisor Gross moved approval of the Resolution of Recognition presented to the Park Authority for its sixtieth anniversary. Supervisor Foust and Supervisor Smyth jointly seconded the motion and it carried by unanimous vote.

8. <u>10 A.M. – REPORT ON GENERAL ASSEMBLY ACTIVITIES</u> (10:41 a.m.)

Supervisor McKay, Chairman of the Board's Legislative Committee, said that the committee met on February 19, and noted that updates of the report were in Board Member's red folders.

Supervisor McKay noted that the 2010 General Assembly is scheduled to adjourn on Saturday, March 13. He said that staff provided the Legislative Committee with a report last Friday on the status of bills post "crossover." Two of the County's initiatives made it over to the Senate: House Bill (HB) 517, which deals with building code violations in nonresidential properties; and HB 1207, which deals with computer crimes.

Supervisor McKay stated that the House funded the Local Composite Index (LCI) implementation by reducing Northern Virginia's "cost of competing" differential; the Senate did not. Both houses, at substantial cost, provided different "hold harmless" provisions to those localities who lose under the LCI. While implementation of the LCI in the 2010-12 biennium should have been routine, these subsequent proposals, by their nature, could hold long-term ramifications for future K-12 funding in the Commonwealth.

Supervisor McKay moved adoption of Legislative Report Number Three dated February 23, 2010. Supervisor Hyland seconded the motion and it <u>CARRIED</u> by a recorded vote of seven, Supervisor Herrity voting "NAY," Supervisor Cook and Supervisor Hudgins being out of the room.

Supervisor McKay further moved to incorporate the two requests for the Park Authority to add land to the Centreville area and to request funding for the Lee District Family Park and Recreation Center to be incorporated into the federal legislative package that were discussed on Friday. Supervisor Hyland seconded the motion, which carried by a vote of eight, Supervisor Hudgins and Supervisor Herrity being out of the room.

9. <u>10:15 A.M. – PRESENTATION OF THE PROPOSED FISCAL YEAR (FY)</u> <u>2011 BUDGET BY THE COUNTY EXECUTIVE</u> (10:46 a.m.)

Following an acknowledgement to staff for their hard work on the budget, Anthony H. Griffin, County Executive, presented his proposed FY 2011 Budget and distributed copies of the PowerPoint presentation with the themes of sustainability, resiliency, and transformation.

Chairman Bulova distributed a detailed FY 2011 Budget Process Board Calendar and briefly explained it. She noted that a discussion on the Massey Building will also be on the agenda for March 26.

Discussion ensued, with input from Mr. Griffin, regarding:

- The number of positions proposed for abolishment as well as additional positions.
- Retirement funding increase and a possible briefing on this.
- Additional Health Department positions and a detailed justification.
- Proposed decrease in the School transfer and funding from the State.
- Cost of snow removal at County facilities (Government Center, police stations, fire stations, et cetera).
- Agency reorganizations including the new Department of Neighborhood and Community Services.
- Increase of sewer service charges and environmental requirements.

Chairman Bulova explained the budget question-and-answer (Q&A) and Consideration Item process. If Board Members have funding requests, they should communicate them in writing to the Chairman as well as Susan Datta, Director, Department of Management and Budget. It will then be shared with the Board, but is not guaranteed for funding. Consideration Items for revenue enhancements or reorganization suggestions will be handled the same way.

Chairman Bulova said that when Board Members raise questions that are not immediately answered and require more research, they will be handled as budget Q&As. Board Members will receive periodic packets of Q&As.

Further discussion ensued, with input from Mr. Griffin, regarding:

- The proposed "sinking of the County Navy," (the Police Department's Boat Patrol).
- Deep reductions to Parks and Libraries.
- Public safety reductions and their ramifications.

Supervisor Frey asked unanimous consent that the Board direct staff to provide a detailed description of the changes implemented in FY 2010 that were built into the FY 2011 base. Without objection, it was so ordered.

Discussion continued, with input from Mr. Griffin, regarding the:

- Housing Blueprint.
- Quality of life in the County and the tipping point where recovery of the quality is more costly than the benefits derived from reductions.
- System of care reorganization piece and integrated service with Schools.

Chairman Bulova recognized the presence of Jane Strauss, Dranesville District Representative to the School Board and its Budget Committee Chair, and warmly welcomed her to the Board Auditorium.

Further discussion ensued, with input from Mr. Griffin and Ms. Datta, regarding:

- Handouts for residents at community meetings and the absence of a Citizen's Guide this year.
- Applied balance and Managed Reserve (two percent).

- Proposed vehicle decal fee.
- The value of one penny on the real estate rate equals \$18.6 million.

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and asked unanimous consent that the Board direct staff to include the following on the Budget Committee agenda for discussion:

- Housing Blueprint on March 26.
- Fluctuation Reserve on March 16.

Without objection, it was so ordered.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Supervisor Smyth asked unanimous consent that the Board direct staff to prepare a Consideration Item for a reduction in the budget for Board offices. Without objection, it was so ordered.

Discussion continued briefly regarding fee adjustments, with input from Mr. Griffin.

Chairman Bulova expressed appreciation to Mr. Griffin, Ms. Datta, and the staff who developed the budget. She reminded the audience that the proposed budget is a basis for a discussion with the community and is not a *fait accompli*. She invited Board Members to announce their public meetings on the annual budget.

Supervisor Frey announced that he will be conducting a budget town hall meeting, jointly with Sully District School Board Representative and Chairman Kathy Smith, on Monday, March 1 at 7 p.m. at the Rocky Run Middle School.

Supervisor Hudgins announced the Hunter Mill District will hold two budget meetings as follows:

- Wednesday, March 3, at 7 p.m. at the Reston Community Center, Lake Anne, with Mr. Griffin and Hunter Mill District School Board Representative Stuart Gibson.
- Wednesday, March 24, 7-9 p.m., James Madison High School.

Supervisor Cook announced four meetings as follows:

Supervisor Gross moved approval of the Administrative Items. Supervisor Hyland seconded the motion.

Supervisor McKay called the Board's attention to:

 Admin 2 – Authorization to Advertise a Public Hearing on a Spot Blight Abatement Ordinance for 7206 Poplar Street (Mason District)

- Admin 3 Authorization to Advertise a Public Hearing on a Spot Blight Abatement Ordinance for 6439 Little Ox Road (Springfield District)
- Admin 4 Authorization to Advertise a Public Hearing on a Spot Blight Abatement Ordinance for 5400 Goolsby Way (Springfield District)

Discussion ensued, with input from Christina M. Sadar, Blight Abatement Program Coordinator, Enhanced Code Enforcement Strike Team, Department of Public Works and Environmental Services (DPWES), concerning the process and the length of time involved between cases going to the Neighborhood Enforcement Task Force (NETF) and the scheduling of those cases before the Board for authorization to advertise the public hearing.

Supervisor Herrity called the Board's attention to <u>Admin 5 – Authorization to Advertise a Public Hearing on Proposed Amendments to The Code of the County of Fairfax, Chapter 67.1 (Sanitary Sewers and Sewage Disposal), Regarding Sewer Rate Changes, noting significant rate revision increases.</u>

Discussion ensued with input from Shahram Mohsenin, Director, Wastewater Planning and Monitoring Division, DPWES, concerning:

- Capital upgrade expenditures for five regional wastewater treatment plants necessary to meet new mandatory nitrogen requirements for Chesapeake Bay regulations.
- Resulting increases in operating expenditures to remove additional nitrogen.

Discussion continued concerning rate increase reviews by the Consumer Protection Commission. Supervisor Herrity asked unanimous consent that the Board direct the Commission to review the proposal for justification of the increases.

Anthony H. Griffin, County Executive, provided input concerning:

- Providing information to the Commission
- Current federal and state focus on point-source pollution
- The expense of upgrades relative to the amount of improvement being made

Chairman Bulova restated Supervisor Herrity's request: that the Board direct the Commission to review the increases to ensure that they were not in excess in order to comply with the mandated improvements. Without objection, it was so ordered.

Additional discussion followed concerning mandates, with input from Mr. Mohsenin, regarding generated revenue being returned to the system.

Following an inquiry regarding efforts to reduce costs, Supervisor Foust asked unanimous consent that the Board direct staff to provide a comparison of the current budget to the proposed budget to identify specific increase expenditures. Without objection, it was so ordered.

Mr. Griffin noted that:

- There has been a reduction in personnel over the last ten years as a result of automation to streamline the operation.
- The costs involved are primarily capital costs driven by state and federal requirements in terms of the quality of the effluent coming out of the treatment process.
- The County has had the lowest water-sewer bills on the East Coast.

Supervisor Gross stated that sewer rates, stormwater issues, and related items have been the subject of the Environment Committee's agenda over the last several years and noted that the next meeting of the Committee is the morning of March 16. She asked unanimous consent that the Board direct James Patteson, Director, DPWES, to include this item on the Committee's agenda so that it can have additional discussion on this item while providing staff the time necessary to provide additional information. Without objection, it was so ordered.

Discussion continued regarding chart data on pages 58 and 59 of the Board Agenda Item dated February 23, 2010, with input from Mr. Mohsenin concerning the cumulative increase.

Following an inquiry from Supervisor Herrity, Chairman Bulova stated that this item would be:

- Reviewed by Consumer Affairs or other appropriate body.
- Discussed in the next Environmental Committee meeting.

Supervisor Herrity called the Board's attention to <u>Admin 8 – Authorization to Advertise a Public Hearing on Proposed Amendments to the Code of the County of Fairfax, Chapter 7 (Elections), Regarding Election Precincts regarding the March 2 election concerning:</u>

- Clarification of any polling place changes.
- Reminding voters that there is an election in the delegate district and for Mason District School Board Re[resemtatove.

Discussion ensued, with input from Edgardo Cortés, General Registrar, concerning:

- The advertisement specifying that the changes start with any June primaries

ADMIN 1 – SUPPLEMENTAL APPROPRIATION RESOLUTION (SAR) AS 10114 FOR THE FAIRFAX COUNTY JUVENILE AND DOMESTIC RELATIONS (JDR) DISTRICT COURT TO ACCEPT GRANT FUNDING FROM THE NORTHERN VIRGINIA REGIONAL GANG TASK FORCE THROUGH THE CITY OF MANASSAS PARK, VIRGINIA

(SAR) Approve SAR AS 10114 for the Fairfax County JDR District Court to accept funding from the Northern Virginia Regional Gang Task Force through the City of Manassas Park, Virginia, in the amount of \$351,874 to continue to provide regional gang prevention and intervention services through the Intervention, Prevention and Education Program. No local cash match is required.

14. <u>A-3 – PARKING REDUCTION FOR HUNTER MILL PLAZA</u> (PROVIDENCE DISTRICT) (12:56 p.m.)

On motion of Supervisor Smyth, seconded by Supervisor McKay, and carried by unanimous vote, the Board concurred in the recommendation of staff and approved a parking reduction of 6.9 percent for Hunter Mill Plaza, pursuant to the Code of the County of Fairfax, Chapter 112 (Zoning Ordinance), Section 11-102, Paragraph 4(B), based on an analysis of the parking requirements for each use on the site and parking reduction study, on the conditions outlined in the Board Agenda Item dated February 23, 2010.

15. <u>I-1 – CONTRACT AWARD – GREAT FALLS FIRE STATION</u> (DRANESVILLE DISTRICT) (12:56 p.m.)

ADDITIONAL BOARD MATTERS

16. **REQUEST FOR CERTIFICATES OF RECOGNITION** (12:57 p.m.)

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and asked unanimous consent that the Board direct staff to:

• Prepare and send a proclamation to the Board of the Northern Virginia Chapter of the Institute of Internal Auditors, recognizing

the twenty-fifth anniversary of the chapter's founding, May 6, 2010.

- Invite Captain Katherine Little, recently retired from the Sheriff's Office, to appear before the Board to accept a certificate recognizing her 36 years of service with that office (joint with Supervisor McKay). Her service is longer than any other Deputy Sheriff in the history of the Sheriff's Office.
- Invite representatives from the Department of Family Services and the Childhelp Children's Center of Virginia, who are co-sponsoring a Blue Ribbon Campaign, to appear before the Board on March 23 to accept a proclamation declaring April 2010 as "Child Abuse Prevention Month" in Fairfax County.
- Invite representatives from the County Asian American History Project and sponsors of the project to appear before the Board on May 11 to receive recognition for their book debut. This book honors 143 years of Asian residents living in the County.

Without objection, it was so ordered.

17. **SNOW SUMMIT SCHEDULED FOR MARCH 16** (12:59 p.m.)

In a joint Board Matter with Chairman Bulova, Supervisor McKay said that the recent storms and their aftermath have provided insight into what happens in an emergency and what it means to be prepared. There was a powerful illustration of government performing its primary function—keeping the community safe. He referred to his written Board Matter and expressed his appreciation to the many individuals, organizations, and businesses that helped out.

Noting that valuable lessons can be learned from these extraordinary storms, Supervisor McKay announced that a Snow Summit/Transportation Committee meeting is scheduled for March 16 in the Board Auditorium from 3:30 p.m. until to 5:30 p.m. This will take the place of the Transportation Committee meeting that had been scheduled for that date.

Supervisor McKay explained that the purpose of this meeting is to assess both what worked well and what did not at the State [Virginia Department of Transportation (VDOT)] and County level. He asserted that the lessons learned from this summit will be invaluable not only for the next snowstorm, but for any emergency, natural or manmade. The agenda will include a report on what took place, what worked well and what did not, as well as suggestions and plans to address identified deficiencies.

Supervisor McKay encouraged Board Members, County agencies, and citizens to report problems and issues to the Office of Public Affairs (OPA) in advance of

this meeting and request OPA to provide these comments to the summit presenters prior to the summit. This will allow staff and presenters to be prepared to address issues at the summit. The snow summit will include VDOT, the County's public safety agencies, Schools, the Facilities Management Department, and the public information officers for the above-referenced agencies. He circulated copies of a draft agenda.

Supervisor McKay announced that the Northern Virginia Delegation to the General Assembly will be invited to attend and participate, as well. The summit will be cablecast on Channel 16.

Supervisor McKay noted that agenda items previously slated for the Transportation Committee meeting will be scheduled another day.

Vice-Chairman Gross clarified that this is an open meeting in the Board Auditorium and the public is welcome to attend, but it is not a public hearing.

Chairman Bulova stated that during the question and answer portion, members of the General Assembly will be welcome to ask questions.

Supervisor Cook recognized the efforts of his staff who handled more than 1500 emails and phone calls during the storm, Rosemary Ryan, Lindsey Smith, and Ann Sharp. He also stated his appreciation for the daily conference calls with VDOT as well as the conference call that led to the volunteer effort that allowed the schools to open on February 16.

Further discussion ensued regarding street-related details, the agenda, Board input in advance of the meeting, and impending potholes.

Chairman Bulova stated for the record that VDOT employees are State employees, not County employees. The Board, however, advocates on behalf of its residents to bring items to VDOT's attentions. The Board is also concerned about budget reductions at the State level that will directly impact VDOT's ability to provide maintenance.

Vice-Chairman Gross clarified for the record that the County does not pay the State for snow removal services; it is a State responsibility.

Supervisor Hyland moved that the Board direct staff to request formally from VDOT its plan, if any, to address the pothole issue and its ability to do what is necessary. This would include its present plan, how it anticipates starting it, and how VDOT would like the Board to feed information to them from citizens. This information is requested as soon as possible. Vice-Chairman Gross seconded the motion.

Supervisor McKay asked to amend the motion to direct staff to copy the local General Assembly members and ensure that this is done prior to the end of the General Assembly session, and this was accepted.

Chairman Bulova asked to amend the motion to direct staff to provide the pothole information response on the County's website, and this was accepted.

The question was called on the motion, as amended, and it carried by unanimous vote.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

18. <u>ELIMINATION OF THE VIRGINIA DEPARTMENT OF TRANSPORTATION'S (VDOT) STATE FORCES CONSTRUCTION GROUP (1:13 p.m.)</u>

Supervisor Foust said that last week he learned that, as part of the ongoing cutbacks at VDOT, a decision was made to eliminate the "State Forces Construction" group. This is a small unit of construction employees and equipment which, over the years, has been able to greatly reduce the cost of implementing small-scale construction projects within Northern Virginia and the County. Because these employees work directly for VDOT and have the needed construction equipment on hand, the usual requirements placed on construction projects, such as plan preparation, permit submission and review, and procurement are not necessary for the small-scale projects completed by this crew. This construction unit has installed most of the traffic calming projects in the County as well as many small-scale turn lane extensions, shoulder and ditch improvements, curb and gutter, curb cut, and sidewalk improvements.

Supervisor Foust noted that the County has recently committed approximately \$19 million to pedestrian, bicycle, bus stop, and spot improvements utilizing the County's commercial and industrial revenues for transportation. In preparing cost estimates for these projects, it was assumed that many of the small scale projects, expected to require no right-of-way or utility relocations, could be implemented as "no plan" jobs quickly and cost effectively utilizing the State Forces Construction group. The ability to rely on State Forces Construction for these types of projects now appears to be at risk, meaning that the County project implementation costs will significantly increase.

Therefore, Supervisor Foust moved that the Board direct staff to contact VDOT to obtain further information on the status and impacts of this decision and to determine if other options are available to the County to implement these types of small-scale projects quickly and cost effectively. Chairman Bulova seconded the motion and it carried by unanimous vote.

19. <u>CHARGING NEWS MEDIA FOR ACCESS TO COUNTY RECORDS</u> (1:16 p.m.)

Supervisor Foust said that Virginia's Freedom of Information Act (VFOIA) allows governments to charge for reasonable costs incurred in collecting requested records. He said that his understanding is that the County, like most other local jurisdictions, has typically waived those fees when responding to public information requests from news organizations. However, a recent article in a local paper stated that the County is the only local jurisdiction that has changed that policy. The article stated that the County was now charging a fee to news organizations to respond to such requests.

In these difficult budget times, Supervisor Foust said that staff is to be commended for looking for ways to reduce costs and increase revenues, especially through what is, in effect, a user fee. However, he said that charging a fee to media organizations may run counter to the Board's strong commitment to ensure that government operations are as open as possible. He added that the news media's access to public records plays an essential role in ensuring that openness. His understanding is that media organizations have been hard hit by the downturn in the economy. Therefore, he believes the decision to charge news media for access to public records is a significant policy issue that the Board should consider before it is adopted as County procedure. He said that he would like to hear from staff before establishing a policy, but his sense is that the revenues raised by charging news media for access to public records will be insignificant compared to the disadvantages relative to the goal of conducting an open government.

Therefore, Supervisor Foust moved that the Board direct staff to report with an analysis of the advantages and disadvantages of the policy to charge news media for access to public records and with a proposed policy for consideration by the Board. Supervisor Herrity seconded the motion.

Discussion ensued, with input from Anthony H. Griffin, County Executive, regarding the relevance to the fee and the manner in which the request was made, and the current policy. Mr. Griffin explained that the staff tries to be consistent in its application of the policy, and he will circulate it to the Board.

Further discussion ensued, with input from Mr. Griffin and Merni Fitzgerald, Director, Office of Public Affairs, regarding different types of requests for information and the long term use of the current policy.

Supervisor Gross asked to amend the motion to include in the analysis non-news organizations, and this was accepted.

Following input from Mr. Griffin regarding the comprehensive policy, the question was called on the motion, as amended, and it carried by unanimous vote.

20. **DULLES RAIL NOISE WALLS (DRANESVILLE DISTRICT)** (1:21 p.m.)

Supervisor Foust said that the Board has been a consistent and strong supporter of the Dulles Rail Project. The project will bring transportation, land use, environmental, and other benefits to the region. However, like any major transportation project, the Dulles Rail Project comes with consequences to the surrounding communities that must be considered and addressed.

Supervisor Foust noted that a major concern is the noise that will be created by the trains and traffic in the road corridors where the rail will be built. Communities along the Dulles Connector Road (from I-66 to the Beltway where the rail will be elevated and in plain view of many adjacent homes) and the Dulles Toll Road (from the Beltway to Wiehle Avenue and beyond) have organized to seek approval and funding of appropriate noise mitigation walls. As part of the agreement to transfer the Dulles Rail Project to the Metropolitan Washington Airports Authority (MWAA), MWAA agreed to construct three to five miles of new noise walls in the corridor. Senator Janet Howell and Delegate Jim Scott are working hard to obtain State funding for additional noise walls. The Northern Virginia Congressional delegation (including Senators Warner and Webb and Congressmen Moran, Connolly, and Wolf) has sent letters to MWAA and VDOT stating that "it is critical that sound barriers are provided along the corridor to mitigate the noise impact of the project on the residents in neighboring areas." Supervisor Foust said that a citizens group has advised him that at least one member of the delegation may be willing to pursue federal funding for the noise walls and that they were told that a statement of support from the Board would be helpful to that effort.

Therefore, Supervisor Foust moved that this issue of pursuing federal funding for noise walls in this corridor be referred to the Legislative Committee to be considered for inclusion in the Board's federal legislative program. Supervisor Hyland seconded the motion and it carried by unanimous vote.

21. TYSONS LUNCH TIME SHUTTLE SERVICE (1:24 p.m.)

Supervisor Herrity said that at the October 20, 2009, Transportation Committee meeting, the Board discussed the implementation of the Tyson's Corner lunch time bus service or "Tyson's Shuttle." At the meeting various concerns were raised including properly gauging internal movements during lunch hours and ongoing surveillance. He indicated his surprise at learning that while the service makes 106 runs on average, only 75 passengers per day were currently using this service. He acknowledged that the lunch shuttle was only recently implemented, but these current ridership numbers are extremely low at this point. With so much construction and congestion in the immediate area, he finds these numbers equally alarming in light of an ongoing marketing program to promote the service and the \$1 million plus cost of the service. While a circulator service in Tyson's will be critical once the High Occupancy Toll (HOT) Lanes and Metro service are complete, and there are additional residents in Tyson's, this service appears to be

well ahead of its time and does not give riders any real time advantage - a key in attracting transit riders.

Supervisor Herrity stated his understanding that this service is funded by Congestion Mitigation and Air Quality (CMAQ), rather than the County. If the original intent and goals of this program are not being sufficiently met, he asserted that these monies, or a portion of them, could be used more effectively in other areas that fall under the criteria for using CMAQ funds.

Therefore, Supervisor Herrity moved that the Board direct:

- Staff to examine the effectiveness of the shuttle service and determine if the program is working sufficiently and meeting its original goals and report with its findings.
- The County Executive to look at options to more effectively utilize these funds if the goals are not being met.

Supervisor Smyth seconded the motion.

Following discussion regarding the motion and giving the service enough time to determine whether it works, the question was called and it carried by unanimous vote.

22. "STOP HUNGER NOW" PACKAGING EVENT AT PRINCE OF PEACE LUTHERAN CHURCH (SPRINGFIELD DISTRICT) (1:28 p.m.)

Supervisor Herrity reported that he attended a "Stop Hunger Now" packaging event at Prince of Peace Lutheran Church in Springfield to help the people of Haiti. Mrs. Lee Warren of Virginia Director of Stop Hunger Now coordinated this event along with John Denninger, Senior Pastor of Prince of Peace Lutheran Church, along with other local churches. While he was there, more than 25,000 meals were prepared and over 142,500 meals, which are being shipped out today, were prepared throughout the entire volunteer-based event on both Friday night and Saturday.

Stop Hunger Now is a 501(c)(3) non-profit organization that has provided over \$66 million worth of direct aid and 20 million meals to more than 70 countries worldwide. Since 2005 at Stop Hunger Now packaging events, volunteers have packaged more than 18 million meals for the world's most impoverished people. In response to the earthquake, Stop Hunger Now has received over 200 tons of supplies for Haiti including:

- 124,000 bottles of purified water
- 123,000 cans of precooked chicken and roast beef

- 5,800 pounds of long grain rice
- 44,000 pounds of peanut butter, canned veggies/fruit/meat, and bottled water

It is important to note that although this particular event was for immediate needs of the victims in Haiti, this program's focus is on day in and day out chronic hunger.

Accordingly, Supervisor Herrity asked unanimous consent that the Board direct staff to invite Mrs. Warren, Mr. Denninger, and representatives of the other churches that were involved with this event to appear before the Board to be presented with a resolution thanking them and the many volunteers and their organizations for hosting such a worthy event for those victims in Haiti. Without objection, it was so ordered.

23. **ROBOWIZ ROBOTICS TEAM (SPRINGFIELD DISTRICT)** (1:30 p.m.)

Supervisor Herrity announced that on December 6, 2009, the Greenbriar West Elementary School's fifth grade FIRST Lego League (FLL) Robotics team "ROBOWIZ" won the Virginia/DC Division 1 State Champions Award competing against 50 teams from all across Virginia and Washington. Based on their State Championship victory and the overall quality of their performance, ROBOWIZ has been invited as one of only seven teams from the USA and Canada to represent their country and their communities at the European Championship tournament in April 2010 in Istanbul, Turkey.

The team worked on a local transportation problem in the Springfield District and identified reasons why kids and adults do not bike to school or to the nearby stores. They determined through surveys that if road projects included physically separated bike lanes there is a possibility that the community would consider using bicycles instead of driving to nearby locations. They have presented their findings to the local VDOT and County Transportation officials, and received the active support of their district's representative to the Virginia House of Delegates Mr. Jim LeMunyon through multiple meetings.

Supervisor Herrity asked unanimous consent that the Board direct staff to invite the members of ROBOWIZ to appear before the Board to receive a resolution recognizing their achievements, and so that the Board can wish them the best of luck in Istanbul. Without objection, it was so ordered.

24. NO BOARD MATTERS FOR PROVIDENCE SUPERVISOR LINDA Q. SMYTH (1:32 p.m.)

Supervisor Smyth announced that she had no Board Matters to present.

25. COMMENTS ON THE SELECTION OF ALTERNATIVES TO BE INCLUDED IN THE NEPA EVALUATION OF THE PROPOSED I-395 HOT LANES ACCESS TO THE MARK CENTER PROPERTY IN THE VICINITY OF SEMINARY ROAD (1:32 p.m.)

In a joint Board Matter with Chairman Bulova and Supervisor McKay, Supervisor Gross said that on January 12, the Board approved a letter to the Virginia Department of Transportation (VDOT) providing its comments on the Interchange Justification Report (IJR) for the addition of direct access to the Base Realignment and Closure (BRAC) Washington Headquarters Service relocation to Alexandria's Mark Center property in the vicinity of Seminary Road. That letter stated the Board's preference for Alternative D, combined with potential additional ramping to/from the south parking garage (as shown in Alternative E), to be carried forward for additional study. The Board expressed its concern in that letter that without the completion of additional High Occupancy Toll/High Occupancy Vehicle (HOT/HOV) capacity inside the Beltway and direct ramp access from I-395 into the Mark Center property, traffic that otherwise should be on I-395 will instead divert to other less desirable arterials, collectors, and neighborhood streets in the region.

Supervisor Gross said that given the regional significance of the I-95/I-395 corridor and its impact on the functionality of the surrounding transportation system, it is imperative that access options which provide an opportunity to substantially improve transit and HOV access and interchange operations at Seminary Road be carried forward into the environmental review process. Although the full impacts (both positive and negative) of those alternatives will not be determined until the full environmental (NEPA) review process is complete, there has already been considerable opposition in the City of Alexandria to the alternative preferred by the Board due to its partial intrusion into the Winkler Preserve.

Accordingly, jointly with Chairman Bulova and Supervisor McKay, Supervisor Gross moved that the Board endorse the letter to be sent to the Alexandria City Council and the Federal Highway Administration requesting that they fully consider the regional implications of any decision at this location and include Alternative D, combined with potential additional ramping to/from the south parking garage (as shown in Alternative E), in the NEPA evaluation process. Chairman Bulova seconded the motion.

Following discussion regarding previous Board efforts for another site and expected traffic gridlock on I-395, the question was called on the motion, which carried by unanimous vote.

26. **ORDERS OF THE DAY** (1:39 p.m.)

Citing the lateness of the hour and the expectation for a 90-minutes closed session, Chairman Bulova relinquished the Chair to Vice-Chairman Gross and

asked unanimous consent that the Board direct staff to communicate with the cafeteria staff to ensure that it will remain open when the Board recesses following the conclusion of Board Matters. Without objection, it was so ordered.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

27. <u>MEETING OF THE NATIONAL ASSOCIATION OF REGIONAL</u> <u>COUNCILS (NARC) BOARD OF DIRECTORS</u> (1:39 p.m.)

Supervisor Gross announced that she would be leaving the meeting early to represent the Mid-Atlantic Region on the NARC Board of Directors. Its conference is ongoing in Washington, DC both yesterday and today and its board meeting is later in the day.

28. <u>ULTRA HIGH SPEED BROADBAND NETWORK</u> (1:39 p.m.)

Jointly with Chairman Bulova and Supervisor Smyth, Supervisor Gross said that the American Recovery and Reinvestment Act (ARRA) of 2009 (Recovery Act) was signed into law on February 17, 2009. The Recovery Act authorizes the Federal Communications Commission (FCC) to create a National Broadband Plan that "shall seek to ensure that all people of the United States have access to broadband capability and shall establish benchmarks for meeting that goal."

Supervisor Gross noted that two weeks ago Google announced that it was planning to build and test ultra high-speed broadband networks in a small number of trial locations across the US that offer competitively priced Internet access at speeds of one gigabit-per-second through fiber-to-the-home connections. Google has issued a request-for-information (RFI), soliciting input from the public, interested communities, and local governments. The deadline to submit responses is March 26, and Google will announce the selected target communities later this year.

As advocates for County residents, local business, and communities, Supervisor Gross said that the Board should consider opportunities like this that can further strengthen and develop infrastructure and ground the County's place as leaders in the twenty-first century information economy.

Therefore, jointly with Chairman Bulova and Supervisor Smyth, Supervisor Gross moved that:

- The Board direct the County Executive to investigate this proposal further, as additional information becomes available, and determine if the County is a viable candidate for consideration.
- If staff determines that submitting information to Google is in the County's best interest, and the County may be a viable candidate,

the Board will authorize staff to submit a response to Google's RFI by the March 26 deadline.

Chairman Bulova seconded the motion, and it carried by unanimous vote.

29. REQUEST FOR CONCURRENT AND EXPEDITED PROCESSING OF SPECIAL EXCEPTION APPLICATION SE 2010-MA-001, SITE PLANS AND OTHER RELATED PLANS (MASON DISTRICT) (1:42 p.m.)
