




Environment for Today's Discussion


- Workload, especially in the <u>residential sector</u>, is increasing.
 - \$1B in Construction Value in 2011 to \$2B in FY 2016.
 - FY 2017 revenues continue to show strong growth.
 - Construction activity and workload volume and complexity have been sustained at higher levels.
- Fairfax First Improvements Netting Results
 - Speed, Consistency & Predictability
 - Well-served Customers
 - Potential negative impact on Fairfax County Homeowner's Insurance rates
- FY 2017 Carryover request forthcoming to meet demands outlined here:
 - \$1,481,826 Expenditures, \$1,481,826 Revenue, 10.0 FTEs No Net General Fund Impact







- Increasing Residential Trends:

- While not sustainable, holdovers have been minimized.




Fairfax First – LDS Key Results

- Project Management Launched with 18+ projects under management
- Cross Agency Working Groups and Work Plans
 - Health Department
 - · Fire Marshal Office
 - Planning & Zoning/ZAD
 - LDS/SDID & Planning and Zoning ZED
- Established Joint Training Academy
- Streamline/Modernize Public Facilities Manual
- Opened the Customer Information Center (3,500 phone (62%) and walk in (38%) customers served to date)


- Streamlined Processes that result in faster time to market for developers

Permit and Inspection Fee Revenue continues to grow




Recovery Rate – Board of Supervisors has set target of 90%




Land Development Services' Investments


- Residential Inspections:
 - 4 Residential Building Inspectors (4.0 FTEs)
 - 1 Residential Building Inspector Supervisor (1.0 FTE)
- Fairfax First
 - 2 Web Content Specialists (2.0 FTEs)
 - Joint Training Academy (\$100K)
 - 1 GIS Analyst (1.0 FTE)
- Site Review:
 - 1 Site Plan Review Engineer (1.0 FTE)
 - 1 Parking Reduction Engineer (1.0 FTE)
- Cost of \$1,481,826/10.0 FTEs No Net General Fund Impact



Residential Inspection Program

- Holdover management:
 - 3 Dual Encumbrance Inspectors
 - · Borrowed Staff from Plan Review and Counter Staff
 - Temporary/Part-time Hires
 - Daily Cap on Inspection Load
- Industry Standard:
 - ISO Standard 10-12 Inspections per inspector per day
 - National Average from 2015 is 9.4 inspections per inspector per day, Fairfax is at 20 inspections per inspector per day
 - This investment will reduce Fairfax County to 15 inspections per inspector per day
- Insurance Service Organization (ISO)
 - · Survey delayed until fall,
 - If inspections are wildly above industry standard, County homeowners may see insurance premium increases
- Time to Review Plans is Rising
- Request 4 Inspectors and 1 Supervisor
- Cost of \$628,722/5.0 FTEs No Net General Fund Impact





Fairfax First Customer Service

- Fairfax First must have a web presence in order to:
 - Deliver services on-line, such as e-plan submissions, payments
 - Communicating LDS' services to industry, homeowners and taxpayers
- 2 Web Content Specialists (2.0 FTE)
- Cost of \$255,777/2.0 FTEs No Net General Fund Impact

Development Process Training Initiative

- Joint Training Academy (JTA) invests in all employees involved in development process
- 600+ employees to be trained over 3 years
- Goal 3 Improve the Speed, Consistency and Predictability
 of the Development Review Process
- Cost of \$100,000/0.0 FTE No Net General Fund Impact



Fairfax First Geographic Information Services


- LDS as a geographically based agency is fundamental to:
 - Department of Tax Administration
 - Department of Planning and Zoning (such as proffers)
 - Public Safety (producing addresses)
- LDS is the 7th highest County agency user of GIS.
 - Only top ten GIS centric agency without dedicated GIS staff
- 1 GIS Analyst
- Cost of \$120,567/ 1.0 FTE No Net General Fund Impact



Site Plan Review Engineer

- 79% Increase in Plans from 2010 to 2016.
- On pace in 2017 to reach nearly 1,200
- Target 21 days for review, continued monitoring for mistakes due to meeting target
- In FY2017, 2.0 FTEs transferred to Urban Forestry Management Division
 - Tree Ordinance Review of Infill Lot Grading Plans
- Cost of \$232,029/ 1.0 FTE No Net General Fund impact, includes \$100K for contractual services to augment staff





Parking Reduction Engineer

- Expected 60 Parking Reduction applications per year, many come to the agency as a result of re-zoning processes
- Impacts of Urbanization in Fairfax County:
 - Parking Costs to projects can be as much as \$30-\$50K per space.
 - Focal point for community, developer and District Supervisor
 - Currently lacking expertise
- Fairfax County Department of Transportation (FCDOT) supports LDS



 Cost of \$144,731/1.0 FTE – Not Net General Fund Impact
