U.S. Small Business Administration

1/3rd of businesses with employees fail within 2 years
Only 50% of those businesses survive over five years
Veterans are 45% more likely to be self employed than non veterans

82% of business failures are due to poor cash management

27% of businesses surveyed had difficulty obtaining enough financing

CBP History


- 1991 Special Commission for small, minority, and disadvantaged businesses
- CBP formed from one of the twelve Commission recommendations
- The Partnership: GMU, FCEDA, Fairfax Co. Supervisors, Fairfax Small Business Commission, NOVA Community College, and Northern Virginia Urban League.
- 1998 accredited as a SBA Small Business Development Center
- 2000 Added Women's Business Center
- 2004 Added Business Incubation Center (4 offices)
- 2015 Added Veterans Business Outreach Center
- 2016 Moved to new, larger location
- 1997 Budget: +/- \$100,000M → 2018 Budget: +/- \$1.4MM
