- (R) On motion of Supervisor K. Smith, seconded by Chairman Bulova, and carried by unanimous vote, Supervisor Cook, Supervisor Foust, Supervisor Gross, Supervisor Herrity, Supervisor Hudgins, Supervisor McKay, Supervisor K. ## 19. A-4 - APPROVAL FOR THE DEVELOPMENT AND IMPLEMENTATION OF A PUBLIC SAFETY UNMANNED AIRCRAFT SYSTEM PROGRAM (UAS) (11:39 a.m.)

Following an inquiry from Supervisor Cook, Deputy County Executive David Rohrer clarified:

- The policy on the use, storage, and retention of imagery and video data
- That the program is for use by public safety agencies for the approved mission types
- That non-public safety agencies wanting to operate a UAS will be required to detail the intended purpose, mission types, scope, and request Board approval
- These items are to be incorporated into the Program Manual

Supervisor Cook stated that he would present a Board Matter later in the meeting that would require other County agencies to obtain Board approval before using UAS.

Supervisor Cook moved that the Board concur in the recommendation of staff and approve the development and implementation of a public safety UAS program with the caveat that the program will be restricted to use by public safety

agencies, with non-public safety agencies required to obtain Board approval before using UAS. Supervisor Gross seconded the motion.

Following discussion, the question was called on the motion and it carried by unanimous vote.

## 20. <u>I-1 - CONTRACT AWARD - HUMAN RESOURCES BENEFITS</u> <u>CONSULTING</u> (11:48 a.m.)

The Board next considered an item contained in the Board Agenda announcing that staff is awarding a contract to Aon Consulting, Incorporated, for consulting services to assist the County with a comprehensive range of employee benefit services and solutions. The contract will begin on June 1, 2019, and terminate on May 31, 2022, with two one-year renewal options. The total estimated amount of this contract over the three-year term is \$675,000.

## 21. <u>I-2 - CONTRACT AWARD - PSYCHIATRIC RESIDENCY SERVICES</u> (11:48 a.m.)

The Board next considered an item contained in the Board Agenda announcing that staff is awarding a contract to George Washington University to provide Psychiatric Residency Services. The contract is for ten years and the total estimated amount of the contract is \$400,000.

Discussion ensued, with input from Cathy Muse, Director, Department of Procurement and Material Management, regarding the award of the sole source contract.

Supervisor Cook asked unanimous consent that the Board direct staff to include a statement, on future Board Items, indicating why the contract is sole source. Without objection, it was so ordered.

## 22. <u>MEMORANDUM OF UNDERSTANDING (MOU) ON A SISTERHOOD</u> RELATIONSHIP BETWEEN FAIRFAX COUNTY, THE CITY OF FAIRFAX, AND LEEDS CASTLE, ENGLAND (11:50 a.m.)

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and announced that this evening, she will be traveling, as a part of a small delegation, which includes County Executive Bryan Hill, Mayor David Meyer of the City of Fairfax, and the former Mayor of the City of Fairfax, John Mason, to visit the City of York

and London in the United Kingdom. This trip is a result of the continuing friendship between Lord Nicholas Fairfax, the City of Fairfax, and the County. Members of the delegation are responsible for their own costs; Chairman Bulova stated that she is covering her airfare and in-country lodging personally. She added that in the past few years, Lord Fairfax participated in the County's 275th anniversary celebration and last year attended a charity motorcycle ride around the perimeter of the original Fairfax land grant.

While there, the delegation will be laying the groundwork with the City of York for a friendship partnership and establishing a MOU on a sisterhood relationship with Leeds Castle, governed by the Leeds Castle Foundation; the City of Fairfax; and the County; a copy of the proposed agreement is attached to her written Board Matter and includes the history of the relationship. The wording for the agreement has been approved by the County Attorney's office; County funds will not be used for this partnership, aside from incidental expenses.

Therefore, Chairman Bulova moved that the Board endorse the attached MOU on a sisterhood-relationship between the County, the City of Fairfax, and Leeds Castle, England. Supervisor McKay seconded the motion.

Following discussion, concerning adding the Fairfax House in York to the itinerary, the question was called on the motion and it carried by unanimous vote.

Vice Chairman Gross returned the gavel to Chairman Bulova.

Supervisor Herrity announced that he had no Board Matters to present today.

## 24. **ACTION ITEM REQUEST FOR DRONE USAGE** (11:54 a.m.)

(NOTE: Earlier in the meeting, this item was referenced. See Clerk's Summary Item #19.)

Supervisor Cook, referencing his written Board Matter and the Board's earlier consideration of <u>Action Item - A-4</u> regarding the use of Unmanned Aircraft Systems (UAS), moved that the Board direct the County Executive to prepare an Action Item, to be presented at the June 25 Board meeting, that would require non-public safety departments, including the Park Authority, to obtain Board approval before using drones, with restrictions anticipated to be similar to those just passed regarding public safety. Supervisor Foust seconded the motion.

Following discussion, concerning clarification of the intent of the requested Action Item and who would/would not be affected, the question was called on the motion and it carried by unanimous vote.

## 25. <u>ESTABLISHMENT OF A SCHOOL RESOURCES READINESS PANEL</u> (12 p.m.)

In a joint Board Matter with Supervisor Hudgins, Supervisor McKay said that the County's *Equitable School Readiness Strategic Plan* (ESRSP) lays out a vision and road map for ensuring that all young children in the County have the support they need to be successful in school and beyond. Referencing his written Board Matter, Supervisor McKay noted that the plan identifies five core strategies for implementation.

A foundational strategy for supporting children's school readiness is to increase the supply, access, and affordability of quality early childhood programs for babies, toddlers, and preschoolers. Ensuring that families have equitable access to high quality early childhood experiences for their children during the formative first five years of life is key to the County's efforts to eliminate disparities and close the achievement gap. The ESRSP seeks to advance racial and social equity as defined in the One Fairfax Policy so that all families have access to quality early childhood education programs in the setting that best meets their family's need.

Approximately 72,700 children under the age of five are County residents. Almost one quarter of children under the age of five are living in economically disadvantaged households with incomes below 200 percent of the Federal poverty level. Children living in families with low incomes and other risk factors may be in greatest need of, and receive the most benefit from, expanded access to early childhood programs. However, all children and families succeed when there is a dynamic system of school readiness supports. In the Fiscal Year (FY) 2019 Budget Guidance, the Board directed the Successful Children and Youth Policy Team (SCYPT) and staff to develop a multi-year plan for expanding early childhood services; and in the FY 2020 Budget Guidance, the Board directed staff to return to the Board in the fall of 2019 with recommendations specific to the multi-year plan.

As the SCYPT identifies options for expanding the County's early childhood mixed-delivery system of school readiness supports in order to serve more children, the County will concurrently need to identify a long-term funding strategy for expanding early childhood services. The convening of a School Readiness Resources Panel will engage community stakeholders, County departments and Fairfax County Public Schools (FCPS) in collectively approaching the work of creatively and systemically planning for the funding and other resourcing of early childhood services and school readiness supports in the coming years.

Similar to the very successful process the County used in the development of the Communitywide Housing Strategic Plan and subsequent Affordable Housing Resources Panel recommendations, the appointment of a panel to identify innovative and bold expansion goals and funding strategies for school readiness supports and services will help to ensure that the Board of Supervisors and School Board have funding recommendations to consider for the FY 2021 budget cycle.

Therefore, Supervisor McKay moved that the Board direct the County Executive to convene a School Readiness Resources Panel comprised of 15-20 community, County, and FCPS representatives to identify school readiness expansion goals and long-term funding strategies.

The Panel should include families, early childhood educators, providers of early childhood services, business leaders, and experts in funding opportunities for school readiness programs, activities, and support. The Panel should be convened with staff assistance from the Office for Children and work through the summer, including SCYPT as needed. Board Members may provide nominees if desired for panel appointment. The recommendations from the panel will be presented to the Board in the fall of 2019 for FY 2021 Budget consideration. Supervisor Hudgins seconded the motion.

Following discussion, regarding adding members of the faith and non-profit communities to the Panel, the question was called on the motion and it carried by unanimous vote.

## 28. <u>BLUE OCEAN DEVELOPMENT, INCORPORATED - SPECIAL EXCEPTION AMENDMENT APPLICATION SEA 2013-HM-012 (HUNTER MILL DISTRICT)</u> (12:11 p.m.)

Supervisor Hudgins said that Blue Ocean Development, Incorporated, has recently submitted Special Exception Amendment Application SEA 2013-HM-012 for the property located at 1283 Serenity Woods Lane, Vienna, Virginia. The applicant proposes to demolish an existing structure located on the property that is in poor condition and construct a new single-family dwelling that will more properly fit within the character of the surrounding community.

Therefore, Supervisor Hudgins moved that the Board direct the Department of Land Design Services to accept for concurrent and simultaneous review of the site plan, architectural drawings, and any other plans or drawings as necessary in conjunction with Special Exception Amendment Application SEA 2013-HM-012. This motion should not be construed as a favorable recommendation by the Board on the proposed applications and does not relieve the applicant from compliance with the provisions of applicable ordinances, regulations, or adopted standards in any way. Chairman Bulova seconded the motion and it carried by unanimous vote.

## 29. <u>APA PROPERTIES NUMBER 6, LP - REZONING APPLICATION</u> RZ 2018-HM-020 (HUNTER MILL DISTRICT) (12:13 p.m.)

Supervisor Hudgins said that APA Properties Number 6, LP, has filed Rezoning Application RZ 2018-HM-020 to rezone from Industrial District-5 to Planned Residential Mixed-Use (PRM), [Tax Map 17-4 ((5)), parcels 3C1, 3E1, 3N1, 3W2, 6S2, 6S4, 7E2, and 7N2]. The proposed neighborhood will comprise up to 2,828,884 square feet of uses (inclusive of any bonus density units), including 2,500,000 square feet of residential uses, 68,884 square feet of retail uses, and 260,000 square feet of office uses. The Planning Commission public hearing is scheduled for September 18, 2019, at 7:30 p.m.

Therefore, Supervisor Hudgins moved that the Board direct the Department of Planning and Zoning to expedite the scheduling of the Board public hearing for Rezoning Application RZ 2018-HM-020 to October 15, 2019, at 3:30 p.m. This motion should not be construed as a favorable recommendation by the Board on the proposed applications and does not relieve the applicant from compliance with the provisions of applicable ordinances, regulations, or adopted standards in any way. Chairman Bulova seconded the motion and it carried by unanimous vote.

## 30. **RECOGNITION OF IRMA CLIFTON** (12:14 p.m.)

Supervisor Storck said that few people have given so much to preserve the history of their community as Ms. Irma Clifton. Referencing his written Board Matter, he noted that a Lorton native, Ms. Clifton lived until recently in the home her parents purchased in 1944. She attended Lorton School and Mount Vernon High School, the only high school in the eastern part of the County at the time. Her many years of sharing information, especially through her writings, about the area have preserved history that otherwise would be lost. After working for 25 years at the D.C. Correctional Facility at Lorton, formerly a Progressive Era Reformatory, and one-time home to the imprisoned suffragists, a former Nike missile site, and Laurel Hill, a plantation house built in the 1700s, Ms. Clifton spent many years working to preserve the history of this unique complex. When the prison closed, Ms. Clifton was appointed by former Mount Vernon District Supervisor Gerry Hyland to serve on the committee charged with determining how the prison property, now owned by the County, would be used. During the prison closing and for many years after, Ms. Clifton was on the scene preserving artifacts for posterity. She had previously rescued the D.C. Court logbooks containing names, offenses, and sentences of the prisoners who served time at the "Occoquan Workhouse" and negotiated to have the books containing suffragist names kept at Lorton. She also rescued numerous artifacts and boxes of legal documents signed by Frederick Douglass as the first U.S. Marshall for D.C. She later worked at The Chronicle community newspaper, writing many historical articles for the paper and other media outlets. She has served on the County History Commission and the South County Federation.

The citizens of the County owe much gratitude to Irma Clifton for her love of the Lorton area, the prison and suffrage history, as well as her commitment to preserve this important national history for the future generations.

Therefore, Supervisor Storck asked unanimous consent that the Board direct staff to prepare a proclamation, to be signed by the Chairman and the Mount Vernon District Supervisor, to be presented to Ms. Clifton on June 6, 2019, at the Turning Point Suffragist Memorial Gala where she will be honored. Without objection, it was so ordered.

## 31. WORKHOUSE CAMPUS PROFFER FLEXIBILITY PHASE I – ZONING APPLICATION FILING CONCURRENCE AND AUTHORIZATIONS (12:17 p.m.)

Referencing his written Board Matter, Supervisor Storck noted that in October 2018, the Board established the Workhouse Campus Steering Committee to focus on recommendations to accelerate implementation of the long-term vision of establishing the Workhouse Campus as a destination of choice providing a wide variety of arts and community building experiences with unique economic development opportunities. On February 28, 2019, the Workhouse Campus

Steering Committee voted to endorse increasing flexibility in the existing proffers applicable to the Workhouse Campus by adding craft beverage and small-scale production uses to the list of permitted uses. This recommendation recognizes that a more comprehensive review of the existing proffers that apply to the Workhouse Campus will also be necessary given the age of the proffers, current trends, and other factors. This Board Matter allows consideration of an initial action that can serve as an incentive for accelerated economic development at the site.

Therefore, Supervisor Storck moved that the Board:

- Concur in the filing of a minor variation request to consider adding craft beverage and small-scale production to the list of permitted uses within the existing or proposed buildings on County-owned property located in the PDC District at Tax Map 106-4 ((1)) 58
- Authorize the County Executive, or his designee, to execute the minor variation statement on behalf of the Board, the property owner
- Authorize and direct the Director of the Department of Public Works and Environmental Services, or his designee, to serve as the agent of the Board, and the co-applicant, as may be needed, to assist the Workhouse Arts Foundation (WAF) during the processing of the minor variation request

This motion should not be construed as a favorable recommendation of the request by the Board and does not relieve the applicant from compliance with the provisions of any applicable ordinances, regulations or adopted standards. This action in no way prejudices the substantive review of the request. Supervisor Herrity seconded the motion and it carried by unanimous vote.

## 32. <u>LORTON COMMUNITY CENTER PROJECT STAFF DESIGNEE</u> CLARIFICATION (MOUNT VERNON DISTRICT) (12:20 p.m.)

Supervisor Storck said that the Lorton Community Center was approved as part of the Human Services and Community Development Bond Referendum in November 2016. The proposed facility includes space for the Lorton Senior Center currently operating in leased space and the Lorton Community Action Center (LCAC). The site for the Lorton Community Center has been identified adjacent to the Lorton Community Library at 9518 Richmond Highway, which is located at Tax Map 107-4 ((1)) 34. The facility will provide a broad array of services, programs, and activities for individuals of all ages and abilities throughout the community and complement the services provided by the Lorton Community Library.

Supervisor Storck referred to his written Board Matter of July 31, 2018, and noted that County staff is concurrently processing the special exception plan amendment for the Lorton Community Action Center, the determination under Section 15.2-2232 of the Code of Virginia, and the related site and building permits.

The Board Matter also designated specific individuals to act as agents on the Board's behalf for all actions associated with these applications. County staff changes require the Board Matter to be revised to designate Department of Public Works and Environmental Services and Neighborhood and Community Services staff for the Lorton Community Center project to act on behalf of the Board as its representative agent.

Therefore, Supervisor Storck moved that the Department of Public Works and Environmental Services and Department of Neighborhood Community Service staffs be designated to act on behalf of the Board as its representative agent for the Lorton Community Center project.

These motions should not in any way be construed as a favorable recommendation on any application or plan by the Board, and do not relieve the applicant from compliance with the provisions of any applicable ordinances, regulations, or adopted standards, and in no way prejudice the substantive review of the applications and/or plans. Chairman Bulova seconded the motion and it carried by unanimous vote.

Supervisor Foust announced that Pomeroy/Clark I, LLC, has filed three concurrent rezoning applications: Proffered Condition Amendment Application PCA C-637-04, Rezoning Application RZ 2016-DR-027, and Final Development Plan Application FDP 2016-DR-027, to permit mixed use development consisting of 2,033,600 square feet of residential uses and a public elementary school. The Planning Commission approved the FDP and recommended approval of the PCA and RZ applications at its November 1, 2018, meeting. ## 36. **SUMMER OPEN HOUSE (SULLY DISTRICT)** (12:29 p.m.)

Supervisor K. Smith announced an upcoming Summer Open House event at the Sully District Government Center on Saturday, June 22, from 10 a.m. until 2 p.m.

This day will be a unique opportunity to raise awareness around two important issues: food insecurity and environmental awareness.

Supervisor K. Smith noted that cases of food insecurity exist regardless of the season and impact more families than often realized. The Sully District office will be partnering with Western Fairfax Christian Ministries to conduct a food drive for the duration of the Summer Open House and she invited all residents to stop by and contribute to this worthy cause.

As temperatures continue to rise, many residents will find themselves spending more time outside. It is during this period that outdoor safety and environmental stewardship must be emphasized. The Summer Open House will feature a panel of environment-related agencies, such as the Park Authority, the Health Department, and the Clean Fairfax Council. Representatives from these branches will be at the event to answer questions and offer helpful information for children as well as adults. Those in attendance will be able to learn about dealing with disease-carrying insects and become familiar with the County's latest conservation efforts.

Michael Lynskey, Planner II, Policy and Plan Development Branch, Planning Division, Department of Planning and Zoning, presented the staff report.

Following remarks by Chairman Bulova, regarding the location of the property in a non-exempt area, Supervisor Cook made the following statement:

Before we begin this afternoon, I have been asked to make some preliminary comments. We are here for a public hearing on a proposed Comprehensive Plan amendment. Because this amendment involves possible residential use, it could implicate Virginia Code Section 15.2-2303.4, which the Virginia General Assembly (GA) enacted in 2016. That statute restricts local authority regarding proffers in certain residential rezonings. While the GA approved amendments to the statute earlier this year, those amendments do not affect our discussion today. And, although this meeting doesn't directly involve a rezoning application, one has been filed and we want to be certain that nothing said or done here could in any way raise an issue under that statute.

So, in an abundance of caution – even though this hearing concerns a proposed Plan amendment, not a rezoning – we will discuss and consider only the impacts of any potential development of the subject property, not any proffers that a rezoning applicant might make to address those impacts. Nothing in our discussion here should be construed as a suggestion, request, or requirements for any proffer.

Due to the statute and the uncertainty over its application, our discussion of certain issues may be more constrained than has been the case historically. In the past, we've had open, collaborative discussions not only about the impacts of proposed development, but also about how those impacts might be addressed. Unfortunately, the current statute doesn't encourage such an open dialogue. Should the discussion today venture into those areas, please understand that no one on the County side is suggesting, requesting, or requiring any proffer; however, there could be another mechanism, such as a development plan associated with the rezoning application, to address some concerns.

Finally, it goes without saying, but I will reiterate it for the record: comments from the public represent the views of the individuals only, not the views of County staff, County officials, the Board of Supervisors, or the locality.

Chairman Bulova again stated that what is in front of the Board is a Comprehensive Plan change proposal and not a rezoning.

Following procedural instructions, Chairman Bulova announced that, at the conclusion of the public hearing, Supervisor Cook will be making a motion to defer decision on the proposed Plan amendment until the Board's meeting on June 4, 2019, at 2 p.m.

Following the presentation of Mr. Neil Gallagher (Speaker 8), discussion ensued concerning the version of the Institute of Transportation Engineers' (ITE) Trip Generation Manual used for his presentation.

Following the public hearing, which included testimony by 24 speakers, Supervisor Cook presented items for the record.

Mr. Lynskey presented the staff and Planning Commission recommendations.
