### Legislative Activities - 2022

- Successes:
  - HB 443 Electric vehicle charging at FCPA properties
    - Adds FCPA to those local and state entities that may locate, operate, regulate the use of, and install signage relating to EV charging stations on property under its jurisdiction.
  - HB 396 Virtual net metering at county properties
    - Amends the state's pilot program (i) to allow participation by municipalities and park authorities installing solar pursuant to PPA; (ii) to authorize larger systems at parking garages and wastewater treatment sites; and (iii) to expand the applicable credit.
- Still no local authority to set building codes
  - HB 701 and HB 905 would have permitted local building code provisions and regulations related to energy efficiency and conservation more stringent than those in the Uniform Statewide Building Code.
