



CECAP Implementation Priorities




Goal: Increase transit & non-motorized commuting to 30% (including telework) by 2030.





- Professional audits and insulation upgrades
- ENERGY STAR windows and appliances
- Thermostat settings
- HVAC filters and maintenance
- Use a clothesline or drying rack
- Wash on cold
- Unplug electronics and/or use power strips
- LED lights and turn lights off
- Power management features on computer
- Water-Sense faucets, showerheads, fix leaks
- Switch to electric stove
