Spring 2006

Our first meeting of a community task force to consider improvements to Little River Turnpike (Rt. 236) took place on December 12, 1995. Eventually, agreement was reached and funding secured for *spot capacity and safety improvements at key intersections in the corridor*. A lot of things were discussed during the years that the task force met. One of them was the possibility that an old cemetery might exist at the southwest corner of Rt. 236 and Guinea Road, where a right turn lane is to be constructed. Almost 11 years, later we now know for sure. This year, the Virginia Department of Transportation began utility relocation for the project. The crew worked very carefully in the area rumored to contain the cemetery. Using the services of the Louis Berger Group, archaeologists sifted through soil next to Guinea Road and beneath an existing sidewalk. On Wednesday, April 19th, I watched as dust was gently brushed from skeletons buried in graves referred to in 19th century maps as "the old cemetery." They will be re-interred at Mount Pleasant Cemetery.

Who were these people? And what was this area like when they were buried at this now busy intersection? These are exactly the sort of questions that prompted our **A Look Back at Braddock Project**, which captures and tells the history of our area. See inside for information about the Guinea Road community called Ilda and our book, **Braddock's True Gold**, which will debut the weekend of **June 2**nd- **4**th **during Lake Accotink Park Heritage Days**.

Other projects and events taking center stage this spring:

Our **Spring Town Meeting** this year provides a forum for discussing **Animal Issues**. I hope you will join me on **Wednesday, May 31st, 7:30 p.m.** as County experts provide information about both domestic and wild animals that share our space, animal rescue and volunteerism, and caring for pets during emergencies.

Several large County projects will be under construction starting this summer. Saturday, July 29th will be a big day, with groundbreaking ceremonies for the Burke Centre Library at 11 a.m., and the Burke Centre VRE Garage at 1 p.m. Both projects should be completed by spring 2008. While we're waiting, my office is hosting a Time Capsule Task Force to work with me and County staff to install a time capsule in the cornerstone of the new library. The group has already begun to consider and gather items for the capsule, which will be opened in the year 2038. This project is still in its beginning stage. Please contact my office if you're interested in participating.

Dredging is underway to remove silt from **Lake Accotink**. Work should be completed by March 2007. Information about the project can be found on the Lake Accotink Park Web site at http://www.fairfaxcounty.gov/parks/accotink/. A project to make safety improvements to the dam spillway at **Royal Lake**, in the Kings Park West area, will be the subject of a community meeting on **June 20th**, 7:30 p.m., in **Braddock Hall**, adjacent to my office in the Kings Park Library building. A neighborhood task force is meeting with staff from my office and the County, State and Federal governments to review and discuss alternative proposals for making improvements.

Lastly, good deeds are contagious. It's not too late to nominate a person or an organization that's made a positive difference for a **BOB** (**Best of Braddock**) **Award.** Categories include: Young Person of the Year, Most "Can-Do" Public Employee, Commercial Beautification or Improvement, etc. The deadline for nominations is <u>May 22nd</u>. ROADWORKS UPDATE

Rt. 236 (Little River Turnpike) Spot Capacity and Safety Improvements - Pickett Rd. to Lake Blvd. at entrance to NVCC (VDOT project - 2 miles). Right-of-way acquisition and utility relocation are underway. Bid advertisement is scheduled for August 2006. Construction is scheduled to begin in 2007. While Rt. 236 is ultimately planned to be widened to 6 lanes, this project provides for spot capacity and safety improvements at key intersections (Pickett, Guinea to Prosperity and Wakefield Chapel) in the corridor.

Route 123, Ox Road @ Braddock Road (VDOT Project). Extend northbound right turn lane on Ox Rd. Design is underway.

Braddock Road @ **GMU**. Extend westbound right turn lane from existing terminus on Braddock Rd. to GMU entrance at Roanoke Ln.; add sidewalk from Roanoke to Ox Rd. Project is under construction, with completion in summer 2006.

Braddock Road @ Ravensworth Road (VDOT

<u>Project</u>). Construct an acceleration lane on westbound Braddock Rd. between Ravensworth Rd. and the I-495 ramp. Project is nearing completion. Design was coordinated with the **Ravensworth**Sidewalk project, which was completed in August 2005. Pedestrian signalization will be done later.

Roberts Road Project. Construct a right turn lane on to Braddock Rd. from southbound Roberts Rd. next to GMU. Project design completed. Construction delayed as significant utility relocation issues are being worked through.

Capital Beltway. In 2005, the Virginia
Commonwealth Transportation Board approved the
12-Lane High Occupancy Toll (HOT) concept for
improving 14 miles of the Capital Beltway between
Springfield and the American Legion Bridge.
Agreement was reached among VDOT, Fluor
Enterprises, Inc. and Transurban (USA) Inc. to
improve the Capital Beltway (I-495). Environmental
Impact Statement (EIS) was approved in April.
Following Federal review and revision of the EIS,
financial analysis and financial backing will follow.
Construction could begin in a couple of years.

YOUR TAX DOLLARS AT WORK FOR YOU

Improved Access to Metro Bus Stops. <u>Guinea Rd. Sidewalk.</u> Extend sidewalk south on Falmead Rd to Guinea Rd. and install missing trail segment on Guinea Rd. Construction to begin spring 2006.

Olley La. Sidewalk. Install sidewalk on west side of Olley La. from Braddock Rd. to Colbert Ct. Construction is scheduled to be completed in fall 2006.

Burke Centre VRE Station Parking Facility. A task force of citizens and county staff participated in the design of this attractive facility, which will fit in with the surrounding community. Construction begins in August 2006. Completion in March 2008. Project includes a bus loop and sidewalks.

Burke Centre Community Library. Project to build a 17,000 square foot community library at Fred's Oak Rd. and Fairfax County Pkwy. In order to provide some temporary parking for VRE commuters during construction of the garage, this project is being phased.

<u>Phase One.</u> Parking lot and site infrastructure underway and will be completed this August. <u>Phase Two.</u> The library building construction will start this August and be completed in spring 2008.

Ossian Hall Park. Phase One. Clear existing trails this summer and construct new paved trails next spring to open up the park and improve visibility in all directions. Phase Two. Community plaza with a decorative hardscape; benches and/or seat walls; trash receptacles; independent lighting throughout the year; additional parking; and a new, multi-purpose playing field. Funding is to be determined.

Fiscal Year 2007 is best viewed in context with the county's budget challenges throughout the decade.

During the 1990's Fairfax County experienced a severe recession and slow recovery. The "**Doomsday**" **Budgets** of FY 1993 and FY 1997 dealt with projected deficits by freezing salaries, eliminating a number of programs and services, reducing spending "across the board" and increasing the Real Estate Tax Rate twice.

Budgets adopted during the early 2000's have come to be known as **The Perfect Storm Years**, as Real Estate assessments rebounded and grew by double digit percentages, but sources of County revenue *other* than the real estate tax fell or remained flat, year after year. A number of **public safety crises** - The September 11th Terrorist Attacks, West Nile Virus, Hurricane Isabel, the Sniper Attacks – created unexpected challenges and public safety demands.

In Fiscal Years 2005 and 2006, the Board of Supervisors sought ways to **diversify our county Revenues** in order to maintain quality schools and county services, while providing a significant reduction to the Real Estate Tax Rate. With a combination of belt-tightening, adoption of an Ambulance Fee, Athletic Fee and a Cell Phone tax, and by increasing the county's Cigarette tax, Recordation fees and Hotel tax, the Board was able to reduce the Real Estate Tax Rate from \$1.13 in FY 2005 to \$1.00.

The Fiscal 2007 Budget reduces the Real Estate Rate 11 cents further to 89 cents of assessed value. Additionally, the Board eliminated the county's \$25 vehicle decal fee.

\$106 million or 55% of growth is associated with increased funding for the Schools. Funding for new facilities and public safety accounts for 35% of the increase.

COUNTY PRIORITIES ADDRESSED IN THE BUDGET INCLUDE:

- A continued commitment to **Affordable Housing**. For the second year in a row, an amount of money equal to one penny on the tax rate is dedicated for the preservation of affordable housing in the County.
- The continued commitment to **Environmental and Stormwater Management Issues.** For a second year, one penny on the tax rate will allow public works projects to continue at a vigorous pace.
- \$30.2 million of the FY 2006 Third Quarter Balance fully funds the **County's Revenue Stabilization Fund.**With what appears to be the beginning of a period of slowed revenue growth in FY 2008, this action provides the County with a cushion against a potential decline.
- Maintenance and infrastructure improvements to support both aging and new County facilities.
- **Public Safety Enhancements** 49 new positions are included for the Police Department and 40 new positions for the Fire and Rescue Department.
- Over \$50 million in investments to keep our children safe and healthy (Head Start Programs, After School Programs, School Public Health Nurses, Clinic Room Aides, Crossing Guards, etc.)
- Initiatives for our growing senior population Long-Term Care and Senior Plus Services

A LOOK BACK AT BRADDOCK



Recently, *The Washington Post* ran a fascinating series about old graves discovered at the intersection of Guinea Road and Little River Turnpike. This was not a surprise to our A Look Back at Braddock Task Force which had recorded the oral history of Springfield resident Dennis Howard.

Mr. Howard knew from family history about Horace Gibson and Moses Parker, both ex-slaves from the Culpeper area, who moved to Fairfax in the 1860s. Both Mr. Gibson and Mr. Parker had earned enough to purchase their freedom. They lived on property which was part of the Fitzhugh plantation, and eventually bought small five-acre lots near the corner of Guinea Road and Little River Turnpike. The Gibson-Parker community, with a church, shops and a cemetery grew from about 10 acres to 400 acres by 1878.

Mr. Gibson and Mr. Parker were both blacksmiths. They opened up a blacksmith shop at the corner of Little River Turnpike and what is today Prosperity Avenue. Their shop was patronized by the entire community. Mr. Howard explains: "He [Horace Gibson] served everybody, black, white, poor, and rich. And the Little River Turnpike was a good location because . . . they would use the Little River Turnpike to come back and forth from Alexandria and Arlington." The community became known as Ilda. According to descendents, Ilda was named after Matilda Gibson-Parker, daughter of Horace Gibson and the daughter-in-law of Moses Parker.

Eventually, Matilda and Page Augustus Parker, her husband, took over the blacksmith shop. After Page's death in 1905, Matilda kept the blacksmith shop operating until 1910. Dennis Howard, a great-great-grandson of Horace Gibson, and Aileen Wright, a granddaughter of Page and Matilda Parker, keep their family history alive through frequent family reunions.

You can learn more about Ilda, including the mysterious "Bean Rain of Ilda" in 1930, in our soon-to-be-released book, **Braddock's True Gold.** The book and companion map will be available at Lake Accotink Heritage Days the weekend of <u>June 2nd</u>. It will also be available at the Fairfax Fair, next to the Park Authority's booth, the following weekend.

PARK NEWS

It's full speed ahead for the Lake Accotink Dredging Project. The section of pipeline at Lake Accotink has been completed and laid across the park access road. The barges, dredge, cutter head and work boat are on the lake. This project is slated for completion in spring 2007. Updates can be found on the Web at www.fairfaxcounty.gov/parks/accotink/index.htm.

Synthetic turf will be installed at Wakefield Park, with completion by spring 2007. Synthetic turf has taken the athletic industry by storm, leading to fewer injuries, accommodating sustained use and requiring minimal maintenance. It is also environmentally safe and helps us meet the need for athletic facilities without having to construct as many expensive, spaceconsuming new fields.

Two new softball fields opened on April 22nd at Wakefield Park. These fields are ideally suited to girls' softball and reaffirm our commitment to equitable recreational facilities for all sports.

The playground at Rutherford Park has been completely renovated, new equipment has been installed, and a habitat restoration project has begun along the stream. Trees have been planted and mowing reduced as part of the county's water quality improvement initiative. A team of volunteers is continuing its work with Park Authority staff to remove the invasive English ivy.

TRAILS TO TRY

The Fairfax County Cross County Trail is officially open! The newest segment completes the trail through Camelot north of Little River Turnpike, and then crosses under the highway to link with the trail through Wakefield Park. It is a vital link in Fairfax County's trail system. Soon, the segment of the Cross County Trail in the Accotink Stream Valley, between the Lake Accotink Dam and Old Keene Mill Road, will be renovated and will link sections of the trail at the Lake Accotink Dam with the stream valley trail between Hunter Village Avenue and the south side of Old Keene Mill Road. This section is almost two miles long and will provide a safe way to cross under Old Keene Mill Road to the stream valley trail to the south. The Cross County Trail is a multi-surface, multi-user trail - enjoy it with your family and friends! For more information, go to http://www.fairfaxcounty.gov/parks/cct/

The Virginia Department of Transportation (VDOT) is a state agency. Your gasoline taxes pay for road repaving and repairs. VDOT plans to repave the following roads this spring and summer, but cautions that the schedule could change depending on state funding of the road maintenance budget.

- Lee Forest Elizabeth La. from Rte.
 236 to Guinea Rd., and Littleton St.

DID YOU KNOW?



• The Fairfax County **Noise Ordinance** prohibits: Operating <u>loud speakers</u> and <u>amplifiers</u> from 11 p.m.-7 a.m. or <u>construction equipment</u> from 9 p.m.-7 a.m. daily (and on Sundays 9 p.m.-9 a.m.) To register a complaint contact the county's Zoning Enforcement Branch at 703-324-1300 during business hours. After business hours, call the Public Safety non-emergency line at 703-691-2131.

Also prohibited are <u>animals that bark</u> frequently and habitually any time and <u>refuse collection</u> in residential neighborhoods between 9 p.m.-6 a.m. These issues are enforced by the police. To register complaints, call the police at 703-691-2131.

YOUR STORMWATER PENNY AT WORK FOR YOU



Beginning in FY 2006, the Board of Supervisors adopted a new program that allocates the equivalent of one penny on the real estate tax rate for improving our watersheds and addressing stormwater problems. This year's allocation is \$21.9 million.

Several critical projects have been identified in Braddock District for funding and design. Projects will involve community input as they move forward in the queue for funding and engineering:

Royal Lake Auxiliary Dam Rehabilitation Project Plan to strengthen the spillway is in design phase. A Neighborhood Task Force will meet during May to review alternatives. A community meeting is scheduled to present recommended alternatives on June 20, 2006, 7:30 p.m. in Braddock Hall. Funding requested for construction in fall 2007.

Woodglen Lake Auxiliary Dam Rehabilitation Project Planning phase initiated, community meeting to be scheduled in fall 2006. A Neighborhood Task Force will be formed to review design alternatives. Construction planned for 2008/2009.

Lake Barton Auxiliary Dam Rehabilitation Project Initiate planning in fall 2008. A community meeting will be scheduled and a Neighborhood Task Force created to review design alternatives. Construction planned for 2009/2010.

CALMING NEIGHBORHOOD TRAFFIC

All roads in Fairfax County are owned and maintained by the State's Virginia Department of Transportation (VDOT). Fairfax County's Department of Transportation (FCDOT) has worked with VDOT to develop the following programs for reducing the impact of traffic in neighborhoods: Multi-Way Stop, Cut Through Traffic and Traffic Calming. Only roads that are designated as residential are eligible for these programs. Minor arterials such as Wakefield Chapel Rd. or Guinea Rd. are not eligible for measures under these policies.

My office serves as a liaison for the community to work with FCDOT and VDOT to implement these policies. To initiate traffic calming efforts, a request in writing should come from the community association. Each program has qualifying criteria, as well as established procedures for working with the community towards a resolution of its concerns.

The Multi-Way Stop Sign Policy requires the community to determine whether there is support for the signs. Locations must be approved by VDOT based on road geometry and other factors. For the Cut Through Traffic and Traffic Calming Policies, the community requests that a speed and volume study be conducted. Both of these policies use a combination of mostly physical devices to affect a change in driver behavior within the residential community. Once a neighborhood qualifies under the speed and/or volume criteria, a task force is created to work with my office, FCDOT and VDOT to develop a plan within the VDOT guidelines that the community must then vote on. Traffic calming requires a great deal of participation and commitment from the community. Please contact my office for additional information on traffic calming.

Fall 2006

Experts project that our region will grow dramatically in the next 25 years, with two million more people and 1.6 million new jobs. Some of that growth will be in Fairfax County. While dramatic changes are unlikely in our mostly built-out Braddock District, some re-development or revitalization of aging commercial areas and neighborhoods can be expected. How would we like to see that happen? What was the planning philosophy during the 50's, 60's and 70's, when most of our Braddock communities were built? What has worked well, and what challenges have resulted? What might we do differently as our County accommodates a growing population in the future? These questions will be the subject of my Fall Town Meeting and Dialog Series, the evenings of Wednesday, October 25th, November 1st and November 8th. Panelists for the series will include policymakers and planners from our past and present. At the conclusion of the series, dialog participants will be invited to adopt a "vision statement" for Braddock District's and Fairfax County's future. I hope you can join me as we look ahead, as a community, at what we would like to see for Braddock Tomorrow.

Some of the changes we have experienced during the **past** 25 years include a growing higher education presence within our Braddock District boundaries. I sometimes describe our district as a place where someone can walk to school, all the way from pre-school through graduate school. During a recent presentation by George Mason University officials at a Braddock District Council of Community Associations' meeting, we learned of plans for Mason to construct new student housing, temporary satellite parking and other potential capital projects within its campus. To provide an effective structure for discussion of upcoming plans and activities, and for addressing university-related concerns, Mason officials have worked with my office and leadership within the community to create a **George Mason – Braddock District Community Forum ("The Forum")**. The Forum has begun with three informational/educational meetings about Mason's plans for the campus, transportation plans for the area near the university and how off-campus, university-related issues are addressed. Once the educational sessions have been completed, The Forum will begin regular meetings in January 2007. Citizen participants in The Forum are designated civic and homeowner association representatives from neighborhoods near the university.

Throughout the next year, several projects are changing Braddock's landscape. A new **Burke Centre Library** will start construction at Fairfax County Parkway at Freds Oak Road in November. A new 1,290-space **Burke Centre VRE Station Garage** will be completed by spring 2008. The architecture includes attractive brick facades, decorative planters and a clock tower. The Burke area community participated in the design of these two new facilities. In our parks, the dredging of **Lake Accotink** is underway (completion estimated March 2007) and safety improvements for the **Royal Lake Dam** (in the Kings Park West area) are expected to begin in summer of 2007. Phase I of the renovation of **Ossian Hall Park** in Annandale begins in October, with construction of a small entrance plaza at Four Year Run and attractive new monument signage at Heritage Drive. Existing trails will be repaved, and new trails built to create a half-mile trail that will open up the park and improve visibility in all directions. Future plans include a new multi-purpose playing field, a community plaza and entertainment pavilion for neighborhood concerts and activities.

There's always something happening in our Braddock District, and always opportunities for the community to be engaged! See inside this issue of the *Byline* for more Braddock news!

ROADWORKS UPDATE

Rt. 236 (Little River Turnpike) Spot Capacity and Safety Improvements. - Pickett Rd. to Lake Blvd. at entrance to NVCC (VDOT project - 2 miles). Right-of-way acquisition and utility relocation are underway. Bid will be advertised this December. Construction mobilizing in spring 2007. While Rt. 236 is ultimately planned to be widened to six lanes, this project provides for spot capacity and safety improvements at key intersections (Pickett, Guinea to Prosperity and Wakefield Chapel) in the corridor.

<u>Braddock Road</u> @ <u>Route 123, Ox Road</u> (County <u>Project</u>). Eastbound right turn lane to southbound Rt. 123. Proposed for 2007 Spot Improvement program.

Roberts Road Project (County Project). Construct a right turn lane on to Braddock Rd. from southbound Roberts Rd. next to GMU. Project design completed. Utility relocation issues have been resolved. Work will begin in spring 2007, and construction is scheduled to be completed by fall 2008.

Zion Drive Curve (VDOT/County Project). To improve traffic safety, VDOT will do the following on the western side of the curve: extend guardrail along the curve, enlarge the warning signs, add chevron signs and restrict on-street parking. The county will move the existing streetlight. Long term, funding to straighten the curve (\$1M) needs to be identified.

Capital Beltway. In 2005, the Virginia Commonwealth Transportation Board approved the 12-Lane High Occupancy Toll (HOT) concept for adding capacity to 14 miles of the Capital Beltway between Springfield and the American Legion Bridge. Agreement was reached among VDOT, Fluor Enterprises, Inc. and Transurban (USA) Inc. to add lanes to the Capital Beltway (I-495). The federal Record of Decision (ROD) on the project's Environmental Impact Statement was approved in June 2006. Financial and design analyses are underway. Depending on the outcome of the financial analysis and financial backing, construction could begin in a few years. Motorists who pay to ride in the new HOT lanes help pay for the project and free up space in the regular lanes. Carpoolers and buses can use the HOT lanes without paying a toll.

<u>Bus Shelters</u> (County). Funded for design and installation at eastbound Braddock at Twinbrook and westbound Braddock across from Carriagepark.

YOUR TAX DOLLARS AT WORK FOR YOU

Improved Access to Metro Bus Stops. Guinea Rd. Sidewalk. Extend sidewalk south on Falmead Rd. to Guinea Rd. and install missing trail segment on Guinea Rd. Redesign was necessary due to easement acquisition issues. Construction will start next spring and be completed in summer 2007. Olley La. Sidewalk. Install sidewalk on west side of Olley La. from Braddock Rd. to Colbert Ct. Final design in VDOT permits. Construction will start next spring and be completed in summer 2007.

Burke Centre VRE Station Parking Facility. A task force of citizens and county staff participated in the design of this facility. Construction begins in October 2006. Completion in March 2008. Project includes a bus loop and sidewalks.

Burke Centre Community Library. Project to build a 17,000 square foot community library at Freds Oak Rd. and Fairfax County Pkwy. In order to provide some temporary parking for VRE commuters during construction of the garage, this project is being phased. Phase One: Parking lot and site infrastructure were completed this summer. Phase Two: Library building construction will start this November and be completed in late spring 2008.

Ossian Hall Park. Phase One: This fall work begins to "limb up" some overhanding trees and to selectively spray a portion of the forest. Existing trails will be repaved and new trails built to create a half-mile trailway that opens up the park and improves visibility in all directions. Improvements will be made to the park entrances, with a small entrance plaza and signage at Four Year Run and attractive new monument signage at Heritage Drive. Phase Two (unfunded): Site plan nearly completed for community plaza with a decorative hardscape; benches and/or seat walls; trash receptacles; lighting; additional parking; and a new, multi-purpose playing field.

Royal Lake Rehabilitation. In August 2006, a rehabilitation plan and concept design for armoring the auxiliary spillway were completed. This project will extend the life of the dam's auxiliary spillway to 70 years from the date construction is complete. Royal Lake provides flood protection and sediment control in the Pohick Creek watershed. Construction is projected to begin in summer of 2007, subject to federal funding.

Woodglen Lake Rehabilitation. The planning phase for improvements to the dam is scheduled for this fall. A task force will be formed to review design alternatives.

STUDENT HISTORY PAPER COMPETITION

As part of a continuing effort to focus on and capture our Braddock District history, my office is working with the *A Look Back at Braddock* Task Force to host a second Student History Research Paper Competition. This contest is being offered to middle and high school students who live in and/or attend school in the Braddock District, with cash prizes being awarded to first, second and third-place winners.

This year's research subject is "Braddock District Roots." Papers will be evaluated by a panel of judges and must address one of the following non-fiction topics:

- patterns and places of settlement in the Braddock District area (for groups or individuals);
- reasons you or your ancestors settled in the Braddock District area; or
- transplanted cultural traditions (e.g., Kwanza, Chinese New Year, Cinco de Mayo, Passover, Christmas).

BURKE CENTRE LIBRARY TIME CAPSULE



In spring 2008, a Time Capsule, to be opened in the year 2038, will be inserted into the cornerstone of the new Burke Centre Library under construction at the intersection of Freds Oak Road and the Fairfax County Parkway. Pat Riedinger, Chair of the Friends of the Burke Centre Library, is organizing volunteers to gather material for the Time Capsule. In addition to historic information about the site (formerly a horse farm), the Time Capsule Committee is compiling a scrapbook/journal of "A Day in the Life of a Librarian," from the morning newspaper, the childrens' school lunch menus, a gasoline receipt, photos of state-of-the-art library equipment and procedures. Students attending school in the area will be invited to submit an essay (to be inserted in the capsule) on "What the World Will Be Like in 2038." A LOOK BACK AT BRADDOCK



Conflict over growth and change is not new to Fairfax County. In the 1970's, *The Washington Post* ran a series of headlines that read: "Man in Bunny Suit Sought in Fairfax," "The Rabbit Reappears," "Bunny Man Seen," and "Bunny Reports Are Multiplying." In *Braddock's True Gold*, the legend of The Bunny Man is recounted through interviews with several long-time residents of the Braddock District area.

Lee Hubbard of Fairfax Station, during his oral history interview, recalled, "Supposedly a guy in a rabbit suit hit (a couple's) windshield with a hammer. I never believed it, but that's where the story started." According to Steve Reynolds, who has researched the Bunny Man story, the Bunny Man was seen several times in 1970. He first made news when he threatened a young couple who were parked on Guinea Road. He threw a hatchet through the car's right front window. The police recovered the hatchet, and a police report was filed.

The Bunny Man was sighted a second time by a construction security guard. He was chopping at the roof support of a house under construction and was overheard accusing people of being trespassers. In a third incident, the Bunny Man accused Kings Park West residents of dumping trash.

Who was the Bunny Man? His identity has never been discovered, but it is assumed that he was a local resident who became unsettled by changes happening around him, as Kings Park West, Long Branch and other new subdivisions sprang up on rural farmlands.

More interesting stories about our Braddock District area can be found in the wonderful new book *Braddock's True Gold*, *20th Century Life in the Heart of Fairfax County*. The book is available for purchase (\$25.00) at my office, as well as the Maps & Publications store at the Fairfax County Government Center. Proceeds from the sale of the book will allow for a re-printing early next year.



YOUR VOTE COUNTS, so please be sure to vote on <u>Election Day – November 7</u>! The last day for voter registration is <u>October 10</u>. Eligible voters must be 18, a current U.S. citizen and live within the County. Voters are strongly encouraged to show valid identification at the polls (e.g., Virginia Voter Information Card, Virginia driver's license or other identification issued by the Department of Motor Vehicles, military

ID card, Social Security card). If you are registered to vote and forget your identification, you may request to sign an "Affirmation of Identity" statement in order to vote. Voters who will be away from Fairfax County on November 7, or who are unable to go to the polls due to illness or disability, may vote by **absentee ballot**. To apply for an absentee ballot, the voter must complete an absentee ballot application, available online at www.fairfaxcounty.gov/eb/absentee.htm. This application must be either mailed to the Fairfax County General Registrar's Office, 12000 Government Center Parkway, Suite 323, Fairfax, VA 22035, or faxed to the registrar's office at 703-324-3725.

ON THE BALLOT this year in Virginia are candidates for the United States Senate and House, three proposed Virginia Constitutional Amendments and two Fairfax County bond issues. For more information on the candidates or issues, please visit the Fairfax County Electoral Board Website at:

The Fairfax County Bonds on the ballot this year pertain to public safety and parks and recreation.

The purpose of the **Public Safety Bond** (in the amount of \$125 million) is to finance construction, renovation and equipment for animal control, police, fire and rescue, and civil and criminal justice facilities. Highlights of the public safety bond:

- Renovations of the Fair Oaks Police Station,
- Renovation and expansion of West Ox Animal Shelter, and
- Facility and security improvements to existing public safety facilities.

The **Park Bond** (in the amount of \$25 million) is for land acquisition, construction and maintenance of trails and park facilities, and installation of synthetic-turf athletic fields. In Braddock District, a highlight of the park bond is the **re-routing and renovation of the trail south of Lake Accotink to Old Keene Mill Rd.**

UPDATE ON BRADDOCK APR COMPREHENSIVE PLAN PROCESS

In Fairfax County, planning and development of both land and transportation are guided by our Comprehensive Plan. First adopted in 1975 and amended over the years, the Plan, while not law, is a major guiding factor when land is rezoned. If challenged in court, decisions about land use are weighed in context with the Comprehensive Plan. Our most recent opportunity for reviewing and modifying the Plan in Braddock (The "Annual Plan Review" or APR process) came to a close with public hearings before the Board of Supervisors in September.

A **Braddock District Task Force** comprised of citizen volunteers from all parts of the district submitted nominations of their own, and made recommendations on nominations received from the public. Task force nominations mostly focused on four areas: improving transit opportunities in our area, improving pedestrian access through the addition of new trails to the Plan, maintaining stable, low-density neighborhoods, and re-enforcing environmental protections in industrial parks in the western part of the district. Five public nominations were submitted and all were withdrawn, except for one, which would allow for the option of including some residential units as part of a renovation of Heritage Mall in Annandale. This nomination was approved. Once the owner of the property files to rezone his property (if he chooses to exercise this option), my office will host a community meeting for residents near the shopping center.

Several times this year, I hosted community outreach meetings to give the nominators (both task force and the public) an opportunity to present their recommendations. These allowed affected property owners and nearby neighbors to hear first hand about the nominations, ask questions and provide feedback. *I would like to thank members of the task force for the tremendous personal commitment they made to this process.* The Task Force first convened in spring of 2005, with educational sessions on Planning, Zoning and Land Use. After 18 months of weekly meetings, the process ended in September, with unanimous votes from both the Planning Commission and Board of Supervisors. TALKING TRASH

In Fairfax County, trash service is provided both by the private sector and by the County. Areas that receive County service are referred to as **Sanitary Districts**, where residents pay an additional fee, which is shown on their property tax bill. The fee for the County to collect trash and recyclables is \$315 per year. A **Sanitary District** is formed when the residents of an area petition the Board of Supervisors for this service. **Sanitary Districts** can be developed as *new districts*, where at least 50 homes desire the service, or as an *expansion* to an existing district, which can be as small as one additional residence.

Some differences between a County **Sanitary District** and a private collection firm:

- The County offers five bulk or special collections at no additional cost per address per year. All private haulers charge a minimum of \$60 for each special collection.
- The County provides a wheeled trash cart and two blue recycling bins to each customer, whereas some private companies do not.
- The County collects trash once per week in each neighborhood. While this is a disadvantage for some homeowners, it does eliminate multiple truck trips into communities, causing less wear and tear on the roads and reducing emissions from diesel trucks. (All County refuse collection trucks use ultra-low sulfur diesel.)
- The County offers vacuum leaf collection in the fall to residents of **Sanitary Districts**, again *based upon their petition for this service*, for an additional fee of \$0.015 per assessed value of the home, with the average cost per year about \$50 per residence.

When recycling, please do not mix paper and plastic products. Plastic contaminates the paper when it is recycled, so please remove all plastic wrappings from newspapers prior to recycling and do not put papers in plastic grocery bags. ATHLETE'S CORNER Synthetic Turf Field at Wakefield Park

Groundbreaking was held on July 28th for a new synthetic turf field at Wakefield Park. The new field, when completed in spring 2007, will allow much more use of the field at a much lower cost to maintain.

The new field is the result of a Fairfax County partnership with local youth and adult athletic associations to fund the cost of site preparation and field installation. In addition to Wakefield Park, synthetic turf fields are being installed at Mason District Park and near the library in Vienna. A large portion of the proposed Park Authority bond referendum, scheduled for November 7th, is to be devoted to fund additional synthetic fields in Fairfax County over the next several years.

In the case of the Wakefield Park field, Braddock Road Youth Club (BRYC) took the lead and, in conjunction with several other athletic groups, pledged \$400,000 as its share of the total cost. BRYC deserves much credit for its efforts on this project, which will benefit many youth and adult athletes in the Braddock District.

PUBLIC SAFETY CORNER

Burglaries are increasing in Fairfax County. From January to June 2006, home break-ins were up over the same period last year. With that in mind, it's important that you do as much as possible to "burglar-proof" your home. The police offer some tips on how to prevent burglaries:

- Make your home look like you're there. Lights turned on and off by a timer give a lived in look when you're away.
- Have good locks. A one-inch deadbolt on every outside door is a basic requirement.
- Never leave your home unlocked!
- Don't hide a key outside your home. Leave an extra key with a trusted neighbor or friend.
- Never put a name or address tag on your house or car keys. It's an open invitation if you lose your keys.
- Plug a radio into a timer when you're going to be away. Tune the radio to an all-talk station and set the volume on low.
- Have a free home security inspection and be an active participant in your Neighborhood Watch.

If the **Neighborhood Watch** in your community has gone out of existence and you're interested in restarting the program, contact Office Doug Coulter at the West Springfield Police Station (703-644-7377).

Beware of the latest scam – voice fishing, or "vishing." Law enforcement agencies, for some time, have been warning about "phishing" e-mail messages that link to phony Web sites. Once there, customers are asked account numbers and other personal information. Now, there's a variation on that theme. Con artists are sending out e-mails that direct people to a telephone number, and an automated voice prompt gathers their personal information. If you think you've been the victim of "vishing," "phishing," identity theft or any scam, call the Fairfax County Police Department's Financial Crimes Unit at 703-246-7800.

- As of July 1, 2006, Fairfax County eliminated vehicle decals and the associated \$25 fee. If you receive a decal citation from another jurisdiction, please call the number on the citation directly. - Noises such as loud speakers and musical instruments are declared a noise disturbance any time when plainly audible across property lines or partitions. To register a compliant during normal business hours, contact Zoning Enforcement Branch at 703-324-1300. During non-business hours, call the Police non-emergency line at 703-691-2131. All animal related nuisance noise issues should also be reported to the police.
- There are new procedures for disposing of dead birds. The Health Department used to collect dead birds (crows, jays and raptors) to test for West Nile virus, but mosquito pools provide a better indicator of the virus than dead birds.

With the emergence of **avian flu**, the Virginia Department of Health has developed a procedure for handling dead bird reports. Birds with webbed feet (e.g., ducks, geese, swans and shorebirds) should be reported to the Department of Game and Inland Fisheries (DGIF) at 804-367-1258. DGIF will decide if the bird should be collected for testing or advise the caller about how to properly dispose of the bird.

Other dead birds should be reported to the county health department. With **fewer than five birds**, the caller should pick up the bird with gloves or a shovel and put it in a double plastic bag. The bird then can be put in the trash or buried. **Five or more birds** should be observed for signs of external injury that would rule out disease or poisoning as the cause of death. If there are no signs of injury, call the Virginia Department of Agriculture if pesticide is suspected or DGIF if disease is suspected. DGIF will determine if the birds should be collected for avian flu testing and advise the caller what to do.
