Dear Neighbor,

On Tuesday, February 2, Fairfax Health Director Dr. Gloria Addo-Ayensu [reported on the County's COVID-19 strategy](#) during a meeting of the Board of Supervisors' Health and Human Services Committee. The meeting provided an in-depth look at the Health Department's vaccine and distribution efforts. I've included key updates from this meeting in the Detailed COVID-19 Information section found on page 10 of this newsletter.

Two of the most-asked questions from constituents are, "Can people who are registered find out their place in the queue?" and "When will I receive my COVID-19 vaccine appointment?"

First, I want to be fully transparent and share the information that we have. Even when that information is frustrating or disappointing. The reality is that we continue to receive a very low supply of vaccine – roughly 13,000 doses per week – while more than 180,000 residents have registered. The Health Department is efficiently using its full supply every week, so that no vaccine is sitting on the shelves. We have the capacity to administer many more doses per week, but due to the limited supply, it could take weeks or months for us to get through the current Phase 1b eligible population.

Unfortunately, the Health Department is unable at this time to inform individuals when they will receive their appointment, nor can they tell someone where they are in the queue. Most of the Health Department's technological efforts have been focused on distribution and administration of the vaccine. However, Dr. Addo-Ayensu did recently describe the dashboard in development which will present a variety of information that when presented together will give people a sense of how quickly they're moving through and where they might fall in the queue. For example, they are looking at a system that would give the date that those currently being served had registered, along with the number of remaining registrations. This will provide some sense of the progress that is being made and how far we might be from your spot in the queue. I will continue to push for additional transparency to give those currently waiting for the vaccine as much information as possible.

It is important to note that appointments are scheduled in the order that registrations are received. During the presentation we learned that periodic messaging to those in the queue is planned. I've included samples of the emails you will receive from the time your appointment becomes available in the COVID-19 section below so that you can understand how the emails will look.

Additionally, CVS recently announced they will begin offering COVID-19 vaccines to eligible groups at select stores. CVS will be receiving their doses through the federal partnership, not the Fairfax Health Department. Currently, 36 stores are expected to begin registering individuals for appointments as early as **Tuesday, February 9, 2021**. CVS expects to begin vaccinations Thursday, February 11, 2021 at locations in Virginia, including Fairfax, Arlington, and Alexandria. Exact store locations should be made available soon. While registration is not yet open in Virginia, individuals will be able to register in advance on the CVS website, CVS app, or by calling CVS' customer service line at (800) 746-7287. Registrations are required; no walk-ins will be accepted.

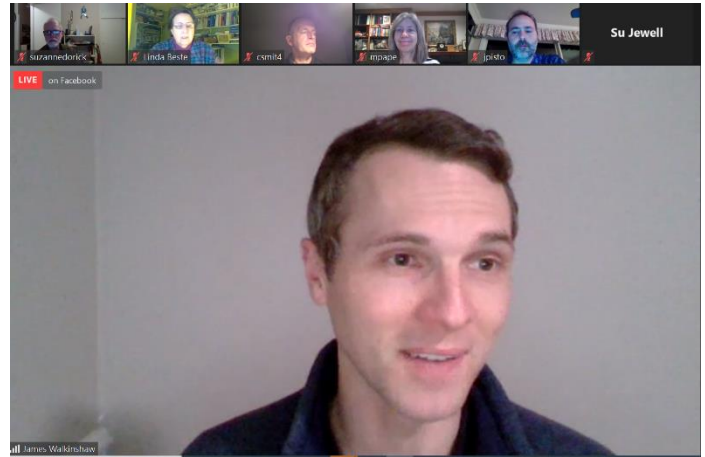

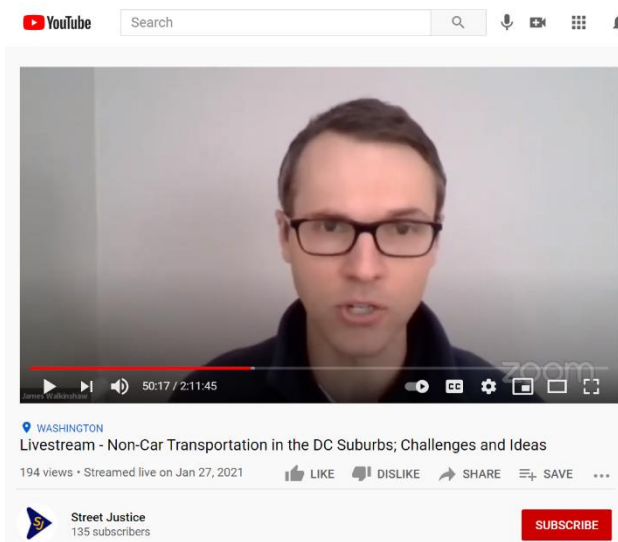

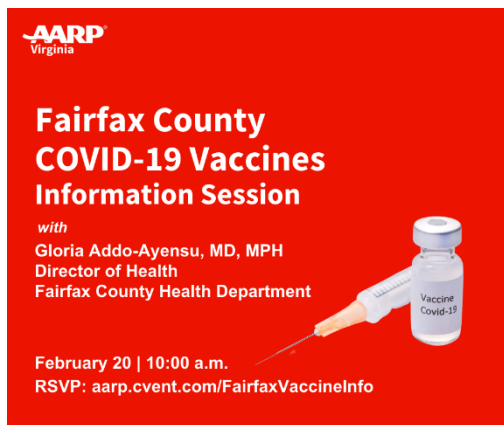

# Detailed COVID-19 Information

The COVID-19 vaccine situation has been changing quickly. This section provides you the most up-to-date information currently available.

As the Health Department receives more questions from residents and from Board of Supervisors offices, they continue to update their [Vaccine FAQ page](#). We recommend you check there frequently for the latest information.

## Vaccine Update Provided by the Health Department

On Tuesday, February 2, Fairfax County Health Director Dr. Gloria Addo-Ayensu provided an update on the county's vaccine distribution efforts to the Board of Supervisors during the Health and Human Services Committee meeting. The [meeting is available to watch](#) and interested individuals can [review the presentation](#).

### Key Highlights Include:

- The nation is facing limited vaccine supplies, which [means limited supply](#) for Fairfax Health District residents through at least March.
- Vaccination will be targeted while supply is limited following guidelines from the Virginia Department of Health.
- As of right now, the Commonwealth of Virginia is receiving about 105,000 doses a week, of which 13,600 doses are sent to the Fairfax Health District.
- Of those 13,600 doses, the Health Department is generally [following state guidelines](#) at this time and allocating about **50 percent for people age 65+ and 50 percent for all other currently eligible priority groups**.
- When supply is sufficient, vaccine will be administered by private providers, pharmacies, occupational health clinics, etc. (similar to flu vaccinations).

### Vaccination Numbers as of Monday, February 1:

- Fairfax County Health Department: 45,238 doses
- Inova: approximately 75,000 doses
- Skilled nursing and assisted living facilities: 6,069 doses
- Others: 16,368 doses

As of Monday, February 1, more than 186,000 residents had pre-registered for the vaccine in the Fairfax Health District.

## What Happens when Your Appointment is Available?

While COVID-19 vaccine supplies are very limited, the Health Department is working extremely hard to ensure everyone who has registered to receive the vaccine will get vaccinated. If you still need to register to receive the vaccination, [use the online registration tool](#). Once your appointment is available, you will receive the following email:

At this point it is critical to make proper accommodations to arrive at your appointment and receive your vaccination.

## **You Have Received Your First Dose.... Now What?**

The Health Department will email you an invitation to schedule your second dose during the most appropriate window based on your first dose date; in general, you will receive this invitation 4-7 days before the second dose is due. **You do not need to contact the Health**

**Department to schedule your second dose, and you do not need to complete the registration form again.**

For individuals who receive their vaccination from dedicated clinics, you will receive information directly from your employer (for frontline essential workers) or agency (for individuals living in correctional institutions).

**Older Adults and the COVID-19 Vaccine in Fairfax**

Here are some quick facts for older adults about COVID-19 vaccine appointments:

- Vaccine eligibility is occurring in phases per the CDC and Virginia Department of Health. More information about vaccine rollout in Fairfax can be found on the [County website](#).
- As more vaccine becomes available, there will be more options on where to access it. In the future, you will likely be able to access vaccine via your doctor, a health clinic, or pharmacy.
- The complete vaccine takes two doses. Follow the directions of your vaccine provider to schedule your second dose.
- One caregiver can attend a vaccine appointment with their loved one.

➤ **Vaccine Appointment Tips**

- If you can, take a picture of your vaccination card. That way you will not have to worry about misplacing it.
- Wear a mask to the appointment.
- [Download and use v-Safe](#), an app that helps you report any reactions you are having to the vaccine.

**What to do If You Receive Your First Dose Outside of the Health Department, but You Are Still in the Health Department's Queue?**

If you receive an appointment with someone else before your scheduled appointment with the Health Department and you want to cancel the latter, wait to receive your email confirming your appointment (email 3 – titled: "Notice of Appointment Confirmation" and go to the bottom of the email where you can click "Cancel Appointment." Or, you can call (703) 324-7404 to cancel your appointment.

**Fairfax County has partnered with Trusted Doctors**

The Fairfax County Health Department has partnered with Trusted Doctors this week to help vaccinate people on the county's waitlist. Trusted Doctors is a local health care practice that will provide first-dose vaccinations to about 800 people who were at the top of our registration queue. These individuals received an email link to make a vaccination appointment through Trusted Doctors, and the vaccine is being provided by the Health Department. The health care practice is performing vaccination over the weekend of February 6 by appointment only.

**CVS Plans to Give Vaccine Appointments at Select Virginia Locations**

Beginning Thursday, February 11, up to 36 CVS locations in Virginia plan to offer COVID-19 vaccine appointments for eligible people under phase 1a and phase 1b. CVS will begin to register these individuals Tuesday, February 9.



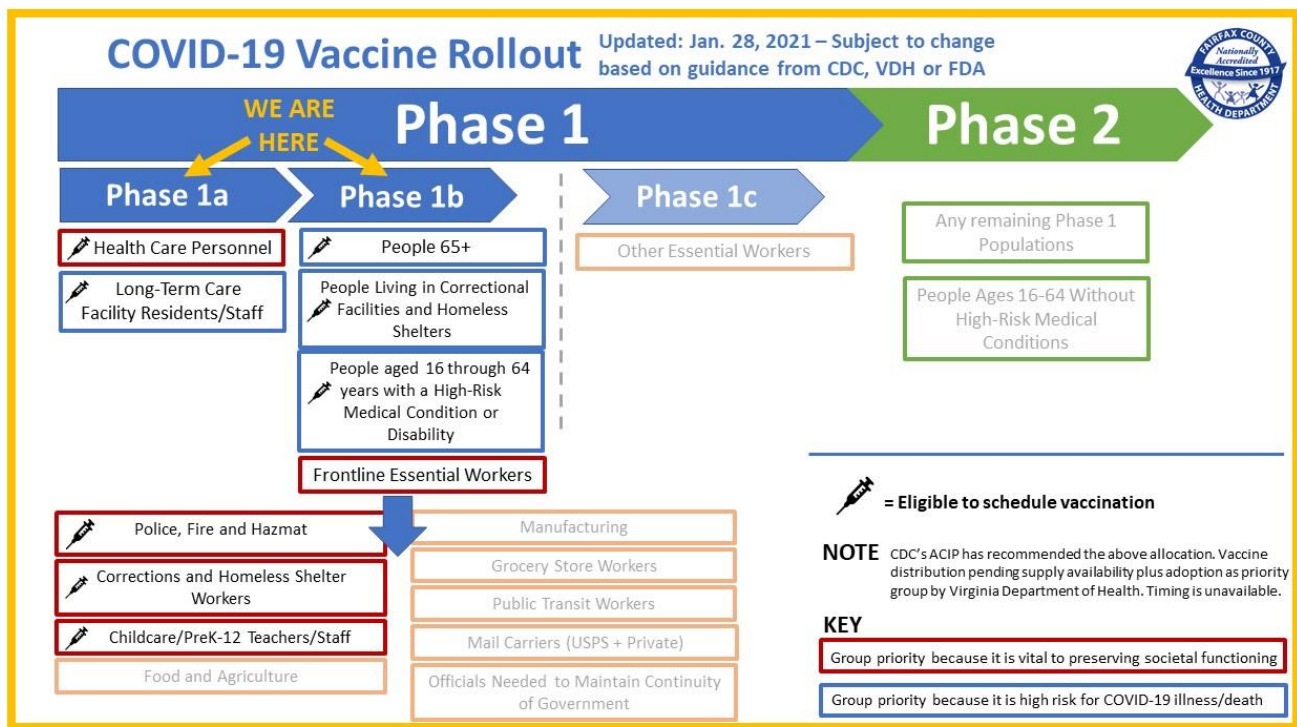

# Environmental News

## Long Branch Central Watershed Management Area Project Update

A community meeting on the Long Branch Central Watershed Management Area Project is scheduled for Thursday, February 11, at 7:00 p.m. This meeting will provide an update on the project, solicit input about the watershed condition, introduce the work plan to be developed in late spring of 2021, and introduce some of the project partners. The [Long Branch Central Watershed Management Area Project](#) is a collaborative effort of the Department of Public Works and Environmental Services, the Fairfax County Park Authority, and the Northern Virginia Soil and Water Conservation District. The project was developed because Long Branch Central was declared an impaired water area by the Virginia Department of Environmental Quality (DEQ).

The primary goals of the project are to:

- Meet the Long Branch Central waste load reduction requirements
- Improve water quality within the Long Branch Central Watershed
- Improve habitat and environmental health

A project implementation plan is being developed as a result of the study, and community input is expected to be completed by April 2021. ## **Yard Waste Collection**

Fairfax County began the transition away from the use of plastic bags for yard waste collection in March 2020. During the recent Board of Supervisors meeting on January 26, authorization to advertise a Public Hearing to consider amendments to the county's Solid Waste Management Ordinance, Chapter 109.1, was approved. Please note that if passed, this amendment would prohibit the use of plastic bags for the set-out and collection of yard waste. The public hearing will be held on February 23, 2021, at 4:00 p.m.



## **Community-wide Energy and Climate Action Plan**

Fairfax County is in the midst of developing its first-ever Community-wide Energy and Climate Action Plan, or CECAP. Climate change occurs when greenhouse gases build up in our atmosphere and trap heat that might otherwise escape, causing shifts in global temperatures and weather patterns over time. The cars and trucks on our roads are one of the top two sources of greenhouse gases in Fairfax County.

In fiscal year 2020, Fairfax County residents owned and operated 933,452 vehicles. In a single year, that many vehicles consume more than 10.6 million barrels of oil. It would take 76 million trees ten years to counteract the carbon produced by these vehicles. Although it would be impractical to plant 76 million trees in Fairfax County, we can take other action. Addressing our greenhouse gas emissions now is a wise investment in our future. This problem will not go away on its own and we will end up paying for it one way or another.

The Fairfax County CECAP is unique in that it is being developed by the community, for the community, with input from dozens of organizational, business, and civic leaders, as well as individual residents. The CECAP will outline greenhouse gas reduction goals for the community and will include recommended strategies and actions community members can take on a voluntary basis to help achieve the goals.



Later this month, online surveys will be available, and the county will host public meetings to gather community input on climate change mitigation strategies and actions. The County will share more information about opportunities for you to participate in the coming weeks.

# Transportation Updates

## Burke Centre VRE Trail Project

On December 14, 2020, the bids opened for construction of the Burke Centre VRE Connector Phase IV project. The project will provide 900 linear feet of 8-foot-wide asphalt trail connecting residential neighborhoods between Oak Bluff Court and Premier Court to the Burke Centre VRE Station, and 715 feet of concrete sidewalk, 365 feet of concrete retaining wall, and related work in the Braddock District. This project is included in the FY 2021-FY 2025 Adopted Capital Improvement Program (With future years to 2030) and is part of the Board's Transportation Priorities Plan adopted on January 28, 2014 and amended on December 3, 2019.

- The project will provide improved pedestrian and bicycle connectivity and safer access to the Burke Centre VRE Station, thereby reducing vehicle trips to the station by commuters.
- Construction work on this project is expected to begin about April 1, 2021. Substantial completion is expected by April 2022.

## Bus Stop Improvement

Fairfax County Department of Transportation (FCDOT) has a project to improve the bus stop at Braddock Road and Dunleigh Drive. The bus shelter is now being fabricated, and the improvements should be completed in April 2021.

## Metrobus 29W Update

As you may have heard, WMATA intends to cancel the Metrobus Route 29W. However, the Fairfax Connector has proposed a service change introducing Route 835 as a replacement for the Metrobus Route 29W. For additional information, visit the [Connector website](#).

You can also view the [Power Point presentation](#) (with route maps) (see slides 22 and 23 for specific information on the proposed Route 835). The proposed service changes will go to the Board of Supervisors in Spring 2021 for approval. If approved, service will begin in July 2021.

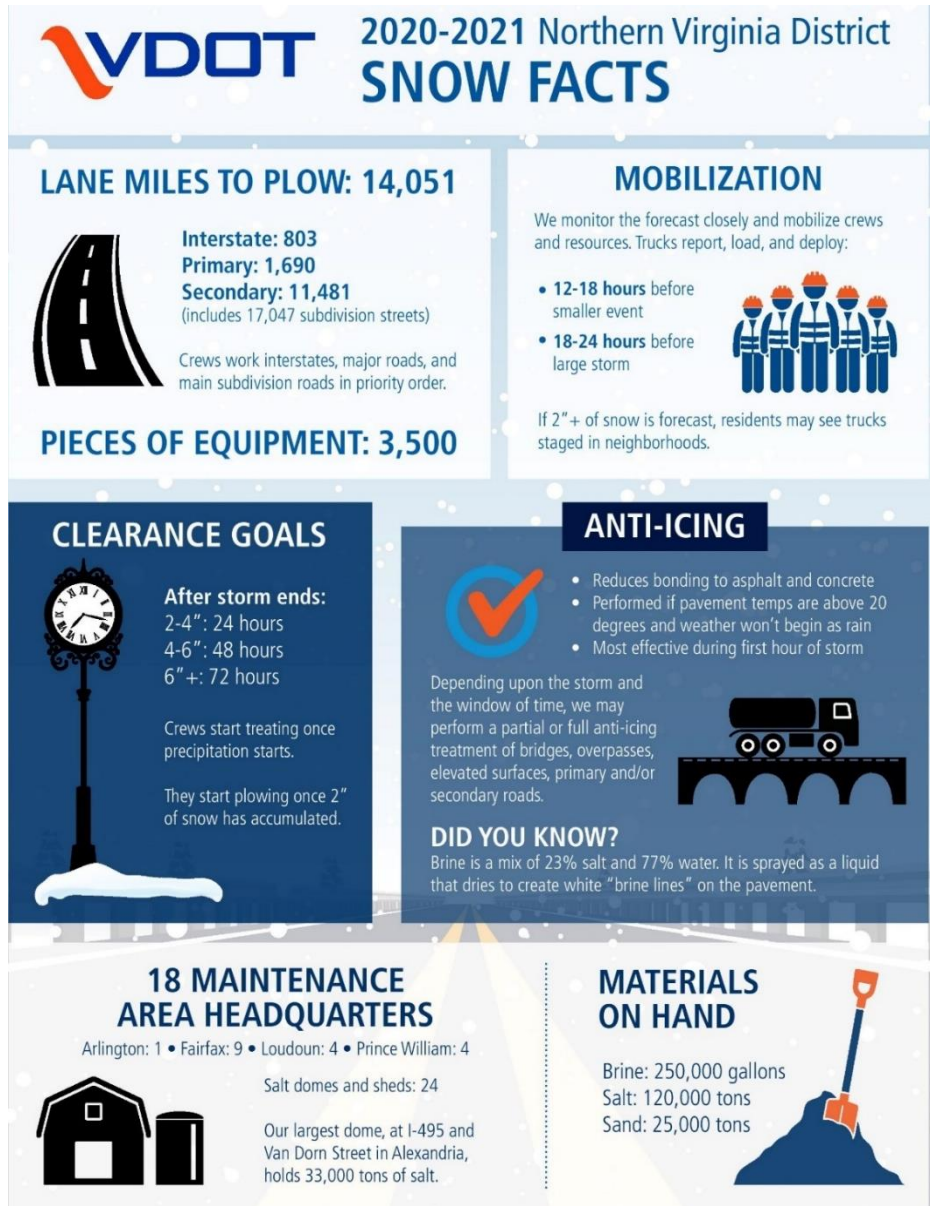
## Fairfax County Transit Strategic Plan Major Update

### **Board of Supervisors Approves Use of Parking Lots G&H at Government Center Complex for Potential Affordable Housing**

At its January 26 meeting, the Board of Supervisors approved Supervisor Walkinshaw's motion to transfer the ownership of a portion of excess surface parking at the Government Center to the Fairfax County Redevelopment and Housing Authority (FCRHA) for the potential development of a new affordable housing complex. Use of this site could help address the critical shortage of affordable housing in Fairfax County.



The Government Center complex is currently overserved by parking spaces. Working with county staff, Supervisor Walkinshaw identified Parking Lots G and H, approximately a 3.5-acre area containing about 340 parking spaces, as a potential site for redevelopment. Transferring ownership of this property will allow the FCRHA to explore development options through the Public-Private Education Facilities Education and Infrastructure Act of 2002 (PPEA). In 2017, the PPEA was used to deliver the Residences at Government Center, an award-winning, extremely successful housing development that provided 270 workforce housing units. Similarly, this site could provide affordable housing to serve up to 250 low- and moderate-income households. It is located near employment opportunities, bus transit, is in walking distance of an elementary school, is near recreation and commercial amenities, and would be in walking distance of a future Metro extension of the Orange Line from Vienna. Because it is already paved, use of this land would not have the negative environmental impacts associated with many other sites.

A potential development partner will be selected through a competitive process in accordance with the PPEA. There will be opportunities for community input and feedback on design concepts and local impacts as the project moves through the Comprehensive Plan Amendment and land use processes expected to begin later this year.



## **Planning Commission Decision on Zoning Ordinance Modernization Draft Scheduled for February 10 – New Standards for Flags and Flagpoles Added**

Supervisor Walkinshaw held a virtual community meeting on January 25 to discuss the changes proposed in the Zoning Ordinance Modernization Project, or zMOD. [Click here](#) to watch a recording of the meeting. More than 40 residents participated in the meeting. Both Supervisor Walkinshaw and Planning Commissioner Mary Cortina heard comments and concerns about proposed changes on a variety of issues, including Accessory Living Units (ALUs), home-based businesses, accessory structures, signage, and food trucks.

What is zMOD? In 2017, the county began working to update its 42-year-old Zoning Ordinance, which regulates land use and development in Fairfax County. The proposed new Ordinance is intended to be easier to read and understand through the use of tables and illustrations and plain language. It is designed to be more flexible to accommodate existing and emerging trends. The revised Zoning Ordinance will also be more accessible online, including on mobile devices. Most uses, permissions, and standards are being carried forward without change. However, in some instances, emerging uses are identified (such as data centers and solar power facilities), similar uses are consolidated (such as indoor recreational uses), and outdated standards are being updated to reflect current practices. The outreach process has included 96 in-person and virtual community meetings, including presentations to the Braddock District Land Use and Environment Committee and the Braddock District Council.

Proposed changes relating to flags and flagpoles were recently added to the zMOD draft. Because they weren't in the version published for the Planning Commission hearing on January 28, a separate hearing on these provisions will be held as part of the Planning Commission's February 10 meeting. Currently, up to 3 flags are allowed per lot with no size limit, flagpoles do not have height requirements, and flagpoles are permitted in a front yard and are subject to location regulations for accessory structures in the side and rear yards. Based on research and a review of neighboring jurisdictions, staff has proposed the following standards be included as part of the zMOD project:

- The height of a flagpole would be limited to 25 feet for a lot developed with a single-family dwelling and 60 feet for all other principal uses.
- Freestanding flagpoles must be set back 5 feet from any front lot line or street line and must comply with location regulations in a side or rear yard.
- Up to 2 flags would be allowed on a lot developed with a single-family dwelling and up to 3 flags for all other principal uses.
- Flags may be up to 24 square feet in size for a lot developed with a single-family dwelling and 96 square feet for all other principal uses.

Small garden flags typically less than 2 square feet in size would be exempt from the limit of 2 flags for a lot with a single-family dwelling. For comparison, flagpoles at Fairfax County Public Schools are typically 25 feet in height and those outside the Government Center are about 60 feet in height.

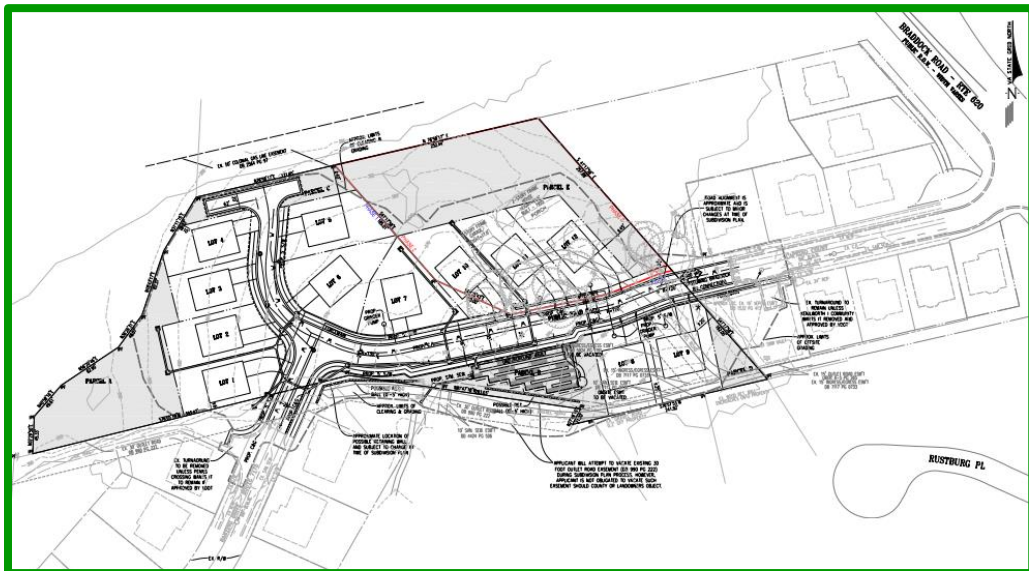

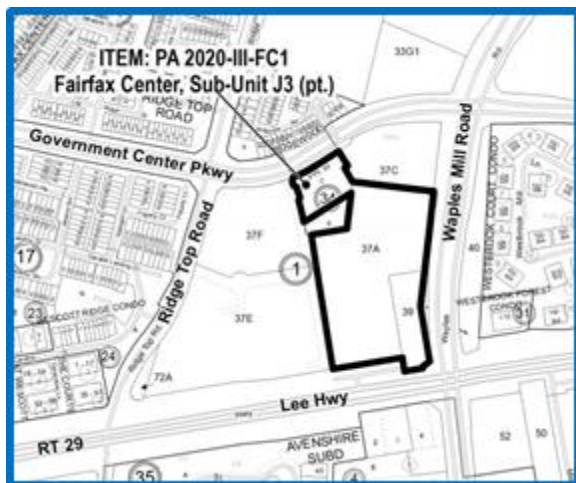

## Revised Plan Submitted for Second Phase of Kenilworth Development – Community Meeting on March 2

Christopher Land, LLC has submitted a revised rezoning application for approximately 4.43 acres of land located just south of the Kenilworth community at Caprino Court and Braddock Road. This property is currently developed with one single-family home built in 1955 that will continue to be occupied by the current owner and would be included in a subsequent phase of the project. The applicant is requesting to rezone this land from the R-1 District to the PDH-3 District to build 12 single-family detached dwelling units at a density of 2.71 dwelling units per acre. Nine houses would be constructed in phase one, and an additional three houses would be part of phase two, when the existing house is removed. Access would be provided by connecting Banting Drive and Caprino Court. The revised design would configure the connection as a “T” intersection.



Supervisor Walkinshaw plans to hold a virtual community meeting on March 2 at 7:00 p.m. for the developers to present their plan and for residents to ask questions of the developer and provide input. The link will be sent out in upcoming Advisories and posted on our website. The Braddock District Land Use and Environment Committee will discuss the application at its March meeting. A hearing before the Planning Commission has been scheduled for April 21.



## Comprehensive Plan for Northwest Corner of Lee Highway & Waples Mill Road

The northwest corner of the intersection of Lee Highway and Waples Mill Road contains an older house and an outbuilding that was formerly used as a contractor's office and workshop. An existing Public Storage facility surrounds the property on the north and west. The corner lot is for sale and Public Storage has expressed interest in expanding its self-storage use onto that property. This area is planned for office use with an option for office/mixed use should it be

redeveloped. The intersection is also planned for a potential interchange after Shirley Gate Road is extended to the Fairfax County Parkway.

Early last year, at Supervisor Walkinshaw's request, county planning staff began considering a Comprehensive Plan Amendment for both the corner lot and the surrounding Public Storage property to ensure that the plan for this corner remains in line with the vision for Fairfax Center. During this review, consideration is being given to what options might be appropriate for the site, whether self-storage or alternative uses. Particular attention is being paid to architecture and design, landscaping, pedestrian improvements, and park/recreational space.

County planning staff and representatives of Public Storage have been meeting for several months to try to come to agreement on general concepts. The Braddock District Land Use and Environment Committee provided additional comments at its November meeting. Based on that feedback, along with staff comments, Public Storage has proposed modifications to their proposal. They will be presenting an update at the Committee's February 16 meeting. A staff report is being developed and is expected this spring.

A concurrent rezoning application has been filed by Public Storage Southeast One, Inc. to consolidate the corner parcel with their existing self-storage property. Public Storage is proposing to demolish one row of its existing single-story self-storage bays and construct a climate-controlled five-story self-storage facility of approximately 150,000 square feet on the southeast corner of the property. Access to the site would be provided through a modified and improved entrance along Lee Highway designed per VDOT standards and the existing service drive that is being used for parking of commercial vehicles, including food trucks, would be removed. Consideration of the rezoning application has been deferred during discussion of the revised Comprehensive Plan.

## **Rezoning Filed for Annandale United Methodist Church**

The Trustees of Annandale United Methodist Church have filed a rezoning application for their 1.77-acre property located on the west side of Heritage Drive and adjacent to Heritage Mall. The existing building was constructed and originally used solely as a place of worship. However, more recently, the Church has increasingly used the site to provide social services to address significant unmet needs in the surrounding community. Residents in the area walk to the Church property to access a food pantry and clothes closet operated by Church volunteers. In response to the COVID-19 pandemic, the Church collaborated with Chef Jose Andres of the World Central Kitchen to coordinate and distribute over 18,000 meals in the Annandale community. Many of these meals were targeted to families who were unable to access free and reduced meals from Fairfax County Public Schools.

The Church now proposes to formalize this operation and, in addition to the place of worship, create a community resource center that will provide a range of supportive educational and healthcare services, including a robust food distribution program, health and wellness screenings, and a mobile dental clinic, among other initiatives. They intend to expand existing collaborations with the Fairfax County Health Department, Department of Family Services, and Neighborhood and Community Services; Food for Others, George Mason University, Northern Virginia Community College; Medical Care for Children Partnership Foundation; and other public and charitable organizations.

Under the county's Zoning Ordinance, this operation would be considered a Public Benefit Association. However, the site is currently split zoned to the C-5 and R-20 Districts. Given this unique split zoning, such a use is not permitted on the residential, or R-20, portion of the property,

which encompasses nearly half of the building. For that reason, the Church has filed an application to rezone the property to entirely C-5, which would allow the public benefit use to legally operate and expand the valuable work and services it provides to the community. No construction or physical changes to the existing site or buildings is planned. The Church will re-stripe the existing travel aisle and parking spaces in accordance with recommendations from the Fairfax County Fire Marshal.

Supervisor Walkinshaw made a motion, cosponsored by Supervisor Penny Gross of the Mason District, which is just across Heritage Drive, to expedite the processing of this application. It was approved by the Board of Supervisors on January 26. A hearing in front of the Planning Commission is scheduled for June 16, and the application is scheduled for a Board hearing on July 21.

## **Demolition of Former NVTC Buildings Underway**

Demolition of the old Northern Virginia Training Center (NVTC) buildings on Braddock Road began this week. This is in preparation for Erickson Living's construction of Woodleigh Chase, a new continuing care community. Please remember that this is an active demolition/construction site and it is unsafe for community members to be on the premises. Erickson will be stepping up security efforts in an effort to keep everyone safe. The building demolition for the entire property is expected to continue through August 2021. Construction

## **Update on Erickson Living's Affordable Senior Housing Site**

Erickson Living has finalized an agreement with the Arlington Partnership for Affordable Housing (APAH) for development of the age-restricted affordable housing component of the project at the former NVTC site. APAH is a nonprofit affordable housing developer with over 30 years' experience in developing and managing quality affordable housing for Northern Virginia residents. This portion of the development will be constructed on 4.3 acres on the western portion of the property, where the group homes were located. It will provide 80 units of affordable age-restricted housing. APAH is in the process of designing the building and will be briefly updating the Braddock District Land Use and Environment Committee at its February 16 meeting.



## **Braddock District Land Use and Environment Committee**

The Braddock District Land Use and Environment Committee will be holding an electronic meeting on Tuesday, February 16, at 7:00 p.m. The agenda is expected to include a brief update from the Arlington Partnership for Affordable Housing on its plans for affordable senior housing at the Erickson site, a presentation on the latest plans for the Public Storage site, and a discussion about the RFP process for potential affordable housing at the Government Center complex. Details on how to connect to the meeting will be posted on the Braddock District website three days in advance. Braddock District Land Use and Environment Committee meetings are open to the public and interested residents are encouraged to participate.

## **Cases Filed With the Board of Zoning Appeals**

The Fairfax County Board of Zoning Appeals (BZA) hears and makes decisions on requests for variances (relief from specific zoning regulations such as lot width, building height, or minimum yard requirements) and Special Use Permits. It meets on Wednesdays beginning at 9:00 a.m. Meetings are currently being held electronically with distance participation due to the State of Emergency caused by the COVID-19 pandemic. BZA meetings are aired live on the county government's cable TV [Channel 16](#). Residents who have concerns about an application are encouraged to submit a letter for the record or testify by phone or video at the hearing on the case. These matters will not come before the Board of Supervisors but will be decided by the BZA. Staff reports are normally available online a week before the scheduled hearing.

### **➤ Deborah P. Buchanan – 10110 Round Top Court, Fairfax SP 2020-BR-075**

The applicant requested modifications to the limitations on the keeping of animals to keep 4 dogs on the site. The Zoning Ordinance allows 1 or 2 dogs to be kept on a lot of this size, 10,537 square feet, without Special Permit approval. On January 13, the BZA approved keeping 3 dogs onsite with modification to the development conditions requiring the applicant to refrain from participating in dog fostering, dog rescue, dog-sitting, boarding, or any other activity which would result in the number of dogs being kept on the property exceeding this maximum. ### **➤ George E. Karch and Laquetta A. Karch – 4817 Marymead Drive, Fairfax SP 2020-BR-071**

The applicants are seeking modifications to the limitations on the keeping of animals to keep up to 21 chickens on a 0.68-acre property. The chickens would be kept in a coop with a fenced run. The Zoning Ordinance allows chickens to only be kept on lots that are two acres or greater without Special Permit approval. Staff recommended a maximum of ten chickens be allowed and recommended a development condition requiring all activities related to the management of chickens to be kept outside of the Resource Protection

Area, including location of the coop, chicken run, and composting area. A hearing on this application was held on January 13 and the BZA deferred their decision until February 24. The applicant is seeking a reduction to minimum yard requirements based on an error in building location to permit an accessory storage structure to remain 2.9 feet from a rear lot line. The applicant is seeking a modification to the limitations on the keeping of animals to raise and keep up to 12 chickens and 4 ducks for meat and eggs on a 0.65-acre lot. The Zoning Ordinance allows chickens and ducks to only be kept on lots that are two acres or greater without Special Permit approval. This application is scheduled to go before the BZA on February 10.
