Braddock Road Park and Ride Lot Survey Pending

Supervisor Cook is asking for community members to respond to an [online survey](#) regarding the potential construction of a 260-space commuter park and ride lot behind the Kings Park Shopping Center (along Braddock Road) as part of the [Braddock Road Improvement Project](#). The park and ride lot, if desired by the community, would be constructed with a number of goals in mind.

The park and ride lot would provide additional parking at the shopping center- which some residents have described as inadequate. It would provide parking for commuters, who may be parking on side streets in nearby neighborhoods. The park and ride would encourage alternative commuting options throughout the corridor by providing the potential for slugging and easing access to bus routes, which would improve traffic flow on Braddock Road.

This is, and will continue to be, a deliberative process, and Supervisor Cook encourages you to share your thoughts about the possible impacts this may have on the surrounding area. In addition to the survey, residents may provide their comments [online](#).

Diversion First Program to Receive Award from the National Association of Counties (NACO) Annual Conference in July

Fairfax County’s Fairfax-Falls Church Community Services Board; Fire and Rescue; Office of the Sheriff; the Police Department; Juvenile and Domestic Relations District Court; and the Office of Public Affairs will receive an award for Diversion First from the National Association of Counties Annual Conference July 21 through 24, 2017, in Columbus, Ohio.

Diversion First is a program which offers alternatives to incarceration for people with mental illness or developmental disabilities who come into contact with the criminal justice system for low level offenses. Diversion First changes the way behavioral health and criminal justice systems interact, resulting in better outcomes for individuals and the community. The program is designed to prevent repeat encounters with the criminal justice system, improve public safety and promote a healthier community. As the Chair of the County’s Public Safety Committee, Supervisor Cook offers congratulations to all for their hard work.

Cooling Assistance and Fan Care Programs

Fairfax County residents who need help to keep their homes cool this summer and to prevent a health emergency resulting from extreme heat may be able to get assistance from two programs locally administered by the county’s Department of Family Services. The [Cooling Assistance program](#), a federally funded program, helps eligible low-income households with at least one person considered especially vulnerable to heat: a child under age six, a disabled individual, or an adult age 60 or older. Cooling assistance can be used to help with:

- Payment of electric bills to operate cooling equipment.
- Payment of security deposits for electricity to operate cooling equipment.
- Repair of a central air conditioning system or heat pump.
- Purchase of a whole-house fan, including ceiling or attic fans.
- Purchase and installation of one window unit air conditioner for households where there is no unit or where the unit must be replaced.

Applications for the Cooling Assistance Program will be accepted from June 15 through August 15.

Royal Lake Ribbon Cutting Ceremony Saturday, July 15

Thunderstorms forced postponement of the ribbon cutting ceremony at Royal Lake, but it has been rescheduled for Saturday, July 15, 1:00 p.m., at Lakeside Park. This event will celebrate the completion of the Royal Lake dredging project. Supervisor Cook will be joined by Chairman Sharon Bulova and representatives from the Park Authority, Department of Public Works and Environmental Services, Northern Virginia Soil and Water Conservation District, and Friends of Royal Lake. Native Plant Rescue Volunteers Needed

Are you interested in helping rescue native plants? Plans are currently underway to conduct a native plant rescue operation at the site of the Pohick Creek Tributary at Queen Victoria Stream Restoration Project in the Southport/Signal Hill neighborhoods near Lake Braddock High School. Along with the guidance of knowledgeable experts, community volunteers can rescue native plants and transplant them to designated “safe” areas along the streambed where they will be preserved. Representatives from the Southport HOA and members of Supervisor Cook’s office walked this area last month with Fairfax County landscape architect Suzanne Foster. Some of the native plants identified include Jack-in-the-pulpit, Mayapple, Christmas and lady ferns, pawpaw, lion’s paw, viburnum, false soloman’s seal, wild rye, and sedge. Fairfax Master Naturalists Fall Training—Applications Now Open!

Are you curious about nature, enjoy the outdoors, and want to be part of natural resource management and conservation in Virginia? Accotink Creek Sediment and Chloride TMDL Study

The final public meeting was held on June 28 for the Accotink Creek Sediment and Chloride TMDL (Total Maximum Daily Load) Study to develop TMDL standards for the Accotink Watershed. The Virginia Department of Environmental Quality (DEQ) has studied the Accotink Creek watershed and identified streams impacted by excessive sediment and seasonally elevated levels of chloride. While these impacts happen naturally, larger amounts are ending up in streams due to human activity, such as an increase in impervious hard surfaces like pavement, rooftops, and sidewalks, and the use of salts to melt snow and ice. To stabilize these waterways, DEQ has developed watershed restoration plans to reduce these factors. You can learn more about the project in our area by visiting <http://accotink.org/TMDL.htm>. Public comments can be submitted through July 21, 2017. Once the report is finalized, it will be submitted to the State Water Control Board and then the EPA for approval. The recommendations will then be incorporated into future permits, as appropriate. If you have any further questions, please contact the office of Supervisor Cook at 703-425-9300.

Land Use Update

Second Community Meeting on Stormwater/Wastewater Consolidated Facility at Freds Oak Road Planned for July 31

On May 23, Supervisor Cook held a community meeting to discuss a proposed consolidation of the county's Stormwater Planning Division, Maintenance and Stormwater Management Division, and Wastewater Collection Division operations on two parcels of land located at Freds Oak Road and the Fairfax County Parkway. Representatives from the Department of Public Works and Environmental Services (DPWES) presented the community with an overview of the proposal and showed three possible layouts. The PowerPoint presentation from the meeting is available [online](#).

Residents raised a number of questions about traffic, lighting, and noise that could result from the proposed facility and DPWES and its consultants have been working to gather more information. **A second community meeting has been scheduled to respond to those questions and further discuss the proposal. It will be held on Monday, July 31, at the Burke Centre Conservancy's Woods Community Center, 10100 Wards Grove Circle, Burke, 7:30 p.m.** All interested community members are encouraged to attend.

Again, because this is a proposed county government facility, the proposal will be considered under the 2232 Review Process. Under this process, a public hearing will be held before the Planning Commission. Following the public hearing, the Planning Commission will determine if the proposal is in substantial accord with the county's Comprehensive Plan and approve, deny, or defer decision. The proposal will not go before the Board of Supervisors for consideration. However, Supervisor Cook is hosting these informational meetings because of the potential impacts on the community.

What is the Zoning Ordinance and How Does It Affect Me?

The Zoning Ordinance of Fairfax County contains the regulations that prescribe the way land can be divided and used in order to promote the health, safety, and general welfare of the public and to implement the adopted Comprehensive Plan for the orderly and controlled development of Fairfax County. The Zoning Ordinance specifies acceptable uses (residential, commercial, or industrial), density of uses, building heights, placement of buildings (setbacks from lot lines), and parking. In essence, it defines what a person can do with his or her land.

There are two significant projects underway that affect the Zoning Ordinance. The first is the annual Zoning Ordinance Amendment Work Program, which was initiated in 1983 and outlines requested changes to the Zoning Ordinance from the Board of Supervisors, Planning Commission, Board of Zoning Appeals, citizens, industry representatives, and county staff. A second parallel effort is the Zoning Ordinance Modernization Project, known as “zMod,” which was described in last month’s Beacon. The county will be seeking input from citizens as various proposals are considered.

Two proposals of particular interest because of their direct impact on residents are listed below, short-term rentals and rear yard coverage. Other proposals currently under consideration include minor modifications provisions, combining use categories related to restaurants and fast food, and the sign ordinance. Zoning—Feedback Wanted on Short-Term Rentals

Fairfax County is considering new Zoning Ordinance regulations for short-term rentals. A short-term rental refers to any home, condo, apartment, or portion of a home rented for less than 30 days, typically on websites such as Airbnb, HomeAway, VRBO, FlipKey, and Roomarama. Earlier this year, the General Assembly passed legislation clarifying that local governments like Fairfax County have the authority to require registration of short-term rentals.

Currently, the Fairfax County Zoning Ordinance prohibits property owners from renting their homes as short-term rentals unless the Board of Supervisors approves a Special Exception for a bed and breakfast use. A Special Exception use can only be considered in the R-P through R-2 or PDH or PRC planned development districts.

As a result of the General Assembly action, a working group has been created to craft a draft proposal which seeks to balance residents’ interests to protect the character of their neighborhood with the interests of those who want to operate short-term rentals within their residences. The regulations may address:

- Where short-term rentals would be allowed in the county
- How often spaces could be rented out
- What types of properties could be rented out
- How many people would be allowed to stay at a property at any one time

This survey is just the first step in the effort to draft possible rules. The Department of Planning and Zoning will be seeking more public feedback this summer. Any proposed regulations must ultimately be approved by the Board of Supervisors, and hearings are not expected until late this year.
