## George Mason University “Innovation District” Could Have Far-Reaching Community Impacts

On May 22-24, 2017, George Mason University hosted a three-day strategic campus-planning workshop and invited community members to participate in the University’s process of exploring options for the future use of the West Campus (Mason’s property west of Route 123). This was promoted as the “Fairfax West Campus Vision.”

At the workshop, Mason unveiled a proposal to build an “innovation district.” Such districts, by the Brookings Institution definition, are geographic areas where leading-edge anchor institutions and companies cluster and connect with start-ups, business incubators, and accelerators. Several of these districts have been built on college campuses, and Mason is considering this innovation district model for the expansion of its Fairfax Campus. The district could contain numerous additional buildings, hundreds of small businesses, an undetermined number of additional students, commercial and retail establishments, and other amenities. Mason envisions Campus Drive, recently built as a transportation bypass to the busy Braddock Road – Route 123 intersection, as a new “main street.” The district would straddle Route 123 and perhaps lower the speed limit to permit more pedestrian use across this busy thoroughfare.

This proposal is striking in its innovation and economic potential, but should be of concern to those who live in the communities surrounding Mason’s Fairfax campus. While Mason faces unique challenges with its location, and seeks to provide amenities to its students, campus growth must be harmonious with the thoughts and input of the surrounding community. The proposed plan is not consistent with the County’s comprehensive plan (although Mason, as a state entity, is exempt from following county zoning.) At the Board of Supervisors meeting of June 6, I asked county staff, including planning and zoning and transportation staff, to review this proposal and report back to the Board within 90 days on its potential impact to the surrounding communities and to the county’s transportation planning. The Board unanimously supported this request.

Until then, I will continue to research the potential impacts this proposal may have on the surrounding community, if implemented. I plan to take this matter to the Fairfax Campus Advisory Board, and if it continues to move forward, will make sure there are sufficient opportunities for community input. ## I-66 Toll Lane Ramps Design Community Meeting Scheduled

On May 9, the Virginia Department of Transportation (VDOT) presented outlines of new designs for toll lane ramps to and from Interstate 66 to the Fairfax County Board of Supervisors. A proposal of interest to residents of the Random Hills area introduced access from the regular I-66 lanes to the toll lanes near U.S. 50. Supervisor Cook would like all Braddock residents to know that they have the opportunity to [learn more](#) about these designs at a public meeting in the cafeteria of Oakton High School (2900 Sutton Road, Vienna) on June 12. The meeting will take place from 6-8:30 p.m. A brief presentation will begin at 7 p.m., followed by a question and answer session. The final formal public hearing will be scheduled this fall after design plans are refined.

## Braddock Lord and Lady Fairfax

Each year, the supervisor from each of the County's magisterial district's is invited to nominate a Lord and Lady Fairfax- individuals who have shown tremendous dedication to their neighbors through community involvement. ### Mary Cortina

Mary Cortina grew up in West Springfield and has been an active volunteer in the Braddock District for two decades. She currently serves as the Vice Chair of the Fairfax County Park Authority Board. An at-large member since 2013, Ms. Cortina chairs the Strategic Planning and Budget Committees and serves as the liaison for volunteer groups and trails. Ms. Cortina served on the Chesapeake Bay Preservation Ordinance Exception Review Committee from 2007-2015 and on the Braddock District Land Use Task Force for several years previous to that.

In the early 2000's, she lead a Burke Centre Conservancy task force that participated in designing the county's Virginia Railway Express (VRE) garage and improving pedestrian/bicycle access to the VRE from Burke neighborhoods. Ms. Cortina's other volunteer service over the years has included the Women in Technology Education Foundation, the Burke Centre Wildlife Committee, Spring-Mar Preschool fundraising, Wakefield Forest PTA and her local Truro community. A graduate of George Mason University, Ms. Cortina was formerly the E-Commerce Director for the National Railroad Passenger Corporation's Amtrak.com and IT Director for The National Wildlife Federation.

### Kevin Morse

A Fairfax County resident since 1982, Kevin Morse has gifted much of his time to county efforts, including his work as President of Woodwalk Condominiums and the Braddock Representative on the Fairfax County Transportation Advisory Commission. He is also the Chairman of the Braddock Road Task Force, a citizen task force formed in 2014 to review and recommend improvements to Braddock Road from Guinea Road to I-495. Mr. Morse also previously served as Treasurer of the Braddock District Council and as a member of the Burke Centre VRE Station Garage Committee, as well as several other committees in Burke Centre and the Braddock District.

# Pedestrian Improvements at Burke Center Parkway & Marshall Pond 50% Complete

Fairfax County's Safe Routes to Schools (SRTS) application at Terra Centre Elementary School was selected by the Virginia Department of Transportation (VDOT) to receive \$150,000 in funding for major pedestrian improvements. The funding will provide pedestrian improvements to the median refuge island and narrow the travel lanes to shorten crossing distances at the intersection of Burke Centre Parkway and Marshall Pond Road/Schoolhouse Woods Road, near Terra Centre Elementary School. The Fairfax County Department of Public Works (DPW) has reported that the project is 50% complete. The milling, paving, and permanent line markings are the major activities that remain. These should be completed in June.

## Code Compliance Corner

The topic for the June edition of Code Compliance Corner is [Accessory Storage Structures](#). Did you know that the Zoning Ordinance regulates the location of all storage structures and that a Building Permit may be required to assure that it is located within required setbacks and meets required height restrictions? If you feel that a storage structure has been constructed too close to your property line or it exceeds 8.5' in height, or if it has been constructed without the appropriate building permits, you may contact [DCC](#) to file a complaint.

## Environmental Update

### Royal Lake Ribbon Cutting Ceremony on June 19

A ribbon cutting ceremony has been scheduled for Monday, June 19, 6:00 p.m., at Lakeside Park, to officially celebrate the completion of the Royal Lake dredging project. In addition to Supervisor Cook, we expect Chairman Sharon Bulova and representatives from the Park Authority, Department of Public Works and Environmental Services, Northern Virginia Soil and Water Conservation District, and Friends of Royal Lake to be in attendance. Please come join in marking this milestone.

Dredging at Royal Lake began in June 2016 and was recently completed ahead of schedule. Approximately 80,000 cubic yards of sediment was removed, 20,000 cubic yards more than originally planned. The project included stream restoration, lake restoration, landscaping (some of which will be completed this fall when the weather is cooler), and upgrades to the lake's structure, including forebays to help prevent sediment from going into the lake and reduce the need for future dredging. The lake will be restocked with native fish in stages over the next couple of years.

## Land Use Update

### Community Meeting on Stormwater/Wastewater Consolidated Facility at Freds Oak Road

Supervisor Cook held a community meeting on May 23 to discuss a proposed consolidation of the county's Stormwater Planning Division, Maintenance and Stormwater Management Division, and Wastewater Collection Division operations on two parcels of land located at Freds Oak Road and the Fairfax County Parkway. One parcel is currently occupied by the Wastewater Collection Division and the adjacent second property is owned by Virginia Concrete. The facility would provide efficiencies by consolidating administrative offices and meeting rooms, locker rooms, testing and analysis labs, maintenance shops, industrial shops, warehousing space, service vehicle parking, fuel dispensing, and equipment and material storage yards. The proposed facility would house administrative offices and storage, not actual treatment operations.

Representatives from the Department of Public Works and Environmental Services (DPWES) presented the community with an [overview](#) of the proposal and showed three possible layouts. Residents then had an opportunity to ask questions and provide feedback. While some questions were about lighting and noise, the majority focused on traffic. Concerns raised included hours of operation, how the new facility would be accessed, effects on neighborhood traffic, and the safety and feasibility of making left turns from Freds Oak Road onto the Fairfax County Parkway.

DPWES has taken the issues raised by the community and is working to gather more information, particularly with regard to the traffic analysis. They will also provide additional metrics so residents can better understand what is being considered for the site and the impacts on those who live nearby. A second community meeting will be scheduled during the summer to answer the questions raised at the May meeting and to further discuss the proposal for the combined facility. A community walk will also be arranged so residents can better understand the screening that would be provided, cutoff lighting to be used, and measures to limit noise.

Because this is a proposed county government facility, the proposal will be considered under the 2232 Review Process. Under this process, a public hearing will be held before the Planning Commission. Following the public hearing, the Planning Commission will determine if the proposal is in substantial accord with the county's Comprehensive Plan and approve, deny, or defer decision. The proposal will not go before the Board of Supervisors for consideration. However, Supervisor Cook is hosting these informational meetings because of the potential impacts on the community. Please look for information on dates, times, and locations for the second community meeting and neighborhood walk in an upcoming Advisory.

## Braddock District Land Use and Environment Committee

The Braddock District Land Use and Environment Committee is a volunteer, independent, and nonpartisan group whose purpose is to review all proposals for modifying existing land use in the Braddock District. The Committee also looks at stormwater and other environmental regulations. It then offers recommendations to Supervisor Cook and Planning Commissioner Hurley.

If you are interested in getting involved with others in the community to review proposals related to land use and environmental matters, including stormwater and tree preservation, you should consider joining the Braddock District Land Use and Environment Committee. Meetings are held on the third Tuesday of each month at 7:30 p.m. in Braddock Hall. Committee meetings are open to the public and citizens are invited to attend. ## Community Council on Land Use Engagement Issues Its Final Report

The Community Council on Land Use Engagement, which was charged with producing a set of recommendations to improve Fairfax County's public outreach and community engagement in the land use and development process, published its final report on June 8. Members of the council included citizens, community association representatives, land use committee members, representatives of developers, and county staff. We particularly thank the Braddock District representatives who served on the Council: Robert Cain, Sherry Fisher, Sandra Lukic Dapoigny, Kevin O'Neill, and Vincent Picciano, as well as Mark O'Meara, who also participated with the group.

The Council noted that the existing citizen engagement process works well in areas where there are active civic and homeowner associations and land use committees. In areas without such associations, or in multi-family or condominium communities without a single point of contact, it has not worked as well. The Council also cited numerous challenges to increasing citizen engagement in the land use process, including competing demands on citizens' time and attention, an emphasis on technical expertise for most county staff involved in land use matters

(as opposed to an emphasis on communications), the sheer size of the County and districts and resulting geographic limitations, and legal restrictions on community engagement such as those resulting from the recently enacted proffer bill in Richmond.

The report contains 21 recommendations on which the group reached consensus divided into three main categories: communication, engagement, and education. In general, the Council recommended that the county better utilize all forms of communication. Traditional forms, including direct mail, newspaper, newsletters, and legal postings (the yellow signs) should be more targeted and clearly written. Other forms of communications, such as email, the FairfaxCounty.gov website, Channel 16, and third-party services like Nextdoor, also offer opportunities to broaden participation. The report recommends that emphasis should be placed on sending better—not necessarily more—information in a timely manner.


The council recommended that the County create a geographically targeted system which would allow residents to sign up to receive land use information specific to their community. It also suggested exploring technological solutions that would allow residents to access and engage in meetings remotely. Revisions to the county website were proposed which would make it easier to find land use information for specific locations and to submit comments. An ongoing Land Use 101 Academy was also supported to help educate citizens on the complicated land use process. More information on the Council can be found [online](#).

## Zoning Ordinance Modernization Project Underway

The county has launched a major initiative to modernize its 40-year-old zoning ordinance. “zMod” is intended to ensure that the zoning ordinance is able to respond to changing circumstances and accommodate uses that we don’t know about today but will be here in the future—emerging trends such as pop-up retail or makerspaces. Key zoning ordinance amendments will be identified for updates. The ordinance will also be reformatted and restructured to make it more user friendly.

As part of the first phase, these areas have been identified for consideration: Streamlining the minor modifications provisions to make them more flexible, allowing the county to better react to changing needs or market conditions; combining uses of similar impact into broader categories for consistency and ease of use, such as creating a general category for eating establishments, fast casual, and fast food; updating regulations relating to signage; and updating the regulations for planned development housing (PDH) districts.

Community outreach will be a key part of this project. A Citizens’ Working Group is being created to review proposals. The Economic Advisory Commission’s Implementation Committee and Northern Virginia Builders Association will also be involved in providing input. Public meetings will be scheduled on specific amendments for county residents to get more specific information and provide comments. We will keep you updated as this process moves forward.
