## Community Input Key to Training Center Site Comprehensive Plan

Your input is needed regarding the future of the former Northern Virginia Training Center site on Braddock Road. That is why I hosted a community meeting last month to talk with residents about the comprehensive planning process we are launching for the site.

The comprehensive planning process will allow the community to express its vision for the Training Center site and the adjacent State Police property. Erickson Living has announced its intent to purchase the 78-acre site from the Commonwealth and is proposing to build an 1,100+ resident continuing care community there. However, this land has never gone through a Comprehensive Plan Review process. The County has begun conducting a community needs assessment to better understand what the area currently lacks or needs to improve on regarding land use, environment, transportation, public facilities, housing, and parks and recreation. We will also host a community meeting in late January to give residents the opportunity to express their opinions on community needs in person.

In order to ensure Braddock residents are involved throughout the comprehensive planning process, I am creating a Training Center Site Task Force. Any Braddock District resident may apply by filling out an application form ([found here](#)). The Task Force will require a significant time commitment from members. The members will be selected the first of December and will begin working in early February. The Task Force will use the needs assessment and community planning meeting as a starting point from which it will develop options for a Comprehensive Plan. These options will be presented to the community at a public meeting in April 2018. The Task Force's work is anticipated to end with a community presentation of its official recommendations in late June 2018.

### **Traffic Advisory Due to Fairfax Water Project**

#### **Temporary Closure of Campus Drive for Fairfax Water Project, November 17 - mid January**

Campus Drive will be closed *to all vehicle, bicycle, and pedestrian traffic* between West Campus Way and Global Lane, beginning Friday, Nov. 17. This is to allow Fairfax Water to construct a new water main. We anticipate this closure will last until mid January. Updates will be provided as they become available.

The university will temporarily open Campus Drive for winter graduation and other major campus events. West Campus shuttles will continue to operate, but only Mason Shuttle buses will be able to pass through the gate to University Drive.

### **Construction Hotline Expands Hours to Evenings and Weekends**

To increase the county's responsiveness to reports of potential construction violations, the Site Construction Hotline is now available on evenings and weekends. The hotline (703-324-7470) was put in place to respond to residents with concerns about development projects in their communities, such as malfunctioning erosion and sedimentation controls, drainage problems, construction beyond or without a county-approved plan or permit, or any activities that may harm the environment, cause safety risks or damage another property. On-call inspectors will now be able to assess and, if necessary, respond immediately to complaints after business hours.

### **VDOT Design Public Hearings Scheduled for Transform 66 Outside the Beltway November 13, 14 and 16, 2017**

The Virginia Department of Transportation (VDOT), in partnership with I-66 Express Mobility Partners (EMP), hosted Design Public Hearings on the Transform 66 Outside the Beltway Project regarding plans for the 22.5 mile corridor from I-495 to University Boulevard in Gainesville. There is still an opportunity for public comment until November 29, 2017.

## Constituent Services

*This is a new section of the Braddock Beacon. This section will let you know of some of the constituent work done by Supervisor Cook's office over the last month. Your tax dollars are hard at work!*

A constituent was out of the Country when a property tax bill arrived. The constituent did not return until after tax bill was due, and was assessed a fine. Staff called the Department of Tax Administration and the issue was resolved to the taxpayer's delight.

A constituent reported concerns about elderly neighbor's ability to continue living in the house since their spouse's death. Provided neighbor with the Aging, Disability and Caregiver Resources Line.

A constituent with a son who has mental health issues was concerned as the Fairfax-Falls Church Community Services Board sent a letter saying her son's services were no longer to be provided by the CSB due to the parents' employment and health insurance status. Staff arranged for the parent and CSB to meet and come to a satisfactory conclusion for all parties.

A constituent wanted to work with George Mason University regarding a campaign to bring handicapped parking to the attention of the general public by personalizing the spaces with pictures of actual people. Constituent found funding for signs but needed an introduction to shopping centers and County owned properties with parking spaces for this to work. Staff provided an introduction for the constituent, and project is in progress.

An elderly couple with a disabled child came to the office to say they hadn't had phone service in 5 months. Staff worked with Verizon and had their phone working the next day.

A parent of disabled child was having difficulty with LogistiCare's only Medicaid/Medicare provider for transportation services in Virginia. Staff contacted the Community Services Board Transportation Coordinator

who worked it out with LogistiCare, and the parent was able to start a new job as the transportation issue was fixed.

## Environment Update

### **Pohick Creek Stream Restoration Project**

The Fairfax County Stormwater Planning Division began work on the Pohick Creek at Queen Victoria Stream Restoration Project the first of November. The project borders the Southport and Signal Hill communities and flows parallel to Queen Victoria Court and Parliament Drive. The project will restore approximately 4,200 linear feet of highly degraded tributaries, including replacement of two pedestrian bridges and removal of one bridge where the outfall pipe will instead be extended. It will:

- Restore the ecological function of the stream corridor by returning incised channel and eroded stream bed/banks to a healthy state
- Create in-stream and riparian habitat for wildlife and develop a healthy ecosystem
- Repair degraded trails and replace unsafe bridges
- Protect property and utility infrastructure
- Improve water quality through the removal of nitrogen, phosphorous, and total suspended solids.

Please note that the trails through the project area will be closed during construction. There will be heavy construction equipment in the area, including excavators, dump trucks, loaders, and backhoes. For your safety, do not use the trails until work is complete and the trails reopen. Please encourage students who may have used these trails in the past to go to/from school to use alternate routes. Construction is expected to continue for approximately 15 months, depending on the weather, and be completed in March 2019.

### **Ian Walker Receives Friends of Trees Award**

Ian Walker, a senior at Robinson Secondary School, has received the Fairfax County Tree Commission's 2017 Friends of Trees Award. He was nominated by Jeanne Kadet, the Braddock District Tree Commissioner, for his active interest in tree preservation and planting. Ian began volunteering with Fairfax ReLeaf in 2014. He became concerned about the potential of declining tree canopy when he saw neighbors cutting down their trees and decided to focus his Eagle Scout project around earth stewardship. In 2014, he planted 121 native trees and



bush saplings at Wakefield Chapel Park. Ian then decided that the best way to help the county achieve the tree canopy coverage goals would be to engage homeowners and increase tree planting on private property. He was able to plant 47 trees on private property in 2015 and an additional 64 tree and bush saplings in 2016. Following the 2016 spring planting event, Ian was invited to attend and participate in Fairfax ReLeaf's board of directors meetings and assists in tree and shrub distributions to private groups and individuals. Thank you, Ian, for your continuing efforts to increase Fairfax County's tree canopy, educating neighbors about the importance of trees, and helping plant more trees in our community.

# Parks Update

The Fairfax County Board of Supervisors named Kiel Stone to the Fairfax County Park Authority (FCPA) Board as the Braddock District Representative. He replaces Anthony J. Vellucci, who resigned earlier this month. The 12-member Park Board has members representing each magisterial district, as well as three at-large members.



“Kiel brings a wealth of knowledge not only of county government and community needs, but of the environmental management issues that are increasingly important for our parks,” said Braddock District Supervisor John C. Cook.

Stone has worked most recently as the Outreach Manager in the president’s office at The Nature Conservancy, delivering operational support to the CEO and president of the world’s largest non-profit conservation organization. Prior to that position, he spent five years serving as Chief of Staff to Supervisor Cook, following two years as a legislative aide.

The new Park Board member earned a master’s degree in natural resources at Virginia Polytechnic Institute and State University and a bachelor’s degree in economics at George Mason University. Stone’s appointment runs through December 2018.

## UPCOMING COMMUNITY MEETINGS

### **Stormwater/Wastewater Consolidated Facility at Freds Oak Road**

2232-B17-21

On October 30, Supervisor Cook held a second community meeting on a proposed consolidation of the county’s Stormwater Planning Division, Maintenance and Stormwater Management Division, and Wastewater Collection Division operations on land located at Freds Oak Road and the Fairfax County Parkway. The primary focus of this meeting was to address questions related to traffic that have been raised by nearby residents. County staff and consultants presented their traffic impact analysis, including projections on the number of vehicles, peak hour traffic, impact on existing intersections, and traffic alternatives. Representatives from both the Fairfax County and Virginia Departments of Transportation were present to help respond to questions. A neighborhood walk around the site of the proposed facility has been scheduled for Wednesday, November 15, at 4:00 p.m. Please meet in the conference room of the existing Wastewater Collection Division facility at 6000 Freds Oak Road, Burke. Staff will be available at the entrance to provide direction. This will be an opportunity

for members of the surrounding community to walk around the property with county staff and discuss proposed layouts, plans for screening, and address any questions/concerns about noise and lighting.

The Braddock District Land Use and Environment Committee will not meet in November. The next meeting will be on Tuesday, December 19, beginning at 7:30 p.m. in Braddock Hall. Braddock District Land Use and Environment Committee meetings are open to the public.

### **Cases Filed Before The Planning Commission & Board Of Supervisors**

#### **Goddard School Child Care Center**

11909 & 11917 Lee Highway and 4613 Holly Avenue  
SE 2017-BR-023

Supervisor Cook held a community meeting on a proposal to locate a Goddard School private preschool and daycare facility on four parcels of land located at the southeast corner of Lee Highway and Holly Avenue. The facility would be one story, approximately 12,146 square feet, and would serve a maximum of 200 students with up to 26 full-time and six part-time employees. The site would have separate outdoor recreation areas for toddlers and for preschool-aged children. A surface parking lot would provide 42 parking spaces. Access would be from Holly Avenue. Because the center would offer half-day, three-quarters-day, and full-day programs, drop-off and pick-up times would be staggered. The applicant has been working to resolve concerns related to stormwater and traffic. We will provide further information when it is available. The Braddock District Land Use and Environment Committee is scheduled to make a recommendation on this proposal at its January meeting. A public hearing before the Planning Commission is scheduled for January 18.

### **Housing Development at Braddock Road and Roberts Road**

RZ/FDP 2017-BR-030

A proposal has been filed to rezone approximately 9.56 acres on the north side of Braddock Road and east of Roberts Road from R-1 to PDH-8 to create a high-end residential development with 49 single-family detached homes. The property is currently developed with three single-family detached homes and a church, which would be removed. The development would include amenities such as a central lawn area, community garden, pavilion, children's playground, and small corner park. Access to the property would be from a single entrance on Roberts Road. Supervisor Cook plans to hold a community meeting on the proposal in early 2018.

### **2232 PUBLIC FACILITIES APPLICATIONS**

#### **VRE Platform Extension**

9016 Burke Road, Burke

The Virginia Railway Express has submitted an application to construct a 291-foot platform extension at the Rolling Road Station. The existing platform is 380 feet and accommodates 5-car trains; longer trains overhang the platform and train crews cannot open all doors. The extension would allow it to accommodate 8-car trains. Additional steel canopy will be added to the north and south ends of the platform extension. The VRE station's platform is located in the Braddock District, although the parking lot is in the Springfield District. Because this is a public use, it is permitted by right subject to Planning Commission approval. The Fairfax County Board of Zoning Appeals (BZA) meets on Wednesdays beginning at 9:00 a.m. in the Board Auditorium of the Fairfax County Government Center, 12000 Government Center Parkway, Fairfax. BZA meetings are also aired live on the county government's cable TV Channel 16. Residents who have concerns about an application are encouraged to submit a letter for the record or testify at the hearing on the case. You may register to testify at <https://www.fairfaxcounty.gov/dpz/bza/bzaspeaker.htm>. These matters will not come before the Board of Supervisors, but will be decided by the BZA. Staff reports are normally available two weeks before the scheduled hearing.

**Jubilee Christian Center,**

4650 Shirley Gate Road, Fairfax

SPA 96-Y-031-02

The applicant has filed a Special Permit Amendment to expand their existing parking lot to add 108 spaces, for a total of 265 parking spaces. Proposed improvements also include installation of new storm sewer inlets and piping, relocation of an existing shed, a possible dumpster pad enclosure, and parking lot lighting. There are no proposed building modifications, use changes, or operational/occupancy changes. This application is scheduled to come before the BZA on December 6.
