Dear Neighbor,

This month we celebrate Asian-American, Pacific Islander, and Native Hawai'ian heritage. Here in the Braddock District and across Fairfax County, we are fortunate to have an active and vibrant Asian-American community. We also celebrated Teacher Appreciation Week this week, which is a great time to do what we should be doing all year long -- thanking our teachers for the life-changing work they do!

Today, the Health Department **announced** that, due to an increase in COVID-19 cases and outbreaks, Fairfax County and other Northern Virginia jurisdictions have moved from "low" to "medium" community level, according to CDC guidelines. As always, I urge all eligible individuals to get their COVID-19 vaccine and first booster. As we wait for the full emergency authorization of the second vaccine booster shot, individuals over the age of 50 and some immunocompromised groups are already eligible for a second booster. For those not yet eligible, please be aware that the Virginia Department of Health is calling vaccinated Virginians who have not received their first booster shot to urge them to **get one as soon as possible**. If you have lost your vaccination card or need another record of your COVID-19 vaccination to present for any reason, you can find your record **here**.

Thomas jumped out of his car to announce that his doctor had given him permission to drive the same day!



Toolkit for Children's Mental Health Awareness Week

Nearly 1 in 5 people experience a mental health concern each year, according to the National Alliance on Mental Illness (NAMI). Mental illness, including depression, substance use disorders, anxiety, or psychosis can happen to anyone. Take this opportunity this month to learn more about increasing awareness of mental health, healthy habits, and how to protect and maintain emotional health and well-being. Help shine a light on mental health and awareness and work to eliminate stigma surrounding mental illness.

COVID-19 Cases and Outbreaks

For several weeks, cases and outbreaks of COVID-19 have increased in Fairfax County and across Northern Virginia. Several jurisdictions in the region have transitioned from low to medium COVID-19 Community Level, as <u>defined by CDC</u>, including Fairfax County and Falls Church City. Fairfax City remains at a low level.

Outbreaks in schools, primarily the elementary grades, have increased rapidly. Last week, there were 74 classrooms that reported outbreaks of COVID-19 cases and this week there were 139. These figures include outbreaks that occurred in both public and private schools, as well as at childcare facilities. An outbreak is defined as a cluster of three or more cases of COVID-19 illness in a group within a 14-day period.

Disease increases are likely related to the emergence of new Omicron sub-variants (BA.2, BA.2.12.1) and fewer people using mitigation measures such as masking or distancing from others. COVID-19 hospitalizations and deaths in Fairfax County remain low though the rate of hospitalizations has more than doubled in the past month.

Lake Accotink Dam Stream Crossing Project

The Fairfax County Park Authority will soon begin construction on the Lake Accotink Dam Stream Crossing Project at Lake Accotink Park located at 7500 Accotink Park Road in Springfield, Virginia. The contractor, Franco's Liberty Bridge Inc, will be mobilizing on site with active construction activities beginning this summer. The project involves creating approximately 300 linear feet of asphalt trail improvements and 325 linear feet on an elevated concrete pedestrian crossing over the dam outfall in Lake Accotink Park, Total project costs, inclusive of design, permitting, testing, utilities, construction and administration, is just over \$3 million.

The Lake Accotink Loop Trail system is currently one of the most heavily used trails in the Park Authority, serving communities around Lake Accotink and park visitors throughout the region. The existing pedestrian and vehicular crossing at the outfall of the Lake Accotink dam floods suddenly and frequently, often stranding trail users

and tempting them to wade through swiftly running water. Excessive damage due to major storm events has required a total reconstruction of the trail twice in the last five years. This project will resolve these issues, enhancing safety and accessibility for park users.

Project completion is anticipated in early 2023. Residents should expect occasional construction traffic entering and exiting the Accotink Park Road entrance. Portions of the surrounding Lake Accotink Trail will be closed and signs posted during construction. Shanes Creek Stream Restoration Project Underway

The Shanes Creek Stream Restoration Project in the Kings Park West area is officially under construction. As a reminder, that means residents should not walk, run, or otherwise be inside the welded wire fencing. The Trail Closed/Area Closed signs were backordered, but should now be in place. There have been reports of what appear to be cuts in the fencing and of people walking through the construction zone. This creates a dangerous situation, particularly as work gears up and more equipment is in use. Please respect the boundaries during the entire construction period.



Work will begin starting in the upper, or western, portion of the project. The required perimeter fencing should be installed by mid-May. Stream work is expected to begin by the end of May. Regular work hours through the summer are 7:00 a.m. to 7:00 p.m. Mondays through Wednesdays and from 7:00 a.m. to 11:00 a.m. on Thursdays. This schedule may change based on weather and project requirements, and Friday or weekend work is possible. The project is expected to take 18 months to complete.

Tennis & Pickleball Court Repairs Slated at Wakefield Park

The Wakefield Park tennis and pickleball courts were resurfaced in fall 2021. At the time, weather conditions were not favorable to complete the work on courts #9, #10, #12 and #13. The vendor, ATC, will return to complete the work this spring, as the temperatures warm up consistently.

ATC will be onsite June 3 through June 17, to accomplish several tasks related to their project punch list and to perform the necessary repair work to the tennis courts. They will need to keep the courts closed for the duration of that two-week period to ensure a successful repair process.

They anticipate the tennis and pickleball courts will be available Saturday, June 18, 2022, providing the weather remains dry during the scheduled repair dates.

Compliance Corner

On-ground Pools

Seasonal on-ground pools gained popularity in the past few years. Even though these pools are not typically in place year-round, they are regulated by the Zoning Ordinance and Uniform Statewide Building Code (USBC). Some of the key requirements are listed below.

- Pools must comply with accessory structure location requirements of the Zoning Ordinance. The following flyer provides information on those regulations: www.fairfaxcounty.gov/code/sites/code/files/assets/documents/pdf/freestan-ding-accessory-structures.pdf.
- A <u>swimming pool building permit</u> is required for any pool with a surface area greater than 150 square feet, a capacity over 5,000 gallons or more, or a depth of 24 inches or more; and barriers are required. If the ladder is removed in between swims, the sides walls of the pool can act as the barrier; otherwise, a fence or other barrier is required.
- Electrical permits are required if seeking to establish service, such as for lighting, outlets, and filtration systems.

How do the Department of Code Compliance enforce?

- If DCC receives a complaint, DCC Investigators inspect the property to determine if there is a violation and try to contact the property owner to discuss the nature of the complaint or violation.
- If there is a violation, a Notice of Violation (NOV) is issued directing the property owners to abate the violation within a specified timeline.
- DCC Investigators reinspect the property after the timeline to comply per the NOV has expired, to determine whether the violation has been abated.
- Failure to comply with a NOV can result in the County taking legal action, such as seeking civil penalties or a court order to abate the violation.

DCC accepts complaints and concerns about potential violations on the <u>DCC website</u> or by telephone during regular business hours, at (703) 324-1300.

Opioid Safety: Recognize Fake Prescription Drugs

The opioid epidemic continues to impact the Northern Virginia region and the nation. Just this

week, two youth fatally overdosed in Prince William County after taking what preliminarily appear to be fentanyl-laced percocets (official causes of death are pending toxicology results).

Fentanyl is extremely fatal, even in the smallest doses. Similar to national and statewide trends, most fatal overdoses in Fairfax County in recent years have involved fentanyl, which is a common substitute or cutting agent in illicit narcotics such as cocaine, heroin, MDMA (also known as ecstasy or molly), as well as counterfeit pills. Nationally, the U.S. Drug Enforcement

Administration reports a dramatic rise in the number of counterfeit pills containing at least two milligrams of fentanyl, which is considered a deadly dose. Counterfeit pills laced with fentanyl can look the same as authentic pills, making it almost impossible to know whether a pill has a deadly dose of fentanyl or not.

This is a communitywide problem and requires a comprehensive approach to prevent future overdoses and connect individuals experiencing opioid and substance misuse to treatment and support services. Take action today.

Following the 2020 Census, there were some changes to the congressional districts in Fairfax County. There is no Republican primary in Fairfax County. The Republican Party is nominating its congressional candidates by convention. In Virginia, political parties decide how they nominate their candidates, including using caucuses, mass meetings, primary elections and other methods.


May is Foster Care Month



Application to Convert Ravensworth Shell Repair Shop into Convenience Store

Capital Services, Inc. has filed an application to modify Ravensworth Shell's existing vehicle fueling station by replacing the light vehicle repair and maintenance component with a convenience store. The gas station is loccated in Ravensworth Shopping Center on Braddock Road, just west of the I-495 interchange.


This site contains a 2,600 square foot building housing four vehicle service bays, associated office and storage space, an exterior vehicle lift, and six fuel pumps with 12 fueling positions under a canopy. The current building was constructed in 1967 and renovated in 1984. The service bays and exterior vehicle lift are located along the south side of the building. To the east of the building is a large paved area where fuel trucks access the underground fuel tanks. The building entrance is located on the north side, adjacent to the fuel pumps.



The applicant intends to retain the existing fuel pumps and canopy, replace the four-bay vehicle service area with a convenience store, and add a small second floor office. There would be two entrances to the convenience store, one on the north and the other on the south side of the building. Both the fuel pumps and convenience store would operate 24 hours a day, 7 days a week. A number of site and architectural improvements would be included as part of the project. The building architecture would be upgraded and be in harmony with the shopping center. This would include brick veneer, glass windows and doors, and a gabled metal roof with a small tower.

Vehicular access is currently provided from both Braddock Road and Port Royal Road. The access from Braddock Road, with right-in and right-out movements, is proposed to remain the same. Port Royal Road includes two curb cuts serving the station along with a traffic signal further south providing full access for the shopping center. The northernmost curb cut on Port Royal Road (closest to Braddock Road) is proposed to remain and become right-in only to allow fuel trucks to access the station's underground tanks without backing up. The second curb cut

further south is proposed to continue to permit full movements. Overall daily trips are expected to increase from the current 3,128 trips to 4,033 trips and would be spread out throughout the day and evening hours. Landscaped islands and outdoor seating would be added, the sidewalk along Port Royal Road would be widened to five feet, speed bumps would be removed and a stop bar would be added along the southern side of the building. The existing signage would remain.



In response to an question about the reason for the change, the applicant stated that customers expect that a gas station will have an associated convenience store, and that there is less need for auto service. There are other facilities on Port Royal Road and in the broader area that provide service and inspections. In addition, service has become more complicated as vehicles have become increasingly computerized.

At its April 19 meeting, Braddock District Land Use and Environment Committee members

asked a series of questions regaring traffic patterns and how the current vehicular conflicts in the area around the gas station would be handled. Many of the inquiries related to a proposed restriping of the second entrance to try to provide visual clues to improve traffic flow while still allowing delivery trucks to navigate the movements. Committee members also asked about the lack of designated loading and air compressor use spaces and the proposed location of the dumpster. Capital Services will provide additional information on this proposal at the May 17 meeting of the Braddock District Land Use and Environment Committee.

A Planning Commission hearing on this application is scheduled for May 25 at 7:30 p.m. Information on how to testify may be found on the **Planning Commission website**. The application number is SEA 83-A-026.

Update on DMV's Customer Service Center at Braddock Road

While it may be quiet at the moment at the site of the future Braddock Road Customer Service Center, the Virginia Department of Motor Vehicles (DMV) has reported that there is a lot going on behind the scenes. The DMV Center will be located on Braddock Road between the State Police office and the new Erickson Living community. The building drawings have been finalized and approved by the State's Art and Architectural Review Board and the Department of General Services, Division of Engineering and Building. Bids for construction of the building are currently in the review process. Once a contractor has been selected, DMV will provide a more detailed schedule for construction. However, tentatively, DMV hopes to break ground in June and open the building in the spring of 2023. Please keep in mind that because this is a state facility being built on state land, it follows the procedures required by the state, not those of Fairfax County.

Update on Construction at Erickson Living's Woodleigh Chase Project

Utility work continues for the first phase of Erickson Living's Woodleigh Chase Project on Braddock Road, but the project is slowly starting to come out of the ground and buildings are beginning to take shape. The second level of the new community building has been poured. The foundation walls of the first residential building are being waterproofed, and once the first floor is poured, they will be backfilling the walls. The building foundations are going in for the second residential building and they are gearing up to pour the slab. On the western portion of the property, site work is nearly complete. Once ready, Erickson will be turning that property over to the Arlington Partnership for Affordable Housing for construction of a new affordable senior housing building. At the marketing center, final landscaping is being installed. Erickson will open the marketing center once their license is approved, which will probably be this fall. Changes are being considered to the county's Site-Specific Plan Amendment (SSPA) process! Join an upcoming virtual Open House to learn all about the **recommendations and enhancements to the SSPA process**, which were formed using public feedback.

The SSPA process allows anyone to submit and review proposed land use changes to the Comprehensive Plan for individual sites, and currently operates on a four-year cycle divided every two years between the North and South County Supervisor Districts. (The Braddock District is included in South County.) The proposed changes include creating a Countywide, two-year cycle, shortening the submission and screening period timelines, adapting community engagement to suit the needs of the study areas, and enhancing the criteria for submissions. Cases Filed with the Board of Zoning Appeals

The Fairfax County Board of Zoning Appeals (BZA) hears and makes decisions on requests for variances (relief from specific zoning regulations such as lot width, building height, or minimum yard requirements) and Special Use Permits. It meets on Wednesdays beginning at 9:00 a.m. BZA meetings are aired live on the county government's cable TV Channel 16. Residents who have concerns about an application are encouraged to submit a letter for the record or testify at the hearing on the case in person, by telephone, or by pre-submitted video. For information on how to submit comments or testify, please visit the Board of Zoning Appeals website. These matters will not come before the Board of Supervisors but will be decided by the BZA. Staff reports are normally available online a week before the scheduled hearing.

Access to information on BZA cases is available through the Planning and Land Use System, or PLUS, which came online for zoning applications on July 1, 2021. This system allows users to create and submit applications online, pay fees, track the status of applications, and receive electronic notifications. It also offers more information to the public than the previous system and does so in real time. Visit the **PLUS Information and Support website** for more information on this new land use platform.

Daniel Forlai – 12219 Rowan Tree Drive, Fairfax SP 2021-BR-00132

The applicant requested a reduction in setback requirements to permit an addition 20.1 feet from the front lot line adjacent to Pheasant Ridge Road and 37.7 feet from the front lot line adjacent to Rowan Tree Drive. This application was approved by the BZA on May 4, subject to Development Conditions which include requirements that any tree removed from the front yard along Pheasant Ridge Road and/or Rowan Tree Drive to construct the addition must be replaced on a one-for-one basis with a similar native canopy shade tree, as space allows. In addition, 4-6 native evergreen trees or shrubs must be planted in the front yard adjacent to Pheasant Ridge Road to soften the ground-level view of the addition from the west. Daniel Forlai – 12219 Rowan Tree Drive, Fairfax VC 2021-BR-008

The applicant requested a Variance to allow a freestanding accessory structure (shed) to remain in a front yard on a lot less than 36,000 square feet in area. Bhardwaj Tushar – 4700 Ox Road, Fairfax VC-2021-BR-00010

The applicant is seeking a Variance to reduce the setback requirements to allow construction of a 6,000-square foot single-family house 18.4 feet from the western front lot line (40-foot setback required), 18.9 feet from the rear lot line (20-foot setback required), and 17.2 feet from the western lot line (20-foot setback required). > SZII-VA, LLC - 5325 Port Royal Road, Springfield SPA 2017-BR-102

The applicant is seeking to amend the Special Permit previously approved for an indoor commercial recreation use (trampoline facility) to allow for a change in permittee. No
