Dear Neighbor,

From all of us at the Braddock District office, Happy New Year. We've had an eventful first week of 2022, with a challenging snowstorm and the resulting closures. As with any weather event, my office remains in touch with local and state authorities as well as utility companies to ensure that issues are resolved. If you are experiencing any winter weather problems, check the County's <u>list</u> of resources and contact my office if you need additional assistance.

We'll have a busy schedule in the coming weeks, and I want to make sure you are aware of some big initiatives and opportunities. First, after many years of community meetings and planning, VDOT is prepared to present an update on the Braddock Road Multimodal Improvement Project during a **public information meeting on January 13**. As I've shared previously, we were successful in securing state funding for Phase One of the project and it is imperative that we continue to receive community input throughout the process.

I'd also like to remind you about the opportunity to join us for Neighborhood College which begins mid-February. This free certificate program is a great opportunity to learn more about Fairfax County government and practical ways you can get involved in your community. I encourage you to <u>view the flyer</u> and sign up today.

As the omicron variant continues to cause a surge in COVID cases, demand for testing has increased as well. Governor Northam <u>announced</u> that nine free testing centers will open, one of which will be in Fairfax, starting Wednesday, January 12. The location will be announced soon. Also, you may have heard that <u>booster shots are available for those aged 12-17</u>.

Finally, I want to acknowledge that yesterday, January 6, was the one year anniversary of the violent attack on our Capitol and our democracy that took place on January 6, 2021. Fomented by misinformation surrounding the 2020 election results, the attack attempted to subvert our Constitution and our democratic process. Police officers, including some who lived here in Fairfax County, were beaten. One died in the line of duty and four have since committed suicide. It is my hope that, moving forward, January 6 will be a day of national unity -- a day on which we can come together across our varied divisions, recommit ourselves to democracy, and speak with one voice against those who would threaten it.

As always, this newsletter is full of information that I hope you and your community will find useful. Stay safe and thank you for reading!

Braddock Road Multimodal Improvements

Thursday, Jan. 13, 2022, at 7 p.m.

The meeting will be held as a virtual/online meeting. Information for accessing and participating in the virtual meeting is available at virginiadot.org/BraddockMultimodal. The project team will make a short presentation beginning at 7 p.m. and answer questions for about an hour after the presentation.

- Find out about planned multimodal improvements and access management for just over three miles of Braddock Road (Route 620) between Humphries Drive in Burke and Ravensworth Road in Annandale, including the eastbound and westbound Braddock Road ramps to south bound I-495 (Capital Beltway Outer Loop).
- . The proposed improvements aim to improve multimodal safety, mobility, and accessibility for all users with intersection and interchange enhancements, new and upgraded shared-use paths along both sides of Braddock Road, and a pedestrian overpass just west of Burke Lake Road.
- Alternative concepts will be presented for three intersections along the Braddock Road corridor: Rolling Road, Wakefield Chapel Rd/Danbury Forest Drive, and Burke Lake Road.
- In compliance with the National Environmental Policy Act (NEPA) and 23 CFR 771, a document in the form of a Categorical Exclusion is under preparation to assess the project's potential impacts to environmental resources.

New Laws in Effect for 2022

New laws passed by the Virginia General Assembly went into effect Saturday, January 1, 2022. Some Fairfax County measures are also in effect for the new year.

> Minimum Wage Increase

The Virginia minimum wage rises from \$9.50 to \$11.00 per hour. In 2026, it will rise to \$15.00 per hour.

> Vehicle Insurance

The minimum liability insurance coverage requirement increases for injury or death of one or more people. Read more on the **DMV website**.

> Surprise Emergency Room Bills

Virginia's "No Surprises Act" **prohibits** healthcare providers from charging you out-of-network prices for an emergency room visit, because patients don't have a choice in where they go.

> Humane Cosmetics Act

Virginia joins three other states in **banning cosmetics testing** on animals. This law also bans the sale of cosmetics that aren't cruelty-free.

> Criminal History on College Applications

This **new law** removes questions about criminal history from most applications for colleges in Virginia.

> Voting and Registration

Primary elections shift from the second to the **third Tuesday in June.** Candidate filing times are adjusted accordingly. Also, 16-year-olds can **pre-register** to vote so they will be ready to vote in a general or special election that occurs on or after their 18th birthday. (Reminder: you can vote in a June primary if you will be 18 by the November election.)

As shared in a recent Advisory, the **5¢ tax on disposable plastic bags** at grocery stores and pharmacies is now in effect.




Braddock District Tax Relief Workshops Hosted by Supervisor Walkinshaw

Hope Cards Now Offered in Fairfax County

Fairfax County now participates in the Hope Card program, a way to enforce a civil protective order and a handy resource for victims of family abuse. A Hope Card is a laminated wallet-sized card that contains all the essential information of an existing, permanent civil protection order. Hope Cards for Protective Orders

In Participating Virginia Localities

Frequently Asked Questions



Keep all the important information from your final protective order on a plastic, wallet-sized card, issued by the court at no charge.

What is a Hope Card? It is a laminated card, similar in size and shape to a credit card, that contains all the essential information about a civil protective order in a durable, easy-to-read format. The card is a convenient way to carry around the important information found on a protective order. It does NOT replace the existing protective order. Law enforcement still must verify the order in the Virginia Criminal Information Network when presented with a Hope Card. The Hope Card has information such as:

- Identifying characteristics of the person being ordered to "stay away"
- Issue/expiration date of the order
- Terms of the order, including possession of residence, etc.
- Other protected parties

Who is eligible to apply for a Hope Card? Hope Cards are available only to holders of a final civil protective order issued in Virginia localities participating in the Hope Card Program. To qualify for a Hope Card, the protective order must be the result of a domestic/family/sexual violence case, or stalking case and be for 12 months or longer. Hope Cards are not issued for emergency protective orders, preliminary protective orders, or "no contact" orders in a criminal case.

<u>How does someone apply?</u> To apply for a *Hope Card*, contact either the court Clerk where your protective order was issued or someone from your local Victim Assistance Program, and ask for an application. They will help you obtain the request form for a *Hope Card*. Once the form has been completed by the applicant and processed by the Clerk, a *Hope Card* will be sent directly to the applicant. For cases in which victim safety is a concern, a Hope Card may be sent elsewhere.

When will the Hope Card arrive? Most Hope Cards are mailed to the applicant within 14 business days of the clerk entering the request into the system.

Hours of Operation Changing at I-95 Landfill Complex and I-66 Transfer Station

The new year ushered in extended operating hours for residents to drop off their trash, recyclables, and various specialty wastes (e.g., used oil, old batteries, scrap metal) at the I-66 Transfer Station and the I-95 Landfill Complex. The new hours took effect on Saturday, January 1, 2022. The new hours are Monday through Friday, 7:00 a.m. to 5:00 p.m. Weekend hours, 7:00 a.m. to 4:00 p.m., will remain unchanged at both facilities.

The additional time is expected to help with operational efficiency, improve staffing efficiency, reduce 'rush hour' traffic in the afternoons and early evenings, and improve safety for residents.

Over time, incoming waste volumes at county facilities have changed in quantity and times of delivery. By adjusting hours of operations, management will be able to adjust staffing to accommodate these changes. Safety is a priority, so maintaining Resident Only on Sundays will reduce the larger vehicle traffic onsite.

Conversely, as of January 1, commercial customers will experience slightly shorter hours of business at these facilities as follows:

Annual Soil and Water Conservation District Seedling Sale Offers Low-Cost Native Trees and Shrubs to Residents

The annual Northern Virginia Soil and Water Conservation District seedling sale will open Tuesday, March 1, 2022! These species were selected because of their value to native bees, but they also serve as valuable food sources for wildlife. All species are native to Virginia.

- **TREE-mendous Flowers** (\$15) includes two each of the following species: American Hornbeam, Canadian Serviceberry, and Winterberry Holly.
- **Un-BEE-lievable Blooms** (\$15) include two each of the following: False Indigobush, Eastern Redbud, and Silky willow.

Visit **Northern Virginia Soil & Water Conservation District** to learn more about these plants and view photographs of the selections.

Using native plants in your home landscape can attract wildlife, protect water and air quality, conserve energy, and reduce carbon emissions. The program is offered in partnership with Fairfax County's Urban Forestry Management Division and the Virginia Department of Forestry's Potomac Work Area.

Payment can be made by credit card to the Northern Virginia Soil and Water Conservation District. Pre-payment is required. To order online, visit the **Northern Virginia Soil & Water Conservation District**. Orders must be picked up on Friday, April 1, or Saturday, April 2, 2022, at the Sleepy Hollow Bath and Racquet Club in Falls Church, or they will be donated to a reforestation project in Fairfax County.

Plastic Bag Tax Began January 1, 2022

Beginning Saturday, January 1, 2022, the 5-cent plastic bag tax took effect in Fairfax County, Arlington County, and the City of Alexandria. **Studies have demonstrated that plastic bag fees are effective** in reducing plastic bag usage and the resulting pollution to our water sources.

Compliance Corner





Vehicle Storage

Do you know Fairfax County's rules for storing vehicles on residential property?

Fairfax County regulates the storage of inoperative vehicles, vehicles under tarps, and vehicles that are covered with fitted car covers.

Inoperative Vehicles:

- Chapter 110 of the Fairfax County Code and Article 4 of the Zoning Ordinance regulate inoperative vehicle storage in residential areas.
- An inoperative vehicle is any motor vehicle, trailer, or semitrailer that is not in operating condition, does not display valid license plates, or does not display an inspection decal that is valid or does display an inspection decal that has been expired for more than 60 days.
- On residential properties, inoperative vehicles must be kept within a fully enclosed structure or completely screened from view in accordance with the County Code.
- To make a complaint about more than five inoperative vehicles located on private property, call the **Department of Code Compliance** at 703-324-1300, TTY 711 or report online at www.fairfaxcounty.gov/code.
- To make a complaint about five or fewer inoperative vehicles located <u>on private property</u>, please contact the Fairfax County Police Department's Impound Office at 703-280-0716 or report online at www.fairfaxcounty.gov/police/report-inoperable-vehicle.
- To report an inoperative vehicle on a public street, please call the Police Department's nonemergency number at 703-691-2131.

<u>Vehicles under Tarps</u>: Any vehicle covered by a tarp is subject to the outdoor storage regulations of Article 4 of the Zoning Ordinance.

<u>Vehicles under Fitted Car Covers</u>: On a residential lot, up to two vehicles may kept under fitted car covers specifically designed for this purpose.

Virtual Public Meeting for Braddock Road Multimodal Improvement Project

Mark your calendar for the Virginia Department of Transportation's Virtual Braddock Road Multimodal information meeting taking place Thursday, January 13 at 7:00 p.m. Alternative concepts will be presented for three intersections along the Braddock Road corridor: Rolling Road, Wakefield Chapel Road/Danbury Forest Drive, and Burke Lake Road.


This project will construct multimodal and access management improvements along three miles of Braddock Road (Route 620) between Humphries Drive in Burke and Ravensworth Road in Annandale, including eastbound and westbound Braddock Road, ramps to southbound I-495 (Capital Beltway Outer Loop), and a half-mile of Ravensworth Road between Braddock Road and Heritage Drive.

The improvements include:

- ➤ Intersection enhancements, including at Rolling Road, Wakefield Chapel Road/Danbury Forest Drive, and Burke Lake Road
- > New and upgraded shared-use paths along both sides of Braddock Road
- > A pedestrian overpass just west of Burke Lake Road

The project's right of way and construction will be done in two phases: Southampton Drive to Ravensworth Road (Phase 1) and Humphries Drive to Southampton Drive (Phase 2). Within the project limits, Braddock Road averages about 71,000 vehicles a day, and Ravensworth Road averages 14,000 based on 2019 data.

Phase 1 is fully funded, and Phase 2 is partially funded. The project is financed with federal, state (including Smart Scale), and local funding. Estimated project costs continue to be developed as the proposed improvements and preliminary design are refined. **Learn more about the project** by visiting VDOT's website. 

Who to Contact About Downed Trees and Wires

Winter storms often cause trees and power lines to fall due to the heavy weight of the snow. If that happens, you can use these contacts to get help:

1.) Life-Threatening

- > If there's an immediate life-safety issue, call or text 9-1-1.
- If a tree falls into your home:
 - 1. Get everyone safely out of your house. Use your cellphone or go to a neighbor's house and call 9-1-1.
 - 2. Stay away from the home until public safety employees can access your home for structural safety (as well as ensuring your utilities are OK or should be turned off.)
 - 3. Only after all these safety measures should you then call your insurance company.

2.) Power Lines

- NEVER touch a downed wire.

3.) Roads

Fairfax County Reports Drop in Total Crime for 2021

The Fairfax County Police Department (FCPD) saw reductions in most major crime categories in 2021, fueled by a focus on community partnership and data-driven policing. The reductions came in many categories including robbery, burglary, auto theft, and malicious wounding. Following the national trend, homicide was a rare category that saw an increase in 2021. This numerical increase of 6 homicide victims is driven by an unusually high number of indoor domestic violence incidents involving adult children killing parents and other family members. FCPD recorded 21 murders in 2021, compared with 15 in 2020. The Major Crimes Bureau solved a total of 399 cases of violent crime, including 16 of the 21 murders. Our homicide detectives continue to pursue leads for the unsolved cases. Our clearance rate is 76.2 percent in 2021, which exceeds the national average rate of 61.4 percent of homicide closures.

"The national rise in violence touched every major urban center in 2021, including Fairfax County," said Chief of Police Kevin Davis.

"Despite this, we remain one of the safest jurisdictions of our size in the country because our patrol officers, detectives, and professional staff work tirelessly for our victims and their families. As we look ahead, FCPD will continue to engage with our community on the important work of public safety."

2021 Crime Highlights:

- ➤ Overall crime fell by 9.6 percent in 2021, compared to 2020
- ➤ The drop in crime resulted in 3,187 fewer victims, compared to 2020
- > Robbery fell by 1 percent in 2021, compared to 2020.
- > Domestic Assaults fell by 4 percent in 2021, compared to 2020.
- ➤ Burglary fell by 11 percent in 2021, compared to 2020.
- > Auto theft fell by 8 percent in 2021, compared to 2020.
- ➤ Larcenies from automobiles fell by 17 percent in 2021, compared to 2020.

Newly Launched Community Initiative (iPAC) Shows Initial Progress:

In the fall, FCPD started a community engagement program called iPAC (Integrating Police and Community) that requires patrol officers to spend a minimum of 30 minutes on foot patrol per shift. The goal of these foot patrols is to interact with residents and business owners in areas where dispatchers receive the highest call volume. The iPAC initiative is different, because officers are not responding to a call for service. Thus, the non-enforcement community engagement is meant to generate more natural conversations about public safety. Police officers know these interactions build greater police legitimacy and strengthen trust. In addition to iPAC being a daily responsibility for patrol officers, FCPD commanders are also required to perform 30 minutes of weekly iPAC engagement. Since the launch, FCPD has recorded hundreds of community interactions.

The department also launched a community feedback measurement tool, which uses a survey linked to a QR code. Community members are asked for their input on the quality of service provided by the department and the professionalism of our police officers during an interaction.


Human Services Corner

Hypothermia Prevention Program

The Fairfax County <u>Hypothermia Prevention Program</u> for people experiencing homelessness begins on December 1, 2021. Since 2005, the program has prevented death and serious injuries among our most vulnerable residents by ensuring that no one must sleep outside during the winter months. This program – available to any adult in need of immediate shelter – provides warm shelter, food, and other supportive services to help connect guests to a variety of basic needs such as clothing, employment, housing, and more. It remains a highly effective partnership between government, nonprofits, and the faith community.

All Neighborhood and Community Services **Community**, **Teen**, and **Senior Centers** are warming centers. Center staff are prepared to accommodate any community walk-in needs during our operating hours.

Crisis Assistance

The Crisis Assistance Program is designed to help households overcome energy emergencies that cannot be met by other resources. An energy emergency is determined when a household has no heat or is in imminent danger of being without heat. Crisis Assistance offers assistance with one or more of the following:

- > Payment of primary heat source utility bills (begins Monday, Jan. 3, 2022)
- > Payment of security deposits for primary heat utility
- > Purchase of primary home heating fuel when the fuel supply is low
- > Repair of inoperable or unsafe heating equipment
- > Replacement of heating equipment for homeowners only (when repair is not possible).
- Provision of supplemental heating equipment/maintenance



Community Meeting Set for January 31 on Proposal to Develop Day Property on Zion Drive

A rezoning proposal has been filed for 10121 Zion Drive, a wooded undeveloped site known as the Day property. This 2.51-acre site is located on the west side of Zion Drive, just north of its intersection with Guinea Road and adjacent to the Burke Junction community. The applicant has proposed rezoning the property from the R-1 District to the PDH-3 District to permit the development of seven single-family detached homes. Access to the property would be provided from James Young Way, which connects to Zion Drive opposite Hillard Lake Road and links to the Burke Junction neighborhood to the south. A



new private street would connect to the public road. Although the property to the north is not part of this rezoning, the applicant has proposed reserving an area for future interparcel access.


The applicant has stated that the proposed layout, design, and lot sizes would be compatible with the surrounding community. Three areas of open space would be provided, with the largest area consisting of tree save adjacent to the Resource Protection Area along the western property line. The development would include a bioretention area to provide treatment for both water quantity and quality. Water flow not captured onsite is proposed to be intercepted by facilities in the Burke Junction community.

Supervisor Walkinshaw will be hosting a <u>virtual community meeting</u> to discuss the proposal on Monday, January 31, at 7:00 p.m. The password is 640088. The meeting link will also be available on the Braddock District website. Those who are interested in learning more about this proposed plan are encouraged to attend. A Planning Commission hearing has been scheduled for May 18.

Application to Redevelop McKenzie Avenue Properties Scheduled for February 2 Planning Commission Hearing

Sekas Homes, Ltd. has filed an application to rezone 6.51 acres of land located along McKenzie Avenue, south of its intersection with Lee Highway in Fairfax. The land consists of four properties developed with three vacant single-family homes and several outbuildings.

The applicant has proposed rezoning the property from R-1 to R-2 Cluster to allow 11 new lots developed with single-family dwellings. The development is being called Marshall Hills. Access would be provided through a new public street extending from an existing stub off Robertson Farm Circle. The development would also connect to Lee Plaza Center just west of KinderCare, which would provide a second access point through the shopping center parking lot. McKenzie Avenue would be closed and revegetated south of the private cemetery entrance. Stormwater management is proposed to be handled through installation of an underground vault facility.



At a meeting held by Supervisor Walkinshaw on October 25, community members raised questions about removal of trees, on-street parking,

additional traffic through Robertson Farm, and access through Lee Plaza Center. The applicant responded that they are just short of meeting the tree preservation target. Because it is narrower in width, no on-street parking would be permitted in the area of the existing stub from Robertson Farm Circle. Future interparcel access to Lee Plaza Center was provided as a condition associated with approval of the KinderCare facility.

The Planning Commission hearing in this case is scheduled for February 2 at 7:30 p.m. in the Board Auditorium at the Government Center. Community groups or individuals who are interested in providing testimony on this application are encouraged to do so. Information on how to testify may be found on the **Planning Commission website**. The application number is RZ 2021-BR-009. No date has been set for a hearing of the Board of Supervisors.

Public Storage Rezoning Application Scheduled for Planning Commission Hearing on February 2

On October 25, the Board of Supervisors approved a Plan Amendment which would allow self-storage use at the northwest corner of Lee Highway and Waples Mill Road. This paved the way for consideration of an application filed by Public Storage Southeast One, Inc. to consolidate the corner parcel with their existing self-storage property and rezone the corner lot into the I-5 District.


Public Storage is proposing to remove the vacant house and contractor's yard on the corner property, demolish one row of its existing single-story self-storage bays, and construct a climate-controlled five-story, 63-foot tall self-storage facility of approximately 150,000 square feet on the southeast corner of the site (see illustration). The building would be red brick with stucco accents and spandrel glass windows to resemble the nearby residential and office buildings. A subdued, darker-colored brick and white lettering would be used for signage. The area near the existing office and lighthouse at the south end of one of the existing single-story buildings would also be demolished and a new office with up to 1,500 square feet and reconfigured parking area would be constructed.

The applicant is proposing to develop a new pocket park, which would be open to the public, adjacent to the existing pocket park on the interior portion of the block. It would include a dog park with seating and a children's play area. Trails on the site would be upgraded. The existing service road along Lee Highway, currently being used for parking of commercial vehicles, including food trucks and contractors' equipment, would be removed and replaced with landscaping and a pedestrian pathway. Additional landscaping, including natural landscape features, would be provided around the new building. The doors of the existing single-story building along Waples Mill Road would be painted a brick color, with alternating decorative art panels along the façade. The stormwater management system for the site would be upgraded and would include an underground storage facility.

A Planning Commission hearing on the rezoning application is scheduled for February 2, 2022. Information on how to testify may be found on the **Planning Commission website**. The application number is RZ 2020-BR-003. No date has been set for a hearing of the Board of Supervisors.

Application Indefinitely Deferred for Child Care Facility at 12019 Lee Highway

NLD Fairfax, LLC has requested indefinite deferral of its Special Exception application to permit a child care center at 12019 Lee Highway. Although it has not been formally withdrawn, it is no longer under consideration. Thank you to the community members who participated in meetings and provided comments during consideration of this application.

On July 28, 2020, the Board of Supervisors authorized a Comprehensive Plan amendment to consider locating residential uses between the 60 and 65 DNL airport noise contours with commitments to noise mitigation measures, notification requirements, and construction techniques for any such uses. An <u>Issues Paper</u> providing background information regarding aircraft operations and aircraft noise in Fairfax County, as well as potential considerations and noise mitigations to be considered as part of the amendment, was published in November.

Cases Filed with the Board of Zoning Appeals

The Fairfax County Board of Zoning Appeals (BZA) hears and makes decisions on requests for variances (relief from specific zoning regulations such as lot width, building height, or minimum yard requirements) and Special Use Permits. It meets on Wednesdays beginning at 9:00 a.m. BZA meetings are aired live on the county government's cable TV Channel 16. Residents who have concerns about an application are encouraged to submit a letter for the record or testify at the hearing on the case in person, by telephone, or by pre-submitted video. For information on how to submit comments or testify, please visit the **Board of Zoning Appeals website**. These matters will not come before the Board of Supervisors but will be decided by the BZA. Staff reports are normally available online a week before the scheduled hearing.

Please note that in some cases, two application numbers may be listed. The first one is the number that was assigned in the old system and the second is the number in the new Planning and Land Use System, or PLUS, which came online for zoning applications on July 1, 2021. Applications submitted before July 1 continue to be available in the old system, but many have been assigned a new number, as well. Applications submitted after July 1, 2021 will only be available in the PLUS system. The new system allows users to create and submit applications online, pay fees, track the status of applications, and receive electronic notifications. It also offers more information to the public and does so in real time. Visit the **PLUS Information and Support website** for more information on this new land use platform.
