While we can't declare victory over COVID-19 quite yet, we have <u>made tremendous progress</u> and it looks likely that we'll be able to enjoy something close to a normal summer. The University of Virginia's Biocomplexity Institute recently said that if vaccine administration continues at its current pace <u>the Northern Virginia region could reach "community</u> <u>immunity,"</u> or localized herd immunity, by mid-summer. Vaccines are the best tool to protect our community and loved ones. Now that everyone 16 years and older is eligible to receive a vaccine and supply is plentiful, addressing vaccine equity and hesitancy is our biggest priority.

To make getting the vaccine as easy and streamlined as possible, the **Tysons Community Vaccination Center** is offering walk-in service, Monday through Saturday, from 9:00 a.m. through 4:00 p.m. You can also schedule an **appointment at Tysons or another nearby clinic**! Giant pharmacies are now offering **walk-in vaccine appointments** at all 25 locations in Fairfax County on Monday and Tuesday mornings. **VaccineFinder** continues to function and has helped thousands of residents schedule their appointments at various locations.

If you or someone you know needs help with transportation to and from a vaccine appointment, Fairfax County and community providers have options to get residents to appointments. ## **Citizens of the Month**

This month's Braddock District Citizens of the Month are the neighborhood volunteers of the Fairfax Villa Neighborhood Association (FVNA). FVNA has been working to clean up the historic Haley Family Cemetery. According to the Fairfax County **Library's Cemetery Survey**, this cemetery is the burial place for Sergeant James Haley, a Revolutionary War soldier.

Volunteers Pat Tarasek, Bill Muras, and Allen Kriskowski are pitching in to clean up the site, further research the history, and restore this historic cemetery that dates back to the late 1700s. Currently, the volunteers are primarily clearing brush and foliage assisted by members of the local community pool, Villa Aquatic Club, as well as volunteers from the Daughters of the American Revolution (DAR). They are also raising funds to remove several large trees that are in danger of falling and injuring bystanders or property and have been further endangered during the recent windstorms. The volunteers are working to develop a landscape plan to plant native species next Spring. Additionally, the FVNA is working with the DAR and the Fairfax County Cemetery Preservation Association to research the history of the plot and to draw more attention to its significance in local history. Volunteers are also working to have a new headstone placed for Sgt. Haley.

Special thanks to Pat Tarasek, Bill Muras, and Allen Kriskowski for leading this effort. The Board of Supervisors recently adopted a Board Matter directing and encouraging support for the Commonwealth of Virginia's celebration of the 250<sup>th</sup> anniversary of the American Revolution. We are very proud of these volunteers for stepping up to take care of a local history site in their community in time for the upcoming 250<sup>th</sup> anniversary of our Nation in 2026. They have spent countless hours researching the records of this cemetery and getting their hands dirty working on the grounds.


## Governor Northam Announces Changes to COVID Related **Restrictions Will Start on May 15**

As you may have heard, Governor Northam recently announced that beginning Saturday, May 15, the cap on social gatherings and venues capacity limits will expand. The mask requirements and social distancing will still be in place. A few of the changes include:

- > Social gatherings: Indoor social gatherings will be capped at 100 people. Outdoor social gatherings will be capped at 250 people.
- > Entertainment venues: Indoor entertainment and amusement venues can operate at 50 percent capacity or 1,000 people, whichever is less. Outdoor venues can operate at 50 percent capacity regardless of capacity limits.
- Recreational sporting events: Indoor recreational sporting events will allow 250 fans or 50 percent capacity, whichever is less. Outdoor events will allow 1,000 people or 50 percent capacity, whichever is less.
- > Alcohol sales: Restaurants can return to selling alcohol after midnight. Dining room closures will no longer be required between midnight and 5 a.m.

## SolarizeNOVA is Back!

The **Solarize Fairfax County program** is back for a fifth year, providing county residents and businesses the chance to install solar arrays at a discount. From now until June 30, Solarize reduced rates will be available through a pre-qualified solar installer, Solar Energy World.

All county residents and business owners are eligible for a free, remote assessment to evaluate if solar is appropriate for their home or commercial building. Those who decide to pursue solar through the program receive a 10%-15% discount off current consumer rates for solar arrays and systems.

In 2021, for the first time, the Solarize program is offering

participants the opportunity to install battery storage systems in connection with their arrays. Residential Solarize participants are also eligible for a complimentary, virtual home energy assessment to help improve their home energy performance holistically. Solarize participants can also bundle electric vehicle charging stations with their solar system purchase at a discount.



## Virginia Department of Rail and Public Transportation Feasibility Study

enhanced public transportation services between the Franconia-Springfield Metro station in Fairfax County and the Quantico Marine Base in Prince William County. Enhanced transit could include options such as additional express bus services, increased VRE commuter rail expansion, Bus Rapid Transit (BRT), or an extension of Metrorail.

## Overnight Full Closure of I-66 East and West at Route 123 (Chain Bridge Road) Planned This Weekend, May 7-8, for Bridge Beam Installation

All lanes of I-66 East and West approaching Route 123 (Chain Bridge Road) are scheduled to be closed during the overnight hours May 7-8 to allow for installation of bridge beams for the new Route 123 South Bridge over I-66 as part of the Transform 66 Outside the Beltway Project. I-66 traffic will be detoured around the closure using the ramps at the Route 123 Interchange. Route 123 will remain open during these operations, but drivers should expect possible delays crossing over I-66. Police will be on scene to direct traffic.

Drivers traveling on I-66 during this time should expect delays and should consider using alternate routes.

### Friday, May 7, and Saturday, May 8:

- I-66 East and West travel lanes will be closed at Route 123 from 11:00 p.m. to 6:00 a.m. each night.
- All eastbound I-66 drivers will be directed to exit the interstate at Route 123. At the traffic signal, follow police direction to continue across Route 123 to the ramp back to I-66 East.
- All westbound I-66 drivers will be directed to exit the interstate at Route 123. At the traffic signal, follow police direction to continue across Route 123 to the ramp back to I-66 West.
- Route 123 North and South will remain open with police direction.

All lanes will reopen by 6:00 a.m.

## **Food Trucks** Do you know Fairfax County's rules for Food Trucks?

**FOOD TRUCK:** Any readily movable mobile food service establishment, to include vehicles that are self-propelled, pushed or pulled to a specific location.

#### **General Food Truck Regulations:**

- Section 2-510 of the Zoning Ordinance regulates the sale of food from vehicles.
- Chapter 82-1-30 of the Fairfax County Code regulates the sale of food from vending trucks on Virginia Department of Transportation (VDOT) roadways. VDOT allows Food Trucks to operate along designated streets. Contact the Health Department to learn where street sales are currently allowed.

#### Permits required for opening a Food Truck Business:

- <u>Business, Professional, and Occupational License</u> (BPOL) from the Fairfax County, Department of Tax Administration (DTA) – only needed if the Food Truck is headquartered in Fairfax County with an annual revenue in excess of \$10,000. Contact DTA at 703-222-8234, TTY: 711.
- <u>Food Establishment Permit</u> from the Fairfax County Health Department. Contact the Health Department at 703-246-2444, TTY: 711.
- <u>Food Truck Operation Permit</u> from the Department of Planning and Development (DPD), if the truck will operate on private property. Contact the Ordinance Administration Branch in DPD, at 703-324-1314, TTY: 711.
- <u>Solicitors License</u> from the Fairfax County Department of Cable and Consumer Services, Regulation and Licensing Branch, 703-324-5966, TTY: 711.

#### Permits to vend on an approved property:

• To vend in selected Fairfax County Parks, a <u>Mobile Food Vendor Permit</u> must be obtained from the Fairfax County Park Authority. Contact the Park Authority at 703-324-8702, TTY: 711.

### Planning Commission Hearing on Kenilworth II Development Proposal Rescheduled for May 19

In March, Supervisor Walkinshaw held a community meeting to discuss the revised zoning application submitted by Christopher Land, LLC for approximately 4.43 acres of land located just south of the Kenilworth community at Caprino Court and Braddock Road. This property is currently developed with one single-family home built in 1955 that will continue to be occupied by the current owner and would be included in a subsequent phase of the project. The applicant is requesting to rezone this land from the R-1 District to the PDH-3 District to build 12 single-family detached dwelling units at a density of 2.71 dwelling units per acre. Nine houses would be constructed in phase one, and an additional three houses would be part of phase two, when the existing house is removed. The application shows that access would be provided by connecting Banting Drive and Caprino Court at a "T" intersection with a three-way stop. An underground stormwater management system would handle stormwater runoff.

During the community meeting, residents expressed their continuing concern about connecting Banting Drive and Caprino Court. Representatives from the Virginia Department of Transportation stated that VDOT adopted a connectivity policy over a decade ago in order to provide for a network of publicly maintained streets and to address concerns with cul-de-sacs and dead-end streets. The State Code requires that when new streets are dedicated, they must be connected to road and pedestrian networks with the existing and future transportation network. Connections provide flow for both vehicles and pedestrians within local developments



rather than requiring people to go onto a larger collector road to access neighboring houses. Connectivity is vital in providing timely access for emergency vehicles. It is also important for school buses, trash collection, street maintenance, and snow plowing. Questions were also raised about tree save, future traffic calming measures, and a potential deceleration lane on eastbound Braddock Road prior to Caprino Court.

Members of the Braddock District Land Use and Environment Committee and the Braddock District Planning Commissioner visited the site in late April. In walking the property, they raised questions about the quality of tree save being proposed and a previously unidentified wet area which should be evaluated. To allow time to gather additional information and for county staff to review it, the developers asked to defer their Planning Commission hearing.

### Update on Construction of Braddock Road DMV Customer Service Center

On April 6, Supervisor Walkinshaw and the Virginia Department of Motor Vehicles (DMV) held a virtual community meeting on construction of a new DMV Customer Service Center at 9911 Braddock Road. The 3.9-acre DMV site is just east of Burke Station Road, across from the entrance to Fairfax Memorial Funeral Home, and is currently being used for motorcycle training. The DMV purchased this property in August 2015 with the intent to build a new facility to replace the Fair Oaks Mall Customer Service Center. Because this is a state facility being built on state property, it follows the procedures required by the state, not county procedures which require notice and provide for community input. The DMV has developed plans and specifications and presented them to the Virginia Department of General Services for review. The next step is for them to present their proposed final plans to the State Art and Architectural Review Board (AARB).

The new customer service center will be 15,435 square feet, with 20 teller windows, one overflow/testing window, and three information windows. All windows will be outfitted with clear plastic partitions, and lobby seating will be arranged to allow for adequate social distancing. The DMV will continue to use the appointment system that has been in place since May 2020, allowing control over customer flow. When it opens, the office will staff nine windows to accommodate 350-400 appointments per day on weekdays and half that on Saturdays. When it is appropriate to increase the number of open windows, the DMV anticipates operating at 75 percent capacity, which would result in 600 appointments per day on weekdays and 300 on Saturdays. The parking lot will accommodate not only customers and employees, but also road skills testing. That will avoid sending cars onto Braddock Road for that purpose.

Meeting participants had numerous questions for Virginia DMV Commissioner Richard Holcomb. Many of them focused on an increase in traffic on Braddock Road, which the DMV predicts will be limited because appointments will be spread out during the day. Commissioner Holcomb offered to engage VDOT to evaluate the concerns and see what potential mitigation may be done. Other questions were raised about green building practices, including solar panels, tree save, and landscaping. Commissioner Holcomb responded that the DMV is pursuing the installation of electric vehicle fast-charging stations, but he said they found solar panels to be cost prohibitive. The new facility will comply with state LEED requirements. He committed to removing only those trees necessary to create enough space for the facility and preserving as many as possible. AARB will be reviewing the proposed plantings, which call for plants native to Fairfax County.

The final plans for design and construction will be presented at the June 4 meeting of the AARB. Those who wish to submit comments may do so at **<u>aarb@dgs.virginia.gov</u>**. 

## Comprehensive Plan and Rezoning for NW Corner of Lee Highway & Waples Mill Road

The northwest corner of the intersection of Lee Highway and Waples Mill Road contains an older house and an outbuilding that was formerly used as a contractor's office and workshop. An existing Public Storage facility surrounds the property on the north and west. The corner lot is for sale and Public Storage has expressed interest in expanding its self-storage use onto that property. This area is planned for office use with an option for office/mixed use should it be redeveloped. The intersection is also planned for a potential interchange after Shirley Gate Road is extended to the Fairfax County Parkway.

For the past year, county planning staff has been considering a Comprehensive Plan Amendment for both the corner lot and the surrounding Public Storage property to ensure that the plan for this corner remains in line with the vision for Fairfax Center. During this review, consideration is being given to what options might be appropriate for the site, whether self-storage or alternative uses. Particular attention is being paid to architecture and design, landscaping, pedestrian improvements, and park/recreational space. County planning staff and representatives of Public Storage have been meeting regularly to try to come to agreement on general concepts. We expect that draft Comprehensive Plan language consistent with these discussions will soon be developed.

A concurrent rezoning application was filed by Public Storage Southeast One, Inc. to consolidate the corner parcel with their existing self-storage property. Based on feedback from meetings with staff and input from the Braddock District Land Use and Environment Committee, Public Storage recently resubmitted their plans to reflect modifications to their original proposal. Public Storage is proposing to remove the existing house, demolish one row of its existing single-story self-storage bays, and construct a climate-controlled, five-story, self-storage facility of approximately 150,000 square feet on the southeast corner of the property (see illustration). They would develop a public park, including a dog park, adjacent to the existing public park on the interior portion of the block. The existing service drive that is being used for parking of commercial vehicles, including food trucks, would be removed and replaced with landscaping and a pedestrian pathway. Additional landscaping would be provided around the new building. A path with public artwork would lead from Waples Mill Road to the new park and dog park. The details of this revised application will be reviewed by county staff. Look for an updated schedule in next month's Braddock Beacon.



## **Rezoning for Annandale United Methodist Church**

The Trustees of Annandale United Methodist Church have filed a rezoning application for their 1.77-acre property located on the west side of Heritage Drive and adjacent to Heritage Mall. The existing building was constructed and originally used solely as a place of worship. However, more recently, the Church has increasingly used the site to provide social services to address significant unmet needs in the surrounding community. Residents in the area walk to the Church property to access a food pantry and clothes closet operated by Church volunteers. In response to the COVID-19 pandemic, the Church collaborated with Chef Jose Andres of the World Central Kitchen to coordinate and distribute over 18,000 meals in the Annandale community. Many of these meals were targeted to families who were unable to access free and reduced meals from Fairfax County Public Schools.

The Church now proposes to formalize this operation and, in addition to the place of worship, create a community resource center that will provide a range of supportive educational and healthcare services, including a robust food distribution program, health and wellness screenings, and a mobile dental clinic, among other initiatives. They intend to expand existing collaborations with the Fairfax County Health Department, Department of Family Services, and Neighborhood and Community Services; Food for Others, George Mason University, Northern Virginia Community College; Medical Care for Children Partnership Foundation; and other public and charitable organizations.

Under the county's Zoning Ordinance, this operation would be considered a Public Benefit Association. However, the site is currently split zoned to the C-5 and R-20 Districts. Given this unique split zoning, such a use is not permitted on the residential, or R-20, portion of the property, which encompasses nearly half of the building. For that reason, the Church has filed an application to rezone the property to entirely C-5, which would allow the public benefit use to legally operate and expand the valuable work and services it provides to the community. No construction or physical changes to the existing site or buildings is planned. The Church will restripe the existing travel aisle and parking spaces in accordance with recommendations from the Fairfax County Fire Marshal.

The applicant received positive comments when this project was presented to the Braddock District Land Use and Environment Committee in April. A hearing of the Planning Commission is scheduled for June 16, and the application is scheduled for a Board hearing on July 21.

## **Child Care Facility Proposed for 12019 Lee Highway**

NLD Facilities, LLC has filed a Special Exception application to permit a child care center at 12019 Lee Highway. This 2.32-acre site is located south of Lee Highway between Spruce Avenue and Marymead Drive. It is currently developed with a single-family dwelling, with the remainder of the property as open space. The applicant has proposed an Everbrook Academy, operated by child care provider Learning Care Group, Inc. The facility would be approximately 13,000 square feet with a 12,500-square foot play area to the rear of the building. Access would be provided from the Lee Highway service road. Enrollment would be up to 151 children at any one time, and they would have 26 employees. Thirty-six parking spaces are proposed. Hours of operation would be from 6:30 a.m. to 6:30 p.m. Monday through Friday. A Planning Commission hearing has been scheduled for November 3. It is still very early in the review process, so look for more information in coming months.

## Update on Erickson Living's Woodleigh Chase Project

Demolition of the former Northern Virginia Training Center buildings on Braddock Road is well underway and should be completed this summer. Building plans for the temporary marketing center and first phase of the new Woodleigh Chase continuing-care facility are being reviewed by the county and Erickson is in the process of soliciting bids and awarding the contract. They anticipate construction will begin this summer begin on this portion of the project. BZA meetings are aired live on the county government's cable TV Channel 16. Residents who have concerns about an application are encouraged to submit a letter for the record or testify by phone or video at the hearing on the case. For **information on how to submit comments or testify**, please visit the County website. These matters will not come before the Board of Supervisors but will be decided by the BZA. Staff reports are normally available online a week before the scheduled hearing.

### Craig J. Herberg – 4614 Tapestry Drive, Fairfax SP 2021-BR-007

The applicant requested a reduction in certain yard requirements to permit an addition 19.5 feet from the rear lot line and a reduction to minimum yard requirements based on error in building location to allow a deck with steps to remain 2.6 feet from a rear lot line.
