

David Curtis Named Braddock District Community Champion

David Curtis, a dedicated volunteer with the Truro Homes Association Stream Team, was selected by Supervisor Cook as the Braddock District's 2017 Community Champion! Dave was recognized at the Fairfax County Volunteer Service Awards on April 21 for his dedication and commitment to the Turkey Run Stream Restoration Project. This award is given annually by Volunteer Fairfax and recognizes volunteers from across the county who make a real difference in the lives of their neighbors.

The Turkey Run Stream, which flows through the heart of the community, has suffered from serious stormwater runoff problems, leading to eroded stream banks, loss of natural habitat, poor water quality, exposed public utility infrastructure, and unstable trees that create a safety concern. There have also been a few cases that have threatened homeowner lots. Dave's continued efforts leading the "Stream Team" ultimately led to development of a project to restore 3,500 linear feet of the stream channel, including regrading and stabilizing eroded stream banks, modifying the stream channel, and replacing seven pedestrian bridges that are part of the heavily-used

I-66 Toll Lane Ramps Design Community Meeting Scheduled

On May 9, the Virginia Department of Transportation (VDOT) presented outlines of new designs for toll lane ramps to and from Interstate 66 to the Fairfax County Board of Supervisors. A proposal of interest to residents of the Random Hills area introduced access from the regular I-66 lanes to the toll lanes near U.S. 50. Supervisor Cook would like all Braddock residents to know that they have the opportunity to <u>learn more</u> about these designs at a public meeting in the cafeteria of Oakton High School (2900 Sutton Road, Vienna) on June 12. The meeting will take place from 6-8:30 p.m. A brief presentation will begin at 7 p.m., followed by a question and answer session. The final formal public hearing will be scheduled this fall after design plans are refined.

Code Compliance Corner

May's topic for Code Compliance Corner is multiple occupancy. Section 2-502 of the Zoning Ordinance establishes rules related to limitations on the occupancy of a single family dwelling unit. If you notice an excessive number of vehicles in the driveway or street, multiple people entering or leaving the residence at different hours of the day, or generally what seems like an overcrowding situation, you may contact DCC to file a complaint. Second Story Open-Door Information Sessions

Second Story, formerly Alternative House, a 45 year old organization that transforms the lives of children, youth, and their families by providing safe havens and opportunities for them to grow and thrive, welcomes volunteers to assist with their programs. Environmental Update

Stream Restoration Projects

As land around us becomes increasingly developed, impervious surfaces such as rooftops, asphalt roads, and concrete replace the trees, shrubs, groundcover, and soil that retain and filter stormwater. As a result, surface water runoff increases and often overwhelms our streams. In order to make more room in the channel, the stream banks and beds erode, creating a wider, deeper channel. This erosion means sediment and attached nutrients wash downstream, ending up in our lakes, rivers, and eventually the Chesapeake Bay. Habitat is damaged, recreational value is diminished, and private properties are sometimes endangered.

We are fortunate to have been able to restore a number of stream segments in the Braddock District. A significant project is currently underway on the Turkey Run Stream in the Truro neighborhood. Supervisor Cook is pleased to have been able to secure a commitment for construction funding for two additional projects, in Long Branch and Southport/Signal Hill, which are scheduled to begin later this year. These projects will help reduce sediment loads being transported downstream by stabilizing channel beds and banks, resulting in improved water quality, protection of private property and public utility infrastructure, and increasing in-stream and riparian habitat.

Turkey Run Stream Restoration – Work is progressing on this complicated restoration, which involves restoring approximately 3,850 linear feet of stream channel in the Truro neighborhood which had become deeply incised, separating it from the natural floodplain, undercutting banks, toppling trees, and in a few cases threatening homeowner lots. This major project includes re-grading and stabilizing eroded stream banks, modifying the stream channel, and replacing seven pedestrian bridges that are part of the heavily-used trail. The project began in October, and progress has been slower than expected due to on-site conditions that have required adjustments to be made during construction. We expect work to be completed in early July.

Long Branch Tributary at Long Branch Falls Park Stream Restoration – Supervisor Cook has secured a commitment for construction funding for a 620 linear feet segment of stream extending from a storm drain outfall at King David Boulevard to a culvert under Windflower Lane. The upstream portion of this channel is stable, as it lies over bedrock, but the stream has meandered and several segments of the channel have become overwidened. One area, in particular, is encroaching upon a resident's property. This project focuses on narrowing

the channel dimensions, redirecting flows away from eroded areas, and installing grade controls to dissipate stream energy and prevent further over-widening and destabilization. Construction is expected to begin within the next three months. After the starting date has been determined, a "Pardon the Dust" meeting will be scheduled with the community to review the project and answer any questions.

Pohick Creek Tributary at Queen Victoria Court Stream Restoration – A construction funding commitment has also been obtained for restoration of 3,353 linear feet of the Pohick Creek Tributary in the Southport and Signal Hill neighborhoods. The Pohick Creek tributary stream that flows parallel to Queen Victoria Court and Parliament Drive (under Lake Braddock Drive) is seriously eroded and the trails and foot bridges have been impacted. Stream stabilization will reduce sediment loads while maintaining capacity and controlling meander. It will also improve safety of a path/trail heavily used by Lake Braddock Secondary School Students, as well as for recreation and use by community residents. It is expected that this project will go out for bid soon, with construction to begin in approximately six months.

Royal Lake Update

The Royal Lake dredging project is nearing completion. Work to repair the forebay berms, which were damaged by the late spring storms, has been completed. The two gates controlling the water leaving the lake are now closed and the lake is filling back up. The length of time it will take to reach its normal level will depend upon the amount of rainfall we receive. A few additional items remain before the contractor can close out the project. A failing stormwater culvert which runs under the paved maintenance road near the Pomeroy Drive entrance parking lot will be replaced. The entire access road and parking lots which were within the project limits of disturbance will be repaved. The remainder of the parking lot off Gainsborough Drive, although outside of the project limits, will also be repaved. Wetland plants will be installed along the shoreline in various areas around the lake. Tree planting will be done in the fall to help improve the trees' chances of survival.

Community Meeting May 23 on Stormwater/Wastewater Consolidated Facility at Freds Oak Road

A proposal has been submitted to consolidate Fairfax County's Stormwater Planning Division, Maintenance and Stormwater Management Division, and Wastewater Collection Division on land currently occupied by the Wastewater Collection Division and adjacent property owned by Virginia Concrete at Freds Oak Road and the Fairfax County Parkway in Fairfax Station. The proposed new Stormwater/Wastewater consolidated facility would house administrative offices and storage, not actual treatment operations. It would involve construction of a new building on the properties for offices, conference space, locker rooms, and testing and analysis labs, plus maintenance shops, industrial shops, warehousing space, service vehicle parking, fuel dispensing, and equipment and material storage yards. Access would be via Freds Oak Road, with potential emergency or small vehicle access from Clara Barton Drive.

Because this is a proposed county government facility, the proposal has been filed and will be considered under the 2232 Review Process. Under this process, a public hearing will be held before the Planning Commission. Following the public hearing, the Planning Commission will determine if the proposal is in substantial accord with the county's Comprehensive Plan and approve, deny, or defer decision.

Although this proposal will not go before the Board of Supervisors for consideration, Supervisor Cook will hold a community meeting on Tuesday, May 23, at the Burke Centre Conservancy's Ponds Community Center, 9837 Burke Pond Lane, Burke, at 7:30 p.m. The Braddock District Land Use and Environment Committee will also be studying the proposal at its regular monthly meetings, held in Braddock Hall on the third Tuesday of each month at 7:30 p.m.

Land Use Update

Kings Park Shopping Center Sign - SE 2017-BR-007

The owners of Kings Park Shopping Center have submitted a Special Exception Application to allow the updating of the existing pylon sign. The replacement would be consistent with the design and colors used in the façade renovation that was completed in 2015. The size of the new sign would be slightly lower in height and area and would continue to be internally lit. This proposal will be examined by the Braddock District Land Use and Environment Committee. It is tentatively scheduled to be considered by the Planning Commission in September.

Saint Bernadette Catholic Church

Saint Bernadette Catholic Church, located on Old Keene Mill Road in Springfield, has filed a Special Permit Amendment to modify development conditions, construct improvements, and make site modifications to their church and school. These proposed changes would not increase the number of sanctuary seats or children in the nursery school and private school of education.

The applicant proposes to modify the development conditions to change the hours of operation for the nursery school from two sessions per day, from 8:30 a.m. to 11:15 a.m. and 12:00 p.m. to 2:45 p.m., to one session from 8:00 a.m. to 3:30 p.m. The application also proposes a building addition containing 1,520 square feet to support one additional classroom and administrative facilities for the nursery school; a two-story building addition containing 980 square feet to support a storage room and an elevator associated with the administrative offices, and modifications to an existing fenced playground resulting from the building additions.

In addition to the modifications associated with the nursery school, the applicant proposes a second floor addition on top of an existing building that would be used as a multi-purpose room and a one-story addition of 1,350 square feet to support administrative facilities for the existing private school of general education. The proposal includes plans to construct two one-story additions to the existing sanctuary building, which would contain a total of 250 square feet and be used for two confessionals. These two additions were previously approved but not constructed.

This Special Permit Amendment will not come before the Board of Supervisors, but will be decided by the Board of Zoning Appeals. A hearing date has not yet been set. Community Council on Land Use Engagement

At its April 17 meeting, the Community Council used breakout sessions to delve into the topics of how the county could improve outreach efforts and how the county might more effectively engage citizens. Council members and guests engaged in robust discussion, after which each focus group presented its top recommendations to the full group. These suggestions will form the basis for the Council's report to the Board of Supervisors. A draft report will be discussed at the final meetings of the Community Council this month.


