

### **Training Center Task Force Recommendations Presented to the Community**

On June 25, I hosted a community meeting for the Training Center Site Task Force to present its recommendations for future development of the former Northern Virginia Training Center (NVTC) site, the adjacent State Police site, and a small parcel of land reserved for a future DMV facility.

The former NVTC site is the largest parcel of land available for development or redevelopment in the Braddock District since Burke Centre, and it is unlikely that we will see another property of this size. Erickson Living purchased the property from the Commonwealth of Virginia in late 2017 and hopes to build a continuing care community with approximately 1,100 independent living units and 200 assisted living and acute care units. However, there is no existing Comprehensive Plan to guide land use on this site because it is classified as institutional.

Public input is a vital part of the planning process because it gives residents the chance to help outline a vision for the future of their community. In order to promote input, I hosted three community meetings, a planning workshop, appointed a task force which met 11 times, and conducted an online survey that received over 1,750 responses. The information gathered from the meetings and survey, combined with the County's Community Needs Assessment and input from a variety of County agencies, from housing to parks and recreation to transportation, helped the task force finalize its Comprehensive Plan recommendations.

For the former NVTC site, the task force recommended a base use of one dwelling unit per acre, with the option for a continuing care facility. Whether the property is developed with housing or a continuing care facility, they recommended a public park in the Environmental Quality Corridor and additional recreation uses on at least four to six acres of the site. The recreational use should include an all-abilities recreation use and intergenerational gathering space. If a continuing care facility is built, it should be compatible with the character of the surrounding community. Development should be limited to the area inside the ring road and the already developed northwestern portion of the property, building height should be limited to five stories, and there should be a landscaped buffer. The task force recommended limiting access to the site to the intersection at Burke Station Road and the entry across from the entrance to the cemetery.

For the 9.7-acre State Police site, the task force recommended a base plan continuing the current public uses, with an option for public park use. The recommendation for the 4-acre future DMV site is also recommended for a base use of public facilities, governmental and institutional use, with an option for residential use up to one dwelling unit per acre or public park use. There are not currently any plans for the Commonwealth to sell this property, but it is important to put a base plan into place in case things change in the future.

County staff will take the task force's recommendation, consider it in terms of how the recommendation meets identified County needs, evaluate impacts to public facilities, and draft text to be included in the County's

Comprehensive Plan for this area. The staff recommendation is due in September and will go to the Braddock District Land Use Committee for Review. 

Road Improvement Project and will help improve walkability, pedestrian safety, and connectivity in the Braddock District. The overpasses will serve as "elevated crossing alternatives" that will allow walkers to cross busy Braddock Road intersections without affecting traffic. County staff introduced the idea in the Braddock Road Multimodal Study, surveyed residents on the topic, and worked with the Braddock Road Task Force to find the best locations on Braddock Road.

The County is proposing a Pedestrian Overpass for the Kings Park Shopping Center at the intersection of Braddock Road/Burke Lake Road/Woodland Way. County staff presented design options for the bridge and answered questions from the audience.



Community input will guide County staff in making final decisions on the Kings Park overpass and any other potential locations. Community members attending the meeting were near unanimous in their support for this overpass.

Additional pedestrian crossings under consideration include Stonehaven Drive, Wakefield Chapel Road, and Port Royal Road. The Stonehaven location was suggested because of the available right-of-way, the proximity to Parkwood Baptist Park and Ride, and the large gap between traffic signals at Burke Lake Road and Southhampton Drive. The Wakefield Chapel location is being considered because of its available right-of-way and proximity to the Canterbury Woods Park and Ride. The final suggested crossing at Port Royal Road was presented due to its available right-of-way and access to the Ravensworth Shopping Center.

# Citizen of the Month



The Braddock Citizen of the Month for July is Brian Jackson from Burke, VA. Jackson was awarded a \$10,000 Live Mas scholarship from the Taco Bell Foundation for his work coaching the Fairfax Fury Special Olympics Track and Field Team. The George Mason student is a Therapeutic Recreation major and a jumper on the George Mason Track and Field Team.

Jackson told the *Braddock Beacon* that coaching helped him learn about the difficulties and triumphs parents of children with disabilities face. He

worked with children of different abilities for several years, but rarely worked with their parents until he started coaching.

"In this program the parents all come to practice and as the coach, I work



closely with a lot of them," Jackson said. "It lets me see just how much love and pride they all have for their children, and it's a pride that I share."

The Taco Bell Scholarship Jackson won is given to the "next generation of innovators, creators and dreamers," Taco Bell said. Students had to submit a 2-minute video where they talk about their life's passion to win a scholarship. The competition received over 8,000 applicants from across the country.

## **Constituent Services**

A constituent called to find out why the County does not have an anti-littering law against businesses that drop leaflets in the driveway. A staff member called the County Attorney's office and was told this falls under "free speech," which was determined by the US Supreme Court.

A constituent called concerned about foxes acting aggressively, coming on to the property and possibly harming local pets. A staff member emailed a County wildlife expert who had Animal Control contact the constituent and advised them about the signs of rabies, mange, and when an officer would respond.

Two constituents called the office about collapsing sidewalks. A staff member contacted VDOT and the sidewalks were repaired shortly after.

A staff member made several requests to VDOT to mow grass in the right of way areas that are not in road medians.

A staff member is working with a group of residents who are concerned about speeding on Whitacre Road.

A staff member sent suggestions to VDOT for traffic calming measures on roads in Burke Centre.

FROM AARP's FRAUD WATCH NETWORK: Summer Time is Prime Time for Home Repair Scams The summer months are prime time for home repair scams. HOW IT WORKS: The general ruse involves someone coming to your door and offering to do work on your home, typically at a big discount. Do your research if an offer seems too good to be true. How it works: A con artist representing himself as a contractor comes to your door and claims he has just finished a job for a neighbor. Since he's in the neighborhood, he'll say, you can get work done at a steep discount. While that's a common sales tactic, it can also be a sign of a scam. Scammers will demand payment upfront, and then disappear. Or they'll do the work but it will be

WHAT YOU SHOULD KNOW: Be wary of anyone who comes to your door and offers to fix a problem. The con artist will try to pressure you into making a decision quickly. He or she will likely ask you to pay for the work upfront.

WHAT YOU SHOULD DO: Get a written estimate and compare bids before starting any work. Ask a contractor for three references – and check them. Check with the <u>Better Business Bureau</u> for complaints before you hire a contractor. Make sure you have a written contract before work starts. Be careful if you choose to work with contractors who contact you. When you do need to get work done, ask friends, neighbors and relatives for recommendations. Most importantly, never pay a thing until you have a written contract in hand. When it comes to fraud, vigilance is our number one weapon. You have the power to protect yourself and your loved ones from scams.

#### Comprehensive Plan for Northeast Corner of Braddock Road and Roberts Road

A proposal has been filed to create a high-end residential development at this site, which is approximately 9.56 acres and is zoned R-1. It is currently developed with three single-family detached homes and a church, which

would be removed. The property owner has proposed developing it with 45 single-family detached homes and amenities such as a corner park and picnic area, community garden, tot lot, and open lawn area. Access to the property would be from a single entrance on Roberts Road, midway between Braddock Road and Shenandoah Lane.

Supervisor Cook held a second community meeting on July 2 to get input from residents about development at this site. Issues discussed included traffic (particularly increased traffic on Roberts Road), density of any development, tree save, stormwater, and screening. County Planning staff will be taking the comments from that meeting, their own research and additional data collection, and will be preparing recommendations for a Comprehensive Plan Amendment for this site. The staff recommendation is due in October and will be considered by the Braddock District Land Use and Environment Committee at its October 16 meeting. ### Cases Filed Before the Planning Commission & Board of Supervisors

The Woodlands Retirement Community 4320 Forest Hill Drive, Fairfax SEA 97-Y-035-02 & PCA 1997-SU-027-02

The Woodlands Retirement Community has filed a Proffer Condition Amendment and a Special Exception Amendment to construct 42 additional surface parking spaces on the property for a total of 98 surface parking spaces and 86 underground parking spaces. This is still fewer than the 126 parking spaces authorized in the original approval. The applicant has also requested a reduction in the minimum age of residents from 62 to a minimum age of 55 to be consistent with the Federal Fair Housing Act and other age-restricted communities in Fairfax County.

A public hearing before the Planning Commission is scheduled for July 12. ### **Cases Filed Before the Board of Supervisors**

### The Ridgewood 4209 Ridge Top Road, Fairfax

The Ridgewood building is a mixed-use development, which was zoned to allow for multi-family residential, office, and retail uses. The approved rezoning application specified the secondary uses that are permitted byright on the property. A Taekwondo studio has expressed interest in locating in an empty retail space in the building. However, a Taekwondo studio is classified as a "private school of special education," which is a permitted secondary use in the zoning district, but was not listed in the proffers for this property. The request has been filed as a Minor Variation, which is permitted if the Zoning Administrator determines that the use substantially conforms to what has been approved and does not materially alter the character of the development. If the Zoning Administrator determines that the use is compatible, the application would then go before the Board of Supervisors for a final decision. We anticipate that this application will be considered by the Board of Supervisors on July 31.

#### **Braddock District Land Use & Environment Committee**

### **Zoning Ordinance Amendments**

#### **Short-Term Lodging (STL)**

#### (Residential Owner/Renter Operated Dwellings Only)

The Planning Commission on June 21 unanimously recommended approval of a Short-Term Lodging Zoning Ordinance Amendment for residential owner/renter operated dwellings. Short-Term Lodging (STL) is identified as any occupancy of a dwelling for a period of less than 30 days. This type of stay is offered on platforms such as Airbnb, VRBO, and FlipKey. The Zoning Ordinance currently does not permit such uses in any dwelling unit and only allows short-term overnight stays as a hotel/motel or bed and breakfast, both of which could require a rezoning or Special Exception.

The goal in developing this proposal was to balance the interests of residents in protecting the character of their neighborhoods with the interest of residents who want to operate STLs in their residences. After extensive public input, County staff developed proposed regulations and the Planning Commission recommended approval of the language in the staff report with three main changes: reducing the maximum number of nights a dwelling may be used as STL, reducing the maximum number of occupants, and requiring at least one parking space. The Planning Commission also recommended that the Board of Supervisors authorize staff to prepare a follow-up Zoning Ordinance Amendment to establish a Special Permit process to allow an operator to request additional nights per year or increase the number of occupants allowed and address enforcement. The proposed Zoning Ordinance Amendment would become effective on October 1, 2018, to give residents time to come into compliance.

The proposal recommended by the Planning Commission would:

- Only allow property owners or renters to offer their primary residence as short-term lodging. This limitation is to prevent businesses from operating multiple, full-time rentals, like a hotel or motel, in residential neighborhoods.
- Limit the number of nights to 45 per year total, of which no more than 15 nights may be without the operator present.
- Limit occupancy to four adults (except where the Building Code provides for a lower maximum occupancy).
- Allow only one rental contract per night, not multiple rentals.
- Require the designation of one parking space available for lodgers, and identify other available parking or public transportation options.
- Prohibit hosting commercial events, like parties, weddings or fundraisers.
- Require that the operator identify an authorized agent who will be available to address issues or emergencies that may arise in the absence of the operator.
- Require a STL permit, which would cost \$200 and be valid for two years.
- Require operators to pay a 6% Transient Occupancy Tax, which would be divided evenly among a general tax, a tourism tax, and a share for regional transportation.
- Establish a Special Permit process to allow an operator to request additional nights per year, with or without the operator present, and/or increase the number of adult lodgers permitted per rental contract. The Special Permit option should include a requirement for a fire and safety inspection, including an appropriate fee for such inspection, and a Special Permit fee of not less than \$910.

- Limit the appeal period for a Notice of Violation citing violations of the Short-Term Lodging Ordinance to ten days, rather than the 30 days currently authorized.
- Request a report to the Planning Commission and Board of Supervisors 12 or 18 months after the effective date to recommend amendments to the ordinance or to the enforcement policy, if such changes are deemed necessary.
- Explore the possibility of entering into an agreement with the three major hosting platforms (Airbnb, VRBO, and FlipKey) to remove non-compliant operators from those platforms.

The Board of Supervisors may adopt the staff recommendation, the Planning Commission recommendation, or other alternatives as long as they fall within the advertised parameters. Residents who have concerns about an application are encouraged to submit a letter for the record or testify at the hearing on the case.
