#### Neighborhood College Returns

#### FY2019 Budget Town Hall Meeting

I will be hosting a Town Hall Meeting on the 2019 budget with County Staff to hear your opinions on the budget plan proposed by the County Executive. The meeting will take place on March 14, 2018 at 7:30 PM in Braddock Hall, 9002 Burke Lake Road, Burke, VA 22015 (accessed through the back entrance of the Kings Park Library). It will be held in conjunction with the Braddock District Council meeting and will feature staff members from the Office of Management and Budget. You may also submit your comments to my office at Braddock@fairfaxcounty.gov or call 703-425-9300. I want to hear your opinions and will keep them in mind prior to making a final decision on the budget.

Fairfax County Executive Bryan Hill presented his budget proposal last month to the Board of Supervisors marking the beginning of budget season. He recommended a real estate tax rate increase of 2.5 cents (from \$1.13 to \$1.155 per \$100 of assessed value). This increase would fully fund the Fairfax County Public Schools' request and the County employee compensation plan. This plan would also cover many of the Board of Supervisors' priorities (including Diversion First and Gang Prevention). The average Fairfax County resident would see \$268 added to their tax bill. You can find more details on the proposed FY2019 budget here.

This significant increase gives me some real concerns. This budget plan funds top Board priorities such Diversion First and increased teachers' salaries. However, I would have preferred to see some proposals for reductions in non-priority programs as a better way of funding key priorities.

The County Executive's proposal is only the first step in our budget process. Your opinion matters. I look forward to hearing your thoughts on this year's budget and tax rates.

## Community Input is Key on Whether to Save Lake Accotink

The future of Lake Accotink is in your hands. Sediment from construction and other man made actions is threatening Lake Accotink's existence and it will cost a considerable amount of money to maintain it.

The Park Authority has presented six options for the future of Lake Accotink. However, the options that save the lake and its watersport recreations will require dredging that will cost between \$29 and \$45 million. The Park Authority cannot fund this scale of a project on its own. In order to save the lake, the Board of Supervisors would have to allocate the funding within the General Fund Budget, most likely through a bond called a capital expenditure. I need your comments and input on whether the Board should allocate the funding

for the options that save the lake, or let the lake fill in whole or in part under other options.

I held a joint meeting with Supervisor Jeff McKay last month at Lake Braddock Secondary School to discuss the options and their impact to the community. Over 200 people attended, including members of the newly formed Save Lake Accotink group and Friends of Lake Accotink Park.

Community members asked questions and spoke about their concerns with the options' effects on property values, ecosystem, and wildlife. Some introduced great ideas for alternatives to the proposed options. Many others gave heartfelt testimony on how important the lake was to our community. Everyone came together to figure out which option will best serve the community for years to come.

I cannot stress enough how much we need your input on these decisions. Whatever option is chosen will have major financial, environmental, recreational, and community impacts. Option A is the "do nothing" option that the lake will fill in on its own by 2025 and become a marshland. Option B proposes the current maintenance method of dredging the lake every 15 years, at a cost of \$29 million each time. Option C keeps the lake at its current 50 acre size with an initial \$45 million full dredging. This would be a deep dredge and would be followed by the construction of mini lakes, called forebays, which would capture incoming sediment and protect the main lake from filling up with sediment. These forebays would need to be dredged annually, but at a relatively small cost. Option D is a cheaper, but temporary option that has beaver dams built upstream to collect sediment. The issue is that the dams would fill up with in five years and would leave us in the same place we are now. Option E would transform the lake into a stream valley by removing the dam structure. The initial cost would be \$11 million with minor annual expenditures to maintain vegetation. Option F is a compromise of the other options that cuts the lake in half and redirects the stream around it. This would cost \$13,218,000 to implement. Whether you like to fish on the lake, boat with your friends, run on the trails, or watch the birds in the woods, each option impacts these activities one or another. Options A and E would remove watersport and change the ecosystem significantly. Meanwhile Option F will limit the amount of water recreation activities. The dredging required to keep the lake would require significant construction activities and the potential of significant truck traffic to remove sediment. This decision is too important to leave up to chance, which is why I ask once again for your input.

My office will host another community meeting in late this spring to provide updates to the community and open the floor for discussion. The Park Authority has extended the comment period on the future of Lake Accotink until May 28. You can submit comments to my office directly at braddock@fairfaxcounty.gov. #### What To Do If You Have Storm Damage

There has been a significant amount of home and car damage related to the wind storm. If you have a safety concern, only call 9-1-1 for emergencies; otherwise call 703-691-2131.

If your power is out, contact your provider:

- NOVEC, call 1-888-335-0500; online at <u>www.novec.com/stormcenter</u>

Here are some tips and resources to help you with storm damage:

#### Insurance

- Contact your insurance company or agent to report any claim that you may have.
- If you do not know your insurance company's telephone number or otherwise need assistance, contact the Bureau of Insurance at 804-71-9741 or toll-free 1-800-552-7945, or email <u>bureauofinsurance@scc.virginia.gov</u>.
- If you experience problems contacting your insurance company, you need to be persistent. Some insurance companies may have problems with their phone lines due to a high volume of calls, etc.
- Take pictures of your damaged property so that these can be given to your insurance company. You should also save any receipts for repair costs and do anything that is appropriate to prevent any further damage to your property.
- If you experience problems in getting your claims paid or have general insurance questions, the bureau has specially trained representatives that can provide you assistance.

#### Contractors

The aftermath of severe storm damage often results in an increase in consumer complaints resulting from contractor fraud or shoddy repairs by unlicensed contractors. If you have a question contact Consumer Affairs at 703-222-8435, TTY 711, to speak to a consumer specialist. Business hours are 8 a.m. to 4:30 p.m. Monday through Friday.

- Always ask to see a copy of a contractor's license from the Virginia Department of Professional and Occupational Regulation (DPOR). You can visit <u>DPOR's website</u> to check for a valid contractor's license or call 804-367-8511, TTY 711. Any contractor seeking work through home solicitation must carry a solicitor license issued by the <u>Fairfax County Department of Cable and Consumer Services</u>.
- Call the Fairfax County Department of Land Development Services Permits Branch, at 703-222-0801, TTY 711, to determine whether a permit is necessary for the intended work. Ask for information on each contractor's licensing and disciplinary status.
- Obtain bids from three contractors, ask for three references from each and find out if the contractor provided a monetary discount or payment in exchange for using a consumer as a reference.

This month's award goes to North Springfield Civic Association president Ken Balbuena and Ravensworth Farm Civic Association president Allan Robertson for

their community organizing efforts in response to the proposed changes for Lake Accotink. After the Park Authority's Lake Accotink community meeting in January both community leaders recognized that this decision called for heavy community involvement. Balbuena reached out to Supervisor Cook's office to

schedule a joint meeting with Robertson to find out what their organizations can do to save the lake. Both leaders called for an emergency meeting with their civic associations immediately. At the Ravensworth Farm CA meeting the attendees decided to form their own community group called "<u>Save</u> <u>Lake Accotink</u>" to help collect 1,000 signatures for a petition. Robertson was named President and Chair of the group's board. Robertson and Balbuena's diligent work prompted this impressive community engagement and created widespread awareness of the proposed changes to Lake Accotink's Master Plan.

#### Supervisor Cook Seeks Community Services Board Member

Supervisor Cook is looking to fill a slot on the Board of the Fairfax-Falls Church Community Services Board (CSB).

Members of the CSB are volunteers who are appointed by the City of Fairfax, the City of Falls Church, their county district supervisor or by the chair of the Fairfax County Board of Supervisors. One member is appointed by the Fairfax County Sheriff. Board members may serve up to three terms consecutively, and each term lasts three years. The CSB oversees county programs on mental health, addiction services, and developmental disabilities.

Members attend monthly meetings of the Board, typically on the fourth Wednesday. Additionally, members are required to serve on at least one standing CSB Board subcommittee. Most of the meetings are held at the Merrifield Center, 8221 Willow Oaks Corporate Drive, Fairfax, VA 22031. Board members participate with local government in the appointment and annual performance evaluation of the agency's Executive Director.

CSB Board members also nominate and elect officers of the Board, review the annual CSB budget request to the County and the State Performance Contract with the Commonwealth of Virginia. Additionally, Board members endorse the agency's strategic plan; develop, revise, and approve relevant agency policies and in so doing ensure that Board policies and procedures properly protect the rights of all individuals of the agency. #### **Comprehensive Plan Amendments**

#### **Training Center Site Task Force Begins Work**

The Training Center Site Task Force has held three meetings since beginning work at the conclusion of the January 20 community planning workshop. Using the Needs Assessment and input given at the workshop, the Task Force is working to develop options for a Comprehensive Plan for the site. Several options will be presented at a community meeting to be held on Monday, April 23, in the Gold Cafeteria of Robinson Secondary School, at 7:30 p.m. Based on the input from that meeting, the Task Force will refine the plan and present its official recommendation to the community in late June.

The Task Force began its work by reviewing the comments made by participants at the January workshop. Park Authority staff presented information on the existing parks within the Braddock District, service level standards, and existing needs based on those standards. At the top of that list are multi-use courts, indoor gyms, and rectangular fields. The Task Force will next meet with staff from Neighborhood and Community Services regarding the needs they see in the community and have a discussion regarding affordability.

In preparation for the April community meeting, the Task Force is working to develop two or three proposed land scenarios for the entire property, including the former NVTC site, the State Police site, and the area currently planned for a DMV office. Those proposals will then be analyzed for their impact on the community, including on schools, parking requirements, and traffic.

### Proposed Housing Development at Braddock Road and Roberts Road RZ/FDP 2017-BR-030

On February 14, Supervisor Cook hosted a community meeting to discuss a proposal by the Peterson Companies to create a high-end residential development at the northeast corner of the intersection of Braddock Road and Roberts Road. This site, which is approximately 9.56 acres and is zoned R-1, is developed with three single-family detached homes and a church, which would be removed. The property owner outlined their vision for this site, which would include 49 single-family detached homes and amenities such as a corner park and picnic area, community garden, tot lot, and open lawn area. Access to the property would be from a single entrance on Roberts Road, midway between Braddock Road and Shenandoah Lane.

Because this site has not gone through a Comprehensive Plan review in a number of years, Supervisor Cook made a motion, which was adopted by the Board of Supervisors, to begin a planning process to consider the owner's proposal along with other potential land uses for the site. The community meeting was the first step in this process. Area residents had the opportunity to ask questions and comment on the potential development. The focus was on what uses would be a good addition to and be compatible with the community. The primary concern raised by neighbors was traffic, particularly increased traffic on Roberts Road. A second and related issue was pedestrian crossings on Roberts Road. Some residents also expressed concerns over the density of the proposal.

Staff from the Planning Division, who were present at the meeting, are looking at options for a Plan Amendment to consider potential changes. Those options will be presented to the community for consideration at a follow-up meeting later this spring. The rezoning proposal has been deferred while a Comprehensive Plan Amendment is being considered.

#### **Cases Filed Before the Planning Commission & Board of Supervisors**

#### Goddard School Child Care Center 11909 & 11917 Lee Highway and 4613 Holly Avenue SE 2017-BR-023

On February 8, the Planning Commission voted to recommend approval of the application of Daniel and Matthew Investments LP to build a Goddard School private preschool and daycare facility on four parcels of land located at the southeast corner of Lee Highway and Holly Avenue. Based on input from the community and County staff concerns about intensity of use, the applicant proposed a decrease in their maximum enrollment from 200 to 150 children. The revised plans also indicate that the applicant would construct a dedicated right turn lane from Holly Avenue onto Lee Highway (eastbound) in addition to the existing lane, which will be used for traffic going straight or turning left (westbound). The applicant committed to prepare a revised plan addressing additional Virginia Department of Transportation comments, including an optional entrance slightly further south on Holly Avenue, a VDOT-approved turnabout for the service drive or additional right-of-way dedication, and a 40-foot-wide entrance or as needed to satisfy VDOT requirements to accommodate larger service vehicles and buses.

#### **University Mall**

#### PCA C-083-03 with PCA 2009-BR-015

The owner of University Mall has filed an application to allow rental of an existing building which was designated for removal to allow future transportation improvements. When the shopping center was renovated, the proffers prohibited renewal of the lease for the former bank on the northwest corner of the property because that land area is reserved for right-of-way dedication for the eventual widening of the Braddock Road/Ox Road intersection. The bank has moved out and the building is now vacant. VDOT recently made improvements to that intersection and does not plan to do anything further for a number of years. The shopping center owner would like to rent the building to another permitted user rather than leave it empty. The new lease would require the tenant to vacate the premises and terminate the lease if VDOT requests to use the dedicated area.

The Braddock Land Use and Environment Committee approved a motion expressing no objection to the proposal. On February 22, the Planning Commission recommended approval of this application. The case is scheduled to be heard by the Board of Supervisors on **March 6**. #### 2232 Public Facilities Applications

### Stormwater/Wastewater Consolidated Facility at Freds Oak Road 2232-B17-21

On February 22, the Planning Commission approved the county's proposal to expand its current Wastewater Collection Division facility at 6000 Freds Oak Road to consolidate the Wastewater Collection, Maintenance and Stormwater Management, and Stormwater Planning Divisions. Because this is a proposed county government facility, the proposal was considered under the 2232 Review Process, in which the Planning Commission determines if the proposal is in substantial accord with the county's Comprehensive Plan in terms of character, extent, and location. The proposal did not go before the Board of Supervisors for consideration.

The Department of Public Works and Environmental Services will now work to finalize their plans, obtain permits, and actually construct the facility. This process is expected to take several years. They will continue to work with VDOT on the traffic concerns that were raised by residents during consideration of this facility.
