Dear Neighbor,

The best part of my job is the opportunity to see – and support – the amazing work that community volunteers and organizations do in collaboration with Fairfax County. Last week, I spent a day in the Annandale area of the Braddock District, visiting the many non-profits, faith groups, and volunteers providing support and opportunity to one of our highest-need areas. Annandale is one of our designated Opportunity Neighborhoods, facilitated by FACETS, a local non-profit, and funded by Fairfax County. Opportunity Neighborhoods is an initiative that brings together residents, service providers, and schools to create a shared vision to address needs and improve opportunities.

I started at the relatively new Annandale Community Center (ACC), a center we opened just last year. There, the Boys and Girls Club of Greater Washington and Fairfax County



Neighborhood and Community Services offer free afterschool programming for kids and teens. Kids can access technology, make art, get homework help, and just hang out. The Boys and Girls Club gives kids opportunities

they might not have had otherwise and relieves hard-working parents from the costly burden of after-school and summer care.

From there I headed across the street to the Annandale United Methodist Church Mission Center for their Thursday food distribution, where each week they provide food and other necessities to hundreds of families.

Untangling some zoning and fire code hurdles allowed the Mission Center to partner with the <u>Medical Care for Children Partnership Foundation</u> to open a low-income dental clinic in the basement. They haven't officially cut the ribbon but are already examining kids and connecting them to higher-level dental care.

Next, I headed over to **Burke Presbyterian Church**, where they were hosting a hypothermia shelter. Every year I try to visit each of the faith community-hosted shelters in the Braddock District to thank the volunteers and get to know those experiencing homelessness.

Later that evening, I went back to the ACC, where the kids had gone home for the evening and the **English Empowerment Center** was holding a night class for English

learners. When planning for the ACC, we held a series of meetings to hear directly from the community about what they most needed, and language learning opportunities were the top request.



The following day I joined the School Board's Mason District Representative, Dr. Ricardy Anderson, at Braddock Elementary School to read with students through <u>Read On</u> <u>Young Readers</u>, a non-profit partner that focuses on literacy learning loss by partnering trusted volunteers with students.

The organization was founded to mitigate the potential reading and English language loss to students due to remote learning during the pandemic. They began working at Mason Crest Elementary School and expanded to Braddock Elementary in 2022!

During the COVID-19 pandemic, the Annandale area of the Braddock District had some of the highest need for food, medical, rent, and other supports that we provided. Since



then, we've been working to fill in the gaps and provide support across the spectrum – from renovations at Braddock Elementary School, opening the ACC, and uplifting partner organizations like the Mission Center, the Enalish

Empowerment Center, Read-On Young Readers, and more. While there is a lot of work to be done, it is powerful to see how far we've come by working together.

I'm deeply appreciative of the community members involved in these organizations, along with the dedicated staff of **Braddock Elementary School**, **Annandale High School**, and Fairfax County. If you'd like to get involved in or support any of this work, please reach out to my office.

## Update on Proposed Stadium at George Mason University

Thank you to all the residents who contacted me with concerns about the proposed cricket facility at George Mason University's West Campus property. Late this morning, we received an important **update from GMU**. GMU and Washington Freedom have committed to not begin construction on such a facility until they meet with the community to hear their concerns in person. They also stated that the discussion is for cricket matches to take place in July 2025.



# **THRIVE Applications Open Now!**

Last year, Fairfax County introduced **THRIVE** – a technical assistance program



dedicated to small business growth. Through this program, approximately 600 businesses will receive consulting services valued up to \$10,000 to help them reach their business goals and continue their post-pandemic recovery.

By offering coaching and consulting services, THRIVE aims to

mitigate the negative COVID-19 economic impacts on local small businesses. Fairfax County's Board of Supervisors authorized \$7,000,000 from the American Rescue Plan Act (ARPA) to establish the THRIVE program. The Latino Economic Development Center (LEDC) will serve as the program grant administrator.

# Serve on a Board, Authority, or Commission

Are you looking for a way to serve your community? There are 84 **Boards**, Authorities, and Commissions (BACs) in Fairfax County that serve in an advisory role to the Board

of Supervisors on a wide range of topics. Most members of these BACs are appointed by the Board and are selected for their experience or expertise in the subject matter, their ties to the community, and their willingness to invest their time and energy. Supervisor Walkinshaw makes nominations to the Board when vacancies arise for Braddock-based and some at-large seats on BACs.

If you are interested in serving, please send your resume and an up-to-500-word statement of interest to <u>braddock@fairfaxcounty.gov</u>. As vacancies arise, Supervisor Walkinshaw refers to the Braddock District's list of those who are interested in serving. Several vacancies are now announced. Position descriptions and application information are below:

### ■ BOARD OF EQUALIZATION OF REAL ESTATE ASSESSMENTS

The Board of Equalization (BOE) is an independent body appointed by the Board of Supervisors to review real estate tax assessments. The BOE, which currently consists of nine members, is concerned with the fairness and equity of assessment values determined by the Department of Tax Administration (DTA). The BOE has the power to increase, decrease, or keep the same assessment upon its review. The BOE acts under the authority and powers conferred upon it by Code of Virginia §15.2-840 and the provisions of Article 14 (§ 58.1-3370 et seq.) of Chapter 32 of Title 58.1 of the Code of Virginia, as amended.

All meetings are conducted in accordance with Chapter 37 of Title 2.2 of "The Virginia Freedom of Information Act" (VFOIA).

- Stipend: \$300 per meeting (The BOE normally meets three times a week seasonally at the call of the BOE Chairman)
- Job Duties:
  - Hear oral testimony and review applicable documentation and evidence presented by the Taxpayer/Taxpayer Representative and the Department of Tax Administration (DTA) regarding the current year's assessment.
  - In meetings guided by Robert's Rules of Order, after both sides have presented their arguments, the BOE members will generally vote to either increase, decrease, or affirm the assessment.
  - The BOE position is seasonal and may last from June through the following March; however, the season typically ends in November or December.
  - The typical number of cases heard on a specific date are between four and six.
  - Depending on the number of appeals, the BOE may have panel hearings on Monday and Thursday evenings if there is a quorum of at least three BOE members.
  - In accordance with Code of Virginia <u>§58.1-3374</u>, as amended, when a BOE panel hears an appeal concerning a commercial, industrial, or multi-family residential, at least one panel member must be a

commercial or residential real estate appraiser, other real estate professional, builder, developer, legal professional, or financial professional.

- Minimum Qualifications:
  - Must be a Fairfax County resident.
  - The BOE is generally comprised of nine members who are residents, and a majority are property owners in Fairfax County. Of the nine BOE members, three shall be members at-large and six shall be commercial or residential real estate appraisers, other real estate professionals, builders, developers, or legal or financial professionals.
  - The BOE members serve in two-year staggered terms with the Chairman and Secretary of the BOE elected annually by the members of the BOE.
  - Must have knowledge of and experience with commercial and residential real property.
  - To serve, each prospective member must attend and participate in the Virginia Department of Taxation BOE training every four years and take continuing education instruction provided by the Tax Commissioner.
  - Must be available to attend hearings as scheduled, currently on Monday and Thursday evenings from 7:00 p.m. to 9:00 p.m. and on Wednesday mornings from 9:30 a.m. to 11:30 a.m. in the Government Center as advertised in the annual Notice of Meetings.
- If you are interested in serving on the Board of Equalization, please contact Chairman Jeff McKay's office at <u>chairman@fairfaxcounty.gov</u> and be prepared to provide a current résumé. Please note that certain members of the BOE must file financial disclosure statements upon appointment and annually thereafter.
- Members of the BOE must follow the Virginia Freedom of Information Act (VFOIA). This act ensures that the people of the Commonwealth have ready access to public records in the custody of a public body or its officers and employees and free entry to meetings of bodies wherein the business of the people is being conducted.

### ANIMAL SERVICES ADVISORY COMMISSION

The <u>Animal Services Advisory Commission</u> serves in an advisory capacity to the <u>Animal Shelter</u> Director and the Board of Supervisors on issues relating to animal health and welfare. It serves to enhance the existing mission and goals of the agency, i.e., to promote responsible pet ownership, to reduce euthanasia and pet overpopulation, and to continue to maintain certification for Shelter Standards of Excellence.

 The Board of Zoning Appeals has <u>upcoming</u> <u>openings for two members</u>. One seat is available now and the other will open on June 14.




- Interested candidates for either position must apply by March 15 to the <u>Fairfax Circuit Court</u>, which appoints the board's seven members.
- Applicants should send their resume to Chief Judge Penney S. Azcarate, Fairfax Circuit Court, by email entitled "Board of Zoning Appeals Application" to <u>kim.callahan@fairfaxcounty.gov</u> OR by first-class U.S. mail to:

    - NOTE: THE APPLICATION SHOULD BE SENT VIA ONLY ONE FORM OF CORRESPONDENCE, WHETHER EMAIL OR U.S. MAIL.
- This position will be for a five-year term from the date of appointment. Members of the Board of Zoning Appeals are appointed for staggered fiveyear terms; are compensated at a bi-weekly rate of \$357.69; and serve as private citizens, not as County employees.
- Applicants **must** be residents of Fairfax County. Previous applicants are encouraged to reapply.
- The Board of Zoning Appeals' powers, duties and procedures are outlined in state law, and they are further detailed in the County's <u>Zoning Ordinance</u>.
- These duties include:
  - Hearing and deciding appeals of administrative decisions made pursuant to the Zoning Ordinance.
  - Hearing and deciding applications for <u>special</u> <u>permits</u> and <u>variances</u> as authorized by the Zoning Ordinance.
  - Hearing and deciding applications for interpretation of the <u>zoning</u> <u>map</u> where there is uncertainty about the location of a zoning district boundary.

Over the last 20 years, over 100,000 native tree and shrub seedlings have been distributed to Fairfax County residents and those in the surrounding area, through this annual sale. In 2021, NVSWCD partnered with the Fairfax County Park Authority to target socioeconomically vulnerable communities identified through One Fairfax that also have poor tree canopy coverage. NVSWCD donated over 2,000 seedlings to be planted in these areas by FCPA Invasive Management Area volunteers.

All seedlings are native to Northern Virginia and were selected with advice from the Fairfax County Urban Forestry Management Division, and the Virginia Department of Forestry. Sale proceeds help to support the stewardship and engagement programs offered by NVSWCD that also support Fairfax County's Environmental Vision, including those that engage the Fairfax

County community in additional local reforestation efforts, volunteer stream monitoring, our local Envirothon high school competition, storm drain marking and education, Green Breakfasts, and others.

## Tax Credits Can Now Be Applied at Point of Sale for EVs

It's easier now to claim the tax credits available for the purchase of new and used electric vehicles. Since January 1, 2024, buyers of new and used electric vehicles (EV)



have been able to reduce the upfront purchase price of their vehicle by the amount of their Clean Vehicle Tax Credit if they transfer the credit to their car dealer.

Previously, eligible EV buyers could only receive this credit after filing their tax returns. Additional requirements apply for vehicles delivered on or after January 1, 2024, and the amount of the credit will depend on whether the vehicle meets critical minerals

and battery components requirements for vehicles delivered after April 17, 2023. # **Compliance Corner**



Fairfax County Department of Code Compliance (DCC) Who are we and what do we do?



## What is compliance? How does it work?

Compliance means following the rules and regulations that apply to properties in the County. DCC responds to reports of code violations and prioritizes cases where there is danger to the health and safety of the public.



## What rules should I know about?

DCC handles various code violations, such as: zoning; property maintenance & fire safety; construction without approval; tall grass; bamboo; noise; and illegal signs in the roadway.

## What happens during an investigation?

Reports are received and assigned to investigators. If problems need to be fixed, we issue a "Notice of Violation," or NOV, which says what needs to be done by a deadline.

We work with the community to seek solutions and compliance. However, refusal to comply may result in legal actions.

# **Transportation Updates**

## Rolling Road Widening Project – Phase 2

Rolling Road between Viola Street and Old Keene Mill Road

The widening of a 1.3-mile stretch of Rolling Road from Viola Street to Old Keene Mill Road is moving forward. The project is split into two phases:

Phase 1 (Complete): Construction of an additional turn lane from northbound Rolling Road to westbound Old Keene Mill Road and the addition of a dedicated right turn lane from northbound Rolling Road to eastbound Old Keene Mill Road. The signal was upgraded and the alignment of the intersection improved. This is now working to ease some of the



congestion at the Rolling Road and Old Keene Mill light.

**Phase 2**: Widening Rolling Road from 2 to 4 lanes along the corridor, including a grass median in sections, adding pedestrian and bike facilities, a new traffic signal at Greeley Boulevard, and construction of noise barriers. The pedestrian and bicycle facilities include an 8' asphalt path on the west side and a 5' concrete sidewalk on the east side. Land acquisition is complete and utility relocation is ongoing.

Construction should start by the end of the year and take two years to complete. When the contractor is selected and on board later this year, a more detailed construction timeline will be available that includes milestones and will be shared at a "Pardon our Dust" meeting.

## FCDOT Conducting Route 29 Study

The Fairfax County Department of Transportation (FCDOT) is conducting a study on the Route 29 corridor, between Buckleys Gate Drive/Summit Drive near the Fairfax County



Parkway (VA 286) and Jermantown Road.

The purpose of this study is to reassess the long-term needs of the corridor and develop solutions that serve residents and commuters, including multimodal options. Feedback from this survey will help inform the Fairfax County Comprehensive Transportation Plan.

## Metro Budget – Comment through March 5

The Washington Metropolitan Area Transit Authority invites the public to <u>comment on</u> <u>the FY 2025 Budget</u>. Unless additional funding comes in from DC, Maryland, and



Virginia, drastic cuts would take place, including the <u>elimination of the 17</u> and 18 Bus routes that serve the Braddock District. However, WMATA's management provided a <u>revised forecast</u> that would "maintain bus service levels and begin Better Bus implementation." Virginia's commitment is contingent upon funding from both the Commonwealth of Virginia and the Northern Virginia localities that are served by Metro.

As Chair of the Board's Legislative Committee, Supervisor Walkinshaw is pressing the General Assembly for the inclusion of Metro funding in the State Budget, which is currently under consideration in Richmond. Fairfax County's **proposed FY25 Budget** includes the County's share of Metro funding.

## Accessible Off-Street Parking Survey Now Available

The federal Americans with Disabilities Act gives people with disabilities the right to access public programs and public accommodations. Having accessible parking spaces, and the ability to reserve those spaces for people with disabilities, is vital for access.

Fairfax County's Land Development Services focuses on the safe and sustainable building of our communities, which includes the regulation of off-street parking areas. LDS is conducting a <u>survey to determine the nature and extent of available accessible</u>, <u>off-street parking within Fairfax County</u>. Information from the survey will help provide a more informed view of accessible parking as the County considers and evaluates future options. If you have an accessible parking placard or license plate from the Department of Motor Vehicles or if you are a caregiver for a person with a placard or license plate, please consider participating. The survey is available through April 15.


## Notice of Willingness to Hold a Public Hearing – Burke Centre Shopping Center Left Turn Restriction

## **FCPD Warns of Law Enforcement Impersonation Scams**

In the law enforcement scam, victims are contacted by phone, email, or in person, by a person claiming to represent the police or other government agencies. These scammers

often use intimidation tactics, such as threatening arrest or legal action if you fail to comply with their demands. They may tell you a family member has been arrested or involved in a crash that requires immediate financial assistance. The scammers demand money, gift cards, cryptocurrency, or even gold to avoid arrest.

Remember, the police will

**never** call you to ask for money, demand immediate payment to resolve legal issues, or offer to drop charges or warrants in exchange for payment. If you get a call about a family member being arrested or in a crash, hang up and call them immediately.

How can you protect yourself? Remember these tips and share them with your family members to help avoid falling victim to a scam:

- 1. Verify the Caller's Identity: If you receive a suspicious call, ask for the caller's name, badge number, and department. Hang up and independently verify their identity by calling the official non-emergency number of that specific agency. Scammers will spoof real government phone numbers in an attempt to legitimize their scheme.
- **2. Stay Calm and Skeptical:** Scammers often use intimidation tactics to pressure victims. Remember, legitimate authorities will not rush you into making payments or divulging personal information.
- **3. Guard Personal Information:** Avoid sharing sensitive information like social security numbers, banking details, or personal identification numbers (PINs) over the phone.
- **4. Question Unsolicited Offers:** Be wary of unexpected calls or messages claiming you've won a prize, inherited money, or that you are entitled to refunds. Always

verify the authenticity of such claims. Remember, if it sounds too good to be true - it probably is.


- **5. Gift Card Payments:** Legitimate organizations and agencies do not request payment via gift cards. Treat this demand as a red flag and refrain from making any transactions.
- **6. Educate Yourself:** Stay informed about the latest scams and fraud tactics circulating in your area.

**Report Suspicious Activity:** If you suspect a scam or have fallen victim to one, report it immediately to the appropriate authorities. You can file a report with FCPD's <u>Financial</u> <u>Crimes Unit's online portal</u>.

## **Hypothermia Prevention Program**

Since 2005, the Fairfax County <u>Hypothermia Prevention Program</u> has prevented death and serious injuries among people experiencing homelessness by ensuring that no one must sleep outside during the winter months. This program – available to any adult in need of immediate shelter – provides warm shelter, food, and other supportive



services to help connect guests to a variety of basic needs such as clothing, employment, housing, and more. It remains a highly effective partnership between government, nonprofits, and the faith community. The program is open every day around the County until March 31.

Overflow shelter capacity in the year-round adult shelters is available each night but is limited. Sign up for <u>Fairfax Alerts</u>, specifically "Homelessness Cooling and Heating Resources," for information on overflow activation.



## Planning Commission Hearing on Application for Adult Day Care Facility Scheduled for April 24

The Friends Health Care Team filed an application for a Special Exception to operate an adult day care facility on the third floor of an existing office building at 8003 Forbes Place in Springfield, near the intersection of Forbes Place and Port Royal Road and south of the Ravensworth Shopping Center. The property is zoned to the I-5 District.

The applicant previously operated an adult day care within the Calvary Church of the Nazarene in Annandale and now proposes to



relocate and enlarge its operation. According to the application, they are proposing to convert the third floor, or approximately 15,329 square feet, of the office building to adult day care use for up to 200 adults, with the first two floors of the building remaining occupied by office uses. A portion of a grassy area along the side of the building, measuring approximately 20 feet by 170 feet, would be used for outdoor recreation, consisting primarily of walking. Four standard picnic tables would be located in that area. Approximately 40 employees would be on site at any one time. Operating hours would be 7:00 a.m. to 5:00 p.m., Mondays through Saturdays. The applicant has stated that there would be minimal traffic impact, because the majority of clients would arrive by buses or minivans. The daily impact is estimated at 100 trips, primarily at 7:00 a.m. and 5:00 p.m.

Based on information the applicant presented to the Health Care Advisory Board (HCAB) and the Braddock District Land Use and Environment (BLUE) Committee, the applicant now plans to locate the facility on the second instead of the third floor of the building and said there would be additional changes to address concerns expressed by staff and the BLUE Committee. The applicant will submit a revised application reflecting these

changes. To allow time for the plans to be resubmitted, for staff to review the new materials, and for a Staff Report to be drafted, the Planning Commission hearing on the Special Exception application has been deferred until April 24. A Board of Supervisors hearing has not yet been scheduled.

Information on the application is available on the **PLUS website**. If the record does not show up from the link, select the "Zoning" tab and enter the application number, SE-2023-BR-00015, in the search box on the right side. Click on the "Record Information" arrow on the left and then click on "Attachments" in the drop-down menu. The most recent documents should be at the end of the list. Details on the application are typically in the "Statement of Justification," and the "Special Exception Plat" shows the drawings. Any schedule updates will also be listed.

# Board of Zoning Appeals Approves Application by Church of the Good Shepherd

The Church of the Good Shepherd owns 10.31 acres at 9350 Braddock Road in Burke. In general terms, the Fairfax County Zoning Ordinance allows religious assembly uses to locate within residential zoning districts under the controls, limitations, and regulations of a Special Permit approved by the Board of Zoning Appeals (BZA). The purpose of this is to help ensure the proposal is compatible with the surrounding



residential uses. The Church of the Good Shepherd has received several Special Permit

approvals over the years which permitted building additions, site modifications, and an increase in land area.

Last fall, the Church of the Good Shepherd requested to amend their previous approval for a religious assembly with childcare center to modify site conditions and remove a 3.12-acre portion of land at the northern end of the site. The Church stated that they no longer need all the previously approved building improvements. This application reduces the size of the proposed sanctuary addition from 9,000 square feet to 3,963 square feet and reduces the maximum number of seats from 942 to 688. The second and third phases of development have been combined into a single administrative building which would be three levels, measure 10,000 square feet in area, and be 36 feet tall. This building would replace the single-family dwelling located along Olley Lane. A 3.12-acre parcel at the northern end of the property would be separated so that the Church could sell the land.

The decision in this matter was made by the BZA, a quasi-judicial body consisting of seven at-large members and one alternate who are appointed by the Circuit Court of Fairfax County. The Board of Supervisors had no role in the decision-making process. The BZA determined that the proposed development with fewer buildings, less gross floor area, less impervious surface, an updated stormwater management system to meet current requirements, and new transitional screening along the north lot line would comply with the County Zoning Ordinance and on February 14 approved the application to modify the plans and remove 3.12 acres of land from the Special Permit area.

The approval was subject to numerous development conditions. The Church committed to maintain the existing 35-foot-wide conservation easement along the east lot line. A portion of the existing conservation easement will be removed from the Special Permit area. However, the BZA imposed conditions requiring the applicant to enlarge the conservation easement on the remaining Church property by an equivalent amount to retain the overall 0.9-acre size of the easement should the land area to be deleted from the Special Permit approval be developed in the future. Supplemental plantings will be provided along the site's Braddock Road and Olley Lane frontage. Transitional screening must be provided along the new north lot line adjacent to the Olley Lane driveway.

## Ask The Experts: Is My Deck Safe?

As warmer weather approaches, Land Development Services is reaching out to County residents regarding deck safety. Collapses and failures of decks, porches and balconies accounted for about 2,900 injuries between 2016 and 2019, according to the Consumer

Product Safety Commission. Jay Riat, Fairfax County's Building Official, answers a few questions to help residents ensure their decks are safe. "The health, safety and welfare of you and your family should never be compromised," said Riat.

# What is the average lifespan of a deck?

The answer to this question varies. It depends on the materials used to build the deck; how much "load" or stress your



deck has undergone and how often; the quality of the work done by the builder; how well the deck was maintained; and more. But in general, if the deck was built and inspected to code and maintained properly, it should last 20 years or more.

### How can I ensure my deck is safe?

You should be evaluating your deck on an annual basis and maintaining it as recommended by your builder. However, we recommend that you have it inspected by a licensed contractor regularly. The older your deck, the more often it should be inspected.

# Is there anything I can do to extend the life of my deck and identify any potential issues before they become dangerous?

Make sure you follow manufacturing and building recommendations for cleaning and maintenance. Minimize the stress your deck experiences. For example, you should shovel the snow off your deck after a heavy snowfall. Look at <u>this checklist</u> from the North American Deck and Railing Association and review the following critical safety elements of your deck. If you see any issues with the connection points or wood quality, consider staying off your deck until a professional inspects it, repairs it, or replaces it.

- Is the material of your wood deck still solid, no wood rot or splitting or insect damage, including the posts at the ground? If your deck is composite, is there mold growth, breakage or delamination?
- Are all the places where your deck is attached to your home secure?
- Is there rust or corrosion on any of the fasteners used to connect your decks, rails, beams, and joists together? (Look at the fasteners, bolts, brackets, etc.)
- Are the guards, rails, and stairs sturdy and well secured?

Please make sure you use your deck safely as well:

- Don't add large heavy items such as swimming pools or hot tubs on top of your deck; this is dangerous and could cause a deck to collapse.
- Make sure all stairs are well lit for safe travel after the sun goes down. This can be as simple as adding inexpensive solar powered lights.

- If you are using grills, heaters, and/or outdoor fire pits on decks, be careful and follow all rules regarding their use. In addition to structure failure or collapse, fire is also a deck hazard.
- Do not overcrowd the deck beyond its designed load bearing capacity.


Remember, before building a new or replacing an existing deck, building permits are required.

## Update on Ilda's Overlook Senior Residences on Braddock Road

Residential Use Permits for the 80 residential units and Occupancy Permits for the common areas have been issued for Ilda's Overlook, the Arlington Partnership for Affordable Housing's affordable senior housing project on Braddock Road. Thirty-two of the units are leased, so March will be a busy month as residents move in. A ceremonial grand opening will be held later this month. A few updated interior photos are below which show the furnished common space and one of the residential floor hallways.



## **Update on Erickson Living's Woodleigh Chase Project**

Erickson Living's Woodleigh Chase campus on Braddock Road is also preparing to open this month. Emerson Square, at the center of the first three buildings, is expected to begin accepting their first residents on March 12. Erickson Living has said that move-ins will proceed slowly, with only one to two per day. Fulton Landing, just to the west, will start accepting residents on March 18. The buildings are not expected to be fully occupied until summer. Move dates haven't been confirmed for Stafford Glen, the building on the east side.

## **Update on the One University Project**

Public improvement work associated with the One University project is currently underway. Open cuts are being made along University Drive for installation of sanitary sewer connections. The work is proceeding from west to east. Lateral connections are being completed for the senior affordable housing building, and connections for the multifamily affordable housing building will follow.

Extension of the northbound left turn lane along Ox Road and reconstruction of the median should be complete within the next three weeks. Pedestrian improvements at the intersection of Ox Road and University Drive are scheduled to begin on March 20 and will take eight weeks to complete (two weeks per corner). Upon completion, connection of the remaining lateral sanitary sewer connections along University Drive will proceed.

The completion of the senior and multifamily affordable housing buildings is anticipated in May 2024. One Main, the student housing project, is scheduled for completion in July 2024.



# **Cases Filed with the Board of Zoning Appeals**

The Fairfax County Board of Zoning Appeals (BZA) hears and makes decisions on requests for variances (relief from specific zoning regulations such as lot width, building height, or minimum yard requirements) and Special Use Permits. It meets on Wednesdays beginning at 9:00 a.m. BZA meetings are aired live on the County government's cable TV Channel 16. Residents who have concerns about an application are encouraged to submit a letter for the record or testify at the hearing on the case in person, by telephone, or by pre-submitted video. For information on how to submit comments or testify, please visit the **Board of Zoning Appeals website**. These matters will not come before the Board of Supervisors but will be decided by the BZA. Staff reports are normally available online a week before the scheduled hearing.

Access to information on BZA cases is available through the Planning and Land Use System, or PLUS. This system allows users to create and submit applications online, pay fees, track the status of applications, and receive electronic notifications. It also offers more information to the public than the previous system and does so in real time. Visit the <u>PLUS website</u> for more information on this land use platform.
