## Senior Safety Summit to be Held March 31

## Applications for Express Lanes Community Grant Programs due March 31

## Braddock Bus Routes Originally Slated for Elimination Are Restored

It was proposed that the Washington Metropolitan Area Transportation Authority (WMATA) cut the 18 P, R, and S bus lines, which serve Burke Centre, and the 17 A, B, F, and M lines, which serve the Kings Park area. To find a solution, Supervisor Cook contacted the Fairfax County Department of Transportation (FCDOT) to learn of possible alternatives to these reductions. After working with his office to identify the most essential bus routes (the 18 P and the 17 M), FCDOT staff members contacted WMATA with the request to include both of them in their revised service changes. Those two routes are being restored, and Braddock neighborhoods will continued to be served with these restorations.

## Code Compliance Corner

The topic for the third installment of “Code Compliance Corner” is unpermitted construction. Fairfax County requires a Building Permit for all new residential and commercial construction. If you notice suspicious new construction or demolition of an existing structure, construction vehicles, construction equipment or materials, mud on the streets, or work occurring late at night, you can call the Department of Code Compliance (DCC) to confirm if there is an active building permit associated with the address. ## CERT Training Begins March 20

The Fairfax County Community Emergency Response Team (CERT) trains people to safely help themselves and their communities in case of major disaster. A CERT Basic Training Class (No. 122) will take place this spring at St. Louis Catholic School. This class follows the FEMA curriculum, tailored to local disasters and hazards. It educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills. The instructor will provide a syllabus with the class schedule at first session. This training does not require any special physical strength or agility. You must attend all 8 sessions to receive the certificate. Classes will meet between 6:30 to 10 p.m. on March 20, 27, April 3, 10, 24, May 1, 8 and 15. Go online to [register](#).

## Royal Lake Update

Thanks to the good weather and hard work by the Department of Public Works & Environmental Services, the project is ahead of schedule. They are hoping to close the gate to the structure by mid-March to allow the lake to fill back up. Paving and sidewalk repair will be done this spring, and landscaping will be done partially in the spring with the remainder this coming fall. The entrance to the park will be closed for a few days during the paving and sidewalk repair, but the park will remain open. Once we get a date, we will pass that information along.

## Land Use Update

### Woodward Property at Burke Lake and Coffey Woods Roads (RZ/FDP 2016-BR-019)

On February 21, the Braddock District Land Use and Environment Committee recommended approval of an application by Tetra Corporation and Christopher Companies to build nine single-family detached homes on a 2.72-acre tract of land at the intersection of Burke Lake and Coffey Woods Roads. The Committee heard five presentations from the developer over the past year and twice heard from the adjacent Burke Village Homeowners Association during its deliberation on the application.

This property is currently vacant. The proposal would include approximately 30 percent open space, a recreational trail with benches, and stormwater management facilities on the site. Tree preservation areas are located around the periphery and supplemental landscaping would be included to enhance the screening. The wetland and floodplain areas at the northeast corner would be preserved.

Of the two possible layouts, the most likely one features entry from Burke Lake Road. The alternate layout would provide access from Coffey Woods Road, but since the adjoining Burke Village Homeowners Association, which owns the small strip of land between the property and Coffey Woods Road, has declined to agree to an easement, it appears as though the first layout is probable. Despite this, the proposal that will go before the Board includes both layouts.

Because the intersection of Burke Lake and Coffey Woods Roads has significant traffic, that has been a primary focus as this project moves forward. Staff from our office have been involved in numerous conversations with FCDOT and VDOT. We are pleased that VDOT has installed an additional signal head on the left-hand side of

Burke Lake Road between Burke Road and Coffey Woods Road as well as signs indicating that a signal at the Coffey Woods Road intersection is ahead. It is our hope that these improvements will help alert drivers going southbound on Burke Lake Road of the upcoming traffic signal and reduce problems at this intersection. VDOT has also agreed to the installation of a “No Turn On Red” sign for eastbound Coffey Woods Road at the intersection with Burke Lake Road. This signage will reduce conflicts with drivers making U-turns as well as help address issues with limited sight lines looking north on Burke Lake Road.

The Planning Commission recommended approval of this application on March 2. A hearing before the Board of Supervisors was scheduled for March 14, but because of the need for a minor technical revision has been rescheduled for Tuesday, April 4, at 2:30 p.m. The Staff Report, which contains details on the project, is available at <http://ldsnet.fairfaxcounty.gov/ldsnet/ldsdfw/4559234.PDF>.
