Dear Neighbor,

It has been a difficult two weeks for our nation and our community. While the COVID-19 pandemic continues, claiming more than 100,000 lives nationwide and 423 here in Fairfax County, the May 25 killing of George Floyd at the knees of a Minneapolis police officer reminded us of the systemic racism present from the founding of our nation that continues to take Black lives. It should serve as a reminder to us all that we must continue to fight for justice at all levels of government, but especially at the local level.

My spirits were lifted yesterday as I joined hundreds of our neighbors in Burke to peacefully protest and rally for that justice. It was a truly grassroots effort, organized largely by young people, including many Lake Braddock and Robinson students and a profound display of unity and testament that Black lives matter to our community. The Fairfax County Police Department demonstrated their professionalism in ensuring that all could safely exercise their constitutional rights. I appreciate their work.

Some of the young people organizing yesterday's event were just-graduated high school seniors. I want to recognize and congratulate the entire class of 2020. While the pandemic cruelly stole their final months in high school and their in-person graduation ceremonies, our schools have organized virtual events and many neighborhoods have held car parades to recognize their achievement. To the class of 2020, we are so proud of you and can't wait to see the amazing things you'll accomplish in the years to come.

Finally, Governor Northam has announced that while most of Virginia will enter Phase 2 of his reopening plan today, June 5, Northern Virginia will remain in Phase 1 for the time being. While our health data continues to improve, we have only been in Phase 1 for a week and Governor Northam concluded we need more time to monitor the data before further easing restrictions. ## COVID-19 Community Testing Centers

We would like to remind you that there is COVID-19 testing available in Fairfax County and surrounding jurisdictions. If you have serious symptoms, such as trouble breathing, pain or pressure in your chest, confusion, or bluish lips or face, call 911. ## CVS Pharmacy Testing

39 CVS Pharmacy locations in Virginia (7 in Fairfax County) have added drive-thru COVID-19 testing centers, including:

- 7205 Little River Turnpike, Annandale, VA
- 3921 Prosperity Avenue, Fairfax, VA
- 10090 Fairfax Boulevard, Fairfax, VA locations.



- COVID-19 testing is available to eligible individuals meeting Centers for Disease Control and Prevention criteria, in addition to age guidelines. A physician's referral is not required.
- Patients need to pre-register, provide their insurance information as appropriate and verify their eligibility for testing. Once they have registered, the patient will receive an appointment window for that same day or up to two days out. Test results should be provided within three days. 

## **Preventing Tick and Mosquito Bites During COVID-19**

By now, you can probably recite the various ways to prevent the transmission of COVID-19, but do you know how to prevent tick and mosquito bites? There are some simple steps you can take to avoid bug bites that can be itchy, painful, or make you ill.

- **First**, according to the Centers for Disease Control, at this time there is no data to suggest that the new coronavirus or other similar coronaviruses are spread by mosquitoes or ticks. However, ticks and mosquitoes do spread Lyme, West Nile, Zika, and other serious vector-borne diseases you want to avoid.
- **Tip and Toss!** Once a week, get rid of standing water where mosquitoes breed. Empty or turn over tires, buckets, planters, toys, pools, birdbaths, flowerpots and trash containers. Mosquitoes can breed in very small puddles, so be thorough.
- **Defend your Castle!** Repair screens on windows and doors to keep mosquitoes outside.
- **Stay Cool!** Use air conditioning when available, or sleep under a mosquito bed net if air conditioned or screened rooms are not available.
- **Shields Up!** Wear EPA-registered insect repellent with DEET, picaridin, oil of lemon eucalyptus, IR3535, para-menthane-diol (PMD), or 2-undecanone. Always follow the instructions on the product's label.
- **Gear Up!** Wear long-sleeved shirts and long pants. Treat outer clothing layers with permethrin, but do not apply permethrin directly on your skin. Follow the label instructions for applying permethrin to clothing.
- **Outsmart Them!** Stay indoors at dawn and dusk to avoid peak mosquito activity.
- **Attack First!** Insecticide used carefully and according to the product label can help eliminate mosquitoes in your yard.

## **Comments by Chief Edwin C. Roessler Jr. on Challenges to the Public's Trust of the Law Enforcement Profession** (05/29/2020)

"The Fairfax County Police Department has been serving our communities for 80 years, and it has troubled all of us in law enforcement to observe events around this country, including what occurred in Minneapolis where the sanctity of Mr. Floyd's life was ignored and other officers did not intervene to preserve another precious life. Earlier today the Hennepin County Attorney issued murder charges, and we shall have faith the local and federal justice systems will navigate toward justice for the Floyd family, the communities impacted, and our entire nation. However, we must be mindful there is a healing process where righteous anger needs to be constructively exercised through the right to free speech." Click [here](#) to read the full message.

## **From the Office of Governor Northam** (06/02/2020)

Governor Ralph Northam today signed Executive Order Sixty-Five and presented the second phase of the "Forward Virginia" plan to continue safely and gradually easing public health restrictions while containing the spread of COVID-19. The Governor also amended Executive Order Sixty-One directing Northern Virginia and the City of Richmond to remain in Phase One."

- "Most of Virginia is expected to enter Phase Two on Friday, June 5, as key statewide health metrics continue to show positive signs. Virginia's hospital bed capacity remains stable, the percentage of people hospitalized with a positive or pending COVID-19 test is trending downward, no hospitals are reporting PPE shortages, and the percent of positive tests continues to trend downward as testing increases. The Governor and Virginia public health officials will continue to evaluate data based on the indicators laid out in April." Click [here](#) to read the full press release.

### **Pool, Water Mine, and Our Special Harbor to remain closed this Summer**

The Fairfax County Park Authority will not open its outdoor water attractions this summer due to COVID-19. The popular Water Mine Family Swimmin' Hole at Lake Fairfax Park in Reston and Our Special Harbor Spray Ground at Lee District Family Recreation Area will remain closed this summer. Also closed is Martin Luther King Jr. pool. Similar actions were announced Wednesday by Prince William Parks & Recreation, echoing closures across the region.

- Water parks, spray grounds and pools are greatly constrained by Centers for Disease Control and Prevention guidelines governing safe use by the public. Current CDC guidelines suggest that people not visit water and spray parks. Operational challenges -- with social distancing, limits to the number of people inside facilities and the pools, the use of recommended safety masks, protocols for public and staff safety -- are significant. ### **Outdoor Athletic Fields Reopened**

The Fairfax County Park Authority, Fairfax County Public Schools, and the Department of Neighborhood and Community Services announced the reopening of outdoor athletic fields in Fairfax County for unpermitted use as part of Forward Virginia Phase 1 for Northern Virginia.

Areas opened include more than 850 athletic fields, including synthetic turf fields and fields at Fairfax County parks and public schools. Click [here](#) to learn more.

- Open, walk-on use of athletic fields is allowed when the field is vacant and only during regular operating hours. All groups that use the fields must follow all state and Centers for Disease Control and Prevention (CDC) guidelines, including limiting group size to fewer than 10 individuals, following social distancing, wearing a cloth face covering if physical distancing is difficult, covering coughs and sneezes, using proper handwashing hygiene, and staying home if sick.

### Phased Approach for Metro Services

Metro is currently in their Stabilization Phase. Metro service levels will not increase substantially during this phase. Once Metro begins their Managed Re-Entry phase, they will begin to restore all bus routes with less frequent service, but the routes will be operating. According to the Metro graphic, this is expected in August- October.

### Fairfax Alliance for Better Bicycling's (FABB) Advisor Program

Volunteers from around the county are available to advise new commuters on bike routes to work or wherever they need to go. ## Fairfax County Public Library's (FCPL) Contactless Curbside Service

FCPL's contactless program began Monday, June 1. Curbside pickup hours at all branches are 10:00 a.m. to 4:00 p.m. Monday through Friday.

- To pick up your holds, please park in the designated area of your library's lot and call the branch phone number on the posted sign. Provide your library card number to staff on the phone and remain in your car until your holds have been deposited on the pickup table and library staff have returned to the building.
- You may request a book or a grab bag based on your reading preferences by calling the branch. Contacting the library with requests ahead of time will provide a faster pickup experience.
- All returned library materials should be deposited in the library's book drop. Do not return library materials to staff or put them on the pickup tables.
