
- Project:

### LONG TERM CARE (LTC) CONTINUUM OF SERVICES

- Promotes the health and independence of the frail elderly and adults with disabilities
- Provides a safe and secure environment
- Is part of the continuum of Long Term Care (LTC) services
- Offers participants a vibrant, stimulating, and nurturing alternative to more restrictive and costly long term care options
- Provides caregiver support and respite






### **ADHC PROGRAM FEATURES**

- Open 5 days a week from 7:00 am to 5:30 pm
- Offer therapeutic activities, nutritious meals, social engagement
- Offers ongoing health care management
- Transportation via Fastran
- Fees based on sliding income scale and range from \$16 – \$109 per day

- Scope of Work:
  - Staff are exploring the feasibility of privatizing Adult Day Health Care Centers operated by the Health Department. There are currently four County operated Adult Day Health Care Centers. They are:
    - Lewinsville Center
    - Lincolnia Center
    - Mount Vernon Center
    - Herndon Harbor Center
  - It is important to stress the Health Department is not proposing to eliminate ADHC services, but rather a new model will be developed with community providers to ensure sustainability, quality and accessibility of ADHC services.





- In addition to the privatization of the Adult Day Health Care Centers, staff will explore whether any opportunity exists to offer other County services at the co-located sites more efficiently. Services/programs currently being reviewed include:
  - Meals administered by the Department of Family Services
  - Transportation administered by the Department of Neighborhood and Community Services (NCS)
  - Senior Centers operated by NCS. Currently, there are four senior centers which are co-located with ADHCs. They include:
    - Herndon Senior Center
    - Lincolnia Senior Center
    - Lewinsville Senior Center
    - South County Senior Center

- Core tenets of the program will continue.
  - Individuals will continue to receive services regardless of income
  - Transportation services to/from the program(s) will continue regardless of who is providing the services
  - Participants will continue to receive meals
  - Programs will continue to operate Monday through Friday
  - Adult Day Health Care centers will continue to be licensed by the Virginia Department of Social Services

#### • Why now?

- In spite of the aging population over the last six years there has been a steady decline in ADHC enrollment.
  - Average daily attendance (ADA) has dropped from 134 in FY 2011 (6 centers) to 90 in FY 2017 (4 centers).
  - Decrease in enrollment was not associated to the reduction in centers.
- The decreased enrollment is in part due to the proliferation in long term care service options available in the County.
  - While the increase in options is a positive trend, many of these options are not affordable for individuals with limited income.
  - However, it is also the proliferation of providers that enables the County to explore privatizing the services.

#### • Potential Benefits:

- Opportunity to identify a more innovative, cost effective and sustainable model of care.
- Build senior service capacity by leveraging available community resources.
- Among persons 85 years and older there is a net in-migration to Fairfax County; therefore, savings realized could be reinvested into programs designed to serve this aging population.





### **NEXT STEPS**

#### • Next Steps:

- Develop a comprehensive communication to inform key stakeholders to include caregivers, participants, county employees, community partners and advisory/advocacy groups.
- Engage a consultant to determine the feasibility of privatizing ADHCs. It is anticipated that the consultant will guide staff on a realistic implementation schedule (timeline) and scope of services (should changes be phased-in over a period of years).
- Research alternative service delivery models utilized by other jurisdictions.
- Present privatization options to the Board at an upcoming LOBs committee meeting.
