Fund Purpose



◆ To reflect General Fund support of agencies and organizations that receive County contributions for the purpose of promoting the general health and welfare of the community. Contributory agencies are nonsectarian, nonprofit or quasigovernmental entities.

General Fund Transfer Growth Since FY 2001

Growth in General Fund Transfer:

- FY 2009: \$13.55 million FY 2001: \$6.02 million
 - An increase of \$7.53 million or 125%
 - An average increase approximately 14%

Fund Reduction Priorities Reduction Philosophy



- Maintain important regional and state memberships where dues are based on population and other formulas. Maintain full funding for organizations where county contribution based on MOUs, agreements, etc.
- Reduce County contribution to most organizations by 15 percent from the FY 2009 Adopted contribution commensurate with funding reductions proposed for County agencies.
- Review certain contributions for elimination or deferral, looking particular at whether services from organization can be provided in-house and where private resources are available to offset the County contribution.
