Community Discussions Summary



Three Fairfax County Lines of Business (LOBs) focused presentations were held to respond to Frequently Asked Questions (FAQs) and to solicit input. The Board of Supervisors' Chairman Sharon Bulova participated in robust discussions at each of the community locations.
