

#### DEPARTMENT OVERVIEW

- 1592 full time personnel (1,574 merit / 18 grant)
  - 350 operational field personnel required daily (minimum staffing)
- 395 Operational Volunteers
- 46 work locations
  - 38 staffed fire stations
  - 8 other staffed work locations (ex: Two Apparatus Repair Facilities, Massey, Burkholder, Urban Search and Rescue (US&R) Warehouse, Welfit, Training Academy, and Lorton Site)
- 127 front line staffed emergency response vehicles
- 95,354 Incident responses FY15
- \$24.2M in Revenue, \$16.9M from transport billing








- First Engine on Scene of a Structure Fire in Under 5:20
  - Meet standard only 51.90%
  - Changing fire environment
  - Larger homes
  - Larger search areas
  - Rapid fire development
  - Occupant life safety

















- First Advanced Life Support (ALS) Provider on Scene of ALS Emergency Under 5 Minutes
  - Meet standard only 58.26%
  - Aging residential population 40% of transports are over age 60
  - Growing daytime population
  - Heart Attack irreversible damage occurs in minutes
  - Stroke for every minute of delay in treatment, almost two million brain cells are lost









**PURPLE SAGE COURT** 

Townhouse Fire October 13, 2015 Reston, VA

- Operations early morning
- Two-story townhouse
- Heavy smoke showing
- Occupants trapped inside
- Rescue operations
- Interior fire attack
- ALS care, treatment & transport of two victims rescued
- Four animals perished, two animals saved by firefighters
- Both rescued victims are alive today because of the efforts & actions by the troops







## **SOUTHAMPTON DRIVE**

#### House Fire March 19, 2015 West Springfield, VA


- Operations early morning Twostory home
- Heavy smoke & fire showing
- Victim trapped on second floor
- Rescue operations without hose lines by crews
- Aggressive interior fire attack
- Victim received ALS care, treatment & transport by paramedic
- Victim delivered alive to the hospital
- Victim succumbed to exposure to fire products
- Outstanding actions & efforts by the troops










#### **Patients Transported: Output**


# Houses Reached through Safety In Our Community (SIOC) Initiative: Output




# Life Safety Education Programs to at Risk Populations – Preschool, Kindergarten & Seniors: Outcome




# Fire Inspection & System Testing Activities Conducted: Output


#### **Fire Investigations Conducted: Output**


#### **Number of Operational Volunteers: Output**


#### Residents completing Community Emergency Response Team (CERT) class: Output


# Public Safety Occupational Health Center Medical Examinations: Output


# Injuries Occurring on Fire Ground Incident Scene: Service Quality


#### **Recruitment Applications Processed Annually**


#### **Recruits Enrolled in School: Output**
