<u>DPWES Mission</u> – As one department, create and preserve a sustainable community

<u>DPWES Values</u> – Safety, Accountability, Initiative, Innovation, Integrity, Open Communication, Personal and Professional Growth, and Teamwork

County of Fairfax, VA - 2016 Lines of Business Presentation



Ensure every structure built in Fairfax County is safe – each year 60,000 permits are issued and 205,000 inspections are conducted.

Recycle and dispose of 1 million tons of solid waste each year – approximately 4,000 tons per day.

Convey and treat 100 million gallons of wastewater every day flowing through 3,200 miles of pipes and 65 pump stations.

Actively managing \$2.6 billion worth of public facilities across the entire department – from the \$140M Public Safety HQ to Lorton Road to bus shelters.

Preserve and protect approximately 900 miles of perennial streams.

Mitigate and respond to community emergencies (floods, snow, extreme weather, other disasters).



DPWES Employee Pay Grade (CY15)




