### **Minutes**

### **Report of the Chairman**

Chairman Fee informed the Commission that Commissioner Samiah Bahhur resigned.

### **Report of the Director**

Director Liberman informed the Commission that the Board of Supervisors Budget mark-up will occur on Tuesday, April 23, 2013 for FY2014 budget.

The Commission began reviewing each article under the By-Laws.

A discussion ensued on referencing special procedures in the By-Laws, Article I, Article II, Election of Officers, and suggested changes were made.

Chairman Fee made the motion was made to accept changes through Section 4 Meeting Time and Location. Commissioner Kirk seconded the motion. The motion passed unanimously.

A discussion ensued on meeting agenda, records, special meetings, and commission matters.
