Vice Chairperson Morris called the meeting to order at 5:05 p.m.

#### **Minutes**

• Member Leach made a motion to approve the March 27, 2024, minutes and it was seconded by Member Stein-McCartney. The motion passed 4-0.

## **Report of the Chairperson**

• Vice Chairperson Morris had no matters to bring before the Board.

#### **Report of the Director**

## **Report of the Staff Liaison**

- Branch Manager Newcomb introduced Officer Culbertson. Officer Culbertson's appointment will be confirmed by the Board of Supervisors on May 21, 2024.
- Director Kastl updated the Board on the Director's Analysis of tow rates and charges pursuant to Fairfax County Code Section 82-5-32(g)(1)(C).

## **Public Comment**

• Mike Fernandez distributed handouts to the Board, staff, and visitors with information from Battlefield Towing on "Administrative Fee Current Cost Per Vehicle".

• Discussion ensued on administrative fees incurred by trespass towing operators, and a study of tow rates currently in-process by the Commonwealth of Virginia.

## **Board Matters**

- Member Fleming discussed the Servicemembers Civil Relief Act (50 U.S.C. App. §§ 501 et seq.) as it relates to disposition of impounded vehicles by trespass towing operators, and discussed numbers provided by Dominion Towing relating to tow fees.
- Member Leach motioned that staff continue with the analysis of administrative fees and Member Fleming seconded the motion. Discussion ensued, and Member Leach withdrew his prior motion. A target date of May 15, 2024, was set for permitted trespassing tow operators to respond to a questionnaire sent by staff requesting information as per the Director's Analysis.

## **Old Business**

## • Election of Officers

Member Stein-McCartney motioned that the slate of elections for Board officers from the February 28, 2024, be accepted and Member Leach seconded the motion. Discussion ensued. Member Stein-McCartney then amended the motion to not accept the slate of nominated officers as an error on the slate was noted regarding the nominations in the previously approved minutes from the March 27, 2024 meeting. Member Leach seconded the motion. Discussion ensued. Member Stein-McCartney withdrew the motion. Member Stein-McCartney motioned to accept the slate of nominated officers as recorded and the motion was seconded by Vice Chairperson Morris. The motion passed 4-0. Vice Chairperson Morris was elected Chairperson, Member Leach was elected Vice Chairperson, and Member Stein-McCartney was elected Secretary, all three positions elected by a 4-0 vote.

• Division Director Kastl reviewed the bylaws as it relates to responsibilities of elected officers, including that the secretary be "responsible for recording the minutes of meetings." Member Stein-McCartney requested staff to record minutes and staff agreed to do so as a "duly appointed agent" in line with the bylaws.

Meeting adjourned at 6:25 p.m.
