**Minutes**

- A motion was made by Commissioner Kocsis and seconded by Commissioner Panettieri to approve the minutes from December 17, 2015. The motion carried unanimously.

**Director's Report**

- Director Liberman provided an update regarding the ongoing discussions and presentations relating to the 2016 Lines of Business (LOBs). Consumer Affairs' presentation is scheduled for March 8th.
- Mail Services staff worked on the President's day holiday in order to get the 2016 real estate assessment notices to County taxpayers mailed.
- Rebecca Makely, Chief of Accounting and Finance provided a summary of the Fiscal Year 2017 Budget Plan and Multi-Year FY 2017-FY 2018 Budget proposed by County Executive Edward L. Long Jr. to the Board of Supervisors. The proposed budget, which was presented on February 16th, includes an increase in the FY 2017 Real Estate Tax Rate, adjustments and increases in county employees' pay, and increases for schools. Public hearings and meetings will be held for public input. The Board will make revisions to the proposed budget and adopt the FY 2017 Budget in April.

## **Staff Report**

- Commissioners Fielding, Geier-Smith & Kocsis were congratulated on their reappointments to a three year term to the Commission by the Board of Supervisors.
- Workshops about Tenant Rights and Responsibilities continue to be offered at the Katherine Hanley Family Shelter. Information and brochures prepared by the Commission are distributed.
- Branch Chief Susan Jones invited Commissioners to participate in activities and workshops during National Consumer Protection Week, March 7 – 11. A schedule of events is available on the Consumer Affairs' website.
