Uniform Interstate Deposition & Discovery Act - §8.01-412.8 through §8.01-412.15 (Applies to depositions, production of documents and inspection of premises requested by an out-of-state court which will be served on a person or entity in Virginia. This uniform act replaces the repealed Uniform Foreign Depositions Act §8.01-411 through §8.01-412.1

DEFINITIONS:

- Foreign Jurisdiction means a state including, Commonwealth of Virginia, the District of Columbia, Puerto Rico, the United States Virgin Islands, or any territory or insular possession subject to the jurisdiction of the United States. This does <u>not</u> apply to foreign countries).
- Foreign Subpoena means a subpoena issued under authority of a court of record of a foreign jurisdiction.

PROCESSES:

The attorney or *Pro-Se* party must first contact the out-of-state jurisdiction to find out if they grant reciprocal privileges to the citizens of the Commonwealth of Virginia and their filing requirements.

If they have adopted the new Uniform Interstate Deposition & Discovery Act:

REQUIRED Documents:

- Request for issuance of a subpoena or subpoena duces tecum
- Written statement that the law of the foreign jurisdiction grants reciprocal privileges to citizens of the Commonwealth for taking discovery.
 (Statement does <u>not</u> have to be notarized.)
- Virginia State Foreign Subpoena form <u>fully completed</u> (original + 1 copy)

IF USING: Commission

REQUIRED Documents:

- Request for issuance of Commission for out-of-state subpoena (original + 1 copy)
 - a written statement that the law of the foreign jurisdiction grants reciprocal privileges to citizens of the Commonwealth for taking discovery.
- Commission for judge to sign
- Virginia State Foreign Subpoena form # CC-1439 <u>fully completed</u> (original + 1 copy)
