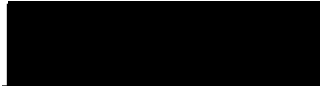
IT APPEARING that the Motion to Withdraw should be granted, it is hereby:

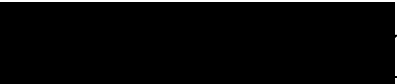
