**DISCOVERY ORDER**

WHEREAS, this matter came on by motion of the Defendant, by Counsel, for an Order pursuant to Rule 7C:5 of the Rules of the Supreme Court of Virginia; and it appearing to this Court that such motion is proper and should be granted, it is therefore

ORDERED that the Commonwealth's Attorney permit the Defendant to hear, inspect, copy, or photograph the following information or material when the existence of such is known or becomes known to the Commonwealth's Attorney and such material or information is to be offered in evidence against the Defendant in the Juvenile and Domestic Relations District Court:

1. Any relevant written or recorded statements or confessions made by the Defendant, or copies thereof, and the substance of any oral statements and confessions made by the accused to any law enforcement officer; and
2. Any criminal and/or traffic record of the accused (available for inspection upon request at the CW's Office); and
3. Any video in possession of the Commonwealth that is otherwise covered by 7C:5 in relation to the above-referenced case number(s).

IT IS FURTHER ORDERED that the Commonwealth make available the required discovery, as provided above, before the trial/preliminary hearing is held (regardless of the currently scheduled date) if the request is submitted to and endorsed by the Commonwealth's Attorney's Office at least 15 calendar days prior to trial/preliminary hearing.
