# FAIRFAX FALLS-CHURCH COMMUNITY SERVICES BOARD EXECUTIVE COMMITTEE VIRTUAL MEETING MINUTES OCTOBER 20, 2021

The Executive Committee of the Fairfax-Falls Church Community Services Board met electronically due to the COVID-19 pandemic that has made it unsafe to physically assemble a quorum in one location or to have the public present. #### 6. <u>Director's Report</u>

<sup>\*</sup>Board Members Jennifer Adeli and Captain Derek DeGeare abstained from the approval of Minutes, they noted they were absent during the September 15, 2021, meeting.

Executive Director Daryl Washington stated his continued meetings with the Department of Human Resources and Department of Management & Budget in regards to salary reclassification to help with retention and recruitment efforts; the regional CSB's have initiated data gathering for boarding (any individual who is in the emergency room that has to wait for more than 8 hours), during the month of September 2021, Fairfax County had 51 individuals were in custody order; Fairfax County is now testing individuals who are not vaccinated and individuals whose vaccination status is unknown on a weekly basis; due to staff shortages there has been a reduction in the numbers of hours that the Merrifield Center; with the carryover approval from the Board of Supervisors, the funding for additional positions for youth and adult outpatient services has been approved; RFP review for the regional crisis call center is underway, the state has selected the IT platform that will be used for the call center, the awardee name will be provided by the end of this calendar year; case management, case coordination and psycho social rehabilitation services review will occur by state advisory group that will look at how those services should be enhances across the CSB's; an individual residing in Gateway Homes went next door and told a neighbor that someone had been shot in the group home, it was a false alarm and the individual is receiving the help they need, the police department and CSB staff is partnering to come up with solutions in cases such as this.

**Deputy Director of Clinical Operations Lyn Tomlinson** clarified that emergency services continue to operate on a 24/7 basis, the assessment services at Merrifield Center have reduced their operating hours Monday through Friday from 9:00 a.m. - 3:00 p.m.,
