6. <u>Director's Report</u>

A. County, Regional, State and Cross Agency Initiatives

Executive Director Daryl Washington stated that the multi-agency group is reviewing the youth mental health and substance abuse issues within the county. More information will be provided soon. The next Opioid Abatement Authority meeting will be held on June 3, 2022, in Richmond, VA. There was an Opioid overdose fatality in Fairfax County, Route 1. The Youth & Family services team have been meeting to discuss problem resolutions. INOVA paused the medical clearances for all emergency medical groups due to the lack of capacity to take individuals with psychiatric issues that will need a medical clearance in the emergency rooms. All patients were sent to Reston Hospital Center. The Diversion Stakeholder meeting will take place after the CSB Board meeting today, I will be discussing the Marcus Alert. Medicaid has moved to a different online platform. The government budget has not been finalized. A new provider is under BOS review to provide short term substance abuse treatment and detox in Fairfax County.

Credible has offered an Optimization Package that we are considering.

C. Fiscal Oversight Committee

Committee Chair Jennifer Adeli highlighted the concern for the high vacancy rate, along with the Data Capacity Reports showing that time to treatment is decreasing. The FMLA is still causing a shortage of staff. **The next meeting is Thursday, June 16, 2022, at 4:00 p.m.**

Major Derek DeGeare stated no input has been reported regarding the nominees. The deadline is May 27, 2022.
