Governor Youngkin's Biennium Budget Proposal

In December 2023, Governor Glen Youngkin announced an additional \$300 million to fund priority one Waiver Slots for every Virginian with a developmental disability on the Waiver Waitlist

The General Assembly proposed 3,440 DD Waiver Slots to be distributed quarterly for the next two fiscal years. Governor Youngkin upheld this proposal.

- 172 Community Living and 1548 Family and Individual Support Waivers will be allocated in Fy25 and FY26
- 387 Waivers will be allocated across the Commonwealth every quarter starting July 1, 2024.

Fairfax-Falls Church currently has 1171 individuals on the Priority 1 Waiver Waitlist.

Fairfax-Falls Church is anticipating receiving 75-80 Waiver Slots per quarter

Fairfax- Falls Church will also receive Waiver Slots through the Regional and State Allocation Process

DD Waiver Slots will be allocated via the Waiver Slot Allocation Process and will be allocated to those in most need
