Support Coordination Services

Services Provided



Intake: Assessment and Eligibility

- Determine eligibility for DD services and placement on the Waiver Waitlist

Targeted Case Management: Link, Monitor and Coordinate

- 30 day/90 day Face to Face Visits
- Annual Individual Service Plans (ISPs) and Quarterly ISPs
- Monthly Collateral Contacts

Monitoring Case Management: As needed

- Housing
- Employment
- Transportation
- Annual Waitlist Updates

Transition Case Management: Final Year of School

- Assist graduating individuals to obtain employment/day support

Why We're Here Today



- Right Help, Right Now
 - Included a plan to eliminate the P1 Waiting List
- 3440 Waiver Slots will be distributed Statewide during FY25 and FY26
 - 430 (387 FIS and 43 CL) Slots will be distributed across the Commonwealth quarterly.
 - Fairfax is anticipating receiving 75-80 slots per quarter

What to Expect

Once You've Been Allocated a DD Waiver Slot



- The CSB is notified by DBHDS of the individuals selected AND the type of waiver slot being allocated
- You will receive a phone call from the CSB
- You will receive information for your review
 - A Letter of Notification of the type of waiver slot
 - A Slot Acceptance Letter from the CSB
 - Additional information regarding waiver services for your review

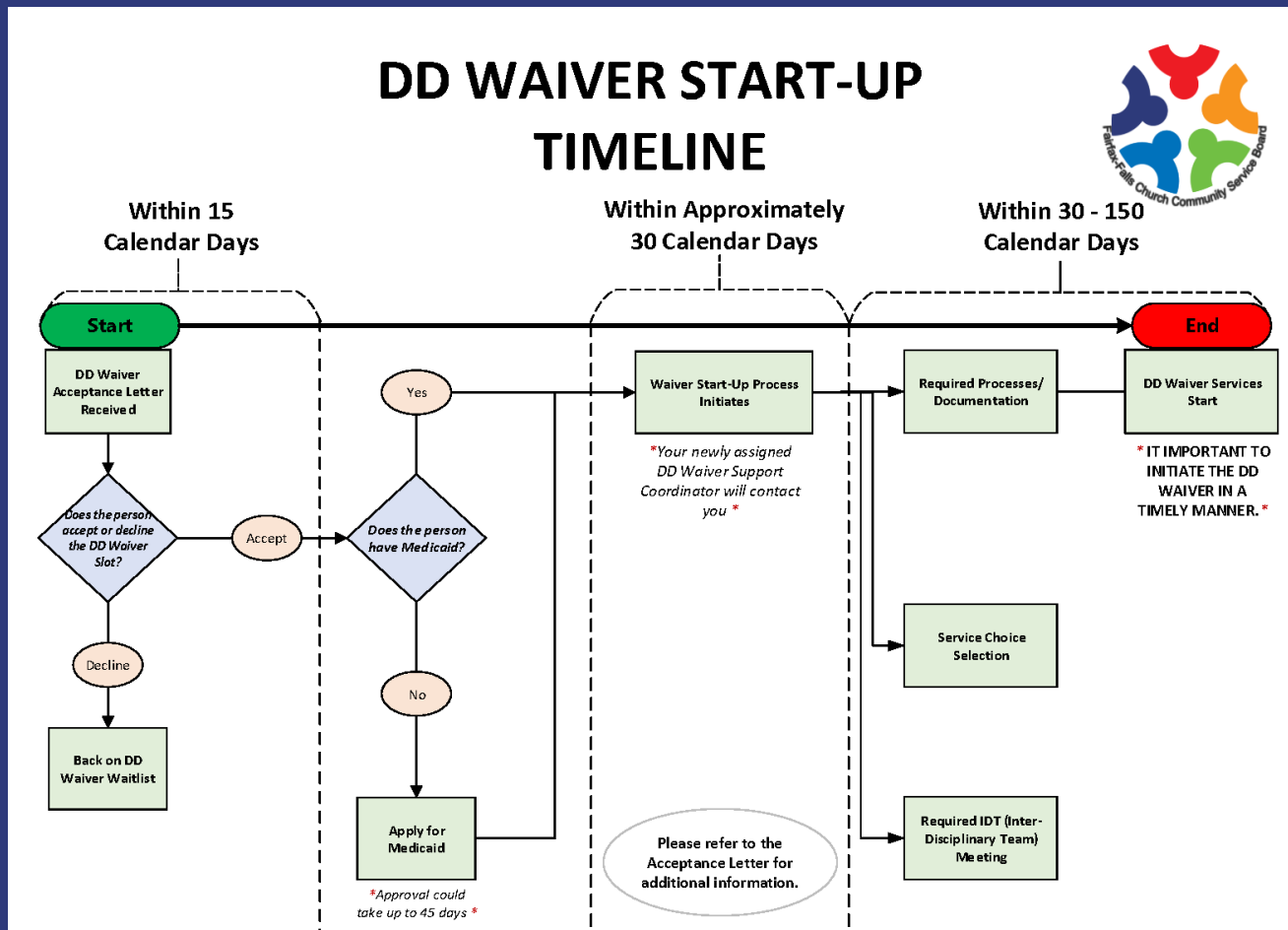
Medicaid Information

Initiating the DD Waiver



Starting the Planning Process



- You MUST have LTC Medicaid AND a current physical (within 1 year from the start date of the waiver)
- You will meet with your new Support Coordinator to update assessments, discuss services and providers, and to develop an Individual Service Plan (ISP)
- Per your Acceptance Letter and accompanying information, if you are currently receiving locally funded services, they will be converted to Waiver services or comparable services will be identified with the help of your Support Coordinator
- The process of initiating the DD Waiver should be completed as quickly as possible

Having a Waiver is Hard Work



- People in your home
- Monthly or quarterly Support Coordinator Visits
- Service Facilitator Visits
- Fiscal Agent paperwork
- Agency paperwork
- Provider tours
- Service approval and authorization
- Medicaid renewals
- VIDES
- SIS
- Annual Plans
