#### Fairfax-Falls Church Community Services Board Executive Committee October 17, 2018

The Executive Committee of the Fairfax-Falls Church Community Services Board met in regular session at the Merrifield Center, 8221 Willow Oaks Corporate Drive, Fairfax, VA.

<u>The following Committee members were present</u>: Suzette Kern, Chair; Gary Ambrose; Ken Garnes; Sheila Coplan Jonas; Bettina Lawton; and Edward Rose

The following Committee members were absent: Captain Basilio 'Sonny' Cachuela, Jr.

<u>The following staff was present</u>: Daryl Washington, Mike Goodrich, Cindy Tianti, and Lyn Tomlinson

#### 1. Meeting Called to Order

The meeting was called to order at 5:11 p.m.

#### 2. Approval of the Minutes

Edward Rose made a motion for approval of the September 19, 2018 Executive Committee minutes as presented, which was seconded and passed.

#### 3. Adoption of the Executive Committee Agenda

The September 2018 Executive Committee meeting agenda was presented for review. As no revisions were forthcoming, Edward Rose moved for approval of the agenda as presented, which was seconded and passed.

#### 4. CSB Board Agenda

Following review of the September 2018 CSB Board meeting agenda a reminder was offered to add a Closed Session notice as a standing agenda item, following which the agenda was accepted as revised.

#### 5. Matters of the Executive Committee

#### A. Behavioral Health Oversight Committee (BHOC):

Committee Chair Gary Ambrose provided an overview of activities of the October meeting, highlighting the following:

- Lyn Tomlinson spoke on concerns related to the implementation and funding of Medicaid Expansion, attendees were encouraged to review the BHOC meeting minutes for additional information.
- O Suzette Kern reported on a plan discussed at the CSB Board Member Retreat for periodic solicitation of feedback from Associate Members related to the CSB community profile, work with partners, services provided, etc. Ms. Kern further reported that the formation of an Ad Hoc Committee to determine the format and objectives is underway, and asked that in the interim, attendees reach out to Ms. her with any recommendations or questions.

 Sheila Coplan Jonas, added that, in support of this plan, it may be helpful to schedule a joint meeting of the Developmental Disabilities and Behavioral Health Oversight Committees to include Associate Member input.

The next BHOC meeting is scheduled Wednesday, November 7, at 5:00 p.m. at the Merrifield Center, Level 1-Room 308A/B.

#### B. Compliance Committee:

No update was provided as the Compliance Committee had convened just prior to this meeting.

The next meeting of the Compliance Committee is Wednesday, November 14, at 4:00 p.m. at the Merrifield Center, Level 1-308A/B.

#### C. Developmental Disability (DD) Committee:

Sheila Coplan Jonas, provided an overview of the October meeting, highlighting the following activities:

- o Barbara Wadley-Young was warmly welcomed in her new position as Assistant Deputy of Community Living Treatment & Supports.
- Four Associate Member agencies and one proposed Associate Member agency provided brief profiles of their individual agencies including background, services provided, a success story, and envisioned Associate Member role with the DD Committee.
- Related to CSB Bylaws, nomination of the two (present) proposed Associate
  Members must wait until the Bylaws are revised to allow for nominations in months
  other than June.
- Ms. Jonas reported attending the Fairfax County Board of Supervisors' (BOS)
  declaration of October as National Disability Employment Awareness Month.
  Noting it was well attended, Ms. Jonas encouraged further involvement by Board
  members and Committee Associate Members as it provides a connection with the
  population and purpose of Board efforts.
- Ms. Jonas announced the WIN (Welcoming Inclusion Network) inspired initiative Creating an Inclusive Workplace in Fairfax County meeting on October 22, 2018. The event is being widely publicized to county, public, and private entities and community members as an opportunity to learn about how to create more inclusive workplaces and employment opportunities for people with ALL abilities across Fairfax County.
- Additionally, Ms. Jonas reported that Lori Stillman, Evan Jones, and Barbara Wadley-Young are working with Mike Goodrich to cost out the WIN stakeholders recommendations in preparation for the final public discussion scheduled in November. This meeting precedes the presentation of the recommendations before the Board of Supervisors in December.

The next meeting of the Developmental Disabilities Committee is Wednesday, December 5, at 5:30 p.m. at the Merrifield Center, Level 1-308A/B.

#### D. Fiscal Oversight Committee:

Suzette Kern, on behalf of Captain Cachuela, offered a reminder that the meeting is the following Friday, noting the agenda items include the 1<sup>st</sup> Quarter Modified Fund Statement,

FY 2018 Carryover Approval by the Board of Supervisors, FY 2020 Budget Submission, and the FY 2020 CIP (Capital Improvement Plan) Review. Erin Bloom will include a reminder of the Budget 101 Training Workshop scheduled to precede the October CSB Board meeting. It was further noted that Ken Garnes will be Acting Chair at Friday's meeting in Captain Cachuela's absence.

The next meeting of the Fiscal Oversight Committee is Friday, November 9, 9:00 a.m., at the Pennino Building, Room 836A.

#### E. *Other Matters*:

Suzette Kern provided a brief overview of the CSB Board Retreat highlighting the Action Items, noting they are highlighted on the provided handouts. Action Items include:

- How to process documentation at the conclusion of a Closed Session. This action recognition of the confidentiality of the matters discussed in Closed Session. Mike Goodrich agreed to research BOS procedure and provide his findings to the Board.
- Decision on how to handle (Action or Information Item) the CIP and document at Board meeting. Following discussion, the Committee recommendation is to present the CIP as an Information item.
- Establishment of an Ad Hoc Committee to determine the preferred method and timing for soliciting Associate Member and community partner feedback and communication.
- Discussion of revising the procedure for Board approval to post the Community Services Performance Contract for public comment.

Mr. Garnes and Mr. Rose followed up the retreat discussion with recommendations to ensure future retreats follow a more informal format including seating and not working through lunch. Additionally, it was recommended that the agenda for future retreats include more high-level, strategic topics that are not typically covered at the monthly meetings.

Discussion regarding the regular Board meetings resulted in a request for more systemrelated topics to better inform the members of the mechanisms of the CSB as well as rearranging the agenda to move the Director's Report to earlier on the agenda.

#### 6. CSB Board Annual Planning Calendar

The CSB Board Annual Planning Calendar was presented for review. Noting no recommendations were forthcoming, the calendar was accepted as presented.

#### 7. <u>Director's Report</u>

Executive Leadership provided several agency updates as highlighted below:

Mike Goodrich and Lyn Tomlinson provided an update to recently filled senior leadership positions including

- Jessica Burris was recently hired as the Chief Fiscal Officer beginning Monday, October 29<sup>th</sup>.
- Georgia Bachman, also starting October 29<sup>th</sup>, was promoted to the position of Assistant Deputy for Acute & Therapeutic Treatment Services.

Lyn Tomlinson provided background and an update to ARTS – Additions and Recovery Treatment Services and OBOT - Outpatient Based Opiate Treatment (inclusive of the ARTS program) program implementation. A workplan has been developed, further noting the

compliance and documentation requirements are burdensome and present a challenge to implementation. It was reported that implementation is likely to need additional funding and positions.

Daryl Washington provided an update to several topics including


- Offering a reminder of the DBHDS Commissioner visit and facilities tour scheduled for the following day, he reported that the visit will include tours of the Joe and Fredona Gartlan Mental Health Center and the Merrifield Center as well as lunch. Mr. Washington noted topics may include the impact to Northern Virginia of Medicaid Expansion funding, the STEP-VA funding flat-rate, the hospital bed shortage, the impact of changing regulations on staff, and PACT team coverage including a map that clearly illustrates areas of need in Fairfax County.
- Reporting an opportunity to attend a presentation by the Deeds Commission (SJ-47) on October 1st. Mr. Washington was offered an opportunity to speak at the event on the topic of Medicaid Expansion challenges including funding. Mr. Washington further noted a previous opportunity to discuss Medicaid Expansion with the Commissioner at the VACSB (Virginia Association of Community Services Boards) conference in early October.
- Offered a reminder of the previously reported BOS declaration of October 2018 as
  Disability Employment Awareness Month and of the *Creating an Inclusive Workplace*in Fairfax County meeting on October 22, 2018. Additionally, the November 13, 2018
  WIN meeting will include the cost determinations and the final opportunity for
  comment on the stakeholder recommendations. It was suggested that following the
  pre-meeting update to Supervisor Cook on November 8<sup>th</sup>, Barbara Wadley-Young
  would provide an update at the November 9<sup>th</sup> Fiscal Oversight Committee meeting.
- Noting attendance at the VACSB conference earlier this month, topics discussed
  included the Commissioner is recommending that some of the smaller CSBs merge
  into regional CSBs to recognize fiscal efficiencies, also the FX-FC CSB will be
  assuming a leadership role in defining STEP-VA.
- Reporting continued follow-up to the Organizational Assessment, Mr. Washington is
  continuing to host bi-weekly Brown Bag lunches at various CSB sites. Some feedback
  include facility and equipment concerns as well as recognition the need to lighten the
  documentation requirements for staff. This will be addressed through a review of
  current documentation to eliminate duplication and redundancy.
- Recent activities related to concerns with Medicaid Expansion include invitations from the County Legislative Office to Mr. Washington to attend scheduled meetings with legislators, confirming that the Board will be kept apprised of meeting details.
- The Community Readiness and Support Program (CRSP) is scheduled for the final move from the Springfield Mental Health Center on November, 2, 2018.
- Copies of the just completed FY 2018 Annual Report were provided to Committee members, with Mr. Washington providing a brief overview of each page. Mr. Rose noted a possible error in statistics that will be investigated and, if needed, corrected.
- Directing attention to the handout provided in the meeting materials *Transition of the Fairfax County Community Health Care Network*, Mr. Washington clarified this recommends transitioning from partnership with the Fairfax County Community

Health Care Network (CHCN) to partnership with federally qualified health centers (FQHCs).

There being no further business to come before the Executive Committee, the meeting was adjourned at 6:23 p.m.
