



# Addressing the Heroin/Opioid Epidemic

The number of people now facing heroin and opioid dependency has grown dramatically, and the crisis has been labeled as a “public health emergency” in the Commonwealth of Virginia. Fairfax County is not immune from this epidemic.

The CSB and partners have a broad range of services and activities to address this growing problem.

- **Walk-in screenings**

Available to youth and adults at the Merrifield Center (8221 Willow Oaks Corporate Drive, Fairfax, 703-383-8500, TTY 711) for mental health and substance use services, Monday - Friday, 9 a.m. to 5 p.m. Youth walk-in evaluations are offered during this time and also until 7 p.m. on Tuesdays.

- **Detoxification services**

The Fairfax Detoxification Center is a short-term residential substance abuse program for adults to safely detoxify from the effects of drugs and/or alcohol (4213 Walney Road, Chantilly, 703-502-7000, TTY 703-322-9080). Services include medication to help with withdrawal from opioids. Detox Diversion is a mobile team of CSB staff which responds to police and community requests to intervene at the scene of a potential arrest to refer the individual instead to detoxification services. The Addiction Medicine Clinic at the CSB's Merrifield Center provides medication-assisted detoxification services and substance abuse treatment to adults in an outpatient setting.

- **Treatment**

The CSB provides a broad range of treatment services for opioid addiction, including outpatient, intensive outpatient, day treatment, residential, medication-assisted treatment, peer support and community support services. A Substance Abuse Prevention program is offered in some schools.

- **REVIVE! training**

Throughout the community, CSB provides REVIVE! training, a program of the Commonwealth of Virginia that makes naloxone (Narcan®) available to lay rescuers to reverse opioid overdoses. - **Encouraging proper drug disposal**

CSB and the Fairfax County Health Department offer drug disposal kits for residents to safely dispose of excess or unused medications to prevent their misuse. Each Fairfax County Police station has drug take-back boxes. Fairfax County also encourages participation in Operation Medicine Cabinet Cleanout and the U.S. Drug Enforcement Administration’s drug take-back program.
