

Fare Analysis



Fare Changes Overview

- WMATA faces a significant budget shortfall in FY 2025 (starting 7/1/2024)
- Fare increases are proposed for FY 2025.
- Fairfax Connector matches WMATA/Metrobus fares
- Fare equity analysis completed
- Route 599 fare also adjusted to match other Fairfax Connector express bus route fares

Preliminary Title VI Analysis

- FCDOT conducted fare equity analysis as part of Title VI requirements
- Several routes were identified as meeting the major service change threshold per Title VI requirements: 351, 352, 610, 670, and 921.
- Further **disparate impact (DI)/disproportionate burden (DB)** were conducted.
- **No DI/DB** was identified for the proposed fare change and service change
- Routes 610/670 will improve connectivity between the Chantilly, Centreville, Vienna, and Franconia areas


