Service Overview

- Routes included in the proposal are 697 and 699
- Route 697 is a new express route providing service between the Stringfellow Road Parkand-Ride and the District of Columbia
- Route 699 will add additional morning and afternoon trips to address rider demand on this service



Service Overview

- Funding for both routes comes from I-66 toll revenues allocated to the Northern Virginia Transportation Commission's (NVTC) Inside the Beltway Commuter Choice grant program
- Both routes provide point to point service to major employment destinations in the District of Columbia from Fairfax County

Route 697 – Stringfellow Park-and-Ride to DC

- Route will feature ten morning and ten afternoon trips
- Route will provide point to point service for riders accessing employment centers in the L'Enfant Plaza Area of DC


