 To add the following lease factors listed below to determine the lease prices for products in "Attachment C" and "Attachment D Complete Price Schedule KMBS dba Meridian". The lease payment can be factored by multiplying the appropriate lease factor to the outright purchase price. For example, if the outright purchase of a MFD is \$10,000.00, then 48-Month FMV will be \$268.50 / month.
